**BILL.**

An Act to amend the Municipal Act of Lower Canada.

**W**HEREAS, it is expedient to amend the Lower Canada Consolidated Preamble dated Municipal Act, in the manner hereinafter set forth; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

5 **1.** The sixteenth sub-section of the twenty-seventh section of the New sub-Lower Canada Consolidated Municipal Act is hereby repealed and the following substituted therefor:

“16. In case of the neglect of the County Council to make By-laws in the month of March in each year, respecting the sale of spirituous liquors, each local Council may then exercise the powers conferred on County Councils by the tenth, eleventh, twelfth, thirteenth and fourteenth subsections of section twenty-six of this Act.”

10 **2.** The following sub-section is hereby added to the twenty-seventh Additional section of the said Lower Canada Consolidated Municipal Act as sub-section 27 of 15 amended by the Act twenty-fourth Victoria, Chapter twenty-nine, and same Act. shall be read and construed as forming part thereof:

20 “22. Every local Council may make By-laws to compel every proprietor, occupant or tenant of a lot or holding, to macadamize, lay with stone, level or pave the front of his property contiguous to streets or highways, or to do or make thereon such other works or improvements as may be prescribed or ordered.”

25 **3.** The twenty-ninth section of the said Lower Canada Consolidated Amendment Municipal Act is hereby amended in such way as to extend to local of 29th section. Municipalities generally, the powers and privileges which it confers on Town and Village Municipalities, and shall hereafter be interpreted as if the words “Local Municipalities” had been therein originally inserted.
