



# LAW DEPARTMENT

## The Western Mniversity.

The School has been established as the Faculty of Law in connection with "The Western University and College," of London, Ontario.

The inadequate method of legal education by examinations only in the Province of Ontario, which has hitherto not had an institution for teaching law, and the number of students in the city of London and western portion of Ontario, led to the consideration of the subject by the Middlesex Law Association, who resolved upon the organization of the Law School as a department of the Western University with the design and object of giving the students by means of frequent lectures and examinations, in addition to their personal study and reading, that general knowledge of law which a University aims to impart, together with that special professional instruction in the laws of Ontario as administered by the courts, which will/fit them for this work as practising lawyers.

The curriculum has been framed with a view to embrace all the subjects of the examinations required by the Law Society of Upper Canada, so that diligent students of the School will have no difficulty in passing their examinations at Osgoode Hall, until such time as the examinations of the School are accepted as equivalent to those of the Law Society, which it is anticipated the practical efficiency of the School will soon justify.

The course of instruction also includes the subjects now required by other Universities in Ontario for the degree of Bachelor of Laws, which degree will be conferred by the University on students of the School who have complied with the requirements of the Faculty.

The School has received the support of the leading members of the profession of law in London, to whose offices most of the students belong.

The inaugural lecture to the students was delivered by His Honor Frederick Davis, Q. C., Junior Judge of the County Court of the County of Middlesex and Vice-Chancellor of the University, in the Court Room, London, on the evening of Friday, 4th December, 1885, and which was largely attended by friends of the University and School.

The regular lectures were begun on Wednesday, the 9th December, and have been since carried on, and will be continued in the manner now provided for by the rules of the School. The number of students, as by reference to the list will appear, has greatly encouraged the members of the Faculty in their efforts, and indicates that the School has been successfully started.

Whereas, the London Law School has been established as a Department of Law in connection with the "Western University and College, of London, Ontario," by a statute of the Senate of the said University, which provides that the Faculty of the School shall be a self-governing body. Therefore, the Dean and Faculty of the London Law School make the following rules for its government:—

### MEETINGS OF THE FACULTY, ETC.

1. There shall be a general meeting of the Faculty immediately preceding the opening of the School and immediately following its close in each year, and such other meetings as may from time to time be found necessary.

2. The Registrar and Bursar shall make a report of the affairs of the School to the general meeting of the Faculty at the close of the school year.

<sup>5</sup> 3. The revenue of the School shall comprise the fees paid by the students, and any donations and other contributions which may be made towards its maintenance.

4. If at any time the funds of the School exceed what may be required for current expenses, such funds shall be invested in the manner hereafter provided by  ${}^{b}$  the Faculty.

### STUDENTS.

5. Any student who intends to submit to the examination with a view to a degree of Bachelor of Laws shall be enrolled as a student of the School on the books of the Registrar after having matriculated as a student of Law at Osgoode Hall, or in Arts or Law in any University in the Province of Ontario, or after having passed an examination similar to that prescribed by the University of Toronto for matriculants-in-law before examiners appointed by the Faculty.

### LECTURES AND EXAMINATIONS.

10

6. The course of instruction by lectures shall extend over a period of four years. The course of lectures for each year shall commence on the third Monday of September, and end on the third Friday of May following.

7. It is not important which annual course of lectures for three of these years be first taken. The fourth year's course will embrace lectures on special subjects of law, and such examinations as will aid the students in passing their examinations for a degree in law, and for call to the bar.

8. For the year 1885-6 lectures will be delivered, and examinations had upon the following subjects:---

Criminal Law. Equity Jurisprudence. Real Property. Personal Property. Contracts. Municipal Corporations. International Law. Constitutional History. Rise of Representative Government.

The students are also required to make themselves thoroughly familiar with the following text-books, upon which they will also be examined .---

11. Students are required to attend at least three-fourths of the lectures of each lecturer, and to pass the examinations prescribed by the Faculty upon the subjects embraced in each year's course.

12. The lectures will be delivered at 4.30 p.m. every Monday, Wednesday and Friday (except during vacation) throughout the Collegiate year, and upon such other days of the week, and at such other hours, as may be found necessary.

13. Vacation will commence on the 24th day of December, and end on the 4th day of January.

14. After three years the special lectures and the examination of the graduating class shall be proceeded with every year at such hours as the Faculty may appoint.

15. The annual examinations, written and oral, shall take place within two weeks immediately following the close of the lecture season, and shall include the subjects embraced in that year's course.

### DEGREES.

16. The Degree of Bachelor of Laws will be conferred by the University upon the recommendation of the Faculty on such students as shall have been duly enrolled on the books of the Registrar, and have pursued the full course of study and attended the lectures of the School for four consecutive years, and have passed the necessary examinations in each year, and have passed a final examination similar to that required for call to the bar by the Law Society of this Province. 17. Every candidate for a degree will be required to prepare and deposit with the Registrar at least once a month before the final examination for graduation a dissertation not less than forty folios in length, on some legal topic selected by himself. The dissertation must be satisfactory as to matter, form and style, and the student presenting it will be examined upon it.

19. All details of the School not provided for by these rules will be settled by the Faculty, or by that member of the Faculty having exclusive control of the detail as occasion may require.

20. These rules shall not be amended or altered to the prejudice of students who have acted upon the faith thereof.

21. Additional and further rules may be made from time to time to carry out the objects of the School.


