PEERS TREADING ON COMMONS' TOES

House of Lords Take Unprecedented Action in Amending Old Age Pensions Bill.

London, July 29.—The House of Lords has taken important steps regarding the Old Age Pension Bill and one which will bring them into direct and violent conflict not only with the majority in the House of Commons, but with Socialists and Laborites throughout the country.

When the House of Commons sent a money bill to the House of Lords it is customary for the latter to reject or pass it in its entirety.

Nevertheless, it was discovered last night that seven pages of amendments to the Pension Bill will be introduced.

The first will be submitted by Lord Cromer, limiting the operation of the bill to a period of six years.

The Lord Chancellor warned the peers that they were interfering with a money bill, and said the amendment would certainly be regarded as a breach of the privileges of the House of Commons.

In the last campaign, for months afterwards, and in fact up to the present, his ministers had been attacked in a shameful manner.

"If Laird wants to take me into court," said the premier, "I will prove it. I use the word 'grafter' knowing what it means and I repeat it again and again."

OLD AGE PENSIONS. New Zealand Scheme More Liberal Than German Legislation.

London, July 29.—As bearing on the British Old Age Pensions Bill some interesting information is given in a return containing a memorandum on the pension scheme in force in New Zealand.

In New Zealand the pension was originally fixed at £10 per annum, but was raised in 1905 to £26.

Each pension is granted for twelve months, and a fresh application must be made nearly for renewal.

The German law came in operation in 1881, and was amended in 1890.

The old age pension now given consists of two parts, an imperial subsidy of £2 10s. per annum and the amount borne by the insurance office, which is derived from joint contributions in equal shares from employer and employed.

Employees are divided into five classes, according to their wages, and the sale of total pension (including state contributions) ranges from £5 10s. per annum in class 1 to £11 10s. per annum in class 5.

Finlay, minister of agriculture, after his extended tour through the central and southern portions of the province, adds his verdict to all the favorable reports of the crop conditions this year. Mr. Finlay returned to the capital last night, and was seen by a Bulletin representative in his office at the Legislative building this morning.

"During my absence from the city, I traversed the district from Wetaskiwin to Sedgewick, stopping at Camrose, Hardisty and Daysland. The meetings held at all these places were very well attended by large and appreciative audiences. I did considerable driving about the country, and found the crops in excellent shape and the farmers in the best of spirit in anticipation of a banner yield of grain."

"In the South I visited the Coleman, Cowley and Blairmore districts. In my 25 years residence in the West I never saw the crops in such splendid shape. With the enormous crop that will be harvested this year there will be a great demand for labor, but I have heard no reports expressed by the farmers that the necessary labor will not be at hand. The railway will certainly be taxed to its utmost to handle the crop, but with their increased facilities they will likely be able to do so."

"Hot Winds at the Hat. "The crops in the Medicine Hat district have suffered greatly from recent hot winds," said the minister. "The crops have been dried up by winds that swept over the prairie like the blast from a furnace. The wind which has been ruminous to the farmers is not so much a matter of regret as the prairie grass has been nipped, cured so that it will not sour by moisture or be affected by frost, while at the same time it retains all its nutriment. This will supply excellent winter forage for the cattle."

"Another source of satisfaction to the ranchers of Medicine Hat and the easterly district, is the great calf crop this year. This is due to the mild weather which has been so common since the severe winter of 1906-07."
