

BY·LAWS

OF THE UNITED

Townships of Pover East and West.

A BY-LAW to confirm and appoint certain Officers of the Municipal Corporation of the united Townships of Dover East and West, and to provide for their salaries.

[PASSED FEBRUARY 11TH, 1859.]

BE IT ENACTED by the Municipal Corporation of the united Townships of Dover East and West, in Council assembled, under and by virtue of the Municipal Corporation Act of 1858, entitled "An Act respecting the Municipal Corporations of Upper Canada."

That Francis A. Thomas and Thomas Shaw be, and hereby are appointed Auditors for the present year, and that each of the said Auditors be paid the sum of Six Dollars, and no more.

That Charles Barillier is hereby appointed Clerk for the Municipality for the present year, and that he be paid the sum of Ninety Dollars, and no more.

That Thomas W. Smith be, and is hereby appointed Treasurer to the said Municipality, and that he be paid the sum of Forty Dollars in lieu of all per centages, and that he give bonds himself in Four Thousand Dollars and two sufficient sureties in Two Thousand Dollars each, for the faithful performance of his duties.

That Toachim Faubert and Finly Cattanach be appointed Assessors, and that each of them be paid the sum of Thirty-five Dollars, and no more.

That William Benton be appointed Collector for Second, Third and Fourth Wards, and Arnold Evans be appointed Collector for the First and Fifth Wards, and that William Benton be paid Forty-five dollars and Arnold Evans be paid Thirty-five Dollars, and no more, and that before entering upon their duties that each enter into Bonds of Six Hundred Dollars and two sureties of Eight Hundred Dollars, for the due performance of their duties, and sureties to be approved of by the Corporation.

That Alexander Reaume be Inspector of Licenses for the present year, and that he receives Two Dollars for each day of inspection.

[PASSED 11TH FEBRUARY, 1859.]

WHEREAS, it is necessary and expedient to open the Side Line Road, between lots 12 and 13, commencing at Second Concession or Fourth Range in the Township of Dover East, and running through said Township to Lake St. Clair.

Be it enacted by the Municipal Corporation of the United Townships of Dover East and West, in Council assembled, under and by virtue of the Municipal Act of 1858, entitled "An Act respecting the Municipal Corporations of Upper Canada."

That a Provincial Surveyor be instructed to survey an allowance for Road, between lots twelve and thirteen, and commencing at the Second Concession or Fourth Range, and running through the said Township to the Lake St. Clair, or as far as may be necessary, and report the same to this Corporation, and that the cost of said Survey be paid out of the funds which may be appropriated to the Second and Fourth Wards of said Township.

A BY-LAW

FOR the purpose of appropriating certain monies in the hands of the County Chamberlain and in the hands of the Treasurer of this Municipality for certain purposes.

[PASSED FEBRUARY 11TH, 1859.] WHEBEAS, it is expedient that the several Roads in this Township should be improved as early in the season as possible.

Be it enacted by the Municipal Corporation of the united Townships of Dover East and West, in Council assembled, under and by virtue of the Municipal Act of 1858, entitled "An Act respecting the Municipal Corporations of Upper Canada."

That a sum of Four Hundred and Forty-nine Dollars and Seventy cents be paid to the Councillor of the First Ward, the like sum to be paid to the Councillor of the Second Ward, the like sum to the Councillor of the Third Ward, the like sum to the Councillor of the Fourth Ward, and the like sum to the Councillor of the Fifth Ward; said several sums appropriated as above to be applied and expended by the several Councillors in the improvement, opening and surveying the several Roads in their respective Wards, and to be drawn from the Treasurer, according to the resolution of the Council passed this day.

To regulate Hotels, Taverns, Beer or Ale Houses, and to regulate the cost or charge for Licensing the same,

[PASSED MARCH 7TH, 1859.]

BE IT THEREFORE enacted by the Municipal Corporation of the

united Townships of Dover East and West, in Council assembled, by virtue of an Act of the Provincial Parliament of Canada, passed A. D. 1858, chap. 99, and entitled "An Act respecting Municipal Institutions of Upper Canada."

That all applicants for License for any Tavern, Inn or Hotel, shall have the following accommodations :---Two good Beds and Bedding, over and above those used by the residents of each heuse; good Stabling for four horses, with hay, oats, and litter at all times, together with good, wholesome food for travellers.

That before a License is granted the applicant shall enter into Bonds in himself in the sum of Eighty Dollars and two suretics in Forty Dollars each, for the due fulfillment of the rules and regulations laid down by the Inspector of Licenses or by By-Liaw.

That all Taverns, Inns, Hotels, Ale-houses, shall pay to the Treasurer the sum of \$25 for such License, which License shall cease and determine on the first day of March, A. D. 1860.

That no fine and forfeiture under this By-Law, when not provided by the Laws of Upper Canada, shall exceed \$50 or twenty days imprisonment.

And be it enacted, that all By-Laws heretofore made respecting the regulating the Licensing of Taverns, Hotels, Inns, or Ale Houses, or for the regulation of the cost or charge to be paid by the applicant for such License is hereby repealed.

A BY-LAW

FOR the relief of certain persons unable to procure Seed without assistance.

[PASSED STH APRIL, 1859.]

WHEREAS, by a By-Law of the Corporation of the County of Kent. passed 30th March, 1859, under and by virtue of the Statute of this Province, passed in the year 1859, entitled "An Act to enable County Councils to raise money for enabling persons in certain cases to sow their land," have raised, by debentures, the sum of \$5,200, of which sum said By-Law appropriates and sets over to the united Townships of Dover East and West, the sum of \$1400 on the conditions and for the purposes in said enactment.

Be it therefore enacted by the Municipal Corporation of the united Townships of Dover East and West, in Council assembled, that the said sum of \$1400 loaned as aforesaid, shall be repaid to the Treasurer of the united Townships aforesaid, in manner following, that is to say :--One-third of the sum so borrowed on the thirty-first day of December, eighteen hundred and fifty-nine, with interest on the sum so borrowed at the rate of six per cent. to that date ; one-third on the thirty-first day of December, eighteen hundred and sixty, with interest to that date ; and the balance with all interest due on the thirty-first day of December, eighteen hundred and sixty-one.

That the value or cost of said Seed so given and distributed to the several parties requiring the same, shall be repaid with interest at six per cent. per annum, one-third with interest on the thirty-first day of December, eighteen hundred and fifty-nine; one-third with interest on the thirty-first day of December, eighteen hundred and sixty; and one-third with interest on the thirty-first day of December, eighteen hundred and sixty-one.

That for the payment and discharge of the said sum of fourteen hundred dollars or so much of it as may be used, and interest

thereon, by those borrowing the same, there shall be levied and raised upon the land in respect whereof the money or seed is lent or delivered, a special annual rate over and above all other rates against such land for the repayment thereof as aforesaid, and all the rights shall apply thereto, which now or at any other time hereafter shall apply to the collection of any other rate or tax upon such land.

WHEREAS, by a By-Law of the Municipal Council of the County of Kent, it is provided that the Municipality of Dover East and West shall raise the sum of \$1312 for County purposes for the year 1859.

Whereas, by another By-Law of the Municipal Council of the County of Kent, the said Municipal Council of Dover is required to raise the sum of \$237 for School rates, equal to the Government grant for the said Townships of Dover East and West for the year aforesaid.

And be it enacted, &c., that if the sums so raised by the aforesaid rates, shall exceed in any case the amount required for such purposes respectively, the Treasurer of the said Townships of Dover East and West, shall pass such excess to the credit of the said Townships, and such sums shall be kept by him and

A BY-LAW

To repeal a By-Law passed August 27th, 1859, for the purpose of al'ering the houndary line between the Fourth and Fifth Wards in the Townships of Dover East and West.

WHEREAS, it is necessary to repeal and amend certain parts of the above recited By-Law.

Be it therefore enacted by the Reeve and Councillors of the united Townships of Dover East and West, in Council assembled, by virtue of and under the Act of the Parliament of the Province of Canada, passed in the year of our Lord 1858, entitled, "An Act respecting the Municipal Institutions of Upper Canada."

That the line dividing the eleventh and twelfth Concessions, commencing at Lake St. Clair and running along said Concession line to lot fourteen, thence along said lot fourteen to the front of the tenth Concession, thence along the front of said Concession to lot sixteen, be the boundary line between the fourth and fifth Wards; any part of said By-Law, repugnant to this, is hereby repealed.

A BY-LAW

To provide for the reimbursement of a certain loan or sum of Fourteen Hundred Dollars and interest thereon, made by the Corporation of the County of Kent, under and by virtue of a certain Act of the Provincial Parliament, passed in the year A. D. 1859, entitled, "An Act to enable County Councils to raise Money for enabling persons in certain cases to sow their land,"

[PASSDD 19TH SEPTEMBER, 1859.]

WHEREAS, it is necessary and expedient to raise the sum of Fourteen Hundred Dollars with interest thereon, from the thirtyfirst of March last past at the rate of six per cent. per annum, for the purpose of reimbursing the said County Corporation the said sum of Fourteen Hundred Dollars and interest as aforesaid.

Be it enacted that one-third of said sum of \$1400, with interest on the same from the 31st March, say nine months, be collected by a special rate from off the lands and persons in a certain list hereunto annexed, and according to their respective shares or parts of said loan, being in all Five Hundred and Thirty Dollars, that this same be collected on or before the twenty-fifth December next and paid over by the Collectors to the Treasurer of this Corporation, and by them paid over to the Treasurer of the County Council ; that the sum of Five Hundred and Twenty-three Dollars be in like manner raised and collected from the said parties in the said annexed list, for the year A. D. 1860, and payable in like manner on or before the 25th of December, A. D. 1860; and lastly, that the sum of \$495 be in like manner raised and collected from the said parties in the said list annexed for the year 1861, and payable in like manner on or before the twenty-fifth of December, A. D. 1861.

For the opening of the original Road allowance between Lots Five and Six, in the Second Concession, Fourth Range, in the Township of Dover East.

[PASSED NOVEMBER 5TH, 1859.]

WHEREAS, it is necessary to open the original Road allowance between lots five and six, in the second Concession, fourth Range, in this Township.

Be it therefore enacted to the Municipal Council of Dover East and West, in Council assembled, by virtue of and under the Authority of an Act of the Parliament of Canada, passed in the year 1858, and entitled "An Act respecting the Municipal Corporations of Upper Canada."

Be it enacted that the Government Road allowance between, lots five and six, in the second Concession, fourth Range, in the Township of Dover East, be opened by the proprietor and left to the use of the public within the first day of May, one thousand, eight hundred and sixty.

WHEREAS, it is necessary to pass a By-Law for directing that on each or either side of a Road between numbers twelve and thirteen, from the River Thames up to the second Concession, fourth Range, and along the said Concession line to a road laid out by the late Westerr District Council, and along said road to the Plains, the trees for a same of twenty-five feet on each side be out down and removed

Be it therefore enacted by the Municipal Council of Dover East and West, in Council assembled, by virtue of and under the authority of the Act of the Parliament of Canada,

passed A. D. 1858, and entitled "An Act respecting the Municipal Corporations of Upper Canada."

Be it enacted that on each or either side of a road between twelve and thirteen from the River Thames up to the second Concession, fourth Range, and along the said Concession line to a road laid out by the late Western District Council, and along said road to the plains, the trees for a space of twenty-five feet on each side be cut down and removed within the first day of August, one thousand, eight hundred and sixty, by the proprietors or on their default by the overseer of highways in whose division the land lies, and in the latter case the trees shall be used by the overseer for any purpose connected with the improvement of the highways and bridges in his division, or shall be sold by him to defray the expenses of carrying this present By-Law into effect.
