BILL.

An Act to amend the Charter of the Bank of Canada.

WHÈREAS it is desirable to amend the Act passed in the twenty-^{first} Preamble.
second year of Her Majesty's reign, chaptered one hundred and
thirty-one, and intituled, "An Act to incorporate the Bank of Can-
ada;" Therefore, Her Majesty, by and with the advice and consent of
5 the Legislative Council and Assembly of Canada, enacts as follows:

1. The corporation constituted by the said Act by and under the name ^{Name of Bank} and style of "The Bank of Canada," shall, from and after the passing ^{changed} changed of this Act, be known as "The Canadian Bank of Commerce."
2. The capital stock of the said Bank shall be reduced to, and be ^{Capital re-}duced to 10 held to be, one million of dollars, divided into twenty thousand shares \$1,000,000. of fifty dollars.
3. It shall be lawful for the subscribers to the capital stock to begin ^{Conditions} the business of banking so soon as the sum of four hundred thousand ^{precedent to} beginning dollars of the said capital stock shall have been subscribed, and a sum ^{business.} 15 not less than one hundred thousand dollars shall have been duly paid into one of the present Chartered Banks of this Province by such subscribers; Provided however, that the further sum of two hundred thousand dollars ^{Proviso.} shall be paid in within two years, and the further sum of two hundred thousand dollars within three years after the Bank shall have com- 20 menced the business of banking, and the remainder of the said capital stock not later than the first day of June, one thousand eight hundred and seventy, under penalty of forfeiture of their charter.
4. The second election of Directors of the said Bank shall take ^{Elections of} place on the first Monday in July, one thousand eight hundred and ^{Directors.} 25 sixty-seven, and the first Monday in July in each year shall be the day on which all subsequent elections of Directors shall take place.
5. So much of the Act cited in the Preamble of this Act as may ^{Inconsistent} provisions of be inconsistent with or repugnant to the provisions of this Act is 22 Vic. (1858) hereby repealed. c. 131 repealed
