Elected to the House of Commons, for Winnipeg, in 1891; Minister of Interior in the Tupper Ministry, 1896; resigning with his leader in the same year. Leader of the Conservative Party in Manitoba, and formed an administration after the defeat of the Greenway Government in December of 1899. Resigned October 1900, to contest Brandon for House of Commons and was defeated.
