At the GENERAL ASSEMBLY of the Province of Nova Scotia, begun and holden at Halifax, on the Twenty Eighth Day of May, Anno Domini 1765, in the Fifth Year of the Reign of our Sovereign Lord GEORGE the Third, of Great Britain, France, and Ireland, KING, Defender of the Faith, &c. and there continued by feveral Prorogations until the Eighteenth Day of June, Anno Domini 1768, in the Eighth Year of His said Majesty's Reign, being the Sixth Session of the Fourth GENERAL ASSEMBLY convened in the faid Province.

## CAP. I.

An ACT for granting to His Majesty, a Duty on Wheel Carriages within the Peninsula of Halifax.

XXX HEREAS it is expedient that the Public Highways with W & in the Peninsula of Halifax, and the Streets of the Tow and Suburbs thereof, should be properly maintained and kept Preamble. 🜣 in good Repair, for the Use, Benefit, and Advantage, as well of the Inhabitants as of the People who resort from the Country to the principal Seat of Government: And Whereas it is just and necesfary that a Revenue be raifed towards defraying the Expences that may be thereby incurred, We His Majesty's most dutiful and loyal Subjects, the Representatives of this Province met in General Assembly, being desirous to make Provision in this Case, have resolved to give and grant unto His Majesty, the Duties hereinaster mentioned, and We do humbly pray that it may be enacted, and Be it Enacted by the Lieutenant Governor, Council, and Assembly, That from and after Duty laid upon the First Day of August One Thousand Seven Hundred and Sixty Wheel Carriages Fight, there shall be raised, levied, collected and paid unto His within the Penin-Eight, there shall be raised, levied, collected and paid, unto His Majesty, His Heirs, and Royal Successors, for the public Use of Ten Shillings for this Province, and the Support of the Government thereof, for eachPair of Wheels. each and every Wheel Carriage used within the Peninsula of Halifax, drawn by one or more Horses or by Oxen, for each Pair of Wheels of such Carriage, a Duty of Ten Shillings, which Duty shall be paid by the Owners or Proprietors of such Carriages (ex-

Owners to enter the Number of their Wheel Carriages, with the Collectors of Excise, under Penalty of 403. to the Use of the Highways.

II. And be it also Enacted, That all Owners of such Wheel Carriages shall within Thirty Days after the said First Day of August, One Thousand Seven Hundred and Sixty Eight, enter their Names, and the Number and Kinds of Carriages and Horses they respectively use, with the Collector or Collectors of Excise Duties at Halifax, under the Penalty of Forty Shillings in Case of Neglect, to be applied to and for the Use of the aforesaid Highways.

Owners of Wheel Carriages to pay the Duty Half Yearly.

III. And be it also Enacted, That the Proprietors of all Wheel Carriages as aforefaid, shall pay the Duties by them respectively payable, into the Hands of the faid Collector or Collectors of Excise in Manner following, That is to say, one Moiety or Half of the said Duty on or before the First Day of February, One Thoufand Seven Hundred and Sixty Nine, and the other Moiety or Half thereof, on or before the First Day of August, in the Year One Thousand Seven Hundred and Sixty Nine. And if any Person or Persons shall refuse or neglect to pay the Duties imposed by this Act, at the respective Periods when the same becomes due, it shall and may be lawful, on Complaint by the faid Collector or Collectors of the faid Duties to any one of His Majesty's Justices of the Peace for the County of Halifax, for such Justice to cause the same to be levied by Warrant of Distress from off the Goods and Chattels of the Person or Persons refusing or neglecting to pay the same, with the Charges. And the Persons hereafter mentioned, at the Expiration of their Office, shall account as hereafter directed.

On Refusal or Neglect, the same to be levied by Warrant of Distress from any one Justice of the Peace.

The Collectors to pay the Monies collected, into the Treasury,

to be issued and applied for the Use of the Roads on the Peninsula, &c.

The Governor, &c. to appoint Persons to superintend the Repairs of the Roads,

to whom Warrants shall be issued for Payment of their Accounts.

Such Accounts to be first auditted.

IV. And be it further Enacted, That the said Collector or Collectors of Excise, shall pay into the Treasury of this Province, all the Monies he or they shall collect by virtue of this Act, in Thirty Days after the First Day of February and the First Day of August annually; which Monies shall be there entered seperate and apart from all other Monies, paid or payable to His Majesty, and shall be there reserved, to be from Time to Time issued and applied for defraying the necessary Expences of maintaining and keeping in Repair the Public Roads within the said Peninfula, and the Streets within the Town and Suburbs of Halifax.

V. And be it further Enacted, That the Governor, Lieutenant Governor, or Commander in Chief of the Province, be and he is hereby impowered to appoint one or more Persons for directing and superintending the Repairs of the said Roads and Streets, to whom Warrants shall be by him issued for Payment, out of the said Duties, of all such Accounts as may justly arise for Materials or Labour, by him or them purchased or directed to be done for the Purposes aforesaid; any Law, Custom, or Usuage to the contrary notwithstanding. Provided always, That before the granting any such Warrants, such Person or Persons Accounts

VII. And Whereas divers Wheel Carriages now used for beavy Burthens are very burtful to the public Highways, and occasion a constant annual Expence for filling up the Rutts made thereby, occasioned by narrow Wheels: And Whereas it has been found by Experience that Carriages on Wheels with broad Fellies, do little or no Damage to the Roads, and are easier in rough Grounds than narrow Wheels; Be it therefore Enacted, That the Owner or Owners of every Waggon, Wain, Cart, Truck, or other Carriage, for heavy Burthens, having the Fel-Carriages with lies of the Wheels thereof of the Breadth or Gage of not less than Wheels Eight In-Eight Inches at the Bottom, shall be totally exempted and ex-ches broad, to be cused from paying the Duties hereby imposed, for and during the Duty. Time they make Use of such broad Wheels only; upon sufficient Proof being made of such Usuage, to the Satisfaction of the said Collectors of Excise.

VIII. And be it also further Enacted, That the Monies arising by Monies to be ac the Operation of this Act, shall be accounted for unto His Majes-counted for in the ty in the Kingdom of Great Britain, and to the Commissioners of Treasury in Great-His Majesty's Treasury, or High Treasurer for the Time being; and auditted by the Auditor General of His Majesty's Plantations, or his Deputy.
