THE STATE PAPER OFFICE.



As the documents in the State Paper Office do not commence generally until the time of King Henry the Eighth (although a small number of instruments of earlier date are found to have been deposited there), a few observations relating to antecedent periods seem to be necessary before commencing the immediate history of the department, for the purpose of guiding the inquirer to the repositories where the earlier documents are to be sought.

Under the Anglo-Norman Dynasty the affairs of State in England were managed by the King's Council, in which the Chancellor officiated, and where he exercised such of the functions of a Secretary of State as those early times demanded, and he had an office to prepare the Public Instruments, in the nature of a Public Office, and not at first a Court of Justice; to him was entrusted the supervision of all Letters, Charters, and other Public Documents which required to be authenticated, and the most formal and solemn manner of authenticating State Documents was by the King's Seal, which the Chancellor had had the custody of, probably from the earliest times of Seals being used. The organization of Chancery rapidly expanded, and in respect of State Documents we find that it became the duty of the Prothonotary of Chancery to write, pass under the Great Seal, and enrol Commissions, Treaties, Leagues, Ratifications, and other Instruments which passed between the Sovereign of this country and other Sovereigns and States; also Commissions, Powers, and Orders to Ambassadors, Patents to Consuls, Diplomas, Declarations, and Grants of Honor and Additions of Coats of Arms to all persons being Foreigners, Pardons of Outlawry, &c.

Like legal proceedings the early State Documents were enrolled, and are preserved in Chancery, both domestic and foreign; the latter come down to 22 Jac. I., when the Prothonotary of Chancery ceased to enrol the instruments made out by him, and his functions gradually ceased, or such as remained fell into other hands. There are also remaining amongst the records of the Chancery many documents from which the enrolments were made, as well as correspondence which was not enrolled; a Calendar of the latter is printed in the several Reports of the Deputy Keeper of the Public Records, viz. Fourth Rep. App. II. pp. 140-164.; Fifth Rep. App. II. pp. 60-96.; Sixth Rep. App. II. pp. 88-115.; Seventh Rep. App. II. pp. 239-276.; and in the Eighth Rep. App. II. pp. 180-184. A Calendar and notices of many documents which were found on the files in Chancery have also been printed in the Reports of the Deputy Keeper.

In process of time the business of the State began to be executed in a less formal manner, and to be diverted into other channels, and the King's Secretary (who was at first styled the King's Clerk, then Secretary, afterwards Principal Secretary, and who probably about the time of Queen Elizabeth was first called Secretary of State,) gradually was employed to execute much of the business formerly pertaining to the Council. But long after the office of Secretary grew into importance, many matters, letters, petitions, &c., were still addressed to the King, to the Council, to the Chancellor, Master of Requests, &c., which afterwards it became the duty of the Secretary of State to receive. This however is not the place to discuss when the establishment and various alterations in the different Public Departments took place, it is sufficient to observe that the King's Principal Secretary had become in the time of King Henry the Eighth a personage of so great importance that his rank and precedence was determined by Stat. 31 Hen. VIII. c. 10., and the business and correspondence of his office so much increased as to require in the same reign a second Principal Secretary, and subsequently a third. Each of these Secretaries, prior to the establishment of an office for

the reception of their papers, as distinct from those of Chancery, had the custody of the papers accumulated in his department.

At length in the year 1578 an office was established for the reception of State Papers, and Dr. Thomas Wilson (then Master of Requests, and afterwards one of the Secretaries of State) was appointed Keeper and Registrar of the Papers concerning matters of State and Council. It was not however until the time of King James the First that these papers were reduced to the form of a library, having before been kept in chests.

A Patent of James I. dated 15th March 1609-10, after setting forth the importance of preserving and well ordering Papers and Records, especially such as concern matters of State and Council, as well respecting Negotiations with Foreign Princes as other instructions and directions, recites,—

“ The careful endeavours of Robert Earl of Salisbury, our
“ Principal Secretary and our High Treasurer of England,
“ to reduce all such papers, as well those that heretofore
“ remained in the custody of Sir Thomas Lake, Knight,
“ being the papers of some of the Principal Secretaries of
“ our Predecessors, as also some such papers as he shall
“ think fit to depart with, being either such as he hath
“ collected of his own times, or such as were left to him
“ from his late father the Lord Burleigh, then Lord High
“ Treasurer of England, into a set form or library, in some
“ convenient place within our palace of Whitehall, to be
“ at all times the readier for our use, and for the use
“ of any of our Principal Secretaries hereafter, for the
“ better enabling them to do us service :”

And then appoints Levinus Muncke one of the Clerks of the Signet, and Thomas Wilson, Keepers and Registrars of the Papers and Records so to be collected and preserved.

On the death of the Lord Treasurer Salisbury in 1612, as stated in the first volume of State Papers, published under the authority of the Commissioners for printing and publishing State Papers, the King's commands were given to his successor Thomas Earl of Suffolk, the Lord Privy Seal, Edward Earl of Worcester, and Sir Julius Caesar.

Chancellor and Under Treasurer of the Exchequer, to take possession of the late Lord Treasurer's papers and deliver them to Muncke and Wilson. The subsequent Patents especially mention the office to contain the papers of Robert Earl of Salisbury. At this period the papers which had been hitherto kept in chests were reduced into the form of a library as before stated, and the King assigned certain apartments in his Palace of Whitehall for their reception. And the part of the palace finally appropriated to this purpose was the Tower over the gateway which connected the eastern and western parts of the edifice, standing across the street now known by the name of Whitehall. The apartments consisted of two rooms, three closets, and three turrets, of all which entire possession was not obtained until 1618. Although the papers escaped the fire which consumed a great part of the palace on 12th January 1619, yet they were thrown into great disorder by having been hastily cast into blankets.

Great losses of State Papers are said to have taken place during the time of the Rebellion, temp. Car. I. A large portion of the documents, however, relative to the affairs of the Commonwealth are regularly entered, and safely preserved in the office.

We find from a Report of a Committee of the House of Lords, made on 19th January 1705-6, the neglected state of this Office, and what documents had not been delivered. In consequence of that Report an Address was presented to Her Majesty to direct some proper method to be taken for the future to preserve the Papers of State for the use of the public. And with reference to this subject, the following observations occur in the Preface to the before-mentioned first volume of State Papers:

“ The office was found in a great state of neglect when
 “ visited in 1705 by a Committee of the House of Lords.
 “ In consequence of a Report from that Committee an
 “ Address was presented to the Queen, in which it was
 “ stated that, with the exception of the papers of three
 “ Secretaries of State, viz. Sir Edward Nicholas (restored
 “ to the Secretaryship after the Restoration), the Earl of
 “ Arlington, and Sir Joseph Williamson, and those left by

“ Sir Leoline Jenkins, few papers had been delivered into
“ the office since the year 1670, and those not perfect. The
“ address recommended the repair and enlargement of the
“ office, and that the papers should be sorted and digested,
“ and bound in volumes. After a reference to Sir Chris-
“ topher Wren, it was determined that the upper floor of
“ the Lord Chamberlain’s lodgings at the Cockpit should
“ be fitted up and appropriated to the State Paper Office.
“ This was accordingly done, and an apartment of eighty
“ feet long and twenty-five feet wide, which is known by
“ the name of the Middle Treasury Gallery, was then added
“ to the office.

“ In this state it remained until the old gateway was
“ pulled down, about 1750, when the contents were found
“ to have greatly suffered from vermin and wet. The papers
“ contained in the gallery which was left standing remained
“ there, but the contents of the rest of the office were
“ removed to an old house in Scotland Yard, where they
“ remained, and suffered still further injury from wet, till
“ 1819, when it became necessary to pull down the last-
“ named house; and the papers were again removed to
“ another old house in Great George Street, the corner of
“ Duke Street, in which, and in the Treasury Gallery, they
“ remained until 1833, when they were removed into the
“ present office in St. James’s Park, built expressly for their
“ reception.

“ In 1764 a Commission was issued for arranging,
“ indexing, &c. the papers, and continued until 1800, when
“ the above Commission was revoked, and a small establi-
“ ment of clerks was allowed to the Keeper of State
“ Papers.”

On the 10th of June 1825 a Commission was issued for
printing and publishing the documents of the State Paper
Office (which has been renewed to the present time, the
Commission of the 2d of July 1842 empowering the
Commissioners to print Calendars also), it having been
then considered, as stated in the Commission, that the
documents were in a great measure arranged and indexed.
This statement, however, would seem to be rather premature,
or to want qualifying, as it must now, in 1849, take many
years to complete the arrangement and indexing. And in
fact it is so qualified in the preface to the first volume of
State Papers, page xx.

The following volumes have been printed in quarto by the above-mentioned Commission:—

1830. Vol. I. Divided into two parts:—

Part I. Correspondence between Henry VIII. and Cardinal Wolsey; this however includes the Correspondence of other persons with Wolsey.

Part II. is the Correspondence of Henry VIII. with his other Ministers. There is a brief calendar prefixed to each part, and a vocabulary at the end of the volume.

1834. Vols. II. and III., being the Correspondence between the Governments of England and Ireland; the first of these volumes contains the Correspondence from 1515 to 1538, and the other volume commences with part of 1538 to 1546. There is a brief calendar prefixed to each volume, and a vocabulary at the end of the latter volume.

1836. Vols. IV. and V. is the Correspondence relative to Scotland and the Borders. Vol. IV. embraces the years 1513 to 1534; and Vol. V. 1534 to 1546. There is a brief calendar prefixed to each volume, and a vocabulary at the end of Vol. V.

The Foreign Correspondence, which completes the series of papers of the time of Henry VIII., is in the hands of the printers, and will make six more quarto volumes, including a General Index of Reference to all the eleven volumes.

This Office, formerly annexed to the northern and southern divisions of the Secretariat of State, is under the control of the three Secretaries of State, but more especially of the Home Department, where application at present must be made by all persons desiring to inspect the documents.

A great change, however, has now been determined upon with respect to this Office. The Select Committee of the House of Commons on the Record Commission in 1836, p. xlii, recommended that, with a view to increased facility of access, and to unity of proceeding in publication, all State Papers not later than the conclusion of the Peace of Utrecht, and probably as late as the Accession of George the Third, should

be placed in the custody of the Record Commission. The Report also from the Select Committee of the House of Commons on the Miscellaneous Expenditure in 1848, p. xvii., recommended a fusion of the office with the Public Record Office; and the Government had had under their consideration this matter in 1845, but in consequence of some obstacles being interposed nothing final was determined upon until 1848, when the following Treasury Minute was communicated to the Secretaries of State, and to the Master of the Rolls as head of the Public Record Office.

TREASURY MINUTE above referred to, dated
8th August 1848.

“ Write to Lord Eldisbury, Mr. Hawes, and Mr. Lewis,
“ and request that they will state to the three Secretaries
“ of State, respectively, that my Lords have on several
“ occasions had under their consideration the functions
“ respectively performed by the State Paper Office and the
“ Record Department, and they are of opinion that it would
“ now be advisable to determine the course which ought
“ finally to be adopted in reference to these two Offices.

“ The State Paper Office is a repository for the reception
“ and arrangement of the documents accumulating in the
“ Offices of the Privy Council and the Secretaries of State,
“ at whose disposal the documents are held, and no person
“ is permitted to have access to these without an order from
“ a Secretary of State. The establishment of the State
“ Paper Office is as follows:—

“ Keeper of the State Papers (Mr. Hobbes).

“ Deputy Keeper and First Clerk.

“ Second Clerk, who has also a Salary as Secretary to
“ the Commissioners for printing and publishing
“ State Papers.

“ Third Clerk.

“ Two Extra Clerks.

“ Four additional temporary Clerks.

“ Housekeeper.

“ Messengers.

“ And including contingent expenses the estimated cost of
“ the Office for the year 1848-9 amounts to £2,650.

“ Commissions for publishing State Papers were issued in
“ connexion with this Office in 1825 and 1840, under the
“ authority of which the Letters of Henry VIII. have been

“ printed, and Calendars are being prepared describing the
“ contents of each document relating to the subsequent
“ reigns, so that the public may be enabled to have ready
“ access to the originals where more full information of their
“ contents shall be required.

“ The Record Department was established in the year
“ 1838, under the authority of the Act 1 & 2 Viet. c. 94.
“ The general superintendence is vested in the Master of
“ the Rolls, who is assisted by the following Officers:—

“ Deputy Keeper of Records.

“ Secretary.

“ Eight Assistant Keepers.

“ Twenty-one Clerks.

“ Besides certain offices and places of custody particularly
“ mentioned in the Act, power is given to Her Majesty,
“ with the advice of Her Privy Council, to order the Records
“ deposited in any office, court, place, or custody other
“ than those before mentioned to be placed under the same
“ charge and superintendence, and their Lordships arranged
“ with the Master of the Rolls that the management of the
“ Records so transferred should be subject to regulations
“ approved of by the heads of the departments to which
“ they respectively belong.

“ Large quantities of papers which had accumulated in
“ the Treasury, Admiralty, and other Offices, have accord-
“ ingly been transferred to the Record Department, where
“ they are not only taken proper care of, but are more easily
“ consulted than they were previously to their transfer.

“ As therefore Parliament has made provision for the
“ whole of the State or Public Records of the country being
“ brought under one central management, and this arrange-
“ ment, besides its greater economy, would be productive
“ of many obvious advantages, their Lordships are of opinion
“ that no new appointments should be made to the separate
“ Establishment of the State Paper Office; that on the
“ retirement of the present Keeper of the State Papers the
“ charge of that office should be transferred to the Master
“ of the Rolls, and that the officers on the establishment of
“ the Record Department should after that be available for
“ any duties for which they may be required in connexion
“ with the arrangement, &c., of the documents deposited in
“ the State Paper Office.

“ In November 1845 it was arranged, in consequence of
“ the want of accommodation in the State Paper Office, that
“ when a sufficient period has elapsed to confer an historical

“ character on particular classes of documents deposited in
 “ that office such documents should be transferred to the
 “ care of the department under the superintendence of the
 “ Master of the Rolls, where numerous contemporary and
 “ analogous records were already deposited, and the Master
 “ of the Rolls on that occasion made the following observa-
 “ tions in reply to some objections which had been offered
 “ to the transfer:—

“ ‘ The Record Office would obey the directions of the
 “ Secretary of State to whose office any particular papers
 “ belonged, would afford the most perfect and convenient
 “ access to the officers of the same office, would send to
 “ the office the originals or copies of any papers whenever
 “ required, and would afford no access to other persons
 “ except by order of the office, or according to regulations
 “ approved by the office.

“ ‘ In all such matters the Record Office would do pre-
 “ cisely as the State Paper Office would do or ought to do.’
 “ Their Lordships have now suggested that the State
 “ Paper Office should, on the retirement of the present
 “ Keeper, become a branch of the Record Department,
 “ under the superintendence of the Master of the Rolls, and
 “ they have made this proposal on the understanding that
 “ the conditions above described by Lord Langdale will be
 “ applied to this, as they have been to the present less com-
 “ plete arrangement.

“ The operations of the Commission for printing and pub-
 “ lishing State Papers will properly cease after the publica-
 “ tion of the Papers of the time of Henry the Eighth, and
 “ when the State Paper Office and the Record Department
 “ shall have been consolidated, the printing of Calendars,
 “ Catalogues, and Indexes, as well as of such Records
 “ as may be approved by Her Majesty’s Secretaries of
 “ State and the Lords of the Treasury, will be conducted
 “ under the superintendence of the Master of the Rolls, as
 “ directed by the 14th and 15th sections of the Record
 “ Act, 1 & 2 Viet. c. 94.

“ State that in case Her Majesty’s Secretaries of State
 “ shall signify their consent to the arrangements above
 “ described, my Lords will communicate with the Master of
 “ the Rolls, with a view to their being carried into effect at
 “ the proper time.”

The assent of the Secretaries of State to the above pro-
 position was communicated to the Master of the Rolls by
 Treasury Letter, dated 14th September 1848, and the Master

of the Rolls, by his Letter dated 24th October following, consented to the arrangement. The advantages to be derived by the Government, and the public generally, by having one department only to refer to for legal and historical information must be obvious.

The State Papers or Documents may be said to be separated into ancient and modern. The ancient, down to the reign of Henry the Seventh inclusive, will generally be found in the Chancery, and in the custody of the Master of the Rolls; and those commencing with the reign of Henry the Eighth are at the State Paper Office, and now about to be brought together under one management. But it is lamentable to reflect on the dispersion of State Papers, commencing with the latter period, in other public departments and libraries; in the Public Record Department, in the British Museum, in the Lambeth Library, in the Libraries of the Universities, and in almost every private Library of note. A very fine collection remains in the Library of the Marquis of Salisbury, a catalogue of which is in the Public Record Office Library.

It would seem to be well worthy the expense and labour for the Government to cause to be formed in all departments, libraries, &c., where access could be obtained, a Calendar of all existing State Papers, and incorporate the same, with proper references, in the Calendars now forming in the State Paper Office.

Calendars alone can disclose the invaluable documents of the State Paper Office. The following view or heads of contents, however, will afford useful information.

Describes Ireland, according to the ancient description, as consisting of five parts: -- 1. Ulster; 2, Connaught; 3, Two Munsters; 4, the other Munster; 5, Leinster. Signifies which of these obey the King's Law, and which do not; names of the Chiefs and Septs. Meaning of the English Pale, as embracing the obedient Shires. Tyrone's manner of conducting himself after the great benefits bestowed upon him by the King; comes to Dublin, probably once in a year, after being sent for two or three times; his dress. Oconnor, the sorest adversary the King or his subjects ever had; his great power.

Sets forth the policy of Englishmen towards the Irish, sometimes taking part with one and sometimes with another, so that none of them get too strong, which when they do they generally prove what they are. The Irish when they are kept in awe and see the sword over them, will speak fair and make many behests, but when out of fear and have strength none are greater tyrants, their own will

being Law. None should have too much strength. Desmond will be obedient as long as he has his own will. Great evil arises by giving Lands in the Pale to the Irish, by reason of their servants going to and fro, and observing the secrets of the country; annuities would be better than lands; doubtful policy of alluring Irishmen to England, &c., &c., &c.

3. A Declaration of the present state of the English Pale, the causes of its misery, what Shires the Pale consists of. 20 pages, temp. Eliz. (after 1590.)

States that the English Pale consisting of five Shires,—1, Dublin; 2, Meath; 3, Westmeath; 4, Kildare; 5, Louth (altogether not much larger than Yorkshire in England),—is much wasted by burning or otherwise by incursions of traitors and rebels, and also by the great insolence, extreme outrages, and disorders of the English paid soldiers; great burthens laid upon the subjects by the Governors, Council, and Commanders; great suffering of the Pale from the extortions of the soldiers exercising great cruelty if not satisfied by their hosts; their extortions, &c., have become so profitable that some of the soldiers receive no pay from their captains. Intolerable impositions, as well by the State as by the principal commanders, for finding men and horses in provisions, &c., which is levied weekly upon the poor inhabitants without consent of the nobility and gentlemen chiefly interested therein: other oppressions by the soldiers in pay of the English, many of whom have been traitors pardoned, &c., who join cordially in order to ruin the Pale better than they could by rebellion. Proclamations issued to prevent such outrages are of no avail: the soldiers set forth that they do not properly receive their pay, which if they did they would maintain themselves without grief to the country.

4. Base Monies, Eliz. — Sterling, Jac. I.
 5. Rowland White's Reformation of Ireland. His suggestions for,—addressed to Sir William Cecil, Principal Secretary to Queen Eliz. (of the assumed date 1570-1, March 23.)

Sets forth the capabilities of the country; fruitful of wood, water, grass, corn ground, and ines-

timable treasures within the ground, good havens, &c., &c., the advantages of which are lost in desolation and waste by the idleness and disobedience of the people, living under no law, more brutish than reasonable, being savage and their counties fruitless; the great expenditure of Her Majesty has not brought quiet and civility, neither the correction of one hinders another from offending. The Reformation purposes to amend all these evils, its tendency being to serve God, and advance his word, to content and comfort the people, to redress and amend abuses, to strengthen and enrich the Realm, to forbid inconveniences and vanities, to extend the Queen's bountiful liberality, and to assure good order and faithful subjection.

The means,—

(1.) *Swearing of Irishmen to the Queen's Allegiance.* The Brehon Law to be abolished; the Irish to be sworn to be faithful to Her Majesty, Successors, &c., the universal subjection being thus begun, the Irish are to be admitted to participate, &c. in Her Majesty's affairs, &c.

(2.) *A Parliament.* The subjects being sworn, a Parliament is to be summoned according to the order observed in England, to be called from every part of the realm, &c. to enact as follows:

(3.) *An Act for Inheritors to take their Lands of the Queen.* In order to ensure right inheritance, all lands to be taken of the Queen by all those having a right of possession.

(4.) An Act ordaining that the next heir of legitimate blood shall inherit by lineal descent.

(5.) An Act restraining the exportation of green and untanned Hides, in order to employ the people in tanning the same, &c.

(6.) An Act restraining the exportation of Linen Yarn, in order to employ the idle in manufacturing the same, &c.

(7.) An Act restraining the exportation of Felt and Skins in order to encourage the manufacture and use of Gloves, &c.

(8.) An Act restraining the exportation of Wool in order to encourage the manufacture of Frieze, &c.

(9.) An Act forbidding all Wines laden in strange bottoms to be discharged within the realm, and also forbidding all merchants, inhabitants of Ireland, to lade or freight in strange vessels, in order to encourage Shipbuilding, useful to the merchants and to the Crown in time of need.

(10.) An Act for inhabiting Waste Lands.

(11.) An Act for the Queen to have the proper right and possessions of all the Havens and Ports in the realm, in order to fortify, &c., the same, a great many of which remain at present in the hands of the Lords of the Country unfortified, &c.

(12.) Order for building Bulwarks in the Havens and Ports.

(13.) Order for building either sixteen holds or four principal Manors.

(14.) Order for building Castles in certain good Towns.

(15.) Order for farmers to be sent out of England to inhabit and till the Waste Grounds.

(16.) An Act forbidding Cosshery, Coyney, and Livery.

Cosshery.—When the Lord feasts any of his friends or strangers, the charge is borne amongst his poor tenants, &c.

Coyney.—The custom of Coyney is, that the poor husbandmen maintain the Kerne, Galloglasses, and other Warriors that the Lord keeps, who are disposed of among them, &c.

Livery.—Maintaining the Lord's Horses, &c.

(17.) An Act forbidding subjects to maintain men of War, *i. e.*, they must seek their right by law, and not by their own power, as they have been accustomed, &c. &c.

(18.) An Act forbidding the wearing of glybbed Heare, and all other vain apparel—ordaining the manner of England. The apparel of the Irish is described, and reasons given for altering the same.

(19.) Foundation of 12 Free Schools.

The Scholars to be trained up to understand English and Latin, &c. &c.

(20.) Foundation of one University.

(21.) Appointment of 12 Preachers to preach in English, Latin, or Irish, as the audience may best understand.

(22.) The Foundation of 12 Hospitals for the Poor.

(23.) Three Presidents and Councils to be established, with 40 horsemen and 20 footmen each, in the three most needful places of the realm.

(24.) Appointment of Pleaders for the Poor, two to each of the Courts of the above-mentioned Presidents.

(25.) Justices of the Peace and Sheriff- to be appointed; the Country to be divided into Shires, &c.

(26.) Bailiffs, Constables, and other Officers to be appointed in every Shire, in order to further the Reformation, &c.

(27.) The appointment of four Provests, in four quarters of the realm, to journey with 20 horsemen each in Circuit, through Munster, Leinster, Connaught, and Ulster, apprehending the evil doers, &c.

Note.—Accompanying each head are the reasons for the suggestion, and at the end of the book is a summary of the enormities of the realm: against each of which is placed the remedy as proposed by the Reformation; also the expense of carrying out the Reformation under the separate heads proposed for the said Reformation.

6. A Dialogue in four parts:—1, Ostracism in Oflaly of King's County; 2, Leinster; 3, Connaught and Ulster; 4, The Comarowall of the County. (About 1598. 148 pages.) Describes the various outrages, by whom perpetrated; a sort of criticism on the proceedings in the above places, by way of dialogue.

7. A View of the State of Ireland, by way of dialogue. Eudoxus and Irenius, about 130 pages, very closely written.

Nœc. This is a very useful paper to consult by these who would write on Ireland, the mismanagement thereof, their customs, laws, &c. &c.; it proposes remedies, &c. &c. It is printed at the end of Spenser's works, and thus commences:—

Eudoxus.—But if that country of Ireland whence you lately come be of so goodly and commodious a soil as you report, I wonder that no course is taken for the turning thereof to good uses and reducing that savage nation to better government and civility.

Irenius.—Marry, so there have been divers good plots devised and wise counsel cast already about reformation of that realm. But they say it is the fatal destiny of that land that no purposes whatsoever, meant for her good, will prosper or take effect, which whether it proceed from the very genius of the soil, or influence of the climate, or that Almighty God hath not yet appointed the time of their reformation, or that he reserveth her in this unquiet state still for some scourge which shall by her come into England, it is hard to be known, but yet much to be feared.

8. A Brief Discourse of Ireland, by Spenser, end of Eliz.

Describes the causes which led to Tyrone's rebellion, how it grew for want of being properly met; original cause of the mischief happened in Munster; inexperience of the Undertakers of the Queen's Lands in Munster, being but husbandmen trained up in peace, &c. The Irish hate the English for two causes, viz.:—1. Because they, the Irish, have ever been brought up licentiously, living each as he listeth, which they esteem half-happiness, so that to be brought into better order they account to be restrained of their liberty. 2. Because they naturally hate the English; the cause of this original hate is that they were conquered of the English, the memory whereof is yet fresh among them; they desire revenge and recovery of their lands. It is

suggested that in the first institution these prejudices should have been provided against; the old buildings should have been pulled down before any new were erected, and not to have thought to have patched them together in an inequality of state; suggests what ought to have been done; priests preaching against the Queen, &c. &c. Question suggested whether it would be better and easier for Her Majesty to subdue Ireland or to reform it; of these two, that must needs be a better and easier way which may be done with less charge, peril, and time. *Reason*:—The assumption then is that it will be less charge, less peril, and less spending of time, to subdue it altogether than to go about to reform it. Proof of the reason, &c. &c.

9. Mountjoy's Discourse on Ireland, 1601.

Describes the country as abounding with all the sustenance for life, as corn, cattle, fish and fowl, mines, quarries of stone and marble, breeding a people of excellent temper, if it were governed by virtue. The ancient obstacle to reducing it to civility was, that after it was inhabited by the first conquerors, their inheritance, for want of issue male, descended to women who, many of them married into England, deprived the land of a lord to be resident upon it; also the divisions of the Houses of York and Lancaster withdrew many of the nobility into England, and bred a war between the rest, &c. &c. The later cause of the general revolt and prevailing of the rebels was the corruptions of the magistrates sent hither, and weakness of their counsels, directed most to private and not public ends; and continual dissensions of the English inhabitants; insufficiency of particular commanders. Mountjoy describes his own proceedings against the rebels, which would have been still more successful had he not been overruled; a grievance that the soldiers are not paid in money and victuals, and to abolish the matter of apparel, which is full of inconvenience.

Irish Letters authorizing the expenditure of money originate in the Treasury, and are countersigned by the Lords.—*See* First Rep. of Com. on Fees, 1837, p. 63. These were directed to be entered at the Signet Office by the Royal Mandates of Car. I. and II. There appear to be some chasms, including one from 1645-6 to June 1660, since which they seem to be complete. There are Indices to them, with chasms to 1776, from which time they are complete. *See* Record Report, 1837, p. 80, second column, bottom.

These transcripts were prepared by the Abbé Marine. By an arrangement with the British Government, through Mr. Wm. Hamilton, in 1825, the Abbé was to be paid at per volume, and to have a pension for life after the production of the documents, to the number of 6000, making about 30 volumes, and costing about 720*l.* Some of these papers have been printed among the State Papers published by the Commissioners for printing and publishing State Papers. Those writing on ecclesiastical matters could make great use of them. Should a new edition of the Monasticon come out, these papers ought to be consulted: for in the letters of Innocent III. are to be found the names of many persons, churches, bishops, abbots, and archdeacons, of which there is little knowledge; also the ancient names and descriptions of the lands, churches, abbeys, &c.; sometimes the incomes of the benefices, exemptions from tythe, privileges of certain monasteries, and many other matters of which there is no knowledge, except from the letters of Innocent III.

The following observations are intended to point out to those desirous of searching the Correspondence of the Low Countries the necessity of searching both that under the head 'Flanders' and that under the head 'Holland' together, during the time of the troubles which led to the separation of the United Provinces from the other parts of the Netherlands.

It would seem to be difficult to draw the exact line when the Correspondence of the Netherlands should be separated into 'Flanders' and the 'United States' or 'Holland.' The Union of Utrecht, 1578-9, Jan. 29, has been considered as the foundation of the Republic of the United Provinces; but this does not appear to be the time to draw the line of separation of the Correspondence. In electing the Duke of Anjou for the head, the States merely withdrew their allegiance from one Sovereign and transferred it to another. At the death of Anjou, 10th June 1584—the assassination of the Prince of Orange, 10th July 1584—the renewal by the Confederates of the Act of Union of Utrecht on 14th July 1584—and the election of Holland on 11th Oct. immediately choosing the second son of the Prince of Orange (Maurice) for their Stadtholder—all seem to combine to draw the line about 1584. After Anjou's death the Confederates entered into negotiations with France, where their Ambassadors were received in the

same form as the Ambassadors of other Powers; this Correspondence, therefore, might be considered as the Correspondence of the 'United Provinces' or, as they have now become, 'Holland,' as separate from that of Flanders.

(4.) COLLECTION OF SIR JOSEPH WILLIAMSON.

Sir Joseph Williamson was appointed Keeper of State Papers on the last day of 1661, which office he held until his death in 1702; in 1673-1674 he was Ambassador to treat of Peace at Cologne; and in 1674 he also became Secretary of State. He formed a Collection of Papers, &c., and bequeathed them to the State Paper Office.

His Collections at the State Paper Office are at present separated into two different portions, and kept distinct from each other in different parts of the office, viz. —

Collection I., of which the *First Series* consists of 40 volumes, under the following heads:—Treaties, Ratifications, Instructions, Commissions, Declarations of War, Ambassadors, Consuls, Admiralty, Navy, Military, Lieutenancy, Ordnance, Musters, Oaths and Obligations, Treaties of Marriage, Declarations and Proclamations, Discoveries, East and West Indies: of this series there are also five large volumes, four of which are General Treaty Books, and the fifth volume contains Miscellanies and Instructions.

Second Series, 19 volumes, viz.—Copies and Extracts of Treaties, 1558 to 1669; Miscellaneous, 1509 to 1698; Treaties of Marriage, 1293 to 1667; Declarations and Proclamations, 1541 to 1698; Commissions and Patents, 1573 to 1641; Original Commissions, Miscellaneous, 1545 to 1638. Also a Diplomatic Index and Notes of Ambassadors. It contains Notes of the time when Ambassadors were sent to and returned from Foreign parts, and other Diplomatic Notes.

Note.—The Foreign part of the above Collection is in course of incorporation with the regular Foreign Correspondence.
