BIG CONTEST PENDING FOR SEA CONTROL

British Will Have to Fight Hard to Regain Superiority in Sea-Carrying Trade.

MERCHANT MARINE OF U. S. GROWING

Battle Should be Fought With Good Feeling Between Nations, But No Favors

London, June 25.—England, from her shipping and industrial interests down to less affected industries, or-santzed labor and the general public, is watching with anxious eyes devel-opment of the American merchant ma-rine. That threatened powerful United States sea-carrying rivalry projects a new influence into the British econom-ic organization and will make itself folt through the entire British indus-trial fabric, is recognized. While conceding the openness of the Seas to friendly rivalry, notes of warning from public leaders and lead-ing newspapers punctuate the atmos-phere almost daily. While maintain-ing good sportsmanship, Britain, they urge, must be ally to the gravity of the pending contest.

"By the end of this year American seagoing shipping will have reached a total of nearly 14,000,000 gross tons. "The shipping movement in the United States has behind it a great volume of public opinion which is finding expression in American news-papers on political platforms, at the meetings of manufacturers and trad-ers, and in Congress. 


