An Act to detach part of the County of Chicoutimi as a separate Municipality, and to authorize the Election of Councillors therein.

HEREAS the Township and Village of St. Jean, and the settle- Preamble. ments around, are situated at a great distance from the other settlements of the County of Chicoutimi, between which and them, no road of communication is yet open, and they have no local interests in 5 common with the other townships of the said county; Therefore Her Majesty, &c., enacts as follows:

I. From and after the first day of January, eighteen hundred and fifty- New municieight, the said Township and Village of St. Jean, and the settlement pality erected around in the unsurveyed lands, shall, for the purposes of the Lower St. Jean.

10 Canada Municipal and Road Act of 1855, or any amendments since thereto, be detached from the said County of Chicoutimi, and shall be united into and form a separate Municipality by the name of "Saint Jean."

II. The Council of the said Municipality shall consist of five members, Municipal 15 elected in the manner prescribed in the said Act with respect to the regulations, elections of members of local Councils, by the inhabitants of the Municipality entitled councillors, &c. to vote at such elections, and shall be subject to the provisions of the said Act with respect to local Councils, except where it is herein otherwise provided, and the said Council and Municipality shall be presided 20 over by an officer elected as the Mayors of local Municipalities are under the said Act, but who shall have the title of Warden, with such of the powers of a Warden as may be consistent with this Act; And the said Municipality and Council shall have all the powers of a local Municipality and Council under the said Act, and also the powers of a County 25 Municipality and Council under the same, except those which relate to the construction of a court house and gaol, or of a registry office, or such as may be inconsistent with its original jurisdiction as a local Council; And the elections of Councillors, and the sittings of the said Council, Chef lieu. shall be held at the Village of St. Jean, which shall be the chef lieu of

III. Notwithstanding anything in the said Act, the Secretary-Treasurer Certain of the said Municipality may be at the same time Superintendent thereof, officers may be councillors. and Commissioners for the Summary Trial of Small Causes may be Councillors.

35 IV. The said Municipality shall be organized and may exercise all its Organization powers and functions although there may not be three hundred souls of Municipality within its limits; And any preprietor of real property in the Municipality, whatever be the value thereof, may be elected a Councillor.

V. This Act shall be deemed a public Act.
