

The Thorold High School District to commence in the North of the County and going South so far as necessary to take in one-fifth of the County; that the Drummondville High School District shall consist of onefifth of the County, as follows: Commencing on the South side of the Thorold High School District, and with the Canal for a Western boundary run so far South as to include one-fifth of the County; the Fonthill High School District to be composed of that portion of the County lying South of the Thorold High School District and West of the Canal running South so far as to include one-fitth of the County; the Welland High School District shall consist of that portion of the County of Welland commencing on the South side of the Fonthill and Drummondville High School Districts running South so far as necessary to include onefifth of the County, and that the Fifth High School District shall be composed as follows: Commencing on the South side of the Welland High School District, thence South including the remaining one-fifth of the County, and that it be our instruction to the Committee on Education to prepare and present to this Council during this present Session a Report giving the limits by metes and bounds of each such High School Division to be numbered respectively from one to five and embracing the limits as near as may be practicable herein-before mentioned.

AN ACT to confirm By-law Number 143, of the Township of Willoughby.

WHEREAS, The Corporation of the Township of Willoughby did on the Fifth day of May, A. D., 1871, pass a certain By-law intituled "By-law for stopping up and sale of a certain road allowance in the Township of Willoughby, which By-law is in the following words and figures:

WHEREAS, In the opinion of the Municipal Council of the Township of Willoughby, the road allowance or part of road allowance in said Township hereinafter mentioned and described is useless to the public and lies between lands owned by different parties; and, whereas, due notice has been given in accordance with the Act 29 and 30 Vict. Chap. 51, Sec. 323.

Be it therefore enacted by the Municipal Corporation of the Township of Willoughby, constituted and assembled under and by authority of the Municipal Laws now in force in the Province of Ontario, and it is hereby enacted by authority of the same that the original road allowance or part of road allowance hereinafter mentioned and described be stopped up and sold to the parties next adjoining to whose land or lands the same lies, and in case of their refusal or either of them to become the purchaser or purchasers there-of at the price or prices hereinafter mentioned, then the same shall be sold to any person or persons whomsoever, but not for a less sum or price than the price for which such road allowance is hereby offered to the first parties.

2. That that part of the original road allowance between lots Number 14 and 15 in the Sixth Concession of said Township of Willoughby, lying between lands owned by James McGlashan and Everard McCredie, be stopped up and sold to James McGlashan for the sum of Seventy Dollars, Everard McCredie declining to become a purchaser of any part of said road allowance; and further, that the original road allowance lying between lots Number 14 and 15 in the 7th Concession of said Township of Willoughby, and between the lands of Martin Dell and Thomas McCre-

die, on the South, and Barsnet Dell and Edward Dell, on the North to be stopped up and sold to Martin Dell and Thomas McCredie in the following divisions and prices, that is to say: That part of the aforesaid road allowance commencing at the front of the said 7th Concession and extending West to the centre of Lyon's Crock to Martin Dell for the sum of Twelve Dollars, and that part of said road allowance commencing at Lyon's Creek Road and extending West to the Townline, Crowland, to Thomas McCredie for Forty-Two Dollars,

3. That the terms of payment for the said road allowance a part of road allowance before mentioned shall be as follows, that is to say: Cash down on the execution of the Deed.

4: That in the event of either of the said parties heretofore mentioned refusing or neglecting to become the purchaser or purchasers of the said road allowance or parts of
road allowance aforesaid, hereby authorized to be sold to
them at the prices heretofore specified, such portion or portions of said road allowances shall be offered for sale at
public auction and at a time and place and in such manner
as the said Corporation of the Township of Willoughby
may appoint and direct.

5. That the Reeve of this Township be and he is hereby authorized and empowered for and in behalf of this Corporation to convey the said road allowance or parts of road allowance to James McGlashan, Martin Dell and Thomas McCredie, aforesaid, in fee simple and at the price and in the manner heretofore specified, the expenses allowing the conveyance and other necessary expenses thereof to be borne by the party purchasing the same.

That is to saythe part of said road allowance extending from the front of the 7th Concession to the centre of Lyon's Creek, to Thos. D. Dell, for the sum of Thirty Dollars, and that part of said road allowance extending from the centre of Lyon's Creek to the Town Line, Crowland, (save and except the part which intersects Lyon's Creek Road,) to Robert C. Sawbrige, for the like sum of Thirty Dollars.

And be it further enacted by authority aforesaid that the Reeve of this Township be and he is hereby authorized and empowered and in behalf of this Corporation to carry the said road allowance to Thomas D. Dell and Robert C. Sawbrige, aforesaid, in fee simple; the expenses attending the conveyance and all other necessary expenses thereof to be

REPORT SPECIAL COMMITTEE ON GAOL RE-PAIRS.

To the Warden and Council of the County of Welland in Council assembled:

Your Committee to whom was referred the matter of repairs upon the County Buildings, beg to report that shortly after the adjournment of the Council in June last, your Committee met at Welland and conferred with Mr. Schooley respecting the matters referred to them, and your Committee agreed with said Schooley to do the following work, that is to say: To put suitable galvanized iron eve-troughs on three sides of the North Wing of the County Jail of the County of Welland, with suitable galvanized iron pipes from upper to lower roof, and from trough to pipe, crossing the Jail yard, and to thoroughly repair the roof of the North Wing and make it perfectly tight and build a plank fence in back yard ten feet high with oak posts, fence to be painted and to make the necessary alterations in the lower part of the building in front of the North Wing to perfect kitchen arrangements in connection with the prison and to put suitable iron grating at foot of stairs going down .. basement story in front of North Wing, and to trim off the stones Projecting on the East end of the North Wing and on the North East corner of the main building, and to put a perfect foundation under the cross wall on the South end of the Registry vault in the County building, and to fill up any and all cracks in walls of North Wing, and point the wall where required and fill up cracks in the wall of the Registry vault, the whole to be accomplished and completed to the satisfaction of the Committee within six months after the 1st of July, 1871, for the sum of \$560.00, and to be paid for when accepted by your Committee.

REPORT OF SPECIAL COMMITTEE ON REGISTRAR'S CLAIM.

To the Warden and Council of the County of Welland in Council assembled:

Your Committee, to whom was referred the Registrar's claim against this County for services alleged to have been rendered under the Acts of 1865 and 1868, respecting Registry offices, beg to report as follows:

That the Registrar's claim, as appears by a statement furnished by himself, is, for copying done under the said Acts, \$618868.

That by the same statement the Registrar's claim for the Abstract Index amounts to \$12,492.90; but your Committee find that there is allowed by the said Acts for preparing Abstract Indexes for Counties respectively, only the sum of \$2000.00.

Thus it appears that the Registrar's claim according to his own showing, and according to the terms of the said Acts amounts to \$8188.68.

But your Committee find that, according to the Inspector's certificate, the Registrar's claim for copying should only be \$3689.60, to which your Committee would recommend the addition for work done by the Registrar of \$161.00, making the Registrar's whole claim for copies, \$3850.60; to this add the amount allowed for the index \$2000.00, and the result shows the Registrar's real claim \$5,850.60.

Your C amittee further find, that the Registrar has drawn from the County Treasurer upon account of work done under the above mentioned Acts, the sum of \$9,964.91.

They also find that a further sum of \$644.60, has been likewise drawn by the Registrar, but it appears to your said Committee that this sum has been paid by the Registrar to the Registrar of the County of Lincoln, and not applied as the said sum of \$9964.91 has been.

Your Committee therefore beg to report that according to the papers submitted to them the Registrar has drawn from the County Treasurer for services under the said Acts over and above the amount allowed by law, the sum of \$4.114.31.

Your Committee further find that the alphabetical Index as required by law has not been prepared by the Registrar as appears by the Inspector's certificate.

Your Committee would therefore recommend that the Warden of this Council be instructed to submit the matter of the Registrar's claim as herein reported, to the County Solicitor for his opinion as to whether the County can recover the amount shown to have been overdrawn by him back from the Registrar and that he report his opinion thereon to this Council at its next meeting.
