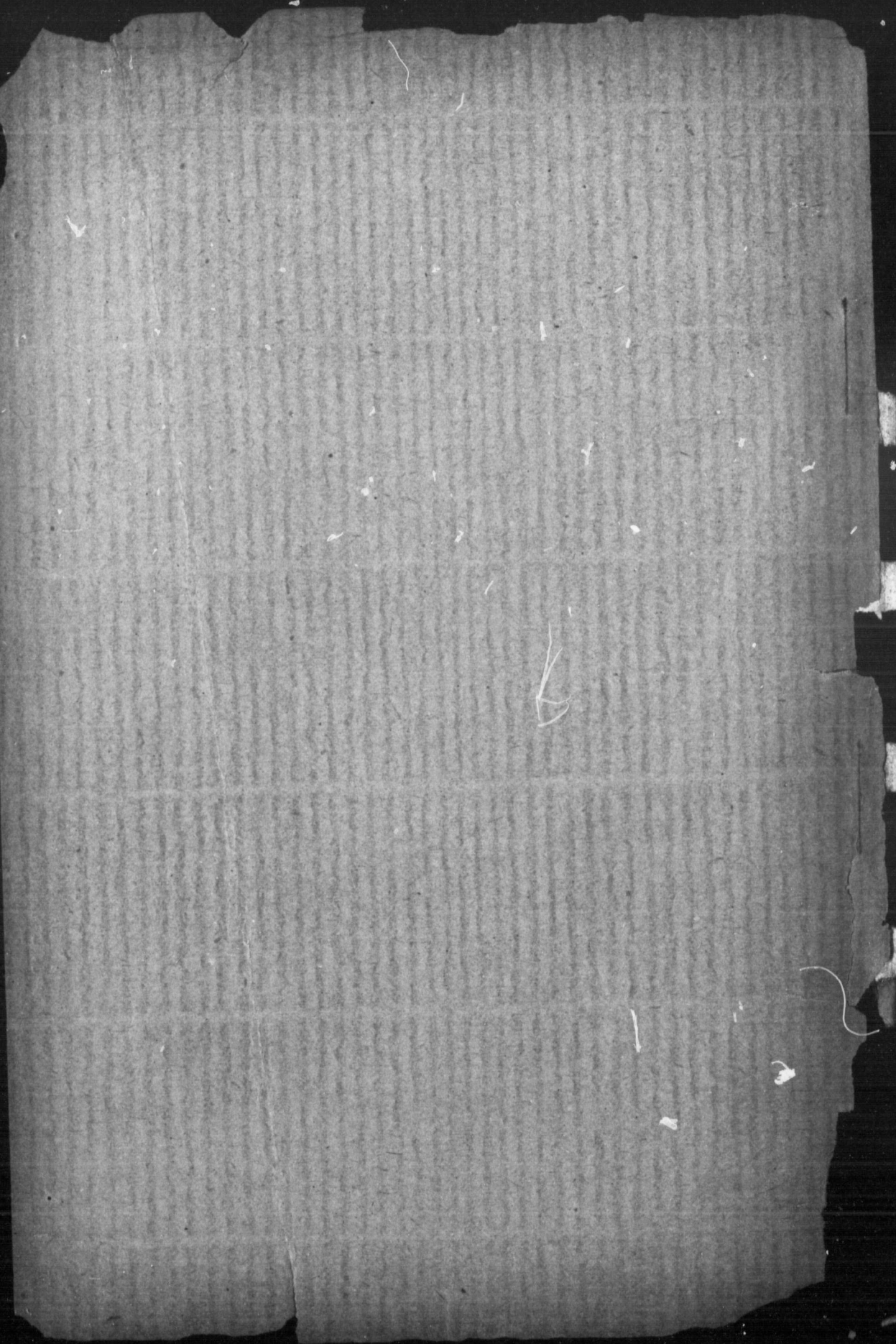

SYNOPSIS OF MINUTES OF THE ANNUAL
MEETING OF THE CONGREGATION.

The annual meeting of the congregation was held on the evening of Monday, January 11, and was largely attended.

Before commencing the business devotional exercises were conducted by the Rev. Dr. McTavish, who then announced his intention of vacating the chair, whereupon Mr. R. Donald was requested to preside, and the Secretary of the Managers was appointed Secretary for the evening.

The report of the Session for the past year was presented by Dr. McTavish, and the Session Treasurer's statement was also submitted.

The adoption of the annual report of the Managers was moved by Mr. Donald, seconded by Mr. Petry and carried.

Abstracts of the results of the work carried on during the year by the various organizations connected with the church were read and a motion was carried for their adoption.

The following gentlemen were elected to act on the Board of Managers during the next two years, viz., Messrs. R. Donald, Sr., A. R. Creelman, A. D. Crooks, R. W. Spence, Wm. Campbell, T. A. Stephens, R. G. A. Paton and A. I. Forster.

Votes of thanks to the Board of Managers for the efficient manner in which they have conducted the financial affairs of the congregation; to the members of the choir and auditors for valuable services rendered during the year, and to the ladies of the church for providing the excellent entertainment which preceded the meeting, were unanimously passed.

It was decided that the reports of the various organizations connected with the church should be printed in pamphlet form and distributed among the members of the congregation, it being understood, that the general tenor of the full report was to follow the lines laid down at the annual meeting last year, *i.e.* that the amounts of the contributions of individual members should not be published.

A resolution was adopted instructing the Session and Managers to devise and put into operation a plan for welcoming strangers to the Church who attend the Sunday or Week-day meetings.

Messrs. John Ferguson and Peter McCulloch were appointed auditors for the ensuing year.

REPORT OF THE SESSION.

In the report of the Session from year to year there is not of course a great deal of variety. An eminent writer has said "Happy are the people whose annals are vacant." As the greatest and most important part of a congregation's work cannot be presented in a report, the published record is no more than a mere outline of its general history. Some homes are brightened by the sunshine of happiness and prosperity, others are darkened by the shadows of trial and adversity, while always over some thresholds the foot of death will silently cross and spread over the home the dark pall of sorrow and mourning. We can record the number of members received and the number removed, and all such data, but behind these statistics there is the unwritten and inevitable history of the congregation. The blessings that have come through prayers ascending from the closet, the family altar, and the sanctuary, through the preaching and teaching of the Divine Word, and through the deeds and words of sympathy in homes of sorrow and distress, cannot be recorded as they are known only to Him in whose hand is the Lamb's Book of Life. No special services of any kind have been held during this year, but the ordinary means of grace have been well attended on the whole. It is however a matter of regret that a number of the members do not attend the Sabbath evening service. It is always a source of weakness, in a service at which there are a considerable number of strangers, to have those who ought to be the most deeply interested in the spiritual prosperity of the congregation absent. A few have engagements that keep them away, but if others who might be present only considered the assistance their presence would lend, apart from the additional benefit they themselves might receive, they would no doubt make an earnest self-denying effort to be present at the evening service also.

Death has made greater inroads on our congregation than usual during the year. It is with especial sorrow that we record the removal by death of a greatly beloved member of our Session, Mr. Thomas Mair. He was a man of deep piety and tender sympathy, an earnest student of the Word of God, and a most devoted and self-denying worker in the Master's cause. He has entered into his rest and reward; but the Session has lost the services of one who might justly be called

an ideal elder, and the congregation, one of its best members. Two other of the older and much esteemed members have also been called away from our midst, viz., Mr. James Watson, and Mr. Allan S. Thomson, both of whom have left behind them a memory that will be dear to their children and to all who who knew them. The Church and especially the Choir has lost, in the sudden death of Miss Alice Fenwick one who was greatly beloved by those with whom she associated in the Church's work. With the relatives of these departed ones, and with the others upon whose homes the shadow of death has fallen we feel the deepest sympathy.

Our domestic Mission on Elizabeth St. has been carried on with most cheering success during the year, and the Missionary and other workers there encourage us greatly by their self-sacrificing devotion. The purchase and improvement of the Mission building which the managers have undertaken will greatly facilitate the carrying on of the work. We have received good news from our Missionary in India, Rev. N. H. Russell, B.A., who expects to be permanently located in Mhow. He is acquiring the language with facility and is already able to accomplish much both in teaching and preaching. Let us all bear him continuously before the Throne of Grace in our prayers.

The different departments of the Church's work, appear to have been carried on with undiminished zeal. But as these will be severally reported, we need not enlarge upon them.

The Ladies' Aid Society, has kindly undertaken to take charge of the organized benevolent work of the congregation, and the Session fund ceases with the close of the year. We trust the congregation will loyally support the Ladies in this very important work.

The regular weekly prayer meeting has been attended much the same as last year. We believe the meetings have been helpful to those who attended, and therefore we wish their influence could be much more widely extended.

The prayer meeting of the Y. P. S. C. E., at the close of the Sabbath evening service has been well attended and is a means of great blessing to many of our young people. We wish all our young people would attend these meetings. It will be seen from the report that a Junior Society of Christian Endeavor has been organized, and under the management of Miss Maggie Anderson and Mr. Alex. Creelman, is meeting with encouraging success.

We record again our sense of gratitude to the leaders and members of the Choir for their invaluable assistance in connection with the service of praise.

During the year eighty-three members have been received into the Church—forty-three by certificate, and forty by profession of faith. After deducting thirty-two who have been certified to other congregations, six who have been removed by death, and a number from absence or neglect, the net increase is 29, making the present membership of the congregation 555.

The attendance at each of the six Communion during the year is as follows:—February, 332; April, 352; June, 347; August, 233; October, 304; December, 357. Baptism has been administered to fourteen infants.

While deeply thankful to our Blessed Lord for past mercies, let us look to the future for richer manifestations of blessing and power from Him whose measure of blessing is "According to His riches in glory."

ANNUAL REPORT OF THE MANAGERS FOR THE
YEAR 1891.

The Managers have much pleasure in presenting to the congregation their Report for the past year, with statements of account, showing the receipts and expenditures for the period under review.

It will be remembered that the year opened with an adverse balance of \$351, and it was hoped that this sum, with other requirements, would be met without difficulty from the weekly offerings, augmented in the manner suggested in the last Annual Report.

As, however, the ordinary contributions were not increased to an extent sufficient to make a material addition to the income, the Managers were obliged to adopt the usual plan of asking for supplementary contributions by special envelope. In the months of May and December appeals were made and received a generous response, the sum of \$520 in all, having been realized in this manner. With the addition just indicated, the income of the Church proved sufficient to meet the ordinary engagements of the year, and the following exceptional payments :

New organ motor.....	\$100 00
Balance of cost of piano.....	150 00
And a part of the deficiency with which the year opened.....	272 00

As a result, there still remains \$79 of the deficiency to be paid, which has been carried over to 1892. It was also deemed advisable to postpone the payment of a few accounts, amounting to \$105.

The Managers also report, as will be seen from the figures submitted, the payment of three hundred pounds sterling, equal to \$1,460, upon the mortgage debt, leaving that obligation standing at the even sum of four thousand pounds sterling, equal to \$19,466.67. During the three years, 1889-90-91, the sum of £1,000, or nearly \$5,000, altogether has been paid upon the mortgage debt.

Towards the latter end of the year, it was found necessary to renew, and in a large measure to reconstruct the plumbing and sanitary system of the church and school premises. A

contract was accordingly awarded, and the work is now nearly, if not quite, finished; everything in connection with it has been most carefully considered in regard to questions of economy and modern efficiency, and although the expense will be considerable, some \$350, the Managers thought it important that the work should be proceeded with when its necessity became known to them.

It has been the practice to some extent in the past to regard renewals to the building, fittings, and furniture as exceptional, and calling for special provision of a pecuniary nature; it is, however, manifest that this idea should no longer be held. The Church has now been built more than fifteen years, and must necessarily demand a constant expenditure to maintain it with due regard to its appearance, and to the comfort of those who congregate therein.

Without presenting any formal estimate of the requirements for the year 1892, it is sufficient to say that the payment of the items referred to, and providing for the future maintenance of the property, will make it necessary to look for some permanent means of increasing the ordinary revenue. The Managers hope that some plan, with this end in view, will suggest itself to their successors.

The Managers think that the congregation should feel gratified with the Report now presented. Although there is a deficiency and some accounts to pay, and a slight decrease in the number and amount of weekly offerings, still the result has in the main been satisfactory. Moreover, it is clear that since the Church has been able to pay so much of its mortgage debt, and to raise the large sums for all purposes, as have been reported during the past few years, there should be no real anxiety felt as to the ability and willingness of the members to meet the purely Congregational requirements.

During the year some changes have been made in regard to the property on Elizabeth Street, occupied as a mission in connection with this Church for some time past. The building was under lease from the trustees of Cooke's Church, who did not give the exclusive right to it, but reserved certain stated times in the week for meetings, which had been established by workers connected with that Church. At length they determined to withdraw from St. John's Ward altogether, and sell the property. The Mission workers connected with the Central Church were anxious to have some arrangement made, whereby the property might be retained for their use, and have certain repairs and improvements made thereto. The facts were presented at a Congregational meeting in 1890, and it was decided that the matter should be dealt with by a joint meeting of the Session and Managers. Such a meeting was duly held, and the only solution of the difficulty which presented itself was the purchase of the property by six of the members, who are under obligation to convey it to the Church at the actual cost, including the amount payable for improvements, should the Congregation at any time within five years decide to buy. The improvements are now nearly complete, and when finished will give greater comfort to the Mission workers, and afford facility for more and better work.

The total cost of the property will be from \$4,000 to \$4,100, the interest on which will be payable by the Church, in lieu of rent, and will exceed what was formerly paid by about \$70. As a change was also deemed necessary in regard to the position of caretaker of the building, Mr. Findlay was requested, and has agreed to undertake the duties at the salary formerly paid.

In connection with the improvements made in the Mission premises, the thanks of the congregation are due to Messrs. Wheeler & Bain, who have generously done all the work of

putting in the furnace gratuitously, asking simply that the congregation shall accept the same, equal to the value of forty-five dollars, as a contribution by them towards the good work done there.

The following Managers retire by rotation at this time, and are all eligible for re-election: Messrs. Campbell, Creelman, Crooks, Donald, Paton, Spence, Windrum, and Dr. Wishart. All of which is respectfully submitted.

The \$25 mentioned above for French Evangelization is, along with \$25 given by the Bible Classes, used in supporting a French Canadian boy at Point Aux Trembles school. A late letter from the principal of the institution states that the little fellow is making good progress in his studies, and "that he is advancing also in the knowledge of the Truth, and we hope, through the influence of the Holy Spirit, he may become a shining light among his fellow countrymen who are still in the darkness of superstition and error." Our prayer is that this hope may be fulfilled.

During the past four years we have been also supporting a pupil at St. Paul's Institute, Tarsus. We have resolved to discontinue contributing to this Mission, and instead intend making a special effort to support a cot in the Sick Children's hospital of this city. "Inasmuch as ye have done it unto the least of these, ye have done it unto me."

We have received several delightful letters from our former scholar and teacher, and now "Our Missionary," Rev. Norman H. Russell, at Indore, India.

Eleven of our scholars received diplomas, having passed creditably the "Higher Religious Instruction" examination. We trust parents will assist and encourage their children in this "Higher Religious Instruction" work, as it is one of the best means of obtaining a knowledge of the Bible itself, as well as the doctrines of the Presbyterian church.

A number of new books have just been added to the library, and a new catalogue issued.

During the year we have with regret parted with the following teachers: Mrs. Archibald, Miss Tudhope, and Messrs. W. D. Wilson, A. Bell, W. York, Alex. Creelman, and F. B. REPORT OF MISSIONARY ASSOCIATION.

The Missionary Association have much pleasure in submitting their report for the year just closed.

We feel that we have great cause for thankfulness to our Heavenly Father for the way in which our contributions for Missions, whether for special objects or for the general funds, have been kept up.

It is a matter for regret however that we have not fulfilled our wish at the beginning of the year,—that the contributions for 1891 would far exceed those of 1890. Still we feel thankful that our congregation, as a whole, has contributed so much, especially when we consider the many other calls upon it, and trust that those who have not contributed in the past will consider it their privilege to do so this year.

As will be seen from the Treasurer's report, there is a slight falling off in the amount for general missionary objects, but we have almost a corresponding increase in the special contributions.

Some of the contributors have not sent in their amounts in time for this report, as we had hoped they would, but we expect yet to receive some which we will carry to next year's account.

The Committee would take this opportunity of reminding all the contributors of the importance of sending in their contributions before the close of the year, as it is desirable to have the books closed promptly.

The contributions for "Our Missionary" have been kept up exceedingly well, and after paying his salary, we carry \$65.16 to balance of account, making a total balance in favor of this account of \$317.53.

At a missionary prayer meeting, held in March, the Rev. Dr. Robertson give an interesting address on Home Missions in the North-west, and at the close of the meeting, the amount necessary for a missionary's salary for the season, \$250.00, was subscribed by some of those present; so that we have supported a missionary for this year in both the foreign and home fields. Besides these we are supporting a native helper in Eromango, and a vernacular school in Central India.

It is to be hoped, however, that with our special givings, we will not let the general mission fund get behind as it is most important that all departments of the work should go on.

We are pleased at the increased interest taken in missions as is evinced by the ever well-attended missionary prayer meetings, which are still carried on monthly. We have had the privilege this year of hearing several who have been home for a visit from the foreign field and it certainly does put new zeal into one to hear from some one who has been actively engaged in the work.

As will be seen from the report of the Elizabeth St. Mission, work there is being energetically carried on, and with the improvements in the buildings, there will be much better facilities for carrying it on in the future.

The Committee have again to thank the lady collectors for their faithful work during the year and regret very much that some of them cannot see their way to continuing it any longer, but trust that others in the Church will come forward to take their places.

The Committee would suggest that the amounts contributed be allocated as set forth in the treasurer's statement.

REPORT OF THE LADIES' AID SOCIETY.

The members of the Ladies' Aid Society have much pleasure in presenting the congregation with this their eleventh annual report.

During the past year, sixteen regular meetings, with an average attendance of sixteen, and two emergency meetings have been held.

Nineteen families have been helped with gifts of money, fuel, food, and clothing; some very substantially, others in a less degree. Tea, sugar, and soap, have been freely distributed; and in one case, cod-liver oil has been provided.

Upwards of one hundred articles of clothing have been made by the Society, and sent to the Elizabeth Street Mission, where they are sold at a very low rate. It has lately been decided, to place a small charge upon cast-off clothing also.

We have adopted the plan of giving sewing to those who require help. By paying for the work done we assist the needy, and at the same time preserve their feeling of independence.

Owing to the desire of the Session to diminish the number of the organizations in connection with the congregation, it has been agreed that the Session Fund shall be combined with, or, merged in that of our Society, and we are to undertake the benevolent work done by that body for one year, experimentally.

We have, of course, found that in some instances our charities have been misplaced, and our good intentions misdirected, but we would indeed be ungrateful if we were not cheered by the report of those cases in which the assistance that we were able to give, has been thankfully received.

Before closing, we must, as in former years, tender our hearty thanks to the many friends in the congregation, who have aided us so frequently, not only pecuniarily, but by kindly words of encouragement.

We now enter upon a new year with the earnest resolve, that we will endeavour to follow the injunction, "Whatsoever thy hand findeth to do, do it with all thy might."

REPORT OF THE YOUNG PEOPLES' SOCIETY OF CHRISTIAN ENDEAVOUR.

Our Society has passed the critical period in the history of every Christian Endeavor Society, when the novelty of the movement has worn away and the members are apt to lose interest, and has reached a position, where, we trust, that the members realize the importance of the work in which they are engaged, and require no other stimulus than the Society's motto, "For Christ and the Church." During the year, we have added 26 active, and 6 associate members to our roll, making our total membership 93; composed of 77 active, and 16 associate members.

We endeavor to provide an attractive and profitable meeting each Sunday evening at which a special topic of Bible study is taken up. A point or two of interest regarding some one of our Church's missionaries is mentioned at each meeting and prayer offered in their behalf. Special missionary meetings are also held at intervals. The object we keep in view is the promotion of a more earnest Christian life among our members, and of usefulness in our Master's service, also to influence those of our young people who have not already a personal interest in Christ.

The Flower Committee provide flowers for anyone in the congregation who may be sick, and will be pleased to have friends advise them of cases of illness, so that they may be looked after. Last winter three cottage meetings were held regularly every week in our mission district. This season one weekly cottage meeting is held and, in addition, our Society has undertaken the responsibility of the Thursday night prayer meeting, at the Elizabeth Street Mission. Some of our members are also conducting a Young Men's Club at the Elizabeth Street Mission.

The Society has contributed about \$160 towards the support of Rev. Norman Russell, B.A., our Church's Missionary in India, during the past year.

In October, a Junior Society of Christian Endeavor was formed, with a membership of twenty one. This Society is composed of those who are too young to become active members of the older Society. Its object is to interest the young in Christian work, and prepare them for active membership in the Senior Society.

MISSION.

We feel deeply grateful to God for what he has enabled us as a band of workers to accomplish for him during the year just closed. The services have been much the same as in previous years. Those requiring special mention are the Sabbath morning service and the open air meetings. The former was carried on during the six summer months, and though the numbers were not large, yet it was a means of great good. The open air meetings were held on the summer evenings once a week. The most degraded parts of the district were selected, and, with our faithful band of singers, etc., by speaking, praying, and singing, we told of Jesus to those who so much need a Saviour. The other usual meetings have been most encouraging. We are glad to report that already eight of our people have professed their faith in Christ by joining the Church. We regret very much that more of the senior members of the congregation cannot be induced to take an active part in visiting the homes of our mission people. This burden falls upon the young and inexperienced. Why should it be so? We are glad to see the Christian Endeavourers going so heartily into the work. Will the older ones not undertake some responsibility also?

We are highly delighted with the complete way in which our friends have improved the mission building. With the new apartments and improved old ones, we feel we are entering upon a new epoch in our work and promise faithful labour.

The missionary would like to gratefully acknowledge help generously given by Mr. Joseph Kilgour, and also by friends in the congregation for our work among the needy.

In presenting this, the eleventh annual report of the Sabbath School in connection with our District Mission, we desire to thank our Heavenly Father for the many blessings which He has bestowed upon us in our work.

We have been greatly encouraged in our efforts to impart a more thorough knowledge of the Word of God to the scholars, and had great joy in seeing three of our scholars make public profession of their faith in the Lord Jesus, by joining the Church last communion service.

We decided to change the hour of meeting for the months of July and August to 10 o'clock, but found that the attendance was so greatly diminished, that we considered it advisable to return to the regular hour after the first of August.

The annual picnic was held June 23rd, at Lorne Park where a very enjoyable time was spent.

The annual entertainment for the children was given Dec. 29th, at which time, each scholar received a present from the Christmas tree; the children were highly delighted with the treat provided. We take this opportunity to thank the many friends who have so liberally assisted us on occasions of this kind.

The average attendance for the year was, scholars 90, teachers and officers 22, making a total of 112. Average for first quarter 139, second quarter 113, third quarter 82, fourth quarter 116. Collections for the year, \$56.72.

The library has had an addition of about 200 volumes.

The bible class for young women, organized last year did not prove as successful as we had expected, chiefly because of the want of accommodation. This obstacle has been removed by the alterations of the building, and we have now the opportunity of opening both a young women's and young men's class. The necessary steps have already been taken to organize these classes.

We desire to thank those who have placed these facilities at our command and look forward to a year of more earnest and efficient work in our Master's cause.

We would again thank Mr. Macdonald for securing for us funds sufficient to carry on our work.
