The great and overwhelming calamity by fire of unusual severity ard extent, destroying the larger and more important portion of the City, and a vast amount of its wealth, and rendering thousands homeless, has in the mysterious dispensations of Divine Providence come upon the City of Saint John, the Commercial Capital of our beloved Province.

The Committee on New Churches report—We have had letters from two Churches laid before us, namely, Lower Toblque and Upper Kent, Your Committee feel, however, we cannot recommend their reception without further information. We would, therefore recommend this Association to correspond with said Churches, stating to them the reason they cannot be admitted, asking them to send delegates to meet with us in 1878.

The Home Mission Committee presented their Report:

The Committee on Home Missions beg to report—That while we acknowledge the binding obligations of the command of Christ to preach the gospei to every creature; we regret that so little interest

is taken, and so little sacrifice is made to carry out that command: we therefore most earnestly urge our brethren, both ministers and Churches, to do all in their power to carry out the command of Christ. Ministers to perform Missionary work, preach Missionary Sermons, thus showing the people the strong desire they have for the coming of the Kingdom of Christ. Having shown a proper example ourselves, then call on others to contribute according as God has prospered them. We would urge each minister to hold, at least, one Missionary meeting each year, in each Church where he labors.

The Committee on Religious Literature submitted their Report:

Your Committee on Religious Literature beg leave to report-That in their opinion, a wider and more extensive circulation of a pure Denominational Literature amongst the people, and particularly in our Sabbath Schools, should be attempted by our ministers and Churches, in order that our views on Christian doctrines and ordinances may be more widely disseminated, and a pure christianity diffused. We recommend, therefore, as far as possible, books and periodicals that present these doctrines and principles in harmony with our denominational views, be used whenever possible to obtain

We also beg to report that in our opinion our denominational organ, the Christian Visitor, is faithful in the discharge of its duties, and is, therefore, worthy of the continued confidence and support of the Lis representation of our principles, and its able defence of them when assailed, also its advocacy and support of our denominational interests and operations in general, entitle it to the hearty support of every Baptist in the land. We desire to see the circulation of the Visitor largely increased, and extended into every Baptist family, and recommend that the ministers and leading brethren in our Churches use proper effort to enlarge its list of subscribers. It is especially important that at the present crisis every subscriber should discharge his duty in supporting the Denominational Organ by prompt payment of dues.

The Committee on Temperance reported as follows:

Your Committee beg to report that the blighting, blasting, and demoralizing influence of the intoxicating cup is still felt in every part of our land. The cry from every earnest Christian and patriot is: How shall the fountains from which flow such streams of death and destruction be dried up?

The Gospel of Christ which is committed to us is the only purifying moral power in existence by which this work can be done; therefore Christ's children are, and should be, the salt of the earth in the realm

of Polities.

In order that this end may be attained:

1st. Let every lover of Jesus purify himself by an individual or personal prohibition, or a tectotal banishment of the intoxicating cup.

2nd. Let every Church and Sabbath School have aliving temperance wheel in the Church machinery.

3rd. As Churches, we should from the pulpit and in the pew, and at the polls, labor earnestly for legal prohibition of the drink traffic in our Dominion of Canada.

We would urge the Churches, every one, to use only the "Fruit of the Vine" at the Lord's table, in strict compliance with our Lord's example, and thus discard the intoxicating cup, which is an unfit emblem of, and an active agent for the destruction of Christ's Kingdom.

The Committee on Sabbath Schools submitted their Report:

The Committe on Sabbath Schools respectfully report-That as many of our Churches have not reported themselves to this body, and as many who have reported have no Schools, and as some who have reported their schools in a very low state, therefore we are obliged to conclude that we are very deficient in this branch of labor compared with what we ought to be. If ever there was a time when Sabbath School work was important, it is now. Our common schools, or even higher, do not teach the Bible, and in many cases, it is not taught in the family. Therefore, if not taught in the Sabbath Schools, many of our children will grow up ignorant of God's Word. Therefore we urge our ministers and Churches to take a greater interest in this Sabbath School work, and, at least, every Spring call the attention of their Churches and congregations to this subject, and preach sermons in favor of this very important branch of Christian labor.

CIRCULAR LETTER.

The Want of the Hearer in Religious Discourse.

DEAR BRETHER,—We have—as is well known—textual, topical, expository, and historical discourses delivered on Sabbath, and other days by devout speakers, and heard by God-fearing hearers.

In these discourses both the speaker and the hearer—if they have given due thought have an object to attain. The one is to impart benefit, the other is to receive it.

To accomplish this object on the part of the speaker, his manner in the delivery of religious discourse will have much to do. An imperfect manner in the delivery of any public address, either secular or religious, detracts inten from its beneficial effect, while a correct manner greatly heighten that effect for good.

Not less to do has a clear conception of the matter to be imparted in religious discourse. If the matter is imperfectly understood by the speaker it will be imperfectly understood by the hearer; if it is clearly comprehended by the one who speaks, it will in all probability—be clearly comprehended by those to whom he speaks.

Having ascertained the best manner in the delivery of religious discourse, and the most distinct conception of the matter, what that matter should be, ought not less to occupy the speaker's thought—the want of the heaver in religious discourse.

The spiritual life is the want of the hearer in religious discourse. We want to know of the remedy for harassing guilt. Recently, says one whose example is worthy of imitation, we went into the sick chamber accompanied by a physician, and heard the earnest enquiry made by the sick one in body to that physician. "What must I do to be cured?" Shortly after we entered the home of one sick of sin, and heard the auxious enquiry addressed to us. "What must I do to be saved." To this anxious enquirer, we spoke of the Lord Jesus, "who, His own self, bore our sins in His own body on the tree." We told him of His "intercession for the transgressor," of his Advocate with the Father, of the Holy Spirit whomthey that believe in, receive to be their comforter, preserver, and sanctifier.

The class who feel their need of the Spiritual Life in every congregation addressed in religious discourse is larger than is often supposed. The causes are many, both of a temporal and spiritual nature to lead

us to feel for a sin sick sou!, and urge feelings for succor to the remedy,

And the need of the spiritual life is frequently more keenly felt than expressed. Many a diseased one in body keeps back a knowledge of his disease from those who could give relief, and many a disordered one in spirit withholds an acquaintance with his disorder from those who are appointed to impart a balm for every wounded breast.

To set forth the spiritual life, earnestly and constantly by the speaker of religious discourse, is indeed, not vain. It is to give bread

which feedeth the hungry soul.

Spiritual lig t is likewise the want of the hearer in religious discourse. We wish to know more clearly how the judgments of the Lord are right. Do you suppose, said one lately to us-one, who at the time he spoke, was passing through a severe trial-that it is on account or the sins we commit that we suffer so much. desired to have light on God's providence, a desire no doubt of many.

We want, also, to know how we may perform, as we ought, our religious and secular duties. A soldier who culists for service under a leader expects to be instructed by him in the duties of that service. In like manner the Christian soldier expects to be taught by his spiritual leader in the duties which he is required to perform.

The duties which are to be taught by the spiritual leader to the Christian soldier are many, and require well spent time and earnest

thought, if they are as they should be taught aright.

None of these duties, however, should be more carefully or constantly set forth than that which relates to discipline. The neglect of that duty has been attended alike to temporal and spiritual leaders, and to these who have come under their care with the most disastrous results. If, says Mr. C. C. Chesney, in his "Essays on Milliary Biography," there was anything deficient in the military life of that great man, General R E. Lee, it was his neglect strictly to enforce discipline. This neglect hindered the success-at least so far as that General was concerned-of the great struggle in which he was engaged; and the neglect on the part of the Christian leaders to carry out that part of Church government which relates to discipline is, we doubt not, a fruitful source of the want of united action against Satan and sin, found so largely in many of the Churches.

And spiritual lave is the want of the hearer in religious discourse.

This is possessed in but a limited degree, if possessed at all.

That grace too, of all the gifts and graces is most important, and its importance ought to be impressed upon the minds and hearts of those who, in religious discourse are addressed. "Now abideth faith, hope, and charity, these three, but the greatest of these is charity," or love.

The Churches are to give those who are to supply the spiritual wants Through them is to come their of the hearer in religious discourse. The conversions at the Penticost, accompanied by the conversion. outpouring of the Holy Spirit, and the preaching of Peter, took place in connection with the Church at Jerusalem, and since that period the Churches have been a means to bring about that desirable end. harmony with God. Grace cannot be made known when comprehended by the natural faculties only, as it can when the one making it known is imbued with the spirit of Christ. "Eye hath not seen, not ear heard, neither hath it entered into the heart of man, the things which God hath prepared for them that love him. But God hath revealed them unto us by His Spirit '

Intelligence also, must be in the possession of the one who speaks, to supply the hearer's spiritual want in religious discourse. This is clearly and strongly expressed by the Apostle Paul in his second Epistle addressed to Timothy, "Study to show thyself approved of God, a workman that needeth not to be ashamed, rightly dividing the

word of truth."

May they seek, and may God grant sufficient grace to discharge it in such a manner as to hear the welcome plaudit, "Well done, good and faithful servant, enter thou into the joy of thy Lord."

The Annual Report of the Executive Committee of the New Brunswick Home Missionary Society for the Year A. D. 1876-77.

The Board now respectfully submit the following Report :-

The several objects embraced by the Society received the attention of the Board during the past year, viz., Home Missions, Ministerial Education, Sabbath Schools and Infirm Ministers and Widows.

The Missionaries aided by the Society have reported very encouraging result. Eighty-eight converts have been baptized, and the gospel has been preached in many parts of, at least, seven Counties of our Province. But we regret to say the Board has been unable to do snything for the three Northern Counties, viz: Kent, Gloucester and Restigouche. These Counties are wholly destitute of Baptist preaching.

In view of the increasing demand for laborers in many of the neglected stations and unoccupied churches, and the very limited amount of funds at the disposal of the Board, it was deemed necessary to call the Society together that some plan may be devised by which the work

may be more efficiently accomplished.

Accordingly, on the second day of October, the Corresponding Secretary was authorized to call the Society together, and, in response, twenty members of the Society met in Leinster street Baptist Church Vestry on the seventh day of November. A. D. 1876. The President occupied the chair. The object of the meeting was stated and a series of resolutions passed.

1st.—With regard to keeping a General Agent in the field.
2sd.—The Board was urged to send out from time to time deputa-

3rd.—The appointment of a Committee to keep up correspondence with mission fields, call in the aid of the churches, and furnish information through the Christian Visitor.

4th.—That Pastors be urged to keep the claims of the Society before their Churches, and ask for an average of two cents per week from all

their members.

5th.—The Board was directed to consider the expediency of confining its efforts solely to the work of Home Missions, and relegate to other organizatious the duties it performed in relation to Education, Sabbath Schools and Infirm Ministers.

Committees were appointed by the Board to carry out the wishes of

the Society as above expressed.

The Committee appointed in accordance with the second resolution submitted a report dividing the Provicee into sections, and asked the Board to appoint Ministers and others to hold public meetings at central points. Said Committee was requested to carry out the ar-

rangement.

The Committee appointed according to the third resolution, reported that they submitted a Circular to 145 Churches, seeking information and only 32 churches résponded; 113 churches disregarded the appeal. Of the 32 churches responding, 20 have pastors. 17 churches report work done at 30 out-stations. 10 churches do not need help to support the destitute. 8 churches need such help as the Board can supply. 8 churches need both money and laborers. 6 churches need money only, and 3 churches need laborers only. The Committee believe that if full information were given by all the churches, it would greatly facilitate the work of the Society.

SAINT ANDREWS.

Rev. T. W. Crawley continued his ministrations in St. Andrews under the direction of the Board, and enlarged his sphere of labor by visiting several of the surrounding stations, viz.: Bay Side, Oak Bay, The Ledge, Bartlett Settlement, Chamcook, and Bocabec. And at the request of Bro. C. F. Clinch, he spent four Sabbaths at Musquash, Dipper Harbor, Mace's Bay and Chance Harbor. This, he reports, was hard but very pleasant work. The church in St. Audrews is in a very feeble condition. But on the 4th of August he reports the conversion and baptism of a young lady. The grant to St. Andrews is \$100 per annum, to which was added \$50, on condition the pastor visited the adjacent unoccupied churches and stations.

BLISSFIELD AND LUDLOW.

Rev. William M. Edwards has preached the gospel here for seventeen years. Last year he reported that a strong desire for a revival of religion prevailed in these churches. This year that holy desire has been gratified, and many have been converted to God. In September he called for a co-laborer, and the Board tried to send him one, but did not succeed. His quarterly reports show, that he travelled 1,546 miles; preached 128 sermons; made 402 religious visits; conducted 52 conference and prayer meetings; attended 4 funerals; administered the Lord's Supper twice, and beptised 38 converts. The grant made to Bro. Edward's field of labor is but \$50 per annum.

GORDONVILLE AND COLDSTREAM.

Rev. John L. Shaw labored under the direction of the Board at Gordonville, Coldstream, and the surrounding stations for seven months, ending the 15th day of Fobruary. His report give us miles tavelled, 550; visits made, 238; sermons preached 90; conference

and prayer meetings conducted, 49; baptized 12 converts; administered the Lord's Supper three times; attended two funerals; visited Sabbath Schools three times. He collected on the field \$50, and received from the Board \$108.

TOBIQUE.

Rev. Samuel Burtt labored on the Tobique Mission field for about four and-a-half months, under the direction of the Board. He reports having travelled 1,223 miles; religious visits made. 334; sermons preached, 66; prayer-meetings attended, 65; baptized 30 converts. He receives at the rate of \$100 per annum from the Board.

SECOND ALMA.

Rev. Solomon Smith devotes one-fourth of his time to Second Alma, He reports having travelled 293 miles; made 108 religious visits; preached 45 sermons; conducted 18 prayer meetings; baptized 7 converts; administered the Lord's Supper once. He receives from the Board at the rate of \$30 per annum.

ST. MARY'S AND GIBSON.

Rev. Benjamin Hughes occupied these stations for six months, closing his labors in connection with the Board on the 1st of November. He says:—"I have held meetings every other Sabbath at Douglas and St. Mary's, morning and evening, and occasionally at Gibson in the afternon of the same day. I have also held a prayer-meeting in the hall of St. Mary's every Monday evening, which has been well sustained. I have been much encouraged by increasing congregations and the interest manifested in Baptist preaching "He received from the Board at the rate of \$100 per annum.

MIRAMICHI.

Bro. G. E. Good spent his vacation of 12 weeks last summer in Newcastle, North Esk, Little South West and other stations. He reports that Baptist sentiments are prevailing, and that two ministers should at once occupy this field,—one at Newcastle and Charham, and the other at North Esk and the up river stations. He travelled 309 miles, preached 34 sermons, held 8 prayer-meetings and 4 conferences, made 152 religious visits, and collected on the field \$77.33; he received from the Board \$20.

NEWCASTLE AND MIRAMICHI.

This spring Rev. T. M. Munro accepted a call from the Newcastle Church, his labors to extend to Chatham and the surrounding stations. The Board and the Trustees of the Estabrooks' Bequest promise to aid this Church, equally, to the extent of \$300 for the first year, \$200 for the second year and \$100 for the third year, with the understanding that at the expiration of this period this Church and Mission be self-sustaining.

NORTH ESK AND LITTLE SOUTH WEST.

Bro. W. P. Anderson, Liceutiate, has been engaged by these churches to labor with them. Most commendable energy and liberality have been shown by some friends of the cause here in providing a parsonage and in contributing to the support of the Mission. The Board, together with the Trustees of the Estabrooks' Bequest, have promised these churches \$200 for the first year, and the H. M. Board has granted \$75 for the second year and \$50 for the third year, with a request to the Trustees of the Estabrooks' Bequest that they grant an equal amount for the second and third years to these churches.

WILLOW GROVE.

AFRICAN CHURCHES.

Rev. H. Haynes was appointed Missionary to the colored brethren for six months. He reports having travelled 150 miles, preached 120 sermons; funeral sermons, two; married three couples; baptized one; administered the Lord's Supper once, collected \$4.79, received from the Board \$18.51.

SECOND FALLS, ST. GEORGE.

The grant of \$25 was renewed to this Church, but no report of labor performed has yet been made to the Board.

GRAND BAY, SOUTH BAY, SPURR'S COVE.

A grant of \$100 for the ensuing year, was made to these stations, and the oversight of the work was entrusted to the Carleton Baptist Church.

Rev. Robert Mutch, Colporteur and general Missionary, reported work performed during 4½ months—viz.: miles travelled, 427; sermons preached, 57; conducted 13 prayer-meetings; established one Sabbath School; visited seven others; made 320 religious visits. He received from the Board \$46.34.

MINISTERIAL STUDENTS.

Two students studying in Acadia College received each an appropriation of \$75.
