

An Act to provide for a better system of discipline, and for a more economical management of Gaols, and for the erection and maintenance of a House of Correction for Juvenile Offenders.

WHEREAS the management of the Gaols of this Pro- Preamble. vince has been unsatisfactory, irregular and unnecessarily expensive, and it is desirable that a uniform system of discipline and management should be devised for 5 their administration, and that juvenile offenders should be placed in a separate place of confinement from older and more hardened offenders and under an influence suited to their years; Be it, therefore, enacted, &c.

That it shall be the duty of the Inspectors of the Provin- Inspectors of 10 cial Penitentiary, to visit and inspect, either separately or Penitentiary jointly, at least once in each year, all the gaols or other of all gaols. prisons and houses of detention in the Province, and at their dueach such visit, they or he shall examine and inquire into all matters connected with the government, discipline and

- 15 police of each prison, and into its state and condition; as to the conduct of its officers, and whether their duty is efficiently performed, and as to the treatment of the prisoners, and the effect of the discipline upon them : It shall be their duty to examine and inquire into the financial and indus-
- 20 trial affairs, and to see that economy and diligence are practised, and proper vouchers and accounts kept of all transactions; that the food is wholesome and sufficient, that offences are wisely and humanely punished, and that order and cleanliness prevail in the prison.
- II. And be it enacted, That it shall be the duty of the Inspectors to 25 said Inspectors, once in every year, to consider and adopt prepare a code of regulations. a uniform system of discipline and management, not inconsistent with the laws of this Province, for the government of all the said prisons and for the modification and
- 30 improvement of the structures thereof; and the said code of regulations shall be transmitted by the said Inspectors immediately after its adoption, to the Provincial Secretary, for the formal approval and sanction of the Governor in Council, and on the receipt of such approval the
- 35 said Inspectors shall transmit copies of the regulations, certified under their hands and seals, to the County Judge, Sheriff, and Clerk of the Peace of each District and County, and to the Keeper, Gaoler or other chief authority of each gaol in this Province; and the said regula-

tions shall be immediately put in force by the said authorities, and be held to be the only rules and regulations in force in the respective prisons.

III. And be it enacted, That it shall be the duty of the Sheriff or Keeper of each gaol or other house of deten-5 give them all tion to admit the said Inspectors, or either of them, into every part of such prison; and to exhibit to them all books, papers, documents and accounts pertaining to such prison or to the detention of persons therein, and to render them every assistance and facility in his power, to 10 enable them to discharge the duties herein contemplated, and to obtain all necessary information.

IV. And be it enacted. That the said Inspectors or have powers of either of them, shall have power to inquire into any abuse or irregularity alleged to exist in the management of any 15 prison; and for this end and for the more certain obtaining of desirable information, the said Inspectors shall have power to examine on oath, to be administered by either of them, the gaoler of the said prison or any other person; and any one neglecting or refusing to appear or to testify 20 when duly summoned before either of the said Inspectors for such purpose, shall be liable to prosecution and summary conviction before any Justice of the Peace for so neglecting or refusing and be subject to a penalty not exceeding five pounds in the discretion of the Justice, to be 25 levied by distress and sale of his goods and chattels in case of non payment, to the use of Her Majesty.

V. And be it enacted, That the said Inspectors or

others having either of them may at any time, but shall at least once sons to report every year, demand and receive written reports upon the 30 state of each gaol or other prison in the Province, from the gaoler or other chief officer thereof; and it shall be the duty of the gaoler or other chief officer of every prison on or before the twentieth day of January in each year to furnish the said Inspectors with an annual report of the 35 affairs of the prison under his charge for the year ending the thirty-first day of December preceding, and the said report shall state clearly and correctly the number of prisoners confined in the prison during the year and their offences, distinguishing those committed for detention as 40 wltnesses-for detention on charge of crime-for contempt of Court-on civil process-for trial-and after conviction: It shall also show how the prison has been sustained during the year and what the cost of its maintenance has been; also the amount of moral and religious instruction 45 afforded the prisoners, and all other points of information and returns which the said Inspectors may require.

Inspectors to report to the Governor.

VI. And be it enacted, That it shall be the duty of the said Inspectors to prepare, from the said reports of the several goal authorities and from their own knowledge 50

- 10 tion of the Government, such amendments or additions to the penal laws or prison system of the Province as their experience may induce them to think advisable.

VII. And be it enacted, That the Governor in Council Institutions may cause to be established within the Province two In- for the refor-ing for the reformation of juvenile delinquents; and venile offenthe said institutions shall be established, one in such part $\frac{ders to be established}{tablished}$. of Lower Canada and the other in such part of Upper

Canada as the Governor in Council may determine, and shall be severally entitled, " The House of Correction for 20 "Lower Canada," and "for Upper Canada." And the said

- Houses of Correction shall be places of detention and instruction for males under sixteen years of age; and each Each shall have two departments, one for lads convicted of two departcrime, and the other for lads committed in the manner ments.
- 25 hereinafter provided for habitual vagrancy, or at the request of their parents or guardians for incorrigible conduct, and also for lads whose parents or guardians, by vagrancy or vicious conduct, are incapable or unwilling to exercise proper care over them ; and the two departments shall be 30 kept separate and distinct, and the inmates of either shall

have no communication or intercourse with the other.

VIII. And be it enacted, That the said Houses of Cor- Expenses to rection and all the property, real and personal, thereto be borne by the Province. belonging shall be vested in Her Majesty, and that all 35 sums necessary for their support shall be paid out of the Consolidated Revenue Fund to the Masters respectively of the said Houses of Correction, on warrant of the Governor and shall be duly accounted for by the said Masters.

And be it enacted, That the said Houses of Inspectors to 40 Correction shall be under the control and direction of have control of the said Instithe Inspectors of the Provincial Penitentiary, subject to tutions, and to the instructions of the Governor in Council; and it shall make Rules be their duty to prepare and submit for the consideration ment thereof. and sanction of the Governor in Council, a system of

45 discipline and management for the said Houses, and rules and regulations for the moral, religious and industrial instruction of the inmates,-which, when so sanctioned, shall form the system of management in the said Houses of Correction, and be obeyed by the Officers thereof.

How long youths shall Institutions.

Power of In-&c.

X. And be it enacted, That all lads committed to youns shall the said Houses of Correction shall be, and remain under the control and direction of the Officers thereof, from the 5 day they are received therein until they attain the age of eighteen years, and the Inspectors thereof shall have power to place the youths committed to their care at such employments, and cause them to be instructed in such branches of useful knowledge as may be suitable to 10 their years and capacities; and they shall have power in spectors to ap- their discretion to bind out the said youths as apprentices while so committed to their care, to such persons and at such places, to learn such proper trades and employments, as in their judgment will be most conducive to their refor- 15 mation and amendment, and will tend to the future benefit and advantage of such vouths.

Who shall be received into the penal department.

XI. And be it enacted, That the Masters of the said Houses of Correction, respectively, shall receive into the penal department thereof, all males under sixteen years of 20 age convicted before any Criminal Court of this Province, of any offence punishable under the existing laws of the Province, by imprisonment in the Penitentiary, and deemed by the Judge, Recorder, Mayor, or other presiding Judge, proper objects for the House of Correction: 25 And who into and youths so sent to the House of Correction shall be the Correction detained therein during the term of their sentence, as they might have been in the Penitentiary; and each of the said Masters shall receive into the corrective department of the House of Correction under his charge,---30

> 1st. Lads under sixteen years of age, committed upon any criminal charge for which if found guilty, they would be sentenced to imprisonment in the County or City Gaol, and deemed by the Judge or other presiding Magistrate, proper objects for the House of Correc- 35 tion; Provided always, that the Parent, Guardian or next friend of each such lad, shall consent thereto.

> 2nd. Lads under sixteen, committed by any County Judge, Mayor, County Warden, Recorder, Police Magistrate or Justice of the Peace, on the complaint and due 40 proof made to him by the parent, guardian or next friend, of any such lad, that by reason of incorrigible or vicious conduct, he has rendered his control beyond the power of such parent, guardian or next friend, and made it manifestly requisite that from regard for the morals and 45 future welfare of such lad, he should be placed in the House of Correction.

3rd. Lads under sixteen years of age committed by any authority last named, on complaint and due proof in each case, that the lad is a proper subject for the House of Correction in consequence of vagrancy, or incorrigible or vicious conduct, and that from the moral depravity, or otherwise, of his parent, guardian or next friend, in whose

5 custody he is, such parent, guardian or next friend is incapable or unwilling to exercise proper care and discipline over such incorrigible or vicious lad.

And it shall be the duty of the functionary committing Reasons of any lad to either of the departments of either House of committal to 10 Correction to state in writing, fully and clearly, the ground writing. on which he is committed, and the names and residences of the parties on whose evidence he acted, and the substance of each witness's testimony; and without such statement is appended to it no commitment will be valid, and the

15 Master shall not receive the lad named therein.

XII. And be it enacted, That the Sheriff or other Powers to per-Officer directed to convey any person to either of such sons convey-Houses of Correction, shall have full power so to do by the Houses of himself or by his Deputy, and to detain such person in Correction. 20 custody or re-take him if he escape, and to command the assistance of others in re-taking him, in each and every District, County or other locality through which he shall have to pass, as well as in the District, County or locality

in which the order was made, and by virtue of such order, 25 without its being indorsed or countersigned by any functionary whatever.

XIII. And be it enacted, That the whole executive Executive management and control of each of the said Houses of control vested in Masters, Correction shall, under the written instructions of the In- subject to in-

- 30 spectors, be vested in the Master of such House, and all structions of Inspectors. transactions and dealings on account of the said House of Correction, shall be conducted by and in his name, and he shall be capable, in law, of contracting, suing and being sued in all Courts and places, and in all matters concern-
- 35 ing the said House of Correction, by his name of office of "The Master of the House of Correction for Upper (or Lower) Canada," as the case may be, and by that name the said Master shall be, and is hereby authorized to sue for any recover all sums of money that may be or become due from any person in the Province on account of such House of Cor-
- 40 rection, and by that name he and his successors in office shall have perpetual succession; and each such Master shall be appointed by the Governor General of this Province, during pleasure, with a salary not exceeding \pounds per annum, with a free house and fuel; and the said Mas-
- 45 ters may be suspended for cause by either of the Inspectors, until the pleasure of the Governor shall be known.

XIV. And be it enacted, That the said Inspectors may Inferior Offappoint such other officers inferior to the Master as may cers.

be found necessary, with such reasonable salaries as their duties entitle them to; and the said officers may be suspended by the Master, at any time, until action is taken on the ground thereof by the Inspectors; and the Master and either of the Inspectors, or the Inspectors jointly, may remove any such officers, when they deem that the interests of the Institution demand it.

And the said Inspectors shall prepare and transmit on or before the 10th of February following the receipt of such Report of the said Masters, an Annual Report to the Governor upon the 20 condition of the said Houses, and the moral and industrial progress of the inmates thereof.
