An Act to amend the Municipal Institutions Act of Upper Canada, and to provide for the regulation of Transient Traders.

WHEREAS it is expedient to amend the Act respecting the Municipal Institutions of Upper Canada, Consolidated Statutes for Upper Canada, chapter fifty-four, in so far as it relates to the licensing of transient traders; Therefore, Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

- II. The following paragraph shall be inserted in the said Act, and shall be taken to be and be read as sub-section four of section two hundred and eighty-four of the same.
- 10 "4. For licensing, regulating and governing transient traders and other persons who occupy places of business in the city or town for uncertain periods less than one year, and whose names have not been duly entered in the Assessment Rolls for the then current year."

III. This Act shall be deemed a Public Act.
