

nouncement of extensive works to be commenced in connection with the forti-fications of Halifax this summer, comes the report, on what is considered the best authority, that Halifax, which has been an important military station since 1749, will shortly pass under the exclu-sive control of the British Admiralty. The intention is to make Halifax one of the greatest naval stations in the world, and in addition to the men of the fleet, there will be a reserve of 2,000 salors and marines, including 600 mar-ine artifleryme. It is proposed to station a regiment to be known as the Royal Garrison Regi-ment at Halifax, which will of course be under the orders of the admiralty, and the general who has always com-manded the station will be replaced by a British admiral. The works at Esquimalt, which hith-erto have been under both Army and Naval departments, are to be controlled in future solely by the Admiralty.
