EVILS OF CROSS-EXAMINATION. It is a question if the ends of justice could not be better served by the abolition of cross-examination in court.

There is a glamor about cross-examination. It is often a spectacular performance, but, too often it does more to satisfy the designs of the cross-examiner than to add to the value of desirable evidence.

Sometimes the cross-examiner is actuated by spite, sometimes by sentiment, in nearly every instance, his object is to bring from the witness testimony that will suit the purposes of his case.

The Royal Commission has shown the folly of cross-examination of witnesses who have strong mental powers, and a determination to adhere to their story.

The cross-examiner can do nothing with the strong witness. It is not the witness who is to be shaken, but the timid man, but this may or may not be in the interest of justice.

The strong witness, telling what is not true, can defy cross-examination that makes easy victims of timid witnesses who are telling the truth.

In other words, perjury may successfully defy the arts that establish contradictions in the testimony of witnesses whose only desire is to tell the truth.

There can be no doubt that the cross-examiner numbers many victims among truthful witnesses. It is equally true that he rarely scores a triumph with a witness who is gifted with a strong mind, a steady self-possession and an iron-clad conscience.

The court, of course, exercises a control over the cross-examiner, but what does this control amount to? There can be no object in controlling the cross-examination of the man who has the determination to adhere to his story, if it is desirable, of course, to control the cross-examination of timid witnesses, who are telling the truth, but what is the object of cross-examining such witnesses? Their evidence, under direct examination, is more likely to be accurate than the evidence they give under cross-examination.

The great weakness in the theory of cross-examination is that it is powerless against the strong and confuses the weak. Its failure to accomplish anything of importance before the Royal Commission must raise serious doubts as to the desirability of permitting cross-examination in courts of justice.

NO PRESS CENSORSHIP. The judges have declared that they will not interfere with general news comment, nor take notice of any press comment which may be regarded as an invasion of the jurisdiction of the Commission, unless it is brought to their attention by affidavit.

The World assumed that the judges would not take the position of forbidding comment on matters of high public importance, and it therefore simply pursued its policy of discussing these questions fairly and with no desire to prejudice the case.

Division Court. ANXIOUS ABOUT THE MARKET

Property Committee Uncertain as to Future of the Trade in the City.

PROPOSED STREET CAR LINES

Works Committee Deal With Suggested Extensions and Cross-Town Lines.

The question of the future for Toronto's cattle trade is a very vital one, Mayor Urquhart, in a lengthy message at the Council meeting on Thursday last, pointed out the necessity for some action being taken, and that at once.

The meeting of the Property Committee yesterday afternoon had been called at the special request of the Mayor to deal with the question. His Worship explained that he had learned that the drovers and cattle men were of the opinion that the City Council were not doing all they could for the furtherance of the trade, and that dealers were going to the Junction. He suggested that a circular letter be sent to the men doing business at the market, to the effect that the city is going on with the market, and not only that but was prepared to have as good a market as possible.

As to the site, if the present site was not the most suitable, the Council would have to look for a new one, or some way to enlarge the present place, he said.

Ald. Chisholm asked the Mayor if he had heard of any inducements from the Junction people, and offered to the cattle dealer, other than the advantages derived from dealing in a larger market. The Mayor said he had, and Ald. Sheppard also said he had heard that the men had received offers to purchase their entire plant.

Chairman Dunn speaks: "If the committee were to consider for a moment the proposal to remove the market from its present position, a mile or so, he would not give a cent for the whole business. There was no site suitable nearer than the Junction, and the city would have no chance against the company there. He thought the idea of the Mayor's, to send a circular to the cattle dealers, a first-class one, and that it would have the effect of putting a quietus upon the rumors that are at present rife in the trade."

Present Location Important. Assessment Commissioner Fleming said it would pay the city insensibly, even if it did not receive one cent for fees, to keep the market in its present location. The centering of the business alone in Toronto would be of tremendous advantage to the city at large.

\$100,000 of a Revenue. Ald. Sheppard stated that outside of all the money expended upon the market in the past ten years, the city had derived an income of \$100,000.

Ald. Richardson was sure that so long as the G.T.R. stood by the city market the city might be assured that the trade would not leave, but if they were to go to the Junction the city would be the loser.

G.T.R.'s Position. Ald. Sheppard: "So long as proper accommodation is provided for the cattle dealers, the G.T.R. will stand by the city market."

Resolves Urgent Attention. The Mayor said that the situation required urgent attention, and that the illness of Commissioner Coatsworth there was no one in charge of the market at present other than a subordinate, and he moved that Assessment Commissioner Fleming be appointed temporarily. Some objection was taken to this proposition upon the grounds that the Commissioner already had too much to do. The motion was lost, and Ald. Starr moved that Superintendent Walker be placed in full charge during Mr. Coatsworth's absence, and to report as to what should be done to make it a first-class business venture.

At the Works Committee. The Works Committee had been called to consider the Engineer's report upon the proposed new car lines through the city. Several new lines are required, and the committee have to decide from a total of sixteen recommendations just which ones and how many are the most desirable.

A plan has been prepared by the Engineer, showing the proposed lines, cross-town, connecting with the Arthur street present tracks, at Bathurst and St. Patrick, running along St. Patrick to Anderson, to Agnes, to Wilton, to River to Gerrard. Another proposal on this line was to run the cars down Teravay-street from Agnes and then down Bay to the waterfront. Still another suggestion is to run the cars up Elizabeth-street to Grenville, to St. Vincent, to Chapel, to North, to Bloor. These lines are for the purpose of relieving the traffic on Yonge-street, and to cut the great stretch from Yonge to McCaul and the Bell Line.

SPECIAL FRANCHISE TAX LAW

In New York State Sustained—Its Effects Are Far Reaching.

Albany, N.Y., April 28.—The Court of Appeals unanimously sustains the special franchise tax law, which amended the general tax law so as to include as taxable real property, the rights of street, gas, pipe line, telegraph, telephone, and other public service companies in the public streets and places.

Taxes assessed during the three years since the passage of the law amount to \$18,142,881, upon an assessed valuation in 1902, for instance, of \$282,011,770.

The court holds that the legislature, in creating a new system of taxation, embracing a new kind of property, never taxed before, had the right to entrust to state officers the power of making the assessment, and that tangible property, which had been formerly taxed by local assessors, is merely incidental to the special franchise, and that there is no infringement upon local self-government.

The matter of franchise companies affected will take the matter to the Supreme Court.

FORMER PRESIDENT EXECUTED.

Sensational Climax to Revolution in Honduras is Reported.

New Orleans, April 28.—The steamship Breakwater, from Puerto Cortez, Honduras, brings news of a sensational climax to the revolution in that country. According to information received at Puerto Cortez, former President Sierra was captured by the revolutionists on the Salvador frontier, and summarily executed. General Arias, who was installed in the Presidential chair by Sierra at the outbreak of the revolution, was pursued and captured by the insurgents, and is now a prisoner in Tegucigalpa.

BOY'S TRAGIC DEATH.

Stratford, April 28.—Herbert Cook, a boy of about 16 years of age, son of Major George T. Cook, was almost instantly killed this afternoon. He was employed at the George Lagard Furniture Company's works, and while endeavoring to get on the factory elevator, going up, failed to catch it, and falling his balance, fell to the bottom of the shaft, a distance of three storeys. He lived only a few minutes.
