An Act to amend the Act respecting the Municipal Institutions of Upper Canada, by enabling County Councils to allow travelling expenses to their members.

**WHEREAS** it is expedient to enable the Municipal Councils of Counties in Upper Canada, to pass By-laws for re-imbursing to the members of such Councils their reasonable travelling expenses incurred in attending the meetings of the said Councils: Preamble.

5 Therefore, Her Majesty, &c., enacts as follows:

L. The 269th section of chapter 54 of the Consolidated Statutes for Upper Canada, shall be so amended as to read as follows: Sect. 269 of cap. 54 amended.

10 "The Council of every County may pass By-laws for paying the Members of the Council for their attendance in Council at a rate not exceeding one dollar and fifty cents per diem, and for their travelling expenses between their respective places of residence and the place where the meetings of the Council are held, at a rate not exceeding for each mile travelled in coming and going." County Councils may allow travelling expenses of members.
