THIRTEENTH ANNUAL REPORT.

This 13th Annual Meeting finds harmony and prosperity prevailing in the affairs of the Home.

The records of the past year show a larger number of inmates than during any similar period of its history, 51 names being at one time on the register. The statement following will explain itself;—

As usual, a number of the more able-bodied inmates have hosen to leave the Home during the summer months to forage or themselves; but the approaching frosts will drive most, if not all of them back for readmission, when the Home will doubtless be taxed to its full limit. The members of the Ladies' Auxiliary still continue untiring in their efforts for the welfare of the institution, and we cannot but express our thorough appreciation of the great assistance they have proved to the Directors in the management of its affairs.

We very much regret their disappointment at the lack o as complete a success as usual (from a financial standpoint) of the Garden Party so recently given. A postponement, on account of rain, and conflicting reports by the press as to the exact date of its holding, accounted for a smaller attendance than usual. The lateness of the date also, which seemed unavoidable, doubtless served as a factor in the meagre attendance.

For good internal management and general neatness everywhere prevailing, the Steward and Matron are to be congratulated.

The Board wish to express their appreciation of the professional services of Doctors Pratt, Robinson, and Shillington, so freely given, and of the readiness with which they have responded to calls. Their prescriptions also have been supplied gratuitously by Messrs. MacCarthy, McCormick and Watters.

The hearty thanks of the Board are likewise due to Mr. Wentworth Greene who has several times given the benefit of his advice in matters requiring legal attention.

The public have continued generous in their contribution of funds and other necessaries during the year, all of which is gratifying evidence of the kindly interest felt in the work being carried on; while it must be admitted that contributions of money have not come in quite as freely as in former years—a condition of things which your Directors attribute to the ever-increasing number of calls now being made on the charitable public.

The Honorary Treasurer, Mr. J. H. Dewar, furnishes a statement which will explain the finances in general.

The portion of the grounds which is utilized as a garden contributes very largely to the requirements in vegetables etc., and furnishes summer employment to those inmates who are able to do more or less work.

Thanks must be again tendered to such of our city pastors and religious organizations as have shown practical interest in the spiritual welfare of the aged men by regularly holding meetings of service and song within the building. They are:—

Report of the Ladies' Auxiliary.

TO THE BOARD OF DIRECTORS.

GENTLEMEN,-

Your Auxiliary has much pleasure in presenting their thirteenth annual report.

In looking over the work of the year just closed we are led to express thankfulness that through the kindness of friends of the institution we have been enabled to provide many necessaries for the inmates.

Not only have the regular wants such as underwear, bedlinen, kitchen utensils etc., been provided, but in addition we have been enabled to make payment of the electric light account.

Special contributions have been sent in at Christmas and at New Year, for the usual holiday dinners, and at Easter an ample supply of eggs; so that it will be seen that the old men laid aside by age and infirmity have not been forgotten or neglected at these holiday seasons.

It is the earnest desire of the Ladies forming the Auxiliary to contribute, as they may be able, towards the welfare of the inmates, and as far as possible relieve the directors of the internal management of the home; and we have reason to believe that our humble efforts in that direction have not been unappreciated either within or without the institution whose interests we endeavor to keep constantly in mind.

A statement of receipts and expenditure is herewith submitted by Mrs. J. C. Glashan, our Treasurer, who continues to give her valued services in that capacity.

This season it was found advisable for various reasons to postpone the garden party usually held in June, to September, and in consequence the attendance was not as large as in former years. The result however, was by no means discouraging, a liberal sale of tickets having been made, and a considerable number attending, even cool as was the weather, so that the sum of one hundred and fifty dollars over all expenses was placed to the credit side of our account.

Thanks are tendered to all friends who in any measure have assisted the Auxiliary in its work.
