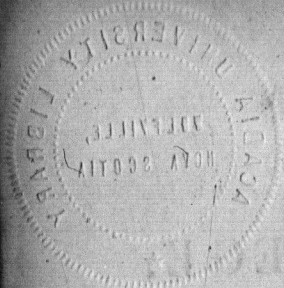

INTRODUCTION.

NONE but those who have studied the history of Collegiate Institutions during the first period of the settlement of the different provinces which now constitute the Dominion of Canada, can form an adequate conception of the delays and difficulties which beset the initiation and subsequent provision for the maintenance of King's College—the first Protestant University established in British North America.

Ontario was then a forest wilderness, Quebec a thinly settled Roman Catholic province, New Brunswick almost a *terra incognita*, Nova Scotia a strictly maritime colony with a few scattered settlements on its coast, numbering in the aggregate not more than twenty-five thousand souls.

Under these adverse circumstances the preliminary steps were taken for the foundation of a College at Windsor in the year 1768, or eight years after the conquest of Canada;* but it was not until the year 1788 that an Act of Parliament was obtained for founding, establishing, and maintaining a College in the province under the title of King's College, of Nova Scotia, and in the year 1790 the College was opened and buildings commenced.

In 1802, a Royal Charter was granted, conferring on the College all the privileges of a University, and ordaining that, “at our town of Windsor, in our said Province of Nova Scotia, there shall be established, from this time, one College, the mother of an Uni-

versity,* for the education and instruction of youth and students in arts and faculties, to continue for ever."

A Provincial Act to incorporate the Governors of King's College, repealing the Act of 1788, received the Royal Sanction in the year 1853. It contains provisions for the appointment and incorporation of Governors of the College, and that the Royal Charter of Incorporation shall not be affected by it.

The Patron of the University is the Lord Archbishop of Canterbury to whose approbation "all statutes, rules and ordinances" of the Board of Governors are subject.

The Board of Governors consists of the Lord Bishop of Nova Scotia for the time being, who is *ex-officio* Visitor of the University and President of the Board, and twelve Governors who must be members of the Church of England.

Two of the present Governors are life members of the Board, and the remaining ten are elected, two in each successive year, by the Incorporated Alumni of King's College. At the demise of the life Governors, the whole of the members of the Board with the exception of its President will be the representatives of the Incorporated Alumni, two retiring each year and two being elected at the annual meeting in June.

The Incorporated Alumni of King's College is a Society formed in 1846 for the purpose of sustaining the College and the Collegiate School by pecuniary assistance, either "towards the maintenance and support of the Teachers therein, or in such other way as may best conduce to the end which they have in view."

The Society has presented to the Board of Governors, in trust for the University and College, a handsome and spacious stone building for a Library and Museum, besides numerous donations of books, minerals, and fossils. It has also annually contributed towards the payment of the salaries of some of the professors in the College, and of some of the teachers of the Collegiate School.

For the last eighty-two years the course of study pursued in King's College has in its general features been modelled on the system in force in the University of Oxford, but the many and growing changes in education, introduced into the great Universities at home and everywhere rendered necessary, have led the Board of Governors to adopt a new Curriculum, which has been carefully modelled to meet the necessities of the age, prominent among which stands a sound training in Science. Henceforth the University will grant degrees and diplomas in Science.

It is evident that the present staff of professors, even with unsparing industry, can not carry out in its integrity the whole Curriculum, but the Board of Governors have not hesitated to adopt it, hoping that the advantages to be derived from it will be so patent to all the friends of education that their assistance will enable the Board speedily to make the necessary additions to the staff.

The University of King's College is the authorized representative of the Church of England in Nova Scotia, and its highest duty

is to educate young men for Holy Orders, but it extends its privileges to persons of all denominations and requires no religious test.

It derives in common with other recognized Colleges in Nova Scotia, a small annual grant from the Provincial Government, and it has received from time to time liberal donations from members of various communions. There are two classes of Students admissible to the College :—

1. *Matriculated Students*: who must pass the Matriculation Examination in one of the Universities constituted by Royal Charter, or of which the members shall be admitted to this privilege by the Governors of King's College.
2. *Elective Students*: who desire to attend during an Academic Year or Term, one, two, or more courses of Lectures.

MATRICULATION.

Every Student presenting himself for Matriculation shall be required to pass an Examination in the following subjects :—

I.—CLASSICS.

THE GREEK AND LATIN LANGUAGES.

One Greek and one Latin Book to be selected and published by the Board of Discipline one year in advance.

NOTE.—By a "book" shall be meant one division of an author's work. For example, one book of Homer's *Odyssey* shall mean any one book out of the twenty-four into which the poem is divided.

II.—MATHEMATICS.

ARITHMETIC.

The ordinary Rules of Arithmetic: Vulgar and Decimal Fractions.

ALGEBRA.

Addition, Subtraction, Multiplication, and Division of Algebraical quantities.

GEOMETRY.

The First Two Books of Euclid.

III.—THE ENGLISH LANGUAGE.

Orthography : Writing from Dictation : the Grammatical Structure of the Language.

IV.—THE FRENCH OR THE GERMAN LANGUAGE.

(*At the option of the Candidate.*)

One passage from some author for translation into English. The Board of Discipline to select the work and publish the name one year in advance.

Candidates shall not be approved by the Examiners unless they pass in *Two* of the above subjects, of which Classics shall be one. It shall also be necessary to pass in Arithmetic.

1. Matriculated Students are required to attend the Lectures and Examinations in all the Departments of their course, and to procure from each Professor a certificate of attendance, without which they will not be allowed to proceed to the Examination held at the end of every term.

2. A certificate of Matriculation will be given to every Student who passes the Examination and pays the fees ordered by Statute.* This certificate will have to be shown to every Professor whose course of Lectures the Student desires to attend.

* See Regulations regarding *nominations* which admit students to nearly all the courses of Lectures without fees.

3. Students in Arts may obtain permission from the Board of Discipline to attend special courses of Lectures in the Science Department.

4. Students who have not Matriculated in any recognized University, and who are therefore not qualified for admission as Undergraduates of the Second Year, may enter at that standing by passing both the Matriculation Examination and the First Year Examination.

5. Matriculated Students of any recognized University, may enter as Undergraduates of the same standing to which they had become entitled in such University, on producing satisfactory Certificates.

Course of Study.

The Course of Study for the first year is the same in the Arts and in the Science Departments.

In the second and third years Students attend the courses in the Department to which they belong.

£16 Sterling per annum. Open to Students in indigent circumstances, and of exemplary conduct.

In the year 1858, Miss Binney, sister of the present Visitor, and daughter of the late Rev. Dr. Hibbert Binney, in the name and on the behalf of her father's executors, handed over to the Governors certain stock, amounting to \$1000, to found an Exhibition at King's College, to be called the "Dr. Binney Exhibition," in memory of her said father.

The design of this Scholarship is to assist poor Students who may require assistance, and who shall have commended themselves by their exemplary conduct, although their abilities and requirements may not qualify them to be successful competitors for an open scholarship.

TERMS.—On or before the last day of May, in every year, the College Board shall nominate two Students, in their third term, at the least, whom they may deem best qualified, having regard to their poverty and the excellence of their characters: and the President shall forthwith transmit their names, together with a brief statement of their claims, to the Visitor, who shall select one of them to be the Exhibitioner, and to receive the interest accruing for the following year, commencing July 1st. Or, at his discretion, if he considers the claims of the two nominees to be equal, or nearly so, the Visitor may adjudge that the amount may be divided between them.

THE AKINS HISTORICAL PRIZE.

T. B. AKINS, ESQ., D.C.L., Barrister-at-Law and Commissioner of Public Records, has vested in the Governors, as Trustees, a sum of money sufficient to found a Prize of Thirty Dollars, annually, for the best Paper or Essay on the County History of Nova Scotia, embracing matter derived from local records, and traditions relating to the early and progressive history of each County. The Essays must be given in to the Secretary of the Governors on or before the 1st of June, 1872. The decision on the merits of the Essays to rest with the Governors, or such persons as they may appoint, and to be announced at the Encænna in June.

Each Essay is to be distinguished by a motto, and to be accompanied by a *sealed* paper, bearing the same motto on the outside and containing the name of the writer. The subject for 1872 is the County of *Yarmouth*.

THE GENERAL WILLIAMS PRIZES.

Three of \$60 each, annually, during his Excellency's life, for the best scholar in—

1. Mining and the Science of Mineralogy as it bears practically on these operations.

2. Mechanics and Civil Engineering as they bear on all matters relating to railroads, motive power for them, and all other modern aids to the human hand.
3. Languages of Modern Europe—German, but more especially French, as the almost universal medium of communication in Europe.

His Excellency has decreed that should no candidate be found duly qualified, the amount in that case, in any year, shall be applied to the purchase of books in that department for the College Library.

TERMS:

I. For the WILLIAMS PRIZE in Engineering.—That the course of study, preparatory to this competition, shall embrace, *first*, that part of Engineering comprehended under the general name of Engineering Geodesy, which depends upon Geometrical principles alone, such as Surveying, both with the chain and by angular measurements, levelling, setting-out works, copying, enlarging and reducing plans, together with a philosophical account of all the instruments used in those operations. *Second*—A summary of the principles of stress, stability, and strength. *Third*—The principles according to which structures are combined into extensive works of Engineering, such as roads, railways, natural and artificial water channels, inland navigation, tidal and coast works. That the prize be decided entirely by the examination.

The course for the ensuing Academical year may be confined to Engineering Geodesy, this being the first year of competition.

II. The WILLIAMS PRIZE in Mineralogy applied to Mining.—That the preparation for such competition shall be, in addition to a course of Geology, a thorough knowledge of such text-book on Metallurgy as shall be adopted by the College, and a practical acquaintance with specimens of metals and minerals, particularly the

natural products of the British North American Provinces, such as ores of gold, copper, iron and other metals, coal, antimony, gypsum, manganese and other useful minerals. That the candidate shall be required to produce satisfactory certificates of attendance, and attention, at lectures on chemical physics and inorganic chemistry, either in the College or elsewhere, in addition to the like satisfactory certificates of attendance at the special lectures by the Professor, and that lectures on practical mining operations shall have been attended.*

III. The WILLIAMS PRIZE in Modern Languages.

That the course of study preparatory to this competition shall embrace a competent knowledge of at least French and German. French must be known grammatically, and must be correctly pronounced. Some knowledge of the best authors must be displayed. Facility in writing the language must be shown, and a readiness and fluency of conversational expression. Similarly in German, but with excellence in one language mediocrity in the others will be tolerated. Provided always, that no Student shall succeed without passing a really good examination in French. The system of examination pursued in electing for each prize, shall be as uniform as possible throughout them all.



They will be permitted thereafter to present themselves at the end of the next Michaelmas Term for their Degree Examination, but should they fail to present themselves or to pass the examination at that time, they will not be allowed to present themselves for examination for a Degree before the end of the next ensuing Easter Term.

There will be no Honours Examination for Degree at the Michaelmas Examination.

All Undergraduates who do not present themselves for the Degree Examination at the end of the Easter Term in the Third Year, or who fail to pass such examination, will be required to attend the regular course of lectures for Third Year Students during the following Michaelmas Term.

All Undergraduates who do not present themselves for the further Degree Examination at Michaelmas, or who fail to pass such examination, will be required to attend the regular course of lectures for Third Year Students during the following Lent and Easter Terms, and to present themselves at every Class and Terminal Examination during that time.

Every Undergraduate, previous to presenting himself for any Terminal Examination, will have to obtain from each Professor whose lectures he has attended during the Term, a certificate of attendance and good conduct.

No Professor will grant such certificate if more than two absences without leave, during the course of the Term, are recorded against the applicant, or if his conduct shall have been in any way reprehensible.

Such certificate will then be handed in by the Undergraduate to the Vice-President three days previous to the beginning of the examination, and no Undergraduate shall be allowed to present himself at any Terminal Examination unless he shall have complied with these regulations.

The certificates shall be returned to each Undergraduate after the conclusion of the examination, and Pass, and Honours Certificates, signed by the Vice-President, shall be delivered to those Undergraduates who shall have attained the required number of Marks at the examination.

The list of candidates who shall have passed the Terminal Examination shall be published in the Hall, within one week after the close of the examination. The names shall be arranged in alphabetical order.

The Honours List shall be published in the same manner, within one week after the close of the Honours Examination. The names shall be arranged according to the order of merit.

Undergraduates presenting themselves for examination for a Degree, shall be required to produce satisfactory certificates of attendance and conduct during the whole of their three years' course. Or, if they shall not have attended the whole time at King's College, they shall be required to produce similar certificates from the University they have attended.

They shall send in such certificates to the Vice-President, at least one month previous to the beginning of the examination. The certificates will have to be signed by the various Professors whose courses of lectures they have attended, and no Undergraduate shall be allowed to present himself at any Degree Examination unless he shall have complied with the above regulations.

The certificates shall be returned to each Undergraduate after the close of the examination, and Pass and Honours Certificates signed by the President and Examiners shall be delivered to those Undergraduates who shall have attained the required number of marks at the examination.

The Examinations shall be carried on mainly by written questions and answers, but the Examiners shall at all times have the power of examining *viva voce*.

Undergraduates who shall have passed the Degree Examination shall be divided into three classes.

None shall be admitted into the First Class but those who shall have taken Honours in any subject.

The Second Class shall comprise those who shall have shown great proficiency in *all* the subjects of the Pass Examination, but who shall not have taken Honours.

The Third Class shall comprise all such as have obtained the required number of marks, but have not sufficiently distinguished themselves to qualify for a place in the First or Second Class.

The lists shall be published in the Hall within ten days after the close of the examination; the names in the first and second class being arranged according to order of merit, and in the third class alphabetically.

Any Undergraduate who shall absent himself from any University Examination without sufficient cause, approved of by the Board of Discipline, shall lose his Term or his Year, as the case may be.

An Examination Fee of One Dollar (\$1) shall be paid by each candidate to meet the expenses of stationery,—for the examinations throughout the year,—which shall be provided by the University.

Elective students shall not be required to pass any examinations, but may do so if they desire on complying with the above regulations.

They may also obtain, in like manner, Pass Certificates, Honours Certificates, and Diplomas in lieu of Degrees.

OF EXAMINERS.

1. The Governors shall appoint Examiners in each year to conduct the various Examinations at the close of Easter Term, viz.: the First Year, Second Year, the Degree Examinations, and the Prize Examinations.

2. These Examiners shall sign the Declaration, No. 4, in the Appendix to the present code of Statutes.

3. The Examinations shall be conducted by means of printed or written papers, and shall take place at such a time as shall permit of the results being made known at the Encenia of that year.

OF TERMS AND RESIDENCE.

The Academical year shall begin in October, and shall contain three terms, in which all scholastic exercises shall be performed, and all degrees conferred. Michaelmas Term shall extend from the first Saturday of October to December 22nd: Lent Term from the second Saturday of January to the Saturday before Palm Sunday: Easter Term from the Monday after Easter Monday to the last Thursday in June.

The following days shall be observed as Holidays in the University. All Saints' Day: Ash-Wednesday: Ascension-Day: Whit-Monday: the birth-day of the reigning Sovereign.

In order to encourage School-teachers and others, whose engagements prevent them from attending the full course, and who desire to obtain the Degree of B. A., the following special arrangements will be made:

Any such Student on making proper application will be permitted to come into residence during the first week of November in each year, and to remain until the end of the succeeding Lent Term, passing the regular examinations. This will be allowed to count as two Terms. After thus keeping eight terms, he will be permitted to present himself for the B. A. Examination on any subsequent occasion.

DISCIPLINE.

The resident students are under the immediate charge of the Vice-President.

A Register shall be kept of the attendance of all students at Lectures and Chapel, and of the resident Students at Commons, and the time of their passing the Gate.

The College doors shall be locked at 9.30 p.m., and no Student shall be out of College after that hour, unless by the permission of the Vice-President.

No visitors shall be allowed to remain in College after 9.30 p.m., unless by permission.

The Vice-President is authorized to impose fines or written exercises for infraction of regulations, insubordination, or disorderly conduct; matters of a more serious nature shall be referred to the Board of Discipline, which shall meet once a week or oftener if required.

Each Professor shall keep a record of the attendance at his Lectures, and of the way each student was prepared, to be handed in at the weekly meeting of the Board, and duly registered by the President.

The Board of Discipline may deprive any Student of his Term, in consequence of repeated absence from Lectures, or neglect of due preparation.

In cases of sickness a medical certificate must be produced, if required by the Board.

Extracts from the Statutes.

No undergraduate shall resort to any inn, tavern, or public house, except for some special cause, to be approved by the President, or shall spend his time in the streets of the town.

All bills of the Undergraduates are to be sent by the tradesmen with whom the debts are incurred, to the Bursar, at the end of every term; and parents are particularly requested to refuse payment of any bills not thus sent in.

The University Library.

The foundation of the Library is due to the efforts of the first Bishop of Nova Scotia, and may be placed in the year 1799. Several contributions in money had previously been received, but it was not till that year that active efforts were made to obtain books.

The original fund at the disposal of the Governors was not more than £250 sterling, and was intrusted to Mr. John Inglis, son of the Bishop, and a graduate of the University, who repaired to England, in 1800, for the purpose of purchasing books. The names of Dr. Moore, Archbishop of Canterbury, Dr. Porteous, Bishop of London, Dr. Horsley, Bishop of Rochester, William Wilberforce, Sir S. Bernard Morland, John Eardley Wilmot, M.P., and others thus became connected with the early history of the Library.

Munificent gifts from the University of Oxford continued to increase the value of the collection, which was further enriched by gifts from various English gentlemen, and from others settled in Nova Scotia.

The room in the College building set apart for many years for a Library Hall, was completed in 1810 at the expense of Sir Thomas Strange, and the Archbishop of Canterbury.

Subsequently valuable works were presented by Drs. Bayard and McCulloch, and by the Society for Promoting Christian Knowledge.

Among later benefactors, must be mentioned Dr. Greswell of Worcester College, Oxford; The Smithsonian Institute; The British and Foreign Bible Society; The Dean and Chapter of Westminster; T. B. Akins, D. C. L., the author of a History of King's College, and the donor of the "Akins Library," a collection of rare and valuable works issued by the most renowned Venetian and Parisian presses; the Society of Incorporated Alumni of King's College, who have largely contributed to the increase of the Modern Languages Department of the Library; E. Binney, Esq., who made a large donation of Standard Theological Works; C. Cogswell, M. D.; the present Bishop of Nova Scotia, and Her Majesty the Queen.

This large collection of books, now numbering 6191 volumes, contained till the year 1864 within a single room in the College building, was then removed to the new Hall specially built for the purpose and presented to the University by the Incorporated Alumni. It contains a large number of Standard works of reference in Theology which is by far the richest department in the Library—and an excellent selection of the great Greek and Latin classics.

In History and Belles-Lettres it is very poorly supplied, and many a work is wanting on the shelves of this department.

In Science the most recent standard books have from time to time been added, and after Theology and Classics, this is the

largest department. The languages of Modern Europe are not so well represented.

In spite of the many blanks, the Library is the largest in the Province and contains all the elements requisite for making it a thoroughly well appointed and efficient Reference Library, capable of benefitting others as well as the members of the University. Steps have been taken to extend, under certain necessary restrictions, the range of influence of the Library, by opening it up to the public.

There is no special Library fund, and the collection can only be increased by grants of money from the Governors, the occasional lapsing of the General Williams Prize Fund, and chiefly by the benefactions of friends of the University and of Literature.

Regulations for the Library.

EXTRACT FROM THE STATUTES.

"The Librarian or his Deputy shall attend daily in the Library at an appointed hour. Undergraduates may use the Library when he is present, and may obtain books from him to be taken to any room within the College, and to be retained for such time as he with the sanction of the President may permit."

"Damage done to any book, plate, or other thing belonging to the Library, shall be made good by the person in whose name it is entered in the Register."

REGULATIONS FOR THE ADMISSION OF THE PUBLIC TO THE LIBRARY.

The Library and Museum of King's College are open to the public from 12 o'clock noon, till 4 P. M. every Saturday during term time, under the following regulations.

1. A written application, (of which a form may be obtained at the Library) must be sent to the Librarian stating the name, residence and profession of the applicant, and the purpose for which admission is sought. If the applicant be not a householder in Windsor, he or she must be recommended by some well known resident.

2. On the application being submitted by the Librarian to the Library Committee and approved of, the applicant will be notified of the fact and will be admitted to the privilege of using the Library as soon as he or she shall have paid into the Librarian's hands a subscription of \$4.00 for the year, dating from the date of the application.

3. Every person admitted to the privilege of using the Library shall sign a declaration to observe the Rules and Regulations ordered for the proper conducting of the Library.

1548, and ordered to be read in churches; a precious copy of the first edition of the *Bishops' Bible*, containing quaint plates and portraits of two great celebrities of the reign of Queen Elizabeth, namely, the brilliant and unfortunate Leicester and the grave Burleigh. Several works from the press of Stephanus of Paris: a large folio edition on vellum of the *New Testament* in Greek, published under the direction of King Francis I., the protector of arts and letters; the great edition of Virgil's works printed by Stephanus in 1532 for the same sovereign, and a copy of the very rare duodecimo edition of the *Nov. Test. Græcum*, from the Royal Library. From Venice there is the remarkably beautiful and precious edition of *Rei Rustica Scriptores*, printed in 1472 by Nicholas Jenson, and well known to book-worms and connoisseurs for its sumptuous execution. It is accompanied by a copy of *Pliny's Natural History*, translated into Italian, and produced by the same printer.

The specimens of Aldine typography number nearly twenty different volumes, all executed in that perfect manner which has rendered that press so celebrated. There is also a very small Hebrew Bible.

The Akins Library contains besides, several illuminated and rubricated manuscripts.

GEOLOGY AND MINERALOGY.

The Geological specimens, many of which are very fine, illustrate the most prominent features of general geology, but the majority have been collected in Nova Scotia and are especially adapted to shew the characters of the Fossil Flora and Fauna of the Province. There are several collections, which may be discriminated as follows:—

1. The Almon Collection, presented about twenty years ago by Dr. W. Almon, of Halifax, contains with many minerals and shells, a considerable number of rock specimens and a few fossils, chiefly from Scotland.
2. The Governors' Collection consists of Coal Fossils obtained in 1860, at the expense of the Governors of the College; these were collected by Dr. How with the valuable assistance of a party headed by Richard Brown, Sr., Esq., then Agent at the Sydney Mines, who from long study was familiar with the district. Many of the specimens are exceedingly fine, and some are of large size.
3. The Alumni Collection consists of Silurian Fossils from Arisaig, N. S., collected, named, and arranged stratigraphically by Dr. Honeyman; purchased and presented, in 1861, by the Alumni of King's College.
4. The Australian Collection consists of specimens obtained in 1863 from Sir William Denison, then Governor of New South

Wales, in exchange for Nova Scotian specimens from the College Cabinet. It contains some beautiful fossils and is arranged stratigraphically: its value is increased by an accompanying large detailed coloured section made by the Government Surveyor of Mines, under instructions from Sir W. Denison.

5. A Collection of British Fossils, chiefly Silurian and Devonian, obtained in exchange for Nova Scotian specimens from the College Cabinet, in 1863, by Captain, now Sir James, Anderson.

6. A Collection from Europe, illustrating chiefly the nature of crystalline and sedimentary rocks, purchased by the Governors.

7. Several Collections, some of which are unnamed, and single specimens, given and obtained by exchange at various times; of these it will suffice to name: Reptilian Tracks of great geological interest, presented by the widow of their discoverer, the late Dr. Harding; valuable Fossils, chiefly carboniferous, presented by H. Poole, Esq.; Silurian Fossils from Arisaig, presented by H. Hill, Esq., Sheriff of Antigonish; Coal Plants from Cumberland Co., presented by Rev. Mr. Townshend, Rector of Amherst; Cretaceous Fossils from England, presented by C. B. Bowman, Esq., and Dr. Honeyman; Silurian and Carboniferous Fossils of Nova Scotia, from Professor How.

The Mineralogical specimens represent the most important species of minerals—some of them are of great beauty. They consist of those in the Almon Collection, of Zeolites collected at the expense of the Governors, and of various others obtained by gifts and exchange, as mentioned with regard to the geological department. Sir Rupert George, Rev. Dr. Robertson, Rector of Wilmot, Mr. H. Brown, Director of the Geological Survey of Victoria, formerly a distinguished student in science at this College, Rev. Mr. Ambrose, Rev. J. C. Cochrane, C. B. Bowman, Esq., J. Bowman, Esq., Rev. D. W. Pickett, Hon. W. Odell, and Prof. How, have presented interesting specimens.

ZOOLOGY.

The Willis Collection consists of specimens fully illustrating Nova Scotia Mollusca, named, arranged and presented by J. R. Willis, Esq.

The department is further illustrated by a collection of foreign shells, some interesting skulls and skins, and a limited number of preserved animals.

BOTANY.

The Cogswell Herbarium, bound in five Imperial folio volumes, contains a fine systematically arranged collection of Phanogamous and Cryptogamous Plants of Great Britain, presented by Dr. C. Cogswell.

The Gossip Herbarium consists of a small number of Scottish Plants, presented by Dr. Gossip.

The Willis Herbarium consists of Nova Scotia Algæ and Terrestrial Plants, presented by J. R. Willis, Esq.

The Strange Herbarium consists of a considerable number of East Indian Plants, presented, in 1805, by Sir T. Strange.

There are also a few woods, barks, leaves and fruits—from various sources—presented by C. B. Bowman, Esq., W. B. Almon, Esq., and other benefactors.

THE GENERAL COLLECTION.

The General Collection consists of various curiosities from different parts of the world, and a small but choice cabinet of coins.

The most interesting curiosities are the beautiful Indian pipe from Vancouver's Island, the models of the Leaning Tower and

the Baptistery at Pisa, and the memorials of Gen. Williams and Gen. Inglis, which include the sword worn by the former throughout the siege of Kars and that used by the latter during the defence of Lucknow. There is also a model of the Cawnpore Memorial Cross, formed of wood from the house in the court-yard of which the women and children were massacred.

The College possesses also a number of autographs of royal and distinguished personages: one of Thomas Moore, the poet, inscribed in a copy of Lucian, presented by him to the College on the occasion of his visit.

The coins illustrate the Numismatics of Rome and most of the countries of the modern world.

The different departments of the Museum are arranged in twenty-four flat cases, supported by the balustrade surrounding the gallery, and four large table cases, all glazed and provided with lock and key. The larger specimens which could not conveniently be placed in cases are arranged on shelves or distributed in different parts of the Hall.

There is still a great deficiency in several of the geological departments, especially those relating to Silurian, Devonian, Carboniferous and Triassic fossils; and owing to the want of additional cases the scientific arrangement is yet very incomplete. The specimens illustrating North American Geology are very few in number. The whole of the New York Series is unrepresented, and the illustrations from different provinces of the Dominion exclusive of Nova Scotia are exceedingly limited. The Curator has accumulated numerous specimens of Nova Scotia minerals and some fossils, and would be glad to exchange these for specimens illustrating the geology of different rock series in various parts of the Dominion and the United States.

The friends of Science in Nova Scotia and elsewhere are respectfully requested to contribute specimens to the Museum of King's College. The steps which have been lately taken by the Governors to provide suitable cases for the arrangement and display of the contents of the Museum in the fine Hall erected at the expense of

the Alumni, offer a guarantee that the liberality of donors will be carefully recognized and faithfully recorded.

The Incorporated Alumni of King's College.

THE organization of this Society was the result of the efforts of the friends of the University of King's College, to provide relief for the pecuniary difficulties which beset the governing body after the withdrawal of the Imperial grant of £1000 stg. a year in 1832, and the further withdrawal in 1846 of the grant of £500 a year, generously made by the Society for the Propagation of the Gospel, to assist the College at a time when the sudden withdrawal of the Imperial grant had overwhelmed it with financial embarrassments.

At a meeting of a Committee in May, 1846, consisting of representatives of the Governors of the College, of the Alumni, and of the friends of the Institution, the Right Rev. the Visitor, the late Bishop Inglis, stated at considerable length the circumstances in which the University of King's College was placed, and urgently and eloquently appealed for sympathy and aid.

On the 1st June 1846, a circular letter, more particularly addressed to the Alumni and known friends of the College, was adopted and ordered to be printed, and the Rev. F. Uniacke and S. L. Shannon, Esq., were appointed a Sub-committee to draw up a prospectus of an Association of the Alumni of King's College.

At a general meeting of the Alumni, (June 20th, 1846,) the "Constitution of the Associate Alumni of King's College," was adopted. The first clause stated that "the object of the Association is to form a bond of union among those who have received their education in whole or in part, at the University or Collegiate School at Windsor, and other friends of the College, and at the same time to promote the well-being of the Institution."

The following officers of the Association were elected at the first general meeting held on the 22nd June, 1846.

A branch Association was formed at St. John, New Brunswick, on the 14th September 1846, to co-operate with the friends of the College in Nova Scotia.

Among the first acts of the Association, were the preparation of the draft of an Act of Incorporation,—the raising of a sum of £2000 to meet the sum of £4000 proposed to be raised by the Right Rev. the Visitor,—and a grant of £125 for the maintenance of a Professor of Modern Languages in King's College.

At the Encenia, celebrated at Windsor on the 19th September, 1846, the Lieutenant-Governor, Sir JOHN HARVEY, expressed himself in very favourable and encouraging words respecting the action of the Alumni. "I feel it to be impossible to conclude those brief remarks without recording my admiration of the manner in which those who have received the benefits of their education from this respected Institution, now resident in this Province, have come forward to sustain it at this period of its difficulties, by an appeal breathing towards it a spirit of reverential and affectionate solicitude. This is as it should be. These, its grateful friends, are precisely the source to which the Institution ought to look for—and from which it ought to receive—that aid and support of which it now and may hereafter be in need, and for ensuring the ready and principal aid of these its natural allies; nothing more can, I am persuaded be requisite on the part of the body over which it is my duty to preside, than at once to enter into communication with them in those feelings of cordiality, confidence, kindness and consideration by which I am sure my colleagues are not less sincerely animated than myself."

The Society was incorporated in March 1847,* "for the promotion of Education," and more particularly for the support of King's College, and the Collegiate School at Windsor.

All persons paying an annual subscription of four dollars, or making at one time a donation of eighty dollars, are entitled to be members of the Society, having been duly admitted under the Bye-laws.

No restriction is placed on religious views, and persons of all denominations may become members of, and eligible to any of the offices or appointments of the Society.

The appropriation of funds for any special purpose is subject to a vote at any general meeting, and all receipts and expenditure of funds are vested in an Executive Committee of nine, by whom the Society is governed and its affairs managed.*

The first general meeting of the Associated Alumni, after the passing of the Act of Incorporation, was held in Halifax on the 17th March, 1848. The committee announced that as a result of their efforts to raise funds for the support of the College, the sum of £1575 had been raised by subscription during the year; and a further sum, exceeding £400 had been contributed towards the foundation of a Scholarship in memory of the late Rev. William Cogswell.

In December 1848, Sir John Harvey, the Lieutenant Governor of the Province, became Patron of the Associate Alumni of King's College. And during the same month the Executive Committee represented to the Visitor the advantages which would be conferred on the College if the Clergy of the Diocese, who had been educated at the College, were to unite themselves with the Association for the purpose of procuring subscriptions to the general fund.

At a general meeting of the Alumni held in the Halifax Hotel, Halifax, on June 21st, 1849, the Treasurer's account showed a balance of £1620 in hand; the annual subscriptions amounted to £85, and the total subscriptions of the friends of the College up to June 1849, including the Cogswell Scholarship fund, reached £2,413 17s. 6d.

In 1851 the sum raised reached £2770 4s. 6d. and the annual subscriptions amounted to £128. Of this sum £162 12s. 6d. together with 40 annual subscribers were obtained in New Brunswick, by the exertions of the Reverend J. C. Cochran, M. A.

At a special general meeting, held February 3rd, 1851, a resolution was adopted and a committee appointed to raise funds for the foundation of a professorship of Pastoral Theology, to be called "The Inglis Theological Professorship" in remembrance of the late Bishop.

At a general meeting held in June 1851, several ladies were elected members of the Society, and during this year the Governors of King's College, at the request of the Alumni, abolished all the oaths heretofore taken by undergraduates on matriculation, except the oath of allegiance, a promise of obedience to the Statutes being required in lieu of them. The income of the Society was now about £200 per annum, from annual subscriptions and invested funds.

In the Society's report for 1855, a résumé was given of the result of the efforts of the friends of King's College to raise funds for its support. With the Alumni originated the scheme to raise the sum of TEN THOUSAND POUNDS for the permanent endowment of the College, which was successfully completed in 1854. Up to that time one half of the salary of the Professor of Modern Languages had been paid by them, yearly assistance afforded to the Academy, and annual prizes established for the encouragement of the youth in both Institutions. The Cogswell Cricket prize and the Welsford Testimonial, founded by Dr. Almon, were created in 1856. The receipts for the year ending April 1857, amounted to £222 4s. 7d. In 1858 resolutions* were adopted that steps should be taken to raise funds for furnishing rooms for a Chapel, a Library, a College Hall and a Museum under the same roof, and that the building should be constructed of brick or stone.

* The Report of the Executive Committee for 1863 briefly recapitulates the circumstances which led to the construction of the handsome stone edifice which now holds the valuable Library and Museum of the College. The subject was first

In 1861 the new building was commenced, the contract amounting to £2,250, of which £1,800 was subscribed at the date of the report of the committee, and a resolution was passed on the 17th April 1862, pledging the funds of the Association for the payment of the contract. Among the liberal benefactors towards the new Hall, the name of Edward Binney, Esq., is especially mentioned as having supplied the funds for the construction of the Tower, which is named in honour of the donor "The Binney Tower."

The expenses attending the building of the new Hall were not wholly defrayed out of subscriptions for that purpose, and the Executive Committee were compelled to draw \$2395 from invested funds, thus diminishing their annual income, and to a considerable degree restricting their operations.

The contract for the main building was \$9620; this, however does not include the Binney Tower, nor various sums paid from time to time for drainage, roads, engineer's reports, &c. The total cost of the new Hall did not fall far short of \$1200.

At the annual meeting held in the new Hall in 1867, subscriptions were handed in to the Treasurer amounting to \$274 towards defraying the expenses of providing accommodation for the Library. The income of the Society amounted this year to \$1047.

In their annual Report for 1868 the Executive Committee strongly urged the necessity for more united action on the part of the friends of the College, and deplored the existing apathy.

"It should be remembered that it behoves those who, from year to year, go forth from the College, after finishing their course of study, to maintain its reputation and to forward its interests, as their predecessors have done. This is, indeed, now more necessary than ever, in view of the greater competition

formally brought before the Association in June 1858, when the following resolution was proposed by the Rev. Dr. Gray, and unanimously adopted:

"Whereas, it is highly desirable that there should be a building erected for the purpose of furnishing rooms for a Chapel, a Library, a College Hall and Museum under the same roof, and that such building should be constructed of stone or brick,"

"Therefore Resolved, that it be deemed a primary object of the Corporation to collect funds for this purpose; and that a committee be appointed to decide means for carrying this design into effect; and that this Corporation do respectfully express their wish to the Governors that some portion of the general funds should be appropriated to this desirable object."

which now exists in the Educational field, and the wider sphere which is opened up for the display of cultivated intellect.

"But it must be confessed, that, at the present time, there seems to be too great a degree of apathy in regard to the life and advancement of the Institution. Where shall we look for more animated effort and more vigorous exertion, if not among the ranks of those who have received their education within the walls of the College? Every one of these, far from considering himself as done with the Institution as soon as he has B. A. attached to his name, may reasonably be expected to be an active agent in its behalf, in whatever vocation or whatever quarter of the world he may be placed, endeavoring to add to the number of its students, making known its wants and capabilities, enriching its cabinet, contributing books to its library, already the largest in the land, meeting unfounded misrepresentations, and, in short, acting the part of an affectionate son towards his Alma Mater.

"This is what may be seen as regards other similar institutions. An obligation is evidently felt by those connected with them to maintain the interests of their respective Colleges through life, and to be found united in their behalf on all occasions. In this connection, the fact may be mentioned, that of some 230 living Alumni of King's, only about 51 have become annual subscribers to this incorporated Association. If the remaining 180 would join our ranks, and give their four dollars each per annum, much good might be done with the money, dormant prizes and scholarships revived, and more life and spirit would probably be infused into all branches of the Institution in whose behalf we are enrolled. The Executive Committee respectfully commend these suggestions to the attention of those who are now members, as well as of those who as yet stand aloof with their influence and their money."

REPORT.

THE Executive Committee of the "Incorporated Alumni of King's College," have great pleasure in again meeting the members of the Association, and in presenting to them their twenty-fourth Annual Report.

During the past year, some changes have taken place in the Faculty of the Institution. The chair of Mathematics, vacant at the last Anniversary, has since been filled for a few months by JOHN HUNTER, Esquire, M. A., of Queen's College, Belfast, and is again vacant by the recent resignation of that gentleman. The Committee trust that this important department of Science may not long be suffered to remain uncared for.

The Professorship of Modern Languages was also vacant at the last annual meeting, but has since been filled by the appointment of F. C. SUMICHRIST, Esquire, who, by the energy and vitality which he has infused into his department, has given good earnest of what may be expected of him in the future. This gentleman has also done good service by personally superintending and cataloguing the books, now arranged for the first time in the place designed for their reception in the new College Hall. This work has long been needed, more especially of late, since the munificent gift of T. B. AKINS, Esq., D. C. L., who with rare generosity, in addition to former benefactions, has bestowed upon the University a portion of his valuable library, comprising some 154 volumes, many of them of great value and interest in the departments of science and literature to which they relate.

May King's College never be wanting in such sons to contribute to her support in the time of need, and by doing so in their life

time enjoy the pleasure of witnessing for themselves the beneficial results of their generosity.

In this connection your Committee would thankfully acknowledge the liberality of Edward Dimock, Esq. of Windsor, who has presented the very useful and handsome Iron Railing which surrounds the galleries.

The Committee acknowledge the receipt of a Circular issued by the Visitor and President of the Board of Governors, referring to a proposed change in the Curriculum, whereby degrees and diplomas in Science shall be conferred by the University, and beg to express their entire approval of the same.

In answer to the appeal therein made to the Incorporated Alumni for assistance in carrying out the objects contemplated by the Board of Governors, your Committee would say that they will be ready so far as their means will allow, in the future as they have been in the past to assist in every thing that has for its object the well being of the University, but at the same time they would remind the Association that its present funds are fully pledged to the payment of obligations already incurred.

The suggestion that each Alumnus should endeavour to procure additional paying members your Committee heartily endorse, and it is a subject that has engaged their attention since the last meeting.

Advantage has been taken of the Bye-Law which allows members to be elected at the monthly meetings of your Committee, and through the exertions of some of the Committee several new members have been added to the roll since the last annual meeting.

As several of those who have heretofore contributed to the funds of the Association have refused this year, from various causes to continue their subscriptions, it becomes more than ever necessary that the list of annual subscribers should be increased so as to maintain the Institution upon its present standing, without any reference to contemplated changes.

Your Committee have great pleasure in stating that the suggestion thrown out in their last annual report for a social re-union of the friends of the College at the Encænia has been acted upon, and

that under the direction of a competent Committee satisfactory arrangements have been made to accomplish the object aimed at, and that the Associated Alumni and their friends will have an opportunity of renewing their friendship of former years, and of thus perhaps reviving their interest in the well-being of their Alma Mater.

The details of the arrangements have been published by the Committee appointed for that purpose, and it is to be hoped that in this effort to infuse fresh interest into the annual meetings they will be well supported by every friend of the College.

It is seldom that your Committee have not to record the death of some members of the Association. During the past year, only one has been called away, viz: JOHN BAYLEY BLAND, Esquire, who since the endowment fund was established has been a life member of the Incorporation.

The Treasurer's Account (now submitted) is made up as usual and as required by the Bye-Laws, to 30th April last, and exhibits a balance to the credit of the Society at that date of \$563.25½, but which is subject to the payment of the Alumni's proportion of the salary of the Professor of Modern Languages for the past year, and also some small bills.

The business calling for the immediate attention of the meeting is the election of two Governors in the place of Rev. Thomas Maynard, M. A. and Henry Pryor, D. C. L. who retire by rotation, and of a President and three members of the Executive Committee in place of Benjamin Curren, D. C. L., Rev. William Bullock, M. A., Rev. Charles Bowman, M. A. and Rev. William Armstrong, M. A. who in the order of their election go out of office, but who may be re-elected.

“That the Governors be recommended to impose an annual fee of \$2.00 upon Students and all persons using the Library, towards the salary of the Librarian.” Which was seconded by Rev. Mr. Ambrose.

By PROF. HIND, seconded by PROF. HENSLEY—

“That the Alumni consider that great advantages would be conferred on Collegiate Education in Nova Scotia if a uniform system of examination were established throughout the Province under suitable control, for degrees in Arts, Science, Medicine, Law and Music.

“The Alumni would cordially co-operate in any scheme the Governors might adopt tending to elevate the standard and secure a uniform examination for degrees in Arts, Science, Medicine, Law and Music, and while zealously guarding all the privileges now enjoyed by this University in conferring degrees in Divinity, they would gladly assent to a plan approved by the Governors for affiliating with a Central University which shall not be a teaching Incorporation, but whose powers shall be restricted to the supervision and control of the examination for all degrees in Arts, Science, Medicine, Law and Music in all Colleges in Nova Scotia receiving Government assistance, and that such Central University shall alone possess the power to confer degrees in Arts, Science, Medicine, Law and Music in any College receiving Government aid.

By MR. CARMAN—

“That the following resolution passed at the annual meeting in June 1865 be reconsidered :

AN ACT TO INCORPORATE THE ALUMNI OF KING'S COLLEGE, WINDSOR.

Passed the 30th day of March, 1847.

WHEREAS, a number of persons have associated themselves under the name of the Alumni of King's College, Windsor, for the promotion of education, and have raised by private contribution sums of money which they are desirous to expend in aid of the funds of the said College, and the Collegiate School, at Windsor, connected therewith, in or towards the maintenance and support of the teachers therein, or in such other way as may best conduce to the end which they have in view, and they are desirous of obtaining assistance from the Legislature, by the passing of an Act of Incorporation for enabling them to hold property, and to manage their affairs with greater ease and convenience.

1. Be it therefore enacted by the Lieutenant-Governor, Council and Assembly: that John T. Twining, James B. Uniacke, Henry Pryor, Hugh Hartshorne, and all and every such other person and persons as now are members of, or in the said society, and their successors, shall be and are hereby appointed a body, politic and corporate, in deed and in name, by the name of "The Alumni of King's College, Windsor," and by that name have succession and a common Seal, and by that name shall sue and be sued, plead and be impleaded, at law and in equity, and in all courts and places, and be able and capable in law to have, hold, purchase, get, receive, take, possess, and enjoy, lands, tenements, hereditaments and rents, in fee simple or otherwise, and also goods and chattels, and all other things real, personal and mixed, and also to give, grant, sell, let, assign or convey the same or any part thereof, and to do and execute all other things in and about the same, as shall or may be thought necessary or proper; and also shall have from time to time and at all times full power, authority, and licence to constitute, make and establish such Bye-Laws, Rules and Ordinances, as may be thought necessary for the rule and good management of said society, the establishing of officers proper for the

management of its affairs, and declaring the extent, duration, and authority of the offices and officers of the society, and their mode of appointment, and generally for promoting the objects of the society, provided such Bye-Laws, Rules and Ordinances be not contrary and repugnant to the Laws and Statutes of this Province; or those in force within the same, or to the Laws and Statutes of King's College, Windsor, respectively, at the time such Bye-Laws, Rules and Ordinances may be constituted and established, or to the provisions of this Act; and provided, also, that the said society shall not hold at any time, lands, tenements, hereditaments, goods, chattels, property or effects, of greater value than ten thousand pounds.

II. And be it enacted, that all persons paying an annual subscription of twenty shillings or upwards, or making at one time a donation of twenty pounds or upwards, shall be entitled to be members of the said society, having been duly admitted, pursuant to the Bye-Laws thereof, provided that such annual subscription or donation be actually paid into the funds of the society, and provided that no person now a member of the said society, or who, hereafter, may become a member of the same, shall, at any time hereafter, continue a member of the same, unless he shall have heretofore paid, or shall hereafter pay at one time into the funds of the said society a donation of at least twenty pounds, or shall hereafter annually, and from year to year, pay into the said funds the sum of twenty shillings or upwards: and if such annual subscription, or payment of any such annual member, shall not be paid on the first day of May in each year, such member shall thereupon cease to be a member of the said society, until such annual subscription or payment shall be actually paid, or until such person shall otherwise become a member of the said society, under some Bye-Law or Rule thereof.

III. And be it enacted that the said society shall be governed, and its affairs managed, by a committee of nine, comprising a President, Vice-President, and seven other members, a Secretary and Treasurer; the said committee to be henceforth called the Executive Committee, and such other officers as the said society, from time to time may think proper.

IV. And provided and be it enacted, that John T. Twining, D.D. now the President of the said society, shall after the passing of this said Act, be the President of the said society; that the Hon.

Henry Hezekiah Cogswell, now the Vice-President of the said society, be the Vice-President of the said society, after the passing of this Act; that Samuel L. Shannon, Esquire, now the Secretary and Treasurer of the said society, be the Secretary and Treasurer thereof, after the passing of this Act; and Samuel P. Fairbanks, Henry Pryor, James B. Uniacke, William J. Almon, Robert Fitzgerald Uniacke, Mather B. Almon, and Charles Twining, now the Managing committee of the said society, shall after the passing of this Act, be the executive committee of the said incorporated society, until an Executive committee be elected under this Act.

V. And be it enacted that all persons, without regard to religious denomination or difference of religious sentiment may be and at any time hereafter become members of the said incorporated society, being in all other respects entitled to be and become members of the said society, and now, and at any time hereafter, may hold any of the said appointments, or any other offices and appointments in the said incorporated society, being duly elected and appointed thereto, pursuant to the Bye-Laws thereof, any thing contained herein, or in any Rules, Regulations, or Bye-Laws of the said society, to the contrary notwithstanding.

VI. And be it enacted that the said society, incorporated as aforesaid, shall have power from time to time hereafter, to appoint the President, Vice-President, and executive committee, at some general meeting of the said society by a majority of the members of the society present, the whole number present being not less than twenty members, according to such regulations concerning such appointments as may hereafter be made by any Bye-Laws of the said society, to be made by virtue hereof.

VII. And be it enacted that the secretary and treasurer of the said society, and such other officers as may hereafter be required for the management of its affairs, shall be appointed in such manner as shall be declared by the Bye-Laws and Rules of the said society, to be passed by virtue hereof.

VIII. And be it enacted that all donations to the said incorporated society, to constitute life members or otherwise, of not less than twenty pounds, shall be invested under the direction of the executive committee as a permanent fund for the benefit of the said society, and that the funds of the said incorporated society shall from time to time, be laid out and applied by the executive com-

mittee in such way and for such purpose only as any general meeting of the said society may direct or appoint, and that the executive committee shall be bound and are hereby required annually to account to the society for all their acts, receipts, expenditure, and doings whatsoever, in the said office, and to make a report annually to the said society, at its general meeting, of the progress and state of the said society, and of its affairs generally

IX. And be it enacted that a general meeting of the said society shall be held once, that is to say, some time within the last ten days of the month of June, in each year, and as much oftener as may be directed by any Rule or Bye-Law of the said society.

X. And be it enacted, that the executive committee of the said society shall meet and assemble as often as there may be occasion, and any three members shall form a quorum.

BYE-LAWS

OF

The Alumni of King's College, Windsor.

PASSED AT A GENERAL MEETING HELD AT HALIFAX HOTEL, JUNE 27, 1848.

I. Besides the Annual General Meeting of the Incorporated Society, it shall be competent for the committee at any time, either of their own accord, or upon a requisition signed by at least ten of the members of the association, upon giving seven days notice in the public papers, to call a special general meeting of the association, specifying the purposes for which it is called, and in which meeting it shall be competent for the association to transact any such business as may be required. Ten members shall be deemed a quorum for the transaction of business.

II. That the books, accounts, and papers of the association shall be open at all times for the inspection of the members, and the secretary shall furnish an account of the affairs of the association whenever required by the committee.

III. That the treasurer and secretary, and such officers as shall be requisite for the incorporated society, shall be annually appointed by the Executive Committee.

IV. That at the annual meeting of the association, the president and vice-president shall alternately go out of office accompanied by the first three of the committee, and that all or any of them having a majority of votes shall be eligible to be re-elected.

V. That at any meeting, members not present may vote by proxy in writing, to be held by any other member; provided that no member shall be entitled to vote either personally or by proxy, whose dues are not all paid up for the preceding year.

VI. That the funds of the association will be appropriated for the payment of one or more professors or lecturers, and one or

more scholarships at the University of King's College, or one or more teachers or exhibitions in the Collegiate School at Windsor, to be denominated the Alumni professorships and scholarships, respectively.

VII. That the association will scrupulously apply such donations as may be made to them, to such specific objects in aid of King's College, as may be directed by the donors respectively.

VIII. That all meetings of the incorporated society shall be opened with prayer.

IX. (*Passed at general meeting of June 21st, 1849.*) That the elections for members of the incorporation shall be by ballot

RULES AND RESOLUTIONS

PASSED AT DIFFERENT TIMES, AND NOW ORDERED TO BE PUBLISHED.

THAT no resolution or proceeding inconsistent with or modifying any resolution or proceeding adopted by a general meeting be entertained by the executive committee in Halifax, except upon a month's notice to the committee being given by the person proposing the same, and that no such resolution or proceeding be carried into effect until the same shall have been confirmed by a general meeting to be summoned for the consideration thereof, *if necessary to be arranged before the annual general meeting.

That a corresponding committee of three residents in Windsor or its neighborhood, the chairman whereof shall be, if possible, a member of the executive committee, be appointed to meet on the second Wednesday in every month, and at such other times as may be expedient, upon summons of the chairman, to confer with the officers of the College or Collegiate School upon any subject to be submitted to them either by such officers, or by the executive committee in Halifax, in reference to the College or School, and to report thereon to the executive committee.

A month's notice shall be given of all resolutions affecting the rights of members, or creating new offices or salaries.

No individual shall be entitled to vote under a parochial certificate unless he be authorized by a parish meeting.

All annual general meetings of this association shall be holden at Windsor:

That the treasurer make up his annual account to the 30th of April in each and every year.

All undergraduates, resident at College, shall be competent to compete for the prize or certificate for modern languages.

At the annual meeting held at Windsor, June 29, 1856, Dr. King moved the resolution, notice of which was given at the last annual meeting by the Rev. Dr. Twining, in reference to the mode of election of Governors, viz.: that the present mode of voting for each individual separately and in alphabetical order be discontinued, and that the usual mode of putting all the names proposed on the

same ballot, out of whom those having the highest number shall be declared elected, should be adopted; which motion was seconded by Dr. Almon. After considerable discussion, Mr. A. M. Cochran moved in amendment that the following proviso be added: "Provided that no person shall be declared elected as Governor unless he have a majority of votes cast." The amendment was seconded by Nepean Clarke, Esq., and carried. The original resolution of Rev. Dr. Twining, as amended by Mr. Cochran's proviso, then passed.

At the general meeting, October, 17th, 1856, it was *resolved*, "That the right of voting by proxy be in no way interfered with."

The following resolution was passed at the general meeting, 24th June, 1857:

Resolved, That the ballot be not sent round for any officer of this association, or of the Board of Governors, whose name has not been previously proposed and seconded by some member of the association; and that the ballot be not taken until all the names of all persons intended to be proposed for any office be given.

At the annual meeting held at Windsor, June 27, 1860, the following resolution was proposed by Dr. Almon, seconded by Rev. Dr. Robertson, and passed:

Resolved, that a prize of £5 be given to the student passing the best examination for matriculation, in June next. The day of examination and other details to be settled by the President of the College.

At the annual meeting held June 25, 1862, this grant was discontinued from the want of funds.

At the same meeting the Rev. G. W. Hill moved the following resolution, which was seconded by Dr. Almon, and passed unanimously:

Resolved, that the Executive Committee of the Associate Alumni be empowered at their monthly meetings, during the interval between one annual general meeting and the next, to elect members of the Incorporation, provided that no black beans be cast against them.

Rev. Professor Hensley moved the following resolution:

Whereas, the funds of this association are pledged, and consequently no funds are left for providing the Alumni scholarship and the usual prizes.

Resolved, that honorary certificates be granted in the several departments instead of the prizes as heretofore. Which passed.

At the annual meeting held at Windsor, on Wednesday, 23rd June, 1865, the following resolution was proposed by A. M. Uniacke, Esq., D. C. L., and seconded by Col. Poyntz, and passed:

Resolved, That any member of this society whose annual subscription shall remain and be unpaid for three years shall cease to be a member of this society, and can only be admitted as a new member by being proposed and seconded and duly elected pursuant to the bye-laws.

At the annual meeting held at Windsor, on Wednesday, 23rd June, 1869, the following resolution was proposed by A. M. Uniacke, D. C. L., seconded by Dr. Almon, and passed:—

"That the Board of Governors be requested to furnish, previous to the annual general meeting of the Associated Alumni in each year, for their information, a copy of the Treasurer's account."

At the same meeting, Rev. Charles Bowman moved the following resolution, which was seconded by Frederick Allison, and passed:

"That all officers of the Associated Alumni shall have been members of the Association, for at least one year previous to their appointment."

MINERALOGY IN ITS APPLICATION TO MINING.

I.—CHEMISTRY AND PHYSICS.

- 1.—How would you determine the specific gravity of a body?
- 2.—I take a glass tube, bent in the shape of a horse shoe, and nearly fill it with a saturated solution of Sulphate of Potassium, colored blue with tincture of violets, in one leg I place the positive and in the other the negative electrode of a voltaic battery. What happens and why?
- 3.—The handle of a metallic corkscrew is connected with the positive pole of a battery, and the point with the negative. A bar of soft iron inside the screw becomes magnetized. How are its poles situated? How can its polarity be reversed?
- 4.—The Atomic weight of Nickel is 58.8 and of Silver 108. Equal weights of each metal being taken, which will give out the most heat in cooling from 100° C. to 0° C.?
- 5.—How many kinds of chemical action are there?
- 6.—How would you prepare chlorine gas. Explain the reaction that takes place by an equation.
- 7.—What takes place when Sulphide and Oxide of Lead are heated together, and how many pounds of Sulphide of Lead will 100 lbs. of Oxide of Lead decompose? (the atomic weight of Lead being 207—Oxygen 16—Sulphur 32.)
- 8.—I pass Sulphuretted Hydrogen through an acid aqueous solution of the following compounds: Nitrate of Copper, Arsenious Acid, Nitrate of Mercury, and Sulphate of Tin. I then take the precipitate and boil it with yellow Sulphide of Ammonium. What takes place?

- 9.—What is the difference between Crystallized, Crystalline, and Amorphous bodies? Give examples of these different modes of structure.
- 10.—What do you understand to be meant by the Physical properties of a mineral as opposed to the Chemical?
- 11.—How many systems of crystallization are there? Name them—In what systems do Galena and Calc Spar crystallize? Specify the most common form of Crystal for each mineral.
- 22.—What minerals are generally associated with Gold in the quartz leads of this country, and how would you distinguish between them?
- 13.—What is the difference chemically between Anthracite and Bituminous Coal, and on what does the evaporative power of coal mainly depend?
- 14.—What is Stellarite? Give its ultimate analysis, and state the effect of Oxygen on the value of a Coal into whose composition it enters.
- 15.—State the physical characters and composition of Magnetite, Specular iron ore, Pyrolusite and Galena?
- 16.—Give a brief outline of the process of amalgamation as conducted at the works of the Port Philip and Colonial Gold Mining Company in Australia.
- 17.—Describe the method commonly employed of measuring the current of air in a Mine.
- 18.—Explain the principles of the Safety Lamp. What proportion of air and fire damp forms an explosive mixture, and what are the products of the combustion?
- 19.—Name and explain the principal terms used in Mining.
- 20.—Explain the action of the furnace in ventilation, and state what other means are used for ventilating Mines.
- 21.—Sketch a method of working a Coal seam by slope from the crop, the seam having a considerable dip, and give the sizes and names of the different openings.
- 22.—Describe the usual methods of securing the sides of circular and rectangular shafts.
- 23.—If a fault is met with in working a seam of Coal, what guide have you as to the position of the Coal on the opposite side of the fault?
- 24.—Describe the characteristics of the classes of Coal most suitable for Gas, Steam and household purposes.

- 25.—In what rocks are the ores of Copper and Lead found?
- 26.—Describe the general position of the ores of Copper and Lead, and state what indications you would consider of a satisfactory character.
- 27.—Describe the treatment of the above named ores from their extraction in the mine to their marketable condition.

- 7.—What will be the distance from the apex to the commencement of a 3° curve, assuming the angle of intersection of two tangents to be 38° 45'?
- 8.—State the capacity, in gallons, of a tank 10½ feet diameter and 8½ feet deep.
- 9.—Describe a circle in a scalene triangle, and write down the solution.
- 10.—State the number of points into which the compass is divided in ordinary land surveying, and also in connection with nautical purposes.

6.—Write down the formula for measuring heights by means of the Aneroid Barometer.
