

Most Gracious Sovereign,

THEREAS it will add to the Security of Trade to prevent Preamble. And be it further enacted, That in cafe any fuch Ship or Veffel fhall fail or depart without Convoy, or fhall afterwards defert or wilfully feparate or depart from fuch Convoy, contrary to the Provisions of this Leave, the In. Act, every Policy of Infurance, or Contract or Agreement for any Infurance upon fuch Ship or Veffel, or upon any Goods, Wares, or Merchandize, laden or to be laden on board thereof, or upon any Property, Freight, or other Interest arising out of the fame, whereon Infurances may lawfully be made, (and which shall be the Property of the Master or other Perfon having the Charge or Command of fuch Ship or Veffel fo failing without Convoy, or wilfully quitting the fame, or of any Perfon interested in such Ship or Vessel, or Cargo, who shall have directed, or have been any way privy to, or inftrumental in, caufing fuch Ship or Veffel

Three or more of them, or the High Treasfurer for the Time being, are or is hereby authorized and empowered to issue and apply the fame accordingly.

XXXIX. And be it further enacted, That if any Action or Suit shall Limitation of Actions. be brought or commenced against any Person or Persons for any Thing done in pursuance of this Act, fuch Action or Suit shall be commenced within Three Calendar Months next after the Fact committed, and not afterwards, and shall be laid in the County or Place where the Cause of Complaint did arife, and not elsewhere; and the Defendant or Defend-General Issue. ants in every fuch Action or Suit may plead the General Issue, and give this Act, and the Special Matter in Evidence at any Trial to be had thereupon; and if the Jury shall find for the Defendant or Defendants in any fuch Action or Suit, or if the Plaintiff or Plaintiffs shall be nonfuited, or discontinue his, her, or their Action or Suit after the Defendant or Defendants shall have appeared, or if upon Demurrer Judgement shall be given against the Plaintiff or Plaintiffs, the Defendant or Defendants shall have Treble Costs, and have the like Remedy for the fame as any Treble Cofts. Defendant hath in any other Cafes to recover Cofts by Law.

Continuance of Act.

XL. And be it further enacted, That this Act shall be and continue in Force until the figning the Preliminary Articles of Peace, and no longer.
