This is, so far as we can remember, the first actual loss the Ontario Reform-ers have suffered since the general elec-tions of 1871. In all the other elections that have since taken place—and there have been a good many of them—the Ministerialists have not only held their own, but in several instances won con-stituencies from the Tories. This pro-cess has gone on until the Opposition in the Legislature has been reduced to a weak and insignificant faction—too weak, indeed, to be of any value to the Pro-vince whatever, for it has commanded respect neither for its numbers nor abili-ty. It was not to be expected that the current of victory would always run in the same direction; that whenever an election took place the Ministerialists, as a matter of course, would carry the day. We are not even certain that such a monotony of triumph would be good for either the Ministry or the Opposition, or for the Province at large. The Legislature.

The Legislature. The House of Assembly on Tues-day was engaged for some time in discussing the Assessment Amend-ment Act. A motion was made by Mr. Gibson to expunge the sub-sec-tion of the Assessment Act which has been held to allow a reduction of forty per cent. on the assess-ment by the County Council. The County Judges of Huron, York, El-gin, and Simcoe had all put this con-struction upon the law, and he held in justice that the Amendment he pro-posed should be adopted. Quite an animated debate followed, when the Attorney-General said it was, evi-dent that the construction which had been put upon the clause was not intended when the Act was framed. He would like to consider the mat-ter with the view of framing an amendment to suit the various sug-gestions made in the discussion, and the debate was accordingly ad-journed. When the Henouse went into Com-

urned. When the House went into Com-itiee of Supply, Mr Lauder repeat-l his old charges of extravagance, Id was ably answered by Mr. Mo-ellar. An acrimonious discussion illowed, after which some items are passed.

The Manufacturers in Council.

A very large and influential meet-ing of the manufacturers of the Pro-vince was held on Tuesday in To-ronto, to take steps for securing an increase of the tariff on articles manufactured in Canada, and for the promotion of the manufacturing in-terests of the Dominion generally. Mr. Wm. Barber, M.P.P., was ap-pointed chairman. After two or three gentlemen had spoken in fav-our of the movement, and the desir-ability of giving more protection to Canadian manufacturers, a series of those present on the subject were read and adopted. A committee was appointed, which in the evening gave in a report, specifying the tariff required on the following manufac-tures:--Woolen, cotton, iron and ma-chinery, room paper, railway cars, musical instruments, cabinet, coffin, and burial cases : leather andleather manufactures, floor cloth, gilt mould. ing, linseed oil, jute and jute twine, rope, tow, flax, hemp, cotton twine, as used in shops : manila rope, glass bottles, barytes, crude oil and its salts, dried paints, not otherwise pro-vided for ; copper works, brass found-ings, scales and weighing machines, billiard tables, silver and plated ware, clothes wringers, 25 per cent. of duty on each of the above. Paper, 25 per cent. duty, excepting printing paper used for daily and weekly newspapers, which is to remain at the present duty of 15 per cent.; sewing machines 20 per cent. duty if value clearly stated, but if not, 25 per cent ; carriage wheels, 30 per cent ; cargars, the duty to be increas-ed 50 per cent; window glass, 50 cent specific duty per box; steel manufactures, under Date's patent, a reduction of duty as stated in detail; sulphuric acid, one cent per pound; earth, oxides of iron paint, 20 per cent ; neady-made clothing, 10 per cent above the duty of raw material; hemlock bark, a duty of \$1.50 per cent. jugares to feined petroleum cil lighter than benzue, free. 




