CONSTITUTION.

I.—NAME.

This institution shall be called, "THE CONGREGATIONAL COLLEGE OF BRITISH NORTH AMERICA."

II.—OBJECT.

Its object is to educate ministers for the Congregational Churches of Canada, and the other Provinces of British North America.

III.—MANAGEMENT.

The ordinary affairs of the College shall be managed by a Treasurer, one or more Secretaries, and not less than ten nor more than fifteen other Directors (five to form a quorum), who shall hold office for one year, and be eligible for re-election.

IV.—ANNUAL MEETINGS.

A meeting of Subscribers to the funds of the College shall be held annually, for the reception of the report of the retiring Directors, the election of a new Board, and the transaction of other necessary business.

V.—BY-LAWS.

The proceedings of the Board of Directors shall be regulated by by-laws, which may be enacted, amended, or repealed at any annual meeting.

VI.—ALTERATIONS OF THE CONSTITUTION.

Alterations may be made in this Constitution by any annual meeting, provided that notice of such alterations has been given at the meeting next preceding.

BY-LAWS.

I.

The Annual Meeting of subscribers shall be held at the same time and place as that of the Congregational Union of Canada.

II.

Every candidate for admission into the College shall present to the Directors:—1. The testimony of the church of which he is a member, respecting his piety and apparent suitableness for the ministry.—2. A written statement of the grounds of his conviction that he is called to that work, and of his views of Christian doctrine and church government.—3. Evidence of sufficient literary acquirements, the *minimum* of which shall be a fair English education.

III.

Approved candidates shall be received for one session, at the close of which, if the results of their probation be satisfactory, they shall be admitted to the full course.

IV.

The course of study shall extend over five sessions of six months each; and shall include the usual branches of a liberal education, the Original Languages of the Scriptures, Biblical Literature, Theology, Church History, Homiletics, and Pastoral Duty. In exceptional cases, the Directors shall have power to admit students for a shorter term.

V.

Attendance upon the classes in the College, and the use of the Library, shall be without charge to the students. Aid may also be granted to them from its funds, to meet the expense of Board; the amount of such aid to be fixed at the beginning of each session.

VI.

As a part of their preparation for their future work, the students, under the sanction of the Directors, shall preach the Gospel, as they have opportunity.

VII.

At the close of every session, the students shall be examined upon the subjects of the year. The examinations shall be conducted in each department respectively, by two or more examiners to be chosen by the Directors; the whole to constitute a board for the general management of the examination, and the preparation of a report of its results. The examinations shall combine the written and oral methods, in such proportions as the examiners may determine. The compositions of the students during the year may also be called for. The length and difficulty of the examinations, in subjects taken by the whole class in common, shall be graduated according to the academical standing of the several students. The report of the board of examiners shall deal, except in special cases, only with the general results of their labors; but they may, when they see fit, make a further confidential statement to the Directors.

VIII.

In reference to matters not provided for in the foregoing by-laws, the Directors may act according to their discretion; subject always to the approval of the subscribers at any regular meeting.

PROCEEDINGS AT THE ANNUAL MEETING.

The Annual Meeting of Subscribers to this Institution was held in the Congregational Church, at Hamilton, on Friday, 13th June, 1862, at half-past ten in the forenoon.

The proceedings were opened by prayer by Rev. D. McCallum.

J. L. Goodhue, Esq., was called to the chair, and Mr. W. W. Smith appointed Secretary for the meeting.

Rev. F. H. Marling, Secretary of the College, read the Twenty-third Annual Report.

It was moved by Rev. W. Clarke, seconded by W. R. Hibbard, Esq.,

I.—That the Report now read be adopted and printed; and that the documents appended thereto be referred to a committee, who shall report to an adjourned meeting of the subscribers to be held on Monday, 16th instant, at 11 A.M.—Carried.

(Remarks were made by the mover and seconder, and by Revs. F. H. Marling, J. Elliot, E. Ebbs, Jos. Hooper and W. F. Clarke, when, on the question being put to the meeting, the resolution was carried.)

IV.—That this meeting, under the present circumstances of special interest, renews the request made, and so generally complied with, in former years, that the second Sabbath in October be observed as a day of special prayer on behalf of the College; and would earnestly impress upon each of the churches the duty of liberal contribution to its funds, for which that season offers such a suitable opportunity.—Carried.

Rev. F. H. Marling made a verbal report on behalf of the Committee on the University question appointed last year. As it appeared the Committee had not yet been convened, he moved, and Rev. J. McKillican seconded—That Rev. A. Burpee convene that Committee, and that the Committee be requested to report to the adjourned meeting of subscribers on Monday.—Carried.

On motion made and seconded, the meeting adjourned to Monday, 16th June, 1862, at 11 A.M.

Rev. W. F. Clarke presented the Report of the Sub-Committee.

Rev. F. H. Marling moved, and Rev. E. Barker, seconded—That the Report now read be received.—Carried.

The Report is as follows :

“The College Committee report—That the course of study in our College shall extend over three years, and shall be exclusively theological ; comprehending the original languages of the Scriptures, Biblical Literature, Theology, Church History, Homiletics and Pastoral Duty.

“That, as a general rule, graduation at one of our Provincial Colleges, or an equivalent literary status, be required in order to admission to our College ; but that the Board of Directors, in special cases, shall have power to suspend the general rule.

“Your Committee would also recommend that the Board, before receiving any young man, shall require from him a written agreement, that should he, after his studies are completed, return to a secular calling, or leave the Province within the period of five years without the explicit consent of the College Board, he shall faithfully repay the moneys which he received for fees and support during the whole term of his studies, or such proportion thereof as the Board may deem right.”

After the presentation of the Report a discussion took place as to the changes contemplated in the Report, (in which Rev. Messrs. Fenwick, Clarke, Pearl, Allworth, Frink, Ebbs and Dr. Lillie took part, following each other in the order named,) when, at a quarter past one, Rev. W. F. Clarke moved, and Rev. F. H. Marling seconded—That the meeting do now adjourn till half-past two P.M. ; which being declared carried, Rev. J. T. Byrne closed the meeting by prayer.

MONDAY AFTERNOON, 2.45 P.M.

The Chairman of the forenoon meeting resumed the chair.

For the information of the meeting the Report presented in the forenoon was again read.

(After some remarks by Rev. Jos. Hooper and Rev. W. F. Clarke) Rev. K. M. Fenwick moved, and W. R. Hibbard seconded,

"That the Report now accepted be handed over to the College Board, with the request that they give the subject all due consideration, and report to the subscribers at their annual meeting next year; and further, that said Board have full power to make temporary provision for the vacancy caused by the resignation of Dr. Wickson."—Carried.

Rev. A. Burpee presented a report from the Committee on the University question; on the acceptance of which some discussion was had in reference to the plan understood to have been lately proposed, namely, to affiliate the denominational Colleges with the University, and to grant increased endowments to the former: whereupon it was moved by Rev. W. F. Clarke, seconded by Rev. F. H. Marling—

"That this meeting renews its earnest protest against the appropriation of University or other Government funds to any College not strictly founded on the non-denominational basis; that it hereby instructs the Chairman and Secretary to transmit, in its name, a petition to the Legislature and Governor-in-Council, against all such appropriations; and that the Board of Directors be requested to watch public movements on the University question, with power to act as they may deem requisite."—Carried.

The minutes were then read, and being slightly amended, were confirmed as amended; and the meeting adjourned.

TWENTY-THIRD ANNUAL REPORT

OF THE

CONGREGATIONAL COLLEGE

OF

BRITISH NORTH AMERICA.

The Board of Directors have much pleasure in rendering to the constituency of the Congregational College the following account of its affairs for the academic year 1861-2. Referring first to their own body, the Board have to lament that shortly after the last Annual Meeting they were deprived, by death, of the services of Peter Freeland, Esq., a long-tried and liberal friend of the institution.

In the last Report it was stated, that at the time of the Annual Meeting for 1861, it was uncertain how many of the students who had completed the term of four years, for which they were admitted, would return for the fifth session which has since been added to the course. Of the five gentlemen thus referred to, four felt it their duty to engage at once in ministerial labour, Mr. R. Burchill having become the Missionary of the Canada Indian Missionary Society; Mr. Robert Brown having accepted a call to the Pastorate of the Churches in Garafraxa and Erin, and Mr. John Brown that of the Church in Eramosa; while Mr. John R. Kean is labouring at Cornwallis, Nova Scotia. Mr. G. Strassenburgh, therefore, alone returned for the fifth year. A special course was arranged for him, including attendance on some classes in University College.

At the beginning of the new session a communication was received from Mr. B. W. Day, stating that the condition of his health continued such as to unfit him for the sedentary life of a student, and asking the consent of the Board to his withdrawal from the College. To this request the Directors felt constrained to accede, though deeply regretting, with the writer, that he was unable to complete

his preparation for the ministry. They have since learned, with much pleasure, that in the active duties of a thoroughly Missionary sphere, at Blue Vale and neighbourhood, Mr. Day's health has much improved.

Two applications for admission were favourably received at the re-opening of the College; that of Mr. Thomas Sanderson, recommended by the Church in Albion, and that of Mr. Richard T. Thomas, to whom the First Church, Toronto, bore its testimony. The former gentleman, however, in a few days after his admission, was taken ill, and ere long informed the Board that he was professionally advised that he would be physically unequal to a life of study, and therefore, reluctantly, sought permission to retire. Such an application could not be declined. We trust, however, that the Master has still a work for our brother to do, though in a private sphere.

The above are all the circumstances which have occurred during the year to affect the composition of the class for the past session. It has accordingly been made up as follows:—

Although the number here given shows a serious reduction from that of the list published in our last report, which contained fourteen names, it must be remembered that of those only twelve were in attendance, while, but for the case of unexpected illness already mentioned, the present class would have consisted of ten members.

The second Sabbath in October having been once more observed by our constituents as a Day of Special Prayer for the College, to an extent and in a spirit most cheering to us, the session was opened on the following Wednesday, 16th. The service, on this occasion, was held in Zion Chapel, the Rev. T. S. Ellerby presiding. The principal address was delivered by Rev. T. M. Reikie, who set forth

chiefly the necessity, on the part of the future minister, of acquiring a thorough and experimental knowledge of that Word of God which it would be the business of his life to teach.

The Rev. Dr. Lillie gives the following report of the studies pursued in his department:—

DR. LILLIE'S REPORT.

During the session recently closed, there were delivered in my department seventy-four lectures; to wit, twenty-five in Theology, twenty-five in Ecclesiastical History, including History of Doctrine, and twenty-four in Biblical Criticism and Interpretation: the customary exercises in Plan-making, Essay-writing, and the composition and delivery of Sermons being at the same time carried on.

Speaking generally, I have been gratified by the application and progress of the young brethren. Their conduct, in so far as it has come under my notice, has been correct and exemplary. Personally, I feel indebted to them for the courtesy with which they have on all occasions treated me.

Of Mr. Thomas, the junior student, it affords me pleasure to report in the most favourable terms, and to recommend his full reception.

The brethren Duff, Sanderson, Smith, and Strasenburg, who have just completed their course, carry with them my respect and confidence, with my best wishes for their usefulness and happiness; as did also the brethren who left last year (Messrs. Brown and Burchill), to whom no reference was made at the time, because of the possibility of their return for another session.

I cannot allow my respected colleague, Dr. Wickson, to retire from the position which he has so long held, with such honor to himself and advantage to the Institute, without expressing my high appreciation of his character, his scholarship, and his zeal and kindness in the performance of his duties; my grateful remembrance of his invariable urbanity to myself, and the confidence and harmony (perfect from the beginning to the end) with which it has been our happiness to work together; with the affectionate interest which I feel and shall ever feel in him and his, and all that may affect his welfare or theirs, temporal or spiritual. It is, and will be my prayer, that the Master whom it has so long been his joy to serve, may grant him full restoration to health, guide all his steps, and honor and gratify him with a usefulness surpassing even his best hopes and aspirations!

In Dr. Wickson's department, the following subjects were taken up:—In Classical Greek, *Medea*; *Iliad*, I.; in New Testament, Greek, *Hebrews*, x. to xiii.; in Latin, *Aeneid*, II.; in English, *Paradise Lost*, V.; in Hebrew, portions of *Genesis*, the *Psalms*, and *Isaiah*. Some other branches, such as have been specified in former Reports, were also embraced in this department, but its work was seriously interrupted by the failure of Dr. Wickson's health in the middle of the session.

The Examinations for the present year were conducted by the Rev. Messrs. Porter, Ebbs, and W. F. Clarke. The following is their Report:—

In Theology, Church History, and Biblical Criticism, eight manuscripts, prepared by the students of the fourth and junior years, were examined, consisting of replies to the Professor's written questions, proportioned in number to the standing of the classes; thus,—five questions in each department being given to the first year's class; six to that of the second; seven to the third, and eight to the fourth. The one student of the fifth year was not thus examined, having already passed an examination upon the same course in his first year.

In Theology the replies differed considerably in degree of fullness and satisfactoriness. While, in general, somewhat below the mark, two or three entire manuscripts came quite up to it, and in the other papers an answer, now and again, indicated vigorous thought.

The written answers to questions in Church History were, on the whole, very good, and displayed considerable familiarity with the facts, dates and philosophy of the Ecclesiastical events embraced in the period under review.

Of the papers in the department of Biblical Criticism, two were, in the judgment of the Examiners, especially good. Four others were creditably written. The remaining two were not satisfactory. In one, if not in both of these cases, the writer, it is understood, had been the subject of certain inevitable disadvantages.

The *vidæ voce* Classical Examination was, we regret to say, attended by a minority only of the students; but those who took part in it acquitted themselves creditably, considering the drawbacks to which they have been subjected by the prolonged illness of their Tutor, Prof. Wickson, and some other circumstances which need not be here specified.

The Exercises in the Greek and Hebrew Scriptures were for the most part satisfactory, and the examination of one of the third year students in the Hebrew especially so.

The *vidæ voce* examination of the whole class, in Theology and Church History, while developing somewhat more fully the readiness of some of its members already referred to with special commendations, did not materially affect the relative standing of the parties as above indicated.

Six Essays were submitted to examination upon the subject of the "Divine Decrees." One struck the Examiners as "very good." Four they consider "good." The sixth they regard as "fair."

Six students handed in Plans of Sermons, which were of nearly the same degree of fullness. One they characterise as "inferior;" two as "fair;" one as "very good," and one as "superior."

Mr. Strasenburgh, having now completed the full term of study in the College, will soon, we trust, be settled in a suitable sphere of labour. Mr. Duff has received a call from the Church in Meaford, and is not likely to return for the additional year. Mr. Sanderson is about to proceed to Florenceville, N. B. We are not in a position to speak as definitely in regard to Mr. Smith.

Allusion has already been made to the fact, that the Classical

Tutor of the College was laid aside from his duties for a part of the session in consequence of ill health. This is the third time that Dr. Wickson has been overpowered by the accumulation of labour required of him by the classes in University College as well as our own. In a communication received from him in March last, he informed the Board that his medical adviser had warned him that "he would seriously endanger his constitution if he again attempted equally laborious engagements," and that he must therefore "retire from the position he had long sustained in the College." The following resolution was adopted by the Board in reference to this communication:

Resolved,—That the Board have received with deep regret the intimation of the Rev. Dr. Wickson, that the state of his health forbids his continuing his connection with the College; that they very highly appreciate the earnest and self-denying spirit in which he has devoted himself to his duties for so many years; and that, while they have no alternative but to accept the resignation thus tendered, they must ever feel the most lively interest in Dr. Wickson's future career, and pray that, his health being fully restored, he may realise his heart's desire in many years of useful labour in his Master's cause.

In these sentiments, the Directors feel assured that their constituents will cordially concur, for during his connection with the College, as student and as tutor, now extending to fifteen years, the distinguished scholarship and the truly Christian spirit of Dr. Wickson have gained for him universal respect and confidence.

In view of the vacancy thus created, the Board have felt called upon to review the entire subject of arrangement of the course of study pursued in the College, and the means of conducting it. The plan which they recommend to the subscribers is described in the document appended to this report.

Should the proposed changes be adopted at the annual meeting, it will be needful to alter the By-Laws so as to correspond therewith. These alterations are also indicated in the Appendix.

An application was received, at our last meeting, from our laborious and devoted Professor, for an increase of his salary. The Directors, however, did not feel at liberty to dispose of so important a question at once, and on the eve of their retirement from office. It therefore remains to be acted on hereafter.

In accordance with the plan suggested in the last Report, and approved by the subscribers, the Treasurer's accounts for the past

year were closed punctually on the 31st May, and, having been audited by Messrs. Robinson and Copp—the latter having been called in by the former in the absence of his appointed colleague, Mr. Ross—are now presented in due form. The receipts and disbursements thus reported are those of eleven months only, practically, even of less, for several contributions received after June 30th were acknowledged in the last account. The total amount received from the churches this year is but \$745, against \$1,341 in 1860-'61. The difference—nearly \$600—is larger than can be properly accounted for by the contraction of the financial year. We earnestly hope that the Report of 1862-'63 will exhibit a return to the former standard of liberality, and an advance upon it. The Treasurer's statement shows an apparent balance in hand of \$76, but this is owing to the non-payment within the eleven months of the last quarter's salaries of the tutors, due on the 30th instant. The actual expenditure of the year has been \$2,174; add proportion of salaries for two months of the last quarter, viz., \$267; total, \$2,441; and deduct the receipts, \$2,351; a balance will then remain *against* the College of \$190. This calculation exhibits our real financial position at the present time, and proves the necessity of increased exertion to add to our resources. We hope that ere long *every* Church will be found contributing as regularly to this cause as to the Home Mission.

With these statements closes the record of the proceedings of the College for the past year. The retiring Directors earnestly commend it to the watchful care, the willing generosity, the wise counsels, and the effectual prayers of the body to whom it belongs. Above all do they invoke upon it the blessing and the guidance of Him who alone can give true "pastors and teachers."

APPENDIX.

A.

REPORT OF COMMITTEE ON VACANCY IN CLASSICAL TUTORSHIP.

The Sub-Committee, appointed at a late meeting of the Board, have agreed to recommend the following propositions:—

1. That the College Course be divided into two years for Literary studies, and three years for Theology.
 2. That there be no appointment of a Classical Tutor, but that the students pursue their literary, historical, and scientific studies (including Hebrew) at University College, according to a programme arranged by the Board.
- The Sub-Committee would recommend to the Board such a course as has been suggested by Dr. Lillie.*
3. That the Fees for attendance at the classes of University College be supplied from the College funds.
 4. That Applicants for admission to the College be prepared (as a general rule), in addition to the present requirements, to give satisfactory proof of an ability to read the 1st Book of Cæsar, or some easy Latin author, and also the Gospel of John in Greek.
 5. That Candidates otherwise deemed eligible for admission to the College, but unable to meet the demands specified in the preceding recommendation, be provided by the College with assistance, for the purpose of pursuing a course of preparatory study. Also, that the same facilities be rendered to such students as the Board have admitted to the College course, but who may still require the aid of a private Tutor.
 6. That Students of the first and second years be required, in common with the Theological Students, to prepare plans of Sermons, and to take part in the reading and exposition of the Greek Testament, and in such other exercises as the Board may direct.
 7. The Candidates who are graduates of any University, or who otherwise can satisfy the Board of their being possessed of sufficient acquirements, may be admitted at once to the Theological course.

* *First Year*—The pass subjects in Classics, Mathematics, English Language and Literature, and Natural History.

Second Year—The pass subjects in Classics, Logic, English Language, and Literature and Geology.

Third and Fourth Years—Hebrew, (in addition to Theological branches.)

Fifth Year—English Language and Literature, do. do.

8. That Students who have entered upon their Theological course, may, in special cases, with the approval of the Board, continue to attend classes at University College.
9. That Students, both in their Literary and Theological course, be required to attend exclusively to the studies approved by the Board.

B.

BY-LAWS, AS PROPOSED TO BE AMENDED.

- I.—As at present. See pages 3 and 4.
- II.—Erase “the *minimum* of.” Add, at the close,—“and, as a general rule, ability to read Cæsar (*De Bello Gallico, I.*), or some other easy Latin author, and the Gospel of John in Greek. Candidates otherwise deemed eligible, but unable to meet this last demand, may be assisted from the College funds in a preparatory course of study.”
- III.—As at present.
- IV.—Insert “full” before course of study. Erase all that follows “Pastoral Duty,” and add,—“The first two sessions shall be devoted to Literary, and the last three to Theological studies. Graduates of any University, and other candidates who satisfy the Board of their being possessed of sufficient acquisitions, may be admitted at once to the Theological course.”
- V.—“During the Literary course, the students shall attend classes in University College, according to a programme arranged by the Board; and, when needful, shall receive other more elementary tuition. They shall also, in common with the Theological students, prepare plans of Sermons, and take part in the study of the Greek Testament, and such other exercises as the Board may direct. They will be under the general supervision of the Theological Professor during the Literary as well as the Theological course.”
- VI.—“Students in Theology shall receive instruction in Hebrew at University College. In special cases, with the approval of the Board, they may continue to attend classes there in other departments.”
- VII.—“During their Literary and their Theological course, students shall be required to attend exclusively to the studies approved by the Board.”
- VIII.—As V. in present list, adding, after “College,”—“and elsewhere as prescribed.”
- IX.—As VI. in present list.
- X.—As VII. in present list.
- XI.—As VIII. in present list.
