# ACREEMENT FOR DISPENSING WITH CONSULAR VISAS ON BILLS OF HEALTH

The under-mentioned Governments desiring, in accordance with the spirit rticle do rementioned Governments desiring, in accordance with the spirit of article 49 (4) and of article 57 of the International Sanitary Convention, signed at Dec.
