EXPLANATORY NOTE

The following document consists of the Table of Contents **only** of the CIIPS "Core Bibliography on Nuclear Weapons, Arms Control and Disarmament," covering the period 1945-1983. The actual text of the Core Bibliography is not being published, but is available in print form in the Institute's Library, and will soon be available in the Library's computerized data-base as well. Readers are invited to submit requests for photocopies of particular portions of the Core Bibliography, specifying particular categories and page numbers as found in the enclosed Table of Contents.

The Table of Contents itself is preceded by a "Summary" (pp. 3-7) laying out the broad framework of the Core Bibliography. It is intended to serve as a guide to the more detailed, comprehensive Table of Contents beginning on page 9, which includes the actual page numbers of the Core Bibliography's print version.

INTRODUCTION

Surprisingly, given the unquestioned utility of bibliographies for students, researchers, and the general public alike, the immense popularity of the issue, and the tremendous outpouring of literature on the subject over the past decade, no truly comprehensive, English-language bibliography on nuclear weapons and arms control has been published since the mid-1970s.

The present Bibliography began as a project of mine at the Centre for Foreign Policy Studies, Dalhousie University, in the early 1980s. I was attempting to prepare up-to-date, supplementary reading lists for my students in a senior undergraduate/graduate seminar on "Nuclear Weapons and Arms Control" in the Department of Political Science. I soon discovered that existing bibliographies were wholly inadequate to the task, either of providing sufficient background references for specialist student use or as an aid to serious research in the field.

The best such volume available -- published by Richard Dean Burns in 1977 under the title *Arms Control and Disarmament: A Bibliography* -- incorporated material only up to about mid-1976.¹ Other standard bibliographic sources tended to be too broad in their scope, and hence overly selective in items dealing with nuclear weapons and arms control; poorly categorized, usually in terms so broad as to render them difficult to use for quick reference; poorly indexed; inconsistent in coverage and categorization; or non-cumulated. The Burns bibliography did an excellent job of covering the English-language literature from the dawn of the atomic age (and even before, in the case of pre-1945 efforts at arms control) to about 1976. By the early 1980s, however, given the vast increase in the growth of literature on these topics, there was a clear need to bring the subject up to date.

This Bibliography was originally intended to be published by the Centre for Foreign Policy Studies at Dalhousie. Unfortunately, its scale became too large for the Centre to handle. When I moved to Ottawa to join the Canadian Centre for Arms Control and Disarmament (CCACD), I took the Bibliography (in the form of over 30,000 hand-written index-cards) with me. Under the CCACD's auspices, and with the assistance of a generous grant from the Gladys and Merrill Muttart Foundation of Edmonton, the data were transformed into a proof-read, word-processed manuscript of some 2,200 pages. However, insufficient funds were available to actually publish and distribute the Bibliography.

The CCACD had received support from the Canadian Institute for International Peace and Security (CIIPS) for the production of annual updates of what had by now become known as the "Core Bibliography." The first update, covering the years 1984-1986, was compiled by Christina Homonylo (now Buczek). Together with the "Core Bibliography," it is now in the process of being integrated into the CIIPS Library database, for on-line searching.

The second update, for the year 1987, was compiled by Jutta Paczulla. Being compact and timely, it was chosen as the first published product of the Bibliography project. At the same time, in order to increase the availability of the "Core Bibliography," we are now circulating copies of its Table of Contents, and offering to provide photocopies of specific sections of the manuscript on demand.

¹ The first volume of a new series edited by Dr. Burns, *Arms Control, Disarmament and International Security, 1987: An Annual Bibliography*, appeared in 1988. However, its scope is much broader than the present Bibliography, while its coverage of the subjects included hereunder is much less comprehensive.

As suggested above, the main purpose of the project was to compile as comprehensive a bibliography as possible, with the detailed categorization necessary to make it readily accessible to the student, teacher, or researcher. There are, of course, some limitations. First, the coverage under some of the individual categories -- i.e., those dealing with the more general aspects of world armaments -- is only illustrative, and not meant to be comprehensive. True comprehensiveness was sought only in regard to all aspects of nuclear weapons, and all aspects of arms control and disarmament. Second, the Bibliography does not include newspaper articles, unpublished conference papers and the like. It is limited to books; articles -- in both popular, mass-market periodicals as well as more scholarly and technical journals; monographs; government publications; and theses.

Within these limits, we have attempted to be as comprehensive as possible, although -- given the nature of the compilation process, which depended to a large extent on periodical and thesis indexes -- the coverage of books, monographs, and government publications is less satisfactory than that of articles and theses. Among those books included, however, edited volumes have been broken down chapter-by-chapter, providing a degree of author and subject differentiation not often found in published indexes or bibliographies.

The present "Core Bibliography" covers the period from 1945 to 1983. However, given the existence of the earlier Burns volume which served as its inspiration, emphasis has been placed on the periodical literature between 1976 and 1983. A third update, for the years 1988 and 1989, is currently in preparation. Comments and proposed additions to the Bibliography are welcome; we intend to add titles missed from earlier years to future updates.

As befits an undertaking of this magnitude, there are many individuals I would like to thank wholeheartedly for their encouragement, sponsorship, and/or direct involvement in the project. During the Centre for Foreign Policy Studies stage, the Bibliography benefitted from the support of successive Directors Gilbert Winham and Robert Boardman, and from the research assistance of Baljinder Dhillon, Denis Dummer, Hugh Dyer, Tonne Orvik, and Sandra Shechter. At the CCACD, Executive Director John Lamb, Research Director Lawrence Hagen, and Board Member Joanna Miller were supportive from the very beginning, while staff members Debra David, Bernard Grebenc, Jan Glyde, Ann Parkes, and George Wolf all played a role. Theresa Venedam carried out the massive job of transforming the data from hand-written index cards to word-processed manuscript, with remarkably good humour. Christina Homonylo and Kornel Buczek contributed greatly to the development of the Bibliography during both the CCACD and CIIPS stages. At CIIPS, the support of Executive Director Geoffrey Pearson and Chief Executive Officer Bernard Wood, Research Directors David Cox and Roger Hill, and Information Services Directors Leslie Wake and Katherine Laundry is gratefully acknowledged. Consultants Jane Beaumont and Anne Barkworth, inputters Jacqui and Michael Bloom, the staff of the Institute's Research, Information Services, and Public Programmes divisions, and in particular Sylvain-Mario Lemieux and Jutta Paczulla, have been instrumental in pushing the project through to fruition. Finally, I would like to thank James Finan, Charles Gellner, William Kincade, and Lawrence Weiler for their endorsements of the project at a critical stage. My greatest debt of gratitude, however, is owed to my long-suffering wife Celia, who has tolerated my obsession with this Bibliography from its earliest days at Dalhousie.
