CONSTITUTION
— OF THE —
MACDONALD CLUB

*As Amended and Adopted at a Meeting
held 13th Feb., 1891.*

NAME.

1. This Association shall be called the "MACDONALD CLUB."

OBJECTS.

2. The objects of the Club shall be to encourage and promote the principles of Liberal-Conservatism among young men, to afford opportunities for social intercourse, to further the interests of the Conservative party, and assist at the election of Conservative candidates at all parliamentary elections.

MEMBERS.

3. All young men desirous of being identified with the Liberal-Conservative party of Canada may become ordinary members of the Club on signing the roll of membership.

4. The Motto of the Club shall be the watchword of the Conservative Chieftain after whom the Club is named :—"By the Party, with the Party, for the Country."

5. The Colours of the Club shall be Navy Blue.

THE EXECUTIVE.

7. The Executive of the Club shall consist of a Patron, two Honorary Presidents, a President, two Vice-Presidents, a Secretary, a Treasurer, and a Chairman for each ward in the city.

ELECTION OF OFFICERS.

7. (a) The election of the Executive shall take place at the annual meeting.

(b) In cases where more than one candidate is nominated for any office the choice shall be determined by ballot.

(c) The Executive of the Club shall retain office until their successors are elected.

(d) All vacancies which occur during the year in the Executive shall be filled within two weeks after such vacancy occurs by a two thirds vote of the Executive Committee.

8. Each Ward Chairman shall as soon as convenient after the annual meeting in each year, call a meeting of the members of the Club in his Ward, for the purpose (among others that may be stated in the notice convening the meeting) of electing a committee to assist him in the duties of his office.

9. It shall be the duty of each Ward Chairman

(a) To see that in his division all Conservatives entitled to vote are on the Voters' List, and to appeal against all names of opponents improperly placed thereon.

(b) To secure as large a membership of the Club as possible.

(c) To see that his ward is thoroughly can-

vassed and the party vote entirely polled at each election.

(*d*) To report from time to time the result of his work to the President.

MEETINGS.

10. (*a*) The annual meeting of the Club shall be held in the month of January in each year, or on such date as shall be appointed by the Executive Committee.

(*b*) Special meetings of the Club may be convened by the President, or upon requisition of five members shall be convened by the President or Secretary, and five days' notice specifying the object of such meeting, shall be given in one or more of the newspapers of the city.

(*c*) Meetings of the Executive shall be held whenever deemed necessary by the President, or any three members of the Executive—notice of which shall be given to all members by the Secretary.

(*d*) At the annual meeting of the Club fifteen members shall constitute a quorum; at all ordi

nary or special meetings ten shall constitute a quorum ; and at meetings of the Executive five members thereof shall constitute a quorum for the transaction of all business.

11. The Secretary shall keep a record of the proceedings of the Club, shall have the custody of its books and papers, and shall be ex-officio member of all Committees. He shall, also, keep in the register of the Club a list of all members, with their addresses.

12. It shall be the duty of the Treasurer to receive all moneys belonging to the Club ; to keep a written account of all receipts and expenditure ; to pay the accounts of the Club on the order of the President or one of the Vice-Presidents, and to present a duly audited report of the finances of the Club at the regular annual meeting.

13. This Constitution may be amended by a vote of the majority of the members present at any meeting, provided that not less than two weeks' notice in writing be given to the Secre-

tary of the intention to amend and the nature of the amendment, and one week's notice be given to the Club. Any clause of this Constitution may be suspended at any meeting of the Club upon a unanimous vote of all members present at such meeting.
