ACTS AND PROCEEDINGS

OF THE

Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, Session XX., held at Kingston, July 11, 1849.

DIET I.

The which day, after sermon by the Rev. John Barclay, A. M., Minister of St. Andrew's Church, Toronto, Moderator of the Synod for the preceding year, from Acts xi. 26, "The disciples were called Christians first in Antioch," the Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, met, according to appointment, and was constituted with prayer by the Moderator.

Presbytery Rolls having been given in, the Synod Roll was made up and read over.

The Synod then proceeded to the election of a Moderator for the ensuing year, when the Rev. James C. Muir, Minister of Georgetown, was unanimously elected, and, at the Synod's desire, took the Chair.

The Synod next proceeded to the election of three Trustees for Queen's College, at Kingston, in room of the Rev. Hugh Urquhart, A. M., the Rev. George Romanes, A. M., and the Rev. John Barclay, A. M., who retire from Office at this time, according to the terms of the Royal Charter of Queen's College, when the Rev. Hugh Urquhart, A. M., the Rev. George Romanes, A. M., and the Rev. The Synod appointed a Committee of Bills and Overtures, with instructions to meet to-morrow morning at nine o'clock,—and all papers to come before the Synod were ordered to be given in to the said Committee,—and it was agreed that all the members of Synod, now present, may take part in the deliberations of the Committee.

It was agreed that an hour should be spent in devotional exercises each morning during the sitting of the Synod;—that the hour of adjournment in the afternoon shall be Five o'clock;—and that there shall be an intermission between One and Two.

The Synod adjourned until Eleven o'clock to-morrow morning, and was closed with prayer.

It was reported to the Synod, on behalf of the late Moderator, that the reception of the Synod's Address to the Queen, of last year, by the Secretary of State for the Colonies, and its having been laid before Her Majesty, had been duly acknowledged,—as well as the signification of the great satisfaction with which Her Majesty had received their Address.

The Synod appointed the following Committee to draft Addresses to Her Majesty the Queen, and His Excellency the Governor General, viz : Mr. Barclay, Dr. Mathieson, Mr. McGill, Mr. Urquhart, Mr. Spence, Mr. J. Malcolm Smith, Dr. Machar, Mr. Malloch, Mr. Thomson, and Mr. Masson.—Dr. Machar to be Convener.

Leave was granted to Presbyteries to meet in Kingston, for all competent business, during the sitting of the Synod, at such hours as the Synod may not be met.

The Synod appointed Mr. Barclay, Mr. Bain, Mr. George Bell, Mr. McMorine, and Mr. Thomson, as a Committee to attend to the Financial concerns of the Synod, in conjunction with the Treasurer; and the Synod instructed Presbytery Clerks and others to pay over to the Treasurer all monies colleted by them for the Synod Fund, and directed all accounts against the Synod to be given in.

The Synod called for the Records of Presbyteries, which were produced; when the Synod appointed the following Committees to revise the same, and report on them, viz: -Mr. McLaurin and Mr. McMorine to revise the Records of the Presbytery of Hamilton; -Mr. Ferguson and Mr. Purkis to revise the Records of the Presbytery of Bathurst; -Mr. McPherson and Mr. Haig to revise the Records of the Presbytery of Kingston; -Mr. Bain and Mr. Williamson to revise the Records of the Presbytery of Toronto; -Mr. Urquhart and Mr. W. Bell, Senr. to revise the Records of the Presbytery of Montreal; -Mr. J. Malcolm Smith and Mr. George Bell to revise the Records of the Presbytery of Glengary.

The Synod made the following appointments for the public services of the Sabbath, viz.: Mr. Spence to preach in St. Andrew's Church, in the forenoon; Mr. J. Malcolm Smith, in the afternoon; and Mr. Haig in the evening :--Mr. McLaurin and Mr. Ferguson to preach at two stations on Wolfe Island, in Gaelic and English.

There was laid before the Synod a statement from the Clergy Reserve Commissioners, in regard to the state of the Fund, and the Synod, having examined the same, expressed their fullest satisfaction therewith. It was also stated to the Synod, by certain of the Commissioners present, 7

and directed to be put on record, that the Commissioners give in to the Provincial Government annually a detailed statement of the expenditure, which, it is believed, is published.

There was laid before the Synod the draft of an address to the members of the Church on Parental responsibility, prepared in accordance with the instructions of last Synod, and now approved of by the Commission of Synod. The same was ordered to be printed and circulated throughout the Church.

The Synod proceeded to the election of three Trustees for the management of the Ministers' Widows' and Orphans' Fund, in room of the Rev. Walter Roach, William Edmonstone, Esq., and Hugh E. Montgomerie, Esq., who retire from office at this time, in conformity with the provisions of the Act of Incorporation, when the said Rev. Walter Roach, William Edmonstone, Esq., and Hugh E. Montgomerie, Esq., were unanimously re-elected, and their names directed to be placed at the head of the list of ministers and laymen respectively.

The Synod next proceeded to the election of two Clergy Reserve Commissioners, in room of the Rev. Dr. Mathieson and the Rev. Hugh Urquhart, who retire from office at this time, according to the Regulations adopted at last meeting of Synod, when the said Rev. Dr. Mathieson and the Rev. Hugh Urquhart were unanimously re-elected, and their names directed to be placed at the foot of the list of Commissioners.

The Synod called for the Report of the Committee appointed to carry on the French mission in Canada East, which was given in, including.— 1. A Report from the Committee appointed to take the spiritual superintendence of the mission.—2. A Report from the Committee in charge of the Financial affairs of the mission, showing in detail the receipts and expenditure for the past year.—And 3. A detailed Report of the operations of the missionaries from Mr. Lapelletrie. The same having been read and fully considered, the following deliverance was agreed to :—

The Synod receive and approve the Reports anent the French Mission, which have been given in and read, and present their thanks to the members of both Committees for the diligence, faithfulness and zeal, with which they have managed the affairs of the mission; and the disinterested manner in which they have devoted their time, their labour, and their attention to the promotion of its interests. And the Synod instruct the Committee to print so much of the Report as they may deem useful for the information of congregations, and circulate the same as

soon as possible. The Synod, further, reappoint the members of the Presbytery of Montreal as a Committee (Rev. William Simpson, Convener,) to attend to the Spiritual superintendence of the Mission, and direct the operations of the Missionaries. And they request the gentlemen, to whom was entrusted the management of the financial affairs of the Mission last year, viz : Hugh Allan, Hew Ramsay, John Greenshields, and Hugh E. Montgomerie, Esquires, again to take charge of the same ; and instruct both Committees to report to the Synod at next meeting. And while the Synod have reason to rejoice that many Ministers and Congregations have, by an increased liberality, responded to the Synod's injunctions of last year, they regret to find that some have entirely disregarded these injunctions and made no collection at all; while others have shown, by the trifling sums which they have contributed, that no interest has been exerted on bohalf of the Missionary operations of the Church. The Synod do, therefore, enjoin the Ministers of Congregations who are in arrears to make collections in aid of the French Mission Fund without delay, and transmit the same to the Committee. And the Synod, being deeply impressed with the duty incumbent on them to carry on the interesting and important work of advancing the cause of Christ among the French population of Lower Canada, and being resolved, with a humble dependence upon the Divine blessing, to prosecute the same, do strictly enjoin all Ministers to bring the claims of this Mission before their Congregations, advocate the same, and allow the Christian people an opportunity to contribute to the support of the Mission on a convenient Sabbath, but not later than the first Sabbath of May. They further enjoin Ministers to promote the increase of the Funds by obtaining subscriptions and donations from the members of their flocks. And Presbyteries are enjoined to deal with such Ministers and Congregations as neglect this order of the Synod. And lastly, the Synod instruct the Convener of the Committee to apply to the Colonial Committee of the General Assembly respectfully requesting a continuance of their grant to the French Mission.

The Synod then called for the Report of the Board of Managers of the Ministers' Widows and Orphans' Fund, which was given in, read, and approved. The thanks of the Synod were given to the Board for the wisdom, zeal, and diligence, with which they have managed the affairs of this Institution during the past year. The Clerk was instructed to print and circulate the Report for the information of the Church. And, further, with the view of carrying out more efficiently the highly important object of this Institution, the Synod approved the following minute, and enjoined the same to be read from the pulpit, with such enforcement as Ministers may deem necessary, in all the Congregations, on the

Sabbath previous to that appointed for the annual collection in behalf of the Fund, namely the first Sabbath in January :

In the actual condition of the Church in Canada, little more can be expected even from the more prosperous and wealthy Congregations, than a bare support for the Minister and his family, without any power on his part of making any provision for them, if, in the Providence of God, his wife should be left a widow, and his children fatherless. To meet such cases, which must be expected to occur among the ministry with the average frequency, it is held and declared to be a duty incumbent on the people among whom a Minister labours, receiving nothing more from them than an immediate temporal support, to co-operate with the design of this Board for providing some relief for the bereaved families of such Pastors as have consecrated their whole time and talents to the spiritual edification of the people committed to their charge. This duty of Congregations may be deemed the more incumbent, inasmuch as the Synod have enacted that every Minister shall contribute out of his public allowance the sum of Three Pounds annually, diminishing by that amount his very limited income. The Synod would, therefore, exhort Congregations also to come forward freely to present their liberal contributions for the same object, not only as a token of regard for their own Pastor, but as an expression of their gratitude to their Divine Lord, who has ordained that they who serve at the altar should live of the things of the altar. Christians have always been wont to honour those who have in any way endured self-denying labours for the sake of Christianity; and it is worthy of a Christian Church to do this by making the Fund for the relief of the Widows and Orphans of their Ministers the monument of their gratitude and dutiful remembrance.

While this claim on the liberality of the people is held to rest on the clearest principles of Christian obligation, it is deemed to be of peculiar force in this country where so much difficulty is experienced in obtaining a suitable supply of Ministers for the Church, on account of the inadequacy of the temporal support that is attainable. This evil, which in present circumstances it may be impossible materially to alleviate, would in some degree be counteracted, if Ministers had any sure prospect that the Church would manifest a benevolent concern for their families after their decease.

The Synod, therefore, with these principles declared, and with the statements contained in the Report before them, indicating the want of a proper sense of duty in this particular on the part of many of the Congregations, enjoin upon Presbyteries to take order that all Ministers and Sessions do use diligence that every Congregation may be brought to

The same

Whereas the prosperity and efficiency of a Church as an Institution for carrying forward the work of Christ in the world, depends, with the Blessing of God, in a great measure, on the high literary and Theological attainments, and devoted piety of her Ministers :- And whereas it is the duty of those who have rule to take especial care that no one shall be admitted into the sacred office of the Ministry, but after the most faithful and searching examination into their ministerial gifts and qualifications :- And whereas it is desirable and necessary to the carrying into effective operation the Act of Synod anent the reception of Ministers, Licentiates, and Students of Divinity from other Churches, not in connection with this Church, that more full provision be made in regard to the conducting of the examinations required by the said Act, the Synod hereby resolve that a Committee of Synod be formed, whose

duty it shall be to examine thoroughly and strictly such candidates as shall be recommended to them by any Presbytery under the jurisdiction of the Synod, on Literature, Philosophy, Exegetical and Systematic Theology, and Hebrew, and, if satisfied, shall, in good faith to the Church and to the applicant himself, certify the same.

This Examining Committee shall be appointed annually, on the second day of the annual meeting of Synod, and shall consist of not less than two members from each Presbytery. Seven members shall be a quorum; and the Moderator of the Synod for the time being shall be the Convener of the Committee.

The Committee shall meet during the meeting of Synod or immediately after its rising; and if it shall be found necessary to hold any other meetings, on account of any applications that may be addressed to the Convener, and which require to be disposed of without delay, the Convener may appoint a meeting to be held at such time and place as shall appear most convenient for the majority of the members, and if possible at the same time and place as the then next meeting of the Synod's Commission is to be held,—notice of which shall be given by Circular to all the members of the Committee in time sufficient to allow them to attend, and stating the object of their meeting.

All Students of Divinity, Probationers, or Ministers from Churches not in connection with the Presbyterian Church of Canada, in connection with the Church of Scotland, desirous of joining this Church, shall, first, place their certificates of character and of Literary and Theological Curriculum on the Table of the Presbytery of the bounds within which they reside, who shall examine the same, and decern,—and, if sustained, shall transmit the same, with their deliverance thereon, to the Synod at its next meeting or to the Examining Committee who are authorized to receive and act on the same. The applicant shall then compear before the Examining Committee and undergo a thorough examination on the several branches of education required by this Church.

The subjects of examination shall be as follows :--

And Presbyteries are enjoined, notwithstanding the appointment of this Synodical Committee of Examination, to take special care that there be no relaxation in the trials of Candidates for the Holy Ministry, but to remember that some of the most important interests of the Church are involved in the faithful discharge of their duty in this matter.

The which Day, the Synod of the Presbyterian Church of Canada, in connection with the Church of Scotland, met according to adjournment, and was constituted with prayer.

On the call of the Moderator, the Rev. Thomas Scott conducted the devotional exercises of the Synod in praise, reading the Scriptures, and prayer.

The Minutes were read and sustained.

The Synod had transmitted to them, by their Committee of Bills and Overtures, an Extract Minute of the Presbytery of Toronto in regard to an application from the Congregation of Brock, Reach, and Mariposa, in the Presbytery of Toronto, to the Colonial Committee of the General Assembly for aid in completing their new Church, sanctioning the application, and stating that the Title Deed of the Property had been laid before the Presbytery and found perfectly satisfactory, and that the Congregation had adopted the Model Constitution prepared by the Synod as their Constitution. It was also stated that their resources being exhausted, unless they could obtain at least £20, the work would have to be discontinued. The Rev. Dr. Mathieson intimated to the Synod that the Commissioners of the Clergy Reserves Fund had been informed by the Government that they could not give the Commissioners more than Six Hundred Pounds in money on account of the monies due from last year, but offered debentures at Three years for the difference,--and thereupon it was resolved, that the Synod is of opinion that the Commissioners should accept payment for last year's dues as proposed by the Government, and that the Commissioners should in like manner accept payment in debentures on future occasions in the event of their deeming it prudent

There was brought before the Synod an application on behalf of the Presbytery of Glengary for leave to take Mr. William A. Ross, Student of Divinity of Queen's College, on trials for license. The Draft of the Form of Procedure in the calling and settling of Ministers was again remitted to the Presbytery of Montreal, as a Committee of the Synod, with instructions to perfect the same as far as practicable in accordance with the opinions of the several Presbyteries sent into them, and report to next Synod.

The Synod had transmitted to them, by their Committee of Bills and Overtures, the Draft of an Act anent regulating the public Collections in the several Congregations, and having maturely considered the same and made several amendments thereon, adopted it as an Interim Act, and transmitted it to Presbyteries that their opinions thereon may be sent up to next meeting of Synod. The same is as follows :--- "Whereas great inconvenience has resulted from the irregular manner in which many Congregations have contributed to the several Funds for carrying on the Missionary and other operations of the Church ;--and whereas it is desirable that a more uniform and regular mode of raising the said Funds should be observed throughout the Church,-the Synod enact that all Ministers of this Church shall annually have collections made in their several Congregations on behalf of each of the following objects at the time specified, viz :-- 1. For the Ministers' Widows' and Orphans' Fund, on the First Sabbath of January .-- 2. For the French Mission, on the First Sabbath of May .- 3. For the Synod Fund, on the First Sabbath in July .-- 4. For the Home Mission Fund, of the Presbytery of the Bounds, on the First Sabbath of October .- Provided always that when the celebration of the Sacrament of the Lord's Supper happens to fall on any of the said Sabbaths, or any of the said Sabbaths is otherwise deemed unsuitable or inconvenient for making the collection, then the collection shall be made within at least four weeks thereafter ;and provided also that in case of any Congregation preferring to raise the contributions required of them in any other way, as by subscriptions and donations, or to furnish them out of any fund under their control, they shall be at liberty to do so .- The Synod also enjoin Ministers to explain and advocate the object for which the collection is to be made, upon a previous Sabbath. And the Synod, also, enjoin Presbyteries, at their meetings next after the times specified, to enquire and take account of how Ministers have attended to the injunctions of the Synod in giving their Congregations an opportunity to contribute, and to deal with those who have disobeyed unless a sufficient reason be given."

Unto the Queen's Most Excellent Majesty.

MAY IT PLEASE YOUR MAJESTY :---

We, the Ministers and Elders of the Presbyterian Church of Canada, in connection with the Church of Scotland, desire, at this time, to renew the expression of our steadfast and unabated loyalty and attachment to Your Majesty's Royal Person, and of our unaltered love of the principles of that happy Constitution under which we and our fellow-subjects throughout the extended territories of Britain, have enjoyed so many blessings.

We have not been indifferent spectators of those eventful times in which we are fallen; and we rejoice, that while almost every country in Europe is convulsed by sanguinary revolutions, and suffering all the miseries of intestine strife, the British Throne remains unshaken, and the Sovereign who occupies it not less distinguished for the exemplary discharge of all the duties of private life than for her princely virtues, holds the highest place in the veneration and affection of her people. In these things we recognize the Providence of Him who has the hearts of all men in His hands, and we love to trace in them an evidence of how long He is disposed to bear with a nation in which, while there is much to provoke His righteous displeasure, we believe there are many righteous persons, whose cry is ascending to Him day and night, that He would not deal with us as we have sinned, but in wrath remember mercy.

Distinguished as this Colony has ever been for its loyalty and its reverence for constituted authority, it has been matter of the deepest concern to us to witness the progress of that spirit of dissatisfaction which has recently manifested itself among a very large portion of the most enlightened of its people, and has in some instances burst forth in a manner which has occasioned sorrow and humiliation in the bosoms of all good men. Our prayers continually ascend to that God who sitteth on the floods, and who can say to those agitations which affiict us,-"Be still!" that He would be graciously pleased to continue to grant us peace; and we assure Your Majesty that nothing shall be awanting on our part that can tend to allay the exasperation which has been excited in the midst of us, and to promote the continuance of the connection which has been so long and so happily maintained with the Parent State, while we shall persevere in pressing upon our people those sacred truths, the reception of which constitute the only real foundation of a nation's stability and improvement. When we look at our sins as a nation,-the drunkenness, the publicly countenanced Sabbath-breaking, and the daring impiety which abounds, we acknowledge how justly an offended God might afflict us with wounds that could not be healed; but we shall not cease to cling to the hope that He will yet in mercy spare us, and that by His blessing upon the Imperial counsels, some healing measure may be devised which shall again restore harmony and peace throughout all our borders.

We can solemnly say that as a Church Court, we have ever carefully refrained from intermeddling with party politics, and we are sure that in adverting, at this eventful crisis in our history, to the views we entertain on the subject of Public Education, we shall not be regarded as departing from the course which we have prescribed for ourselves. .

These views are in conformity with those which have been so long held and so successfully carried out in our native land. We believe that the stability of government, the peace of the community, the supremacy of the laws, the harmony of neighbourhoods, all that regards man's welfare in time as well as his happiness in eternity, have their only sure basis in the instruction of the people in the truths of the Bible; and, holding these views, it is impossible for us adequately to express our grief and disappointment at the attempts that are made to sever religion from the public instruction. We refer especially to the University measure carried through the late Session of the Provincial Parliament, and now become law, which, though the University was endowed by one of Your Majesty's Royal predecessors, expressly for the education of the youth of these Provinces in the Christian Religion, as well as in Literature and Science, does yet so thoroughly exclude Christanity, that there is no security, that the men to whom shall be confided the high work of informing and training the minds of our youth shall be men who even believe in the only true God and Jesus Christ, whom He hath sent. As a Christian Church, we should be betraying the cause we are bound to uphold, did we not draw Your Majesty's attention to this disastrous measure, and if we did not express our earnest hope, that since it so cirectly contravenes the intentions of the enlightened Founder, while it is regarded with dissatisfaction by all the great religious bodies of the country, means may yet be taken, by Your Majesty's gracious direction, to amend the provisions of the statute, and so to avert from us and our posterity a calamity so great as its permanent adoption must inevitably bring upon us, if it be true that "them that honour God he will honour, while they that despise Him shall be lightly esteemed."

That Almighty God may long preserve Your Majesty to rule over us; -that He may guide all your counsels, and establish your Throne in righteousness ;--that He may abundantly bless all the members of your Illustrious Family;—and, that after a happy reign upon earth, He may exalt you to an unfading Crown in the Heavens, is our fervent and

embrace this opportunity of again expressing our regard for your Excellency, and through you, as the Representative of our Gracious Queen, our loyalty and attachment to her person, and our unabated admiration to the British Constitution.

As Ministers of Religion, as well as loyal subjects of the Queen, and earnestly desirous of the prosperity and advancement of this portion of her Empire, we have observed the spirit of the times with deep interest, and we have offered up daily prayer to the Supreme Disposer of all things, that he may over-rule every event for our good.

In the discharge of those duties which properly belong to us, as Ministers and Elders of a Christian Church, we endeavour to inculcate upon our people those sacred truths which by the grace of God are fitted to exert the happiest influence upon their character and conduct. We have enforced, according to the grace given to us, those moral principles which have been revealed to direct us in the conduct of life, and which constitute the best foundation for national improvement and happiness. We are earnest in declaring that the Divine favour is the source of prosperity both to individuals and nations; and that we cannot escape those righteous judgments which are sont for the punishment of National sins, if in any way we dishonour Him "by whom Kings reign and Princes decree justice."

To the dissemination of truth,—the practice of religious daties,—the religious discipline of families,—the advancement of a Scriptural education among the youth of our charge,—our attention has been sedulously directed. These are the best and surest means of leading ultimately to a sound and healthy state of feeling in the community at large, and of disposing men to a calm and enlightened discussion of public questions. Such a disposition it is our sacred duty to inculcate and promote, and in so far as our efforts, and those of our fellow labourers in the same cause, are attended with success, those unhappy disturbances which sometimes afflict society, as well as the causes from which they spring, will disappear.

The views entertained by us on the subject of education,—that which it is the duty and the wisest policy of the State to provide for the people,—are in conformity with those held and so successfully carried into practice in our native land. The foundation of public education must be laid in the Bible; for the formation of the religious character demands the chief care, not only for the eternal salvation of the individual, but for the temporal order and well being of society.

We are filled with regret and disappointment in observing the almost total exclusion of the religious element from the public education of Canada, both in our Common Schools, and more strikingly in the recent act for the Amendment of the Charter of King's College,—the only Collegiate Institution in the Province endowed at the public charge. If, as has been pleaded, the total exclusion of the religious element became necessary because of the impossibility of reconciling the different branches of the Christian Church existing among us upon any Catholic basis, we regret the result all the more on account of the alleged necessity, and we declare to your Excellency our belief that]

And this Commission is to continue until the next meeting of Synod; and members are required to attend the diets of the said Commission :- And for the better securing a full attendance of members on the Commission, the Synod prohibit any of the Presbyteries from meeting on any of the days or weeks appointed for the meeting of this Commission ; and such members of the Presbytery within whose bounds the Commission meets, as are on the Commission, are required, all of them, to attend,-and other Presbyteries are to take care that at least two of their members. who are named on the Commission, shall attend.

The Minutes were read over.

The Synod appointed their next meeting to be held in St. Andrew's Church, in the City of Toronte, on the First Wednesday in July, 1850, at Seven o'clock, P. M.

The Moderator then addressed the Synod ;-when, after prayer and singing, the Synod was closed with the Apostolical Benediction.

APPENDIX.

ACT ANENT THE COURSE OF STUDY FOR THE HOLY MINISTRY.

(Omitted at the top of Page 17.)

Whereas it is expedient, that the course of Study to be henceforth pursued by those who look forward to the office of the Holy Ministry in the Presbyterian Church of Canada, in connection with the Church of Scotland, should be more definitely prescribed than it has heretofore been : It is hereby enacted, by the Synod of the aforesaid Church, that the literary and scientific Course of Study shall embrace four sessions' attendance on the classes of Queen's College; each session to consist of six months; the classes to be attended in the following order:-

1st year, Junior Latin, Greek and Mathematics.

2nd year, Senior Latin, Greek and Mathematics.

3rd year, Third Latin, Greek and Third Mathematics, and Natural

4th year, Logic, Rhetoric, and Moral Philosophy.

And it is also enacted, that the Theological Course shall consist of three sessions of six months each, the subjects of study to be arranged as the Professors of the Faculty of Theology shall see fit; always pro-

viding that the study of the Hebrew language shall form a part of the business of each session, unless in cases where a dispensation may be obtained from the Synod or the Senatus; and providing also, that all the discourses and exercises prescribed by the rules of the Church of Scotland, shall be delivered by each Student during his Theological

And it is also enacted, that before a young man enters on his literary course, he shall come before the Presbytery in whose bounds he resides, or before such a Committee as they may appoint, and after due examination, shall receive a certificate of his being of good moral and religious character, and also of his proficiency in the ordinary branches of education, and in those subjects which are required by the rules of Queen's College, as qualifications for matriculation; such certificate to be presented by him when he applies for admission.

And it is also enacted, that if any young man shall have gone through a part of his literary or theological course at any College or University, and produce certificates thereof, the same shall be held and accounted as part of his course of study as prescribed by this Act; providing always that his progress, when examined, either by a Presbytery, or a Committee of Synod, or the Senatus of Queen's College, shall be found to be such as to entitle him to assume the standing which he may
