

Several letters from Grand Officers of this G. L. were read, ex pressing regret at their unavoidable absence.

M. were deposited, and the usual solemn masonic funeral ceremony was performed, after which Grand Lodge, under the direction of the Grand Director of Ceremonies, was formed into procession and being joined by a great number of the Craft and many citizens, and following the body proceeded to the Dorchester Street Methodist Church, where the religious services were performed.

Afterwards the procession of Masons was re-formed and proceeded to Mount Royal Cemetery, where, the concluding Masonic Funeral ceremony having been performed under the directions of M. W. • the G. M. and M. W. Bro. A. A. Stevenson, P.G. M., the members of Grand Lodge returned to Masonic Hall, and the following business was there transacted.

The M. W. the Grand Master addressed Grand Lodge as follows :

Officers and Brethren :--It is peculiarly due to you that I should commend you for the alacrity with which you have obeyed the summons to attend this emergent communication of the Grand Lodge, to attend the funeral of our late M. W. Bro, Bernard whose mortal remains you have just now accompanied to their last resting place, with masonic honors befitting his exalted rank in the Craft.

Our late M.W. Brother was devotedly attached to our Order; and more especially in connection with the organization and upbuilding of the Grand Lodge of Canada of which he was elected Deputy Grand Master, his zeal was most remarkable and his labors most abundant, for all which he was most suitably rewarded by having conferred upon him by that Grand Body, the honorary rank of Past Grand Master.

It was our fortune to differ from him very considerably, in regard to the formation of the Grand Lodge of Quebec, but as he, with others who shared his opinions, had fully accepted and recognised our Grand Body as an accomplished fact,—it had long since become our duty and our priyilege to overlook and treat as by-gones, all past differences; and when death summoned him hence, " to cast around his foibles whatever they may " have been, the broad mantle of a mason's charity and cheerfully to " render to his memory the praise to which his virtues," and his unusual abilities displayed in so many departments of a long and active public life, " have entitled him." " His meritorious actions, it is our duty to imitate, and from his " weakness we ought to derive instruction."

I am sure that you all will heartily join with me in expressing our deep sympathy for the bereaved wife and children in their sad affliction, and unite in the prayer that an All-wise Providence may sanctify it to their preset and everlasting welfare.

My Brethren, I need hardly, in closing, admonish you that by the death of our late Brother, we are all forcibly reminded of our own inevitable destiny, and that it behoves us all to improve our brief remaining period of our existence here, that we may be duly and truly prepared when summoned heres to be welcome into the Grand Lodge above, where the Great Architect of the Universe for ever presides. Fo mote it be.

The address was listened to with the utmest attention, and ordered to be entered upon the minutes.

The Grand Sceretary read the minutes, and the Grand Chaplain having effered a closing prayer, Grand Ledge was closed in ample form at alout 6 p.m., and the brethren departed in peace and harmony.

#### The Board of General Purposes presented the following Report:

On the applications to this Grand Lodge by Mrs. Galer and her daughter for assistance to the extent of Fifty dollars, and by Bro. Wm. Elder for Twenty-five dollars, both recommended by B. W. Bros. O'Halloran and Pickle. After careful investigation into the circumstances of each case, the Board cannot recommend the granting of either sum without obtaining fuller particulars as to the necessities of the applicants.

#### The motion was unanimously carried.

The Grand Secretary then presented his report, as follows :

#### To the M. W. the Grand Master, Grand Officers and Brethren of the Grand Lodge of Quebec:

In making this my report I have to observe that as nothing of unusual interest or importance has transpired during the past year in immediate connection with the duties of my office, I have only to lay before you the following information :

I have received since the last annual communication, on account of Grand Lodge, the sum of two thousand three hundred and thirty-eight dollars and fifty cents (\$2,338.50), all of which has been paid to the Grand Treasurer, as per his receipts given for same.

Further sums to a considerable amount have been handed to me since 23rd September instant, the date of closing the books of Grand Lodge, and this in persistency of the reprehensible practice of paying dues after the time fixed by the Constitution.

I have issued from this office during the last twelve months four dispensations for the establishment of new lodges, viz.: for Hochelaga Lodge at Hochelaga, Bedford Lodge at Bedford, Montarville Lodge at Longneuil and St. Francis Lodge at Sorel; and, pursuant to instructions given at the last annual communication I have written to the late W. M. of Clarke Lodge, now defunct, demanding that the warrant and property be surrendered to Grand Lodge. Up to the present it has not been transmitted.

In view of the importance of the subject, and that the same may be more readily understood, I have caused to be printed and circulated in Grand Lodge the whole of the correspondence had between this Grand Lodge and the Grand Lodge of England in reference to the question of recognition by the Grand Lodge of England of the Grand Lodge of Quebec.

A new edition of the Book of Constitution has been issued by R. W. Bro. Alex. Murray, the publisher, under my superintendence, and there is now no reason why any lodge should be without it.

I respectfully ask from Grand Lodge a vote of sufficient money to enable me to cause to be properly bound the printed proceedings of sister Grand Lodges, which are now fast accumulating in this office.

The issue of Grand Lodge certificates has been heretofore from time to time considerably delayed by reason of the difficulty of at all times obtaining proper parchament; I have, however, made such arrangements as will, I trust, in the future remove all delays.

It is with devout thankfulness to the Great Architect of the Universe that, as your chief executive officer, I am again privileged to meet you in this our annual assembly, to render an account of my stewardship; to preside over your important deliberations, and to aid you in drafting your designs on the trestle-board, for the guidance of the craftsmen during the coming year. May our labors thus begun in order, be conducted in peace and closed in harmany.

The year just closed has, in general, been one of peace, harmony and prosperity within our borders and throughout the Masonic world. The workmen in our temples have, with commendable zeal and fidelity, devoted themselves to their allotted tasks, so that their overseers have had but little of which to complain and much to praise; and thus we trust it may always be, so that peace may ever be within our walls and prosperity within our palaces, and that at last each one, having finished his labors, may receive the welcome plaudit from the Great Master Workman, "Well done, good and faithful servant, enter thou into the joy of thy Lord."

#### AT REST.

You are already aware of the death of M. W. Brother Aldis Bernard and his burial with due respect under the anspices of Grand Lodge, and of the death of R. W. Bro. George Thompson, of Quebec, one of the best of men and most scalous masons within our jurisdiction. I have now to communicate to you the sad intelligence of the death of our illustrious and R.W. Brother A. T. de Oliveria, 33°, of the city of Rio Janerio, Grand Representative of this Grand Lodge ever the Grand Lodge of Brazil; and also the death of our zealous and talented R. W. missed and long lamented in their respective jurisdictions.' I have also to report the early death of our able and promising W. Bro. J. B. Colson, LL.D., of the city of Quebec. In token of our sorrow on account of the decease of these and other Brethern, I propose that this Lodge Room be draped in mourning during the present communication.

#### GRAND REPRESENTATIVES.

I have appointed R. W. Bro. Joseph P. Hornor of New Orleans, as Grand Representative, at the Grand Lodge of Louisiana, in the place of our late R. W. Bro. J. B. Scot, and R. W. Bro. McKelvie, near the Grand Lodge of Prince Edward Island, and V. W. Bro. David A. Manson, of Mansonville, has been duly commissioned as Representative of that Grand Lodge near the Grand Lodge of Quebec, which appointments will doubtless be acceptable to this Grand Body.

#### NEW LODGES.

I have also to report that I have granted Dispensations for the establishment for the four following new Lodges, viz.: Bedford Lodge, at Bedford; Hochelaga Lodge, at Hochelaga; Montarville Lodge, at Longueuil; and Richelieu Lodge at Sorel, and I trust their affairs will be found in such a satisfactory condition that Grand Lodgé will be pleased to grant to them Warrants of Constitution.

#### GRAND LODGE LIBRARY. &C.

I beg to submit also for the consideration and action of Grand Lodgethe important subject of making a beginning of a Grand Lodge Library. Doubtless the B. O. G. P. will submit a report to Grand Lodge on the matter, as also anent recompensing Bro. Smithers for his arduous labors in preparing the Report on Foreign Correspondence, which I trust will be found eminently satisfactory to Grand Lodge, and I would also request the Board to consider and report on the recommendation of the Grand Master submitted last year anent the subdivision of the large District of Montreal, I trust also that the Committee on re-numbering the Lodges will be prepared with their report during the present asson.

#### PHYSICAL QUALIFICATIONS OF CANDIDATES.

In view of the cases which not infrequently occur, of candidates otherwise well qualified, but having some physical defect, and as to whose acceptance doubts arise, it seems necessary to remind the brethren that no person should be initiated into Freemasonry who has any maim or defect of body, which would render him incapable of learning the art, of serving his master's lord, and of being made a brother, and in due time a fellow craft, and a Master Mason.

All doubtful cases of applicants should be referred by the Master to the District Deputy, who should carefully inquire into, and if practicable personally, make examination of the case, and fully report the same to the Grand Master, who will then render a decision thereon.

#### MASONIC HISTORY.

The recent publication of the History of Masonry in the Maritime Provinces of the Dominion should remind us of the duty to which I have heretofore called the attention of the Grand Lodge, namely, the preparation for the publication of the interesting history of the craft in the Province of Quebec. I beg to advise the Grand Lodge to appoint a permanent committee

for the collection and preparation of material, for such a history, and I would request that each private lodge will forthwith do the same thing, and that reports from each be submitted at the next annual communication of Grand Lodge. Let not this important matter be longer delayed.

#### LODGE INCOMES AND OUTLAYS.

It seems particularly necessary that I should call the especial attention of the representatives of lodges, in Grand Lodge assembled, to the very important subjects of lodge incomes and expenditures. All funds of the lodge should safely and profitably be invested or deposited in savings or other banks by the proper officers as frequently as even a small amount is on hand; and a semi-annual or annual official report of the same be made to the lodge; and monies should be drawn from its funds only as needed for the relief of urgent distress, except after due consideration by the lodge or by its officers, as prescribed by the by-laws. I fear that some lodges are to oremiss in regard to this important matter. It appears to me also that some lodges need admonition in regard to their various expenditures. Over frequent, after-labor refreshment ought not to be indulged in at the expense of the lodge, perhaps not offerer than quarterly, and should then be governed by a rigid but generous economy, and the strictest regard for the best possible promotion of social intercourse. I fear also that some lodges are too form of mere display in fitting up their lodge-rooms, and are somevitimes actuated by a desire to emulate or outdo their older and perhaps wealthier neighbors, while something less expensive would be amply sufficient, and would leave more funds for the great purpose of true benevolence and the more abundant relief of our brethren or their widows or orphans in distress. My brethren' think of these things.

#### MASONIC MAGAZINE.

It is deeply to be regretted, that the excellent Masonic magazine, the News, started and ably conducted by our Rev. Bro. Myets, should have died but one year old, of that fell destroyer of Masonic journals, want of adequate support; and our good brother could hardly be expected to continue it at a loss, or distribute it gratituitously for the benefit of the Craft.

It appears very desirable that there should be some Masonic paper published within our own juriediction. We could not as yet expect tomaintain a magazine equal to the "*Crafteman*,' in Ontario, but could not a small "Quarterly" be published at a very reasonable price and wholly devoted to information of what is transpiring at home and abroad in the Masonic world, and the brief presentation and discussion of matters of special importance to the Craft? Perhaps some satisfactory arrangement may be made with the Grand Secretary, aided by the Chairman of the Committee on Foreign Correspondence, to issue such as the recognized organ of the Grand Lodge. I would suggest the advisability of appointing a committee to consider the matter.

#### DISPENSATIONS, ETC.

It is exceedingly important that officers of Lodges should bear in mind the inadvisability of asking for Dispensations to Pass and Raise Masons in less time than that prescribed by the Constitution, except in most ugentcases. Every Apprentice should faithfully serve his allotted time, in order that he may be fully instructed, and no Worshipful Master should on any account omit the lectures and charges in the several degrees; and I have reason to fear that the spirit of "office sbeking" is unfortunately manifest-

ing itself on the part of some who have not the requisite qualifications for the high and responsible duties of Masters of Lodges and rulers in the Craft. It is generally better by far for lodges to elect old and efficient officers than to elect those not well qualified, as it will too often happen that over-ambitious and ill-qualified candidates for office will, after election, fail to prepare themselves to perform their important duties as they ought, and most of the labors of the lodge will have to be performed by past officers. This should not be; and I must admonish you effectually to suppress the reprehensible and unmasonic practice sometimes occurring of "canvassing" for office. Nothing is farther from the spirit and principles of Freemasonry, or more subversive of the best interests of the Craft, than "canvassing" for office personally or through others either in private lodges or in Grand Lodge. It ought to be an impassible barrier to advancement in office among Freemasons. The great principles of our Order, and the laws laid down in our ancient constitutions in regard to these things are so well known and understood, especially by the older and more experienced brethren, that there is need only of calling your attention to them in order that they may be fully realized and faithfully practiced by the Craft.

#### THE DISTRICT DEPUTIES.

The requirements of the constitution and the interest of the craft demand at least one annual official visit to each lodge from the District Deputy, for the purpose of counsel, instruction and inspection. To perform these duties satisfactorily, requires, in most of the rural districts, a very considerable amount of time and outlay of money, and therefore, in the absence of any constitutional regulation, it seems in most instances to be asking too much of these officers to necessitate their bearing the whole of the expense of these official visits, and I beg to advise each lodge to pay to the Deputy, the actual expense of at least one official visit made per year.

In this way these worthy officers will be materially aided and encouraged in the discharge of their important duties.

#### GRAND LODGE SOVEREIGNTY.

The exclusive sovereignty of each Grand Lodge within its own territory must be maintained. It is the foundation and copestone of our Grand Lodge existence and the principal source of our unity, harmony and prosperity. The irregular interference of certain European Grand Orients or assemblages, in certain jurisdictions on this continent, the establishment of a clandestine lodge by one of these in the city of London, England, and the intermeddling of officious innovators with the "body" and established "ordeer" of Freemasonry, under the pretended guise of reform and progress, deserve and should receive the severest condemnation.

#### ENGLAND AND SCOTLAND.

In accordance with a resolution passed at the last annual communication of Grand Lodge, I appointed a committee consisting of R. W. Brothers O'Halloran, Stearns, Copeland, Tait and Isaacson, to confer with delegates (if appointed) from the Lodges, four in number, in the city of Montreal, still continuing in allegiance to the Grand Lodges of England and Scotland. I exceedingly regret to report that no conference has been held, chiefly on account of the non-co-operation of said private Lodges. It did not appear to me that the resolution referred to as passed at last session in restricting the action of the Grand Master in the matter to one particular course of action, was well calculated to facilitate the consummation so

earnestly desired by many leading members of the craft in England, Scotland and Quebec.

I cannot, for many obvious and important reasons, recommend the acceptance by Grand Lodge of the conditional recognition prefered by the Grand Lodge of England.

The present, however, seems to me to be an auspicious time for the final adjustment of our relations with these mother Grand Lodges and their excellent daughter lodges, here, and thus secure that perfect unity within our Grand Lodge juriadiction without which complete harmony and the highest welfare of the craft cannot be fully secured.

#### THE GRAND LODGE OF MISSOURI.

I beg to inform Grand Lodge that there/has been received by me a very kind, fraternal letter fram R W. Bro. Ged. Frank Gouley, Gr. Sec. of the Grand Lodge of Missouri, enclosing s' commission from G. M. of that Grand Body to me, as the Grand Representative of the Grand Lodge of Missouri near the Grand Lodge of Quebec, and also an admirably prepared copy of their proceedings for 1875, and a copy of their constitution, &c., for all which I desire to return especial thanks; and although I had declined while in the office of Grand Master to accept the Representativeship of many of the leading Grand Lodges of the world, which had been kindly tendered me by the Grand Masters of their respective Grand Bodies, preferring to honor others by recommending them for such appointments instead of retaining so many of such honors and privileges for myself, yet I confess that from past considerations, well understood by most of you, it would have pleased me to have made an exception in the case of Missouri, could I have consistently done so. Yet under the circumstances I deemed it my duty to decline the profierred honor, nor can I recommend this Grand Lodge to accept the recognition 'tendered her by the said Grand Lodge.

Whereas, The Grand Lodge of Quebec has been recognized by the Grand Lodge of Canada, therefore,

Resolved, That the Grand Lodge of Missouri hereby recognize the Grand Lodge of Quebec A. F. and A. M., having jurisdiction in the Province of Quebec as at present defined, said recognition not to interfere with the vested rights of the Grand Lodges of England, Ireland and Scotland over such of their daughter Lodges as may prefer to remain under their original charter.

Resolved, That the Grand Lodge of Missouri extends to the Grand Lodge of Quebec her best wishes for peace and prosperity.

And while grateful for and heartily reciproceting, the good wishes expressed in the last resolution, I cannot recommend this Grand Lodge to accept recognition from the Grand Lodge of Missouri, or from any other Grand Lodge, on any such conditions as are contained in the preamble and the first resolution.

The Grand Lodge of Quebec will cheerfully accept insternal recognition from the Grand Lodge of Missouri on the condition that this Grand Lodge has the same right of exclusive sovereign jurisdiction within this Province of our Dominion that the Grand Lodge of Missouri claims and exercises within that State of the American Union.

It is my painful duty to report for your consideration and action the existence of a much to be lamented schism amongst our brethern in the sister Province of Ontario. It has always appeared to me to be most unfortunate that the "Grand Lodge of Canada," when all her relations to this Grand Lodge had been adjusted and recognition accorded, that she did not then at least constitute and declare herself to be the Grand Lodge of the Province of Ontario. Her same "The Grand Lodge of Canada," has, since Confederation, become synonymous with "The Grand Lodge of the Dominion of Canada," and seems to involve what some may consider a menace to, or a claim to superiority over, the other Grand Lodges of the Dominion, any one of which is as much a "Grand Lodge of Canada," as she is. Had she thus reconstituted and remand herself "The Grand Lodges of Ontario," it would have wholly prevented any claim being put forward that there existed no such Grand Body.

Forward that there existed no such Grand Body. From an examination of the papers forwarded to me from London, Ont., it does not clearly appear to me what were the real causes of the existing schism—or that the proceedings had in the formation and incorporation of what is called "The Grand Lodge of Ontario," were in accordance with the well-known and generally accepted principles governing the formation of Grand Lodges of Freemacons, such as those on which this, and other regularly constituted Grand Lodges have been duly founded and recognized I cannot therefore recomend Grand Lodge to extend fraternal recognition to the Body now claiming to be the Grand Lodge of the Province of Ontario, notwithstanding she may bring to the support of her claims some exceptional circumstances as precedents; or the non-performance of and have followed as a sequence to the disseverment of the old Provinces of Canada into Ontario and Quebec.

Having received no official Communications from the "Grand Lodge of Canada" abent this schiam or her action regarding the same, I am therefore not in a position to advise Grand Lodge with certainty, as to what ought to be done under the circumstances, and hence it seems to me better to defer action upon the matter, hoping, as I think we justy may, thist a peaceful and fraternal solution of existing difficulties may yet be had.

It appears to me from the information I have of the many excellent Brethren who are involved in this unfortunate affair, that a proper spirit of conciliation and a prudent exercise of authority might have prevented the difficulty from assuming such proportions; but if not, I cannot com-

mend for your approval the reported numerous "suspensions by edict," nor any action of "expulsion" of more than doubtful legality—and hence it sppears to me that there are good reasons to hope that if there is further opportunity given, the second, soper thought of so many good brethren on either side, will lead ere long to a happy solution of existing difficulties, and so avoid what otherwise may be a permanent alienation of those who ought to be one in spirit and action.

Brethren from without the jurisdiction of Ontario may also be able to counsel and co-operate, with our good Brethren there, in healing existing troubles. In olden time under somewhat like circumstances the good example of *Old London* and *Old York*, in the motherland, may not be wholly lost among their loyal children in this land of the setting sun.

#### COLORED LODGES

Among the many incidents peculiar to this Centennial year of our good has been the thrusting into what I cannot otherwise than consider, the and been the throwing into what I cannot otherwise than consider, the undue and unwise prominence of the subject of the colored private and Grand Lodges, so-called, reported to exist there, and likewise to call attention to those claiming existence in the Province of Ontario, whose application for recognition has heretofore been laid before me.

It appears to me to be far better for the colored people themselves, for us patiently to await the more full development of their destiny on this continent. The gravest possible doubts exist in my own mind as to the regularity of any of those so-called lodges of colored Freemasons, either in the United States or Canada, and hence if they are irregular as I believe, no proposals for their recognition can be entertained by this or any other duly constituted Grand Lodge; the more especially as these so-called colored Grand Lodges claim to exist where regular and duly constituted and recognized Grand Lodges of Freemasons exist already. "Freemasons are of all nations, tongues, kindreds, and languages," but all regular private Lodges alone have the initial and final right to decide who shall or shall out become regular members of our Fratemity and no new results winter Longes sione news the initial and nual right to decide who shall or shall not become regular members of our Fraternity, and no new regular private lodges can be created except in the manner prescribed by the constitution, and no proposition for the recognition of any Grand Lodge should be entertained except on the basis of exclusive jurisdiction of each Grand Lodge within its prescribed and lawful territory.

Our constitutions do not require any "fifteenth" or other amendments to meet the wants of all people, or to conserve the just rights of all regular lodges of Freemasons of every color.

#### MUTUAL AND SYSTEMATIC BENEVOLENCE.

It has often appeared to me that the various lodges do not arrange so systematically as they might the matter of assessments and disbursements for the purposes of benevolence and depend too much on the ordinary dis-bursements from the funds of the lodge for the ald of needy brehteren, or their widows and orphans in distress. I would not advise any decrease, but wherever practicable, rather an increase of the contributions or appropriations to the ordinary fund of benevolence, and I would also recommend for the consideration of the Grand Lodge, the advisability or allowing the members of other lodges in the several cities and districts to form themselves, under approved regulations, into some form 'of associ-

ation, as an extension of, or as supplementary to the ordinary existing methods of benevolence, and I nurther advise that the B. O. G. P. consider the matter and afford an opportunity for brethren to appear before them and express their views in relation thereto, and that the Board make report thereon at this session of Grand Lodge.

#### MASONRY AND OTHER BODIES.

It is very generally acknowledged that Masonry is a "peculiar" fraternity. It is indeed unique in this our world. Its real origin is lost in the mists of time. It is a growth and development of the ages, and it will remain permanent as human society. It exists as a necessity of human desires and human necessities. It has given much to like and more modern organizations, but needs and takes but little in return. It is not a system of religion, but the fundamental principles of true religion are its full embodiment.— It is not a mere benefit society, yet among its prominent tenets are true and genuine benevolence and fraternal aid in distress. It is not a temperance organization, but one of its cardinal virtues is the due restraint of all our appetites and passions. Language would fail to give it a full definition. Off-shoots from Masonry or other organizations somewhat modelled upon it, and wherever seeking to accomplish a good work, we wish them God-Speed, but let nome be called by its name or taken under its wing. Let it ever exist, as it ever has existed, separate and independent, unique in its origin and being, and ever seeking to fulfil its sublime mission among the sons of men.

For various reasons it now seems particularly fitting to re-annunciate to the world the great fact that Freemasonry is a non-political, non-sectarian, and non-proselyting fraternity.

Let a man's religion or mode of worship be what it may, he is not excluded from the order, provided he believes in the glorious Architect of Heaven and earth, and practices the sacred duties of morality. Masonry is the centre of union between good men and true, and the happy means of concillating friendship amongst those who must otherwise have remained at a perpetual distance.

A Mason is a peaceable subject to the civil powers wherever he resides or works, and is cheerfully to conform to every lawful authority, to uphold on every occasion the interests of the community, and always to promote the prosperity of his own country; and wise rulers in every age have been much disposed to encourage the craftsmer on account of their peaceableness and loyalty. Differences of opinion and quarrels about religion, or nations, or state, or church policy, must never be brought within the Lodge. We are also of all nations, tongreek, kindred, and languages, and are resolved against all politics and sectarianism as what never yet conduced to the welfare of the Lodge, nor ever will. All others practising other principles, and claiming to be Freemasons, are "stealing the livery of heaven to serve the devil in."

It is with lively satisfaction that I am enabled to report to you at this annual communication, that the craft is generally enjoying peace and healthy progress throughout the Dominion, and from the reports constanty

received, the same is true to a gratifying extent in the United States, South America, Great Britain, on the continents of Europe, Asia, Africa, and on the Isles of the Sea. There are trials which our brethren in a few portions of the world are still subjected to, on account of the unwise interference of ecclesiasticism, from which we are now so happily free, and which happy state of affairs amongst us, it is to be hoped, may ever continue. Let our brethren, wherever situated, faithfully adhere to and carry out at all times and under all circumstances, the great and unchanging principles of our ancient constitutions, and it will soon appear that only temporary inconvenience and trouble will arise from the assaults of their enemies, and that permanent good to them and to the craft universal, will be the glorious and final result.

Enlightened civil and ecclesiastical rulers are fast learning that our world-wide Fraternity, is the loyal friend of man, of religion, and of the commonwealth. It is a false policy which alienates the best of friends, and which makes an enemy of the best of neighbors. No wise, civil, or ecclesiastical authority will long pursue it. Let the masterbuilders and the chief rulers of the craftsmen be alone selected from among the best skilled, most prudent, and wisest of the brethren, else a year, or a day even, may undo what an age is needed to accomplish. Lay the foundations firmly upon the everlasting rock of truth, raise the superstructure on the level and by the plumb and square; in wisdom, strength and beauty, and in faith, hope and charity carry on your good work as for all times and for the acons beyond, and without fail, and as sure as his promise stands, the blessings of the Great Architect of earth and heavens, will forever abide with you and yours.

#### CLOSING WORDS.

In returning to you the supreme authority in the craft with which you have so long entrusted me, I beg, most heartily, to request your kindly acceptance of my sincere fraternal thanks for the many honors and other substantial tokens of favor which I have so frequently and gratefully received from this Grand Lodge, and also from so many of the brethren in different parts of our jurisdiction, and at the same time I desire formally to communicate to you my desire and purpose to withdraw from active official duties in connection with the craft at the close of this session of Grand Lodge. Of the results of about fifteen years of Masonic official labor in the Grand Lodge of Canada, and in aiding to establish and upbuild this Grand Lodge, I must leave you and others to judge. About one-third of my life thus devoted to the craft will, I am sure, in your opinion, entitle eme to put off the harness and withdraw from active labor into that quiet retirement from official duty which in *otime cum dignitate*, one is wont to look forward to, with sincere satisfaction.

The following reports from District De ty Grand Masters were read and referred to the Board of General Pu poses to report thereon.

#### MONTREAL DISTRICT.

#### To the M. W. Grand Master and Grand Lodge of A.F. and A.M. of Quebec.

In conformity with the requirements of the Constitution, I have to sub-mit my report on the condition of Masonry in the Montreal District.

There are twenty-one lodges in this district, working under warrants from this Grand Lodge, and three under Dispensation. There are also three under the Grand Lodge of England, and one under the Grand Lodge of Scotland.

I have been unabled to visit all the Lodges in the District, and regret that my business engagements have prevented me from attending to my Masonic duties as well as I could wish. However, it affords me much pleasure to report that the Lodges I have visited are in a prosperous condition, and from the fact that no Masonic complaint has been brought to my notice during the past year, I am led to believe that harmony prevails in all the Lodges.

Since my appointment as D. D. G. M. I have had the honor of constitut-ing St. John's Lodge in this city, and installing its officers. I have also forwarded to the M. W. Grand Master petitions from the requisite number of brethren, requesting permission to open the following new Lodges :---

## Hochelaga at Hochelaga. Montarville at Longueuil.

## St. Francis at Sorel.

St. Francis at Sorel. The M. W. Grand Master having granted his Dispensation to open these Lodges, I have, with the assistance of Brethren from Montreal who kindly lent their time, formally presented their Dispensations and installed their officers. As all these Lodges will probably apply for warrants of confirma-tion, I would heartily recommend the Grand Lodge to grant them, believing that they are for the best interests of our order. The St. Francis Lodge, at Sorel, will also netition the Grand Lodge to change its name to that of Richelieu Lodge, which I also recommend the Grand Lodge to grant.

The members of Union of Strict Observance Lodge having by regular order united themselves with Zetland Lodge, "late Canada Register," surrendered to me their warrant, which I have returned to this Grand Lodge, through the Grand Secretary.

It is my painful duty to report that the hand of death has removed fromour midst M. W. Bro. Aldis Bernard, Past Grand Master. The M. W. the Grand Master convened the Grand Lodge, and the remains of Bro. Bernard were deposited in their last resting-place with Masonic honors.

I have also to report that death has removed from the Kilwinning Lodge Bros. John Glennon and James Sommerville, and from St. George, No. 6, Bro. George Hunter.

In conclusion I beg to thank the Brethren of Montreal District for their many courtesies and kinduess during my term of office.

#### M. W. Sir, Officers and Brethren,

In accordance with the requirements of the Constitution I herewith submit my annual report upon the condition of the Craft in the Bedford District.

During the year I have visited a large number of the lodges in the District and corresponded with all, and found them working very harmoniously and, taking a general interest in Masonry, excepting Clarenceville Lodge, which has had no meeting for the last two years, and is completely demoralized and broken up; I would therefore recommend the erasure of it.

I have granted four dispensations for Masonic festivals, of which all have passed off without jar and to the credit of the several lodges under whose auspices they were granted.

I have much pleasure in reporting the amalgamation of the two "Nelson" Lodges, which was harmoniously effected, also a contemplated union of the two "Prevost" Lodges, and Burland and Dorchester Lodges, which when effected, I trust, will clear up the Masonic horizon of the Province.

In the month of October last I had the pleasure of forwarding to the M. W. the Grand Master a petition from certain Brethren to open a new lodge in the Village of Bedford, called Bedford Lodge. The M. W. Grand Master was pleased to grant the prayer of the petitioners, and accordingly issued a Dispensation to them, and Bedford Lodge was formally opened by me in January last, V. W. Bro. Hobart Butter being the first W. M., Bro. D. A. Hart, M.D., the first Senior Warden, and Bro. H. F. Parker the first Junior Warden. Under the able management of these Brethren this Lodge has made great and healthy progress. I have much pleasure in recommending that a Warrant of Constitution be granted by the Grand Lodge at its present session to Bedford Lodge.

<sup>\*</sup> During the present month I received a petition from several Brethren of Rougemont asking for a Dispensation for a lodge there, which I sent to the M. W. the Grand Master, with my approval endorsed thereon.

I would recommend to the Grand Lodge that the Masonic District of Bedford be divided into two Districts. As now formed it embraces too much territory—too many lodges, rendering it expensive for one D. D. G. M. to preside over and do justice to the Craft.

#### The Grand Chaplain then delivered his discourse, as follows :

#### Most Worshipful Sir and Brethren :

In addressing you once more at our great annual gathering, I propose tofound my remarks on words which are familiar to you all, and which, although originally written for the guidance of a Christian community, as such, may well be employed to describe the duties of a Mason to the Great Architect of the Universe, to his fellow-men at large, and to the members of his own Fraternity. "Honor all men. Love the Brotherhood. Fear God, Honor the King." I wish to treat those often-quoted words, as containing within themselves a short but comprehensive homily on the duty of Reve-reflecting mind. This subject is presented in what, for convenience sake, I may call my text, under four aspects. 1st, Generally; "Honor all men;" 2nd, In its closer and more tender relations: "Love the Brotherhood;" 3rd, In its most sublime and yet most lordly aspect; profound, but not abject; complete, yet not servile; of fear, though not of terror; not cower-ing or cringing, but nevertheless prostrate and utterly dependent; reve-rence of the creature and the sinner, yet the child, before the Lord God Almighty: "Fear God." 4th. In its civil and political aspect, the reve-rence of submission, of obedience, of fidelity, towards him, or her, or those, who hold their power by the ordinance and at the will of the one source of power. God Omninotent: "Honor the King." To put it still more shortly. power, God Omnipotent : "Honor the King." To put it still more shortly, loving regard for those who are bound to us by special ties of brotherhood. 3. Complete submission to and dependence upon God. 4. The recognition of the divine right of properly-constituted human authority. The subject thus opened out to us is a great and important one, and ought to be of paramount interest to us is a great and important one, and ought to be of paramount interest to us, upon whom its varied lessons have been im-pressed at every step of our Masonic progress. There can be no question, my brethren, that the general tendency of thought and inclination and opinion in the world around us, at the present day, is in the direction of irrevence, and self-assertion, and insurbordination, and one part, and by no means the less the less the present day is in the direction of 1 no means the least important, of our mission as Masons is to stem the rising torrent which menaces all that is best and most valuable in the social and political world, by a steadfast adherence to those time honored principles. political world, by a steadfast adherence to those time honored principles. which have been handed down to us from the forefathers of our Order. In-dependent! This is one of the favorite watchwords of the day. There is a good sense in which the expression may be used, but most often it is only another name for pride, insubordination, self-will, self-conceit,—national social or individual. " Be independent," cries the active spirit of irreve-rence, using the covering of a plausible term. " Be independent." And, so we have questionings of the love and wisdom and even the existence of God; so we have denials of the revelation of God. So again, we have im-patience of constituted authority—in nations, rebellions; in cities, outbreaks and seditions, or the dictation of turbulent crowds; and, in families, the disobedience of children and sevants, whe are quick in catching the con-tagion from those who should set them a better example. So, again, we have the presence here, there and everywhere of the spirit of mockery, and have the presence here, there and everywhere of the spirit of mockery and discontent and murmuring; a captious and censorious spirit so prevails that it seems as if fault must be found with all kinds of rule and management, and the result is an uncomfortable sense of restlessness and dirgust, and an inaptitude for the calm, orderly and persevering fulfilment of daily duties towards God and man. this condition of things, let us reflect, for a moment, how entirely it is opposed to the cardinal principles of our Order, as contained in the ancient "Charges of a Freemason."

"A Mason" (we are taught) is a peaceable subject to the "civic powers; wherever he resides or works, and is never to be concerned in plots and conspiracies against the peace and welfare of the nation, nor to behave himself undutifully to inferior Magistrates. He is cheerfully to conform to every lawful authority; to uphold, on every occasion, the interest of the community, and zealously promote the prosperity of his own country."

The passage I have just quoted enforces our duty to external authorities; that which I am about to read is no less decisive as to our demeanor towards those who bear rule within the Fraternity :-- "The ruler and governors, supreme and subordinate, are to be obeyed in their respective stations by all the brethren, according to the ancient charges and regulastations by all the brethren, according to the ancient charges and regula-tions, with all humility, reverence, love and alacrity." A few additional words may be said upon each of the four sentences which form the motto of my remarks. 1. What is our special duty as Masons, in reverence towards all men, indicated by the words, "Honor all men?" It is simply a fulfilling of that golden rule, which deserves to be inscribed over the portais of every Masonic temple, as it ought to be deeply graven in every Mason's heart, "Do unto all men as you would they should do unto you." We may say specially that thus we are taught to avoid that habit of ill-natured talk and hasty judging, one concerning another, which is so common; that so we are bidden to recognize God's image in every one of our fellow creatures, and to try and discover the good in him, instead of holding up the evil to reproach and scorn ; bidden to be fondest of imputing good motives instead of ill; in short, in all our intercourse with all men to practise that universal charity which "thinketh no evil," and "hopeth all things." 2. " Love the Brothe hood," is an injunction which concerns a closer tie, a tenderer, holier bond of reverence, even than that of our common nature and creation. Love all those who are your brethren of the mystic tie; love them in the Brotherhood; love them in the individual members. As regards the Brotherhood, not only do not be disor-derly and self-willed and self-seeking within the Order, but give it your love; a filial, loval and true-hearted love. And, as regards the individual members, revere and love them as men who are pledged, with you, to the prosecution of the highest aims, and the cultivation of the nobiest virtues. 3. "Fear God." Obedience to this command, according to the royal Solomon, "is the beginning of wisdor," the wisdom which is from above, " pure, peaceable, gentle, easy to be entreated, without partiality, and without hyporisy." In truth, this fear is love. Our great patron, St. John the Francelic save, " There is no fear in love." But the is east if John the Evangelist says: "There is no fear in love," but that is not this fear. That far hath torment," but this is fear of holy joy and humble confidence, for none can so truly rejoice in God, or so wholly trust Him, as those who, leaning not on their own understanding and will, mingle reverence with their affection, lowly adoration with their clinging confidence. May this fear be always with us, ruling and influencing thought and word and deed; making us more humble and watchful in our conduct, more devout in prayer, more reverent in our latuage and manner, when, in any way, we deal with sacred subjects, names and things. 4. Lastly, "Honor the King." Upon this last injunction it is not necessary to say more than this. Properly to obey it will, perhaps, sometimes bring us under the contempt of those around us in our generation. Let it be considered by us a small thing to be judged by the temper of an irreverent time. Let all with whom we are

#### GRIEVANCES AND APPEALS.

The Board on the subject of Grievances and Appeals beg to report on the matter of the complaint of W. Bro. Hugh Brodie, W. M. of Prince-Consort Lodge, No. 37, against W. Bro. Charles Boon, P. M. of same Lodgeras follows:

The Board finds the following facts established, as well by the minutes of the Lodge as by the admissions of Bro. Boon himself to the Board, viz.

That at the regular communication of Prince Consort Lodge, held 23rd May, 1876, W. Bro. Boon occupied the chair as W. M. in consequence of the absence of Bro. Brodie.

That the Committee, duly appointed at the regular communication of the previous month, on the application of Mr. Joseph Ward, a candidate for initiation, reported favorably, and W. Bro. Boon directed the ballot to be passed, which being done was found unfavorable to the candidate; and that the ballot was thereupon passed a second and a third time, and was

on each occasion found unfavorable; and that after the result of the third ballot was ascertained, W. Bro. Boon declared from the chair that the candidate was rejected, and an entry of such declaration was recorded by the Secretary.

That at 9 p.m. the business of the Lodge was suspended for the purpose of receiving dues, and was again resumed at 9.30 p.m., when several communications were read and accounts passed; and that it was then moved by Bro. Byrd, seconded by Bro. H. Goodrick, S. W., and carried unanimously, that the ballot on the application of Mr. Ward should again be passed, which was done and found to be in favor ot the candidate, who was thereupon initiated into the first degree by W. Bro. Boon.

That at the regular communication of said Lodge held 22nd August; 1876, W. Bro. Boon was again in the chair as W. M.; and upon Mr. Ward being called to the East to be examined as to his proficiency, the Secretary notified the Lodge that it was the W. M.'s orders that Mr. Ward should not receive his second degree until the meeting of Grand Lodge in September, but W. Bro. Boon ruled that as there were no documents on the table relating to the subject the Bro. was entitled to receive his second degree, which he accordingly conferred upon him.

That between the regular communication of May and the conferring of the second degree as above, it had been intimated to W Bro. Boon that he had acted irregularly and unconstitutionally in initiating Mr. Ward; and that he was aware when he conferred the second degree that W. Bro. Brodie considered his action unconstitutional, and was desirous that the second degree should not be conferred until the meeting of Grand Lodge.

And upon the foregoing facts the Board are of opinion :

1. That W. Bro. Boon in allowing the ballot to be passed a fourth time, after he had declared the candidate rejected and the Lodge had pro eeded with other business, acted in direct violation of the constitution of Grand Lodge and the by-laws of his own Lodge; and that the initiation of Mr. Ward was irregular.

2. That although W. Bro. Boon stated to the Board that he could not see that the constitution prohibited him in allowing the ballot to be passed a fourth time, the Board consider the constitution is clearly against the pretensions of W. Bro. Boon, and consider that he should not have been ignorant of the law of Masonry upon so important a point.

3. That W. Bro. Boon, even if he erred in the first place from ignorance, was clearly wrong in conferring the second degree upon Mr. Ward, after the unconstitutionality of the former action, as well as the desire of W. Bro. Brodie respecting the matter, had been intimated to him.

4. That Bro. Byrd, who moved the resolution to have the ballot passed a fourth time, and Bro. Goodrick, S. W., are deserving of censure, more particularly the latter, who is presumed to be, and who ought to be, sufficiently acquainted with the constitution of Masonry to be enabled to govern the Lodge in the absence of the W. M.

It is well known to the Board that W. Bro. Boon has ever since his admission to the Order been one of its most scalous and active members, and has by his attention and zeal gained a high place in a comparatively short space of time; but the Board cannot but feel that if such proceedings in private Lodges are allowed to pass unnoticed, the ancient landmarks and constitutions of Masonry, which every Mason is bound to

#### REPORT ON GRAND MASTER'S ADDRESS.

The Board of General Purposes, to whom was referred the annual address from the Throne, beg leave most respectfully to report, that having carefully considered this very able and lengthy communication from the M. W. the G. M., they join in thankfulness to the G. A of the U. that the M. W. the G. M., who has so efficiently presided for so many years over this Grand Lodge, and to whom this Grand Lodge and to whom this Grand Lodge which he has always filled with so much credit to himself and usefulness to the Graft, and devoully prays he may be long spared to render that assistance to the Grand Lodge which his great experience and deep research in Masonic matters render him so well able to impart.

The Board has great pleasure in congratulating this Grand Lodge upon the general harmony and prosperity which has attended Masonry during the past Masonic year, while at the same time they cannot but regret the loss of several distinguished and zealous brethren within the jurisdiction of and connected with this Grand Lodge, and feel with the M. W. the G. M. that they will be sadly missed and long lamented. May the tokens of mourning which now surround us, while they remind us of the removal of our late esteemed brethren, also remind us of our inevitable destiny, and teach us so to live that when we depart hence our names may be revered, as are those of our distinguished brethren who have gone before us.

The Board regard the appointments of Grand Representatives, mentioned in the Grand Master's address, as being most judicious.

The Board has already had the honor of reporting to this Grand Lodge anent the dispensations granted to new Lodges during the past year.

There can be no doubt but that the establishment of a Grand Lodge Library would be highly beneficial to the Craft, and would suggest the appointment of a committee to consider and report upon the best means of carrying the suggestion of the Grand Master into effect. The thanks of this Grand Lodge, and some more substantial recognition, are due to Bro. Smithers for his services in preparing the report on Foreign Correspondence and the Board recommend that the sum of \$50, in anticipation of the completion of the report, be now paid over to Bro. Smithers.

The Board are led to believe that the Committee on re-numbering of Lodges will be able to present its report at the present session of Grand Lodge.

With regard to the division of the large District of Montreal, the Board suggests that the section of this Province situated north of the Island of

Montreal, not already forming part of any District, should be formed into a new District, to be called the Ottawa District.

The Board would strongly recommend the appointment of a permanent committee for the preparation and collection of materials for a history of the Oraft in this Province.

In addition to the important suggestions of the M. W. the G. M. as to Lodges' incomes and outlays, the Board feel it an imperative duty to call the attention of private Lodges to the expediency and importance of keeping Lodge property fully insured.

The Poard suggest the appointment of a committee with a view to arrange, if possible, for the publication of a Masonic Magazine in connection with this Grand Lodge.

The Board recommend that a provision should be made by the Lodges of each District for the payment of the necessary expenses of the D. D. G. Ms. incurred in visiting the various Lodges in their respective Districts.

With regard to the all important question of Grand Lodge Sovereignty, the Board feel that it is a matter requiring the most careful and thoughtful consideration of this Grand Lodge. While the Board cannot do otherwise than heartily sgree with the principles of Grand Lodge Sovereignty, as enunciated in the address of the M. W. the G. M., and heartily agree with his observation that this Grand Lodge cannot accept conditional recognition from any Grand Body, such as proferred by the Grand Lodge of England, yet the peculiar circumstances under which Lodges under the jurisdictions of England and Scotland have existed in this Province, even from a time prior to the existence of the Grand Lodge of Canada, should not be lost sight of; and the Board cannot but suggest that this circumstance, as well as others well known to the Grand Lodge, render the connection of these Grand Bodies with this Province of a very exceptional character. With these observations, the Board confidently leave the decision of this weighty matter to the consideration of Grand Lodge.

The remarks of the M. W. the Grand Master, in the sense that this Grand Lodge should not recognize so-called Colored Lodges claiming to exist where regular and duy constituted and recognized Grand Lodges of Masons exist, meet with the hearty approval of the Board.

The Board have not had sufficient time during the present communication to mature any plan to recommend to this Grand Lodge upon the question of systematic and mutual benevolence, brought before it in the Grand Master's address; but the Board hope that any suggestions which the members of Grand Lodge can make upon this important matter may be handed in to the Grand Secretary prior to the semi-annual meeting of the Board in March next, when the Board will have more time to give the matter the consideration it deserves.

Although no special prominence has been given in the present address of the Grand Master to the question of a Masonic Temple, the question has frequently heretofore been brought before it, and the Board having had occasion to feel, especially at this Communication, the inconvenience of the present arrangements for the accommodation of the Board and of the Grand Lodge, desire to bring the matter prominently before Grand Lodge. The Board consider that the time has now arrived, when this Grand Lodge would be fully justified in taking active measures towards the erection of a Masonic Temple, with suitable accommodation for Board still Committee purposes; and the Board would recommend the appoint-

## United Grand Lodge of England, A. F. & A. M.

Royal Sir & M. W. Bro.—I have the honor, by command of the M. W. the Grand Master of this Grand Lodge, to call your attention to former communications addressed by M. W. Bro. John H. Graham, P. G. M. of this Grand Lodge, and by the Grand Secretary of the Grand Lodge of Quebee, under dates 12th Dec. 1869, 21st June, 1872, and 11th April, 1875, to the M. W. the Grand Master and Grand Lodge of England, asking fraternal recognition by the Grand Lodge of England of the Grand Lodge of Quebec; to all of which communications no formal or official reply has ever yet been received.

I beg respectfully to state for the information of Your Royal Highness, as Grand Master of the Grand Lodge of England, that the difficulties heretofore existing between the Grand Lodge of Canada and the Grand Lodge of Quebec, have been fully, finally and satisfactorily terminated by the recognition of the Grand Lodge of Quebec by the Grand Lodge of Canada, and by the unconditional withdrawal on the part of this latter body of all claim to jurisdiction in the Province of Quebec, and by the admission on the roll of lodges under the Grand Lodge of Quebec of all subordinate lodges in this Province formerly under the protection of the Grand Lodge of Canada.

I have further to state that the Grand Lodge of Quebec is now recognized by, and is in fraternal communication with nearly every Grand Lodge on the continent of America, (north and south) and several in Europe.

In view of the above, I am directed to state that the Grand Lodge of Quebec, now occupying the same masonic status as the Grand Lodges of Canada, Nova Scotia and New Brunswick,—prays for formal recognition by the Grand Lodge of England, and the M. W. the Grand Master ventures to hope that Your Royal Highness, with the consent of your Grand Lodge, in your capacity of Grand Master, will issue forthwith such directions in the premises as to cause the Grand Lodge of Quebec to be recognized as a sister Grand Lodge, with all the privileges of such a body.

W. the Grand Master of the Grand Lodge of England, asking recognition by the Grand Lodge of England of the Grand Lodge of Quebec, and request you will see it delivered; at the same time asking pardon if in it I am deficient as to language or style, for the fact is I am quite unaccustomed to correspond with Royalty. You will remember my conversation had with you during my visit last summer to England, upon the subject of the recognition of Quebec by England, and you will recollect also that it was understood that so soon as the differences between Canada and Quebec were settled, and your Grand Lodge officially notified thereof, that the necessary steps should be taken to obtain such formal recognition.

I send, by mail of to-day for England, a copy of proceedings of Grand Lodge of Canada, and refer you to page 665, showing the action of that Grand Body; and I new forward on another page a resolution of this Grand Lodge adopted at its regular communication held last September.

I know that in a great measure, owing to your promptness and decision, Grand Lodge certificates, issued by the Grand Lodge of Quebec, have been honored and recognized in England; yet it is desirable that full, formal and complete friendly relations between England and Quebec should be established. And to that end the Grand Master of this Grand Lodge desires me to say that he will gladly receive the name of any Brother here whom you and your Royal Grand Master may this to be appointed as Grand Representative of England near Quebec; and will also, without delay, after recognition, with same approbation, name a Brother in England as Grand Representative there of Quebec.

I gladly avail myself of the present opportunity to express to you my warm thanks and high appreciation of the fraternal kindness, politeness and hospitality extended to me by you on each occasion when I visited you during the past year. Be assured, R. W. Bro. I shall always remember your goodness with gratitude and pleasure.

Grand Master has received official information from the "Honorable Sir John Macdonald K.C.B. the Representative of this Grand "Lodge at the Grand Lodge of Canada, that the difficulties subsisting bet-"ween the latter and the newly formed Grand Lodge of Quebec, have "been happily adjusted, and the Grand Lodge of Quebee recognized by "the Grand Lodge of Canada. The M. W. Sir & Bro.—I have to acknowledge the receipt yesterday afternoonof your letter of the 14th inst., as Grand Secretary of the Grand Lodge of Quebec, in reference to my nomination as one of a Committee to represent St. Paul's Lodge in a conference having in view the amicable union of that Lodge with the Grand Lodge of Quebec.

It is, to me, a matter of great regret that the revocation of that committee nominated during the recess of the Lodge, and under a misaspprehension, should not have been notified to you in sufficient season to have prevented both you and myself from being placed in a false position.

As you have addressed me under an erroneous impression, I should be wanting in courtesy to you, as a Brother Mason, if I did not at once acknowledge receipt of your communication, and set you right. After reading the foregoing correspondence, the Grand Secretary called the attention of the M. W. the Grand Master and Grand Lodge to the fact that St. Lawrence Lodge No. 424 E. R. had refused or neglected to return any reply to the communication addressed to its officers on the above subject.

The Special Committee named by the M. W. the Grand Master in the month of April last, to confer with Lodges in this city under the jurisdictions of the Grand Lodges of England and Scotland, with a view, &c., &c., then made the following report,

To the Most Worshipful the Grand Master and Brethren of the Grand Lodge of Quebec,

Your Committee appointed in pursuance of a resolution passed at the last annual communication of Grand Lodge for the purpose of "conferring with the Lodges now existing in this Province under Warrants from other jurisdictions, with a view to effect, if possible, the amicable junction of said Lodges with this Grand Lodge," beg respectfully to report:

That, having assumed the duties of their appointment, they put themselves in communication with the Lodges referred to in said resolution, both by formal written communication and by personal interviews with leading members of said Lodges, the result of which will be seen by the printed copy of the correspondence now read and in the hands of members of this Grand Lodge.

Your Committee are pained to be compelled to report that the reasonable hope that an anicable arrangement might be effected, by which a union of said Lodges with this Grand Lodge would be accomplished, has proved unfounded, and that at present they see no ground for any expectation that such a desirable consummation can at present be realized.

Having, therefore, taken into consideration the communication of the Grand Secretary of the Grand Lodge of England, of the 31st of March, 1875, tendering to this Grand Lodge conditional recognition on the terms therein proposed, and having duly considered the same, as well as the attitude assumed by the Lodges in this Province working under foreign Warrants, your Committee respectfully recommend to this Grand Lodge the following resolutions:

Resolved,—That the Grand Lodge of Quebec respectfully declines to accept conditional recognition from any Grand Lodge, and that more especially it is pained to be compelled to decline the recognition tendered by the Grand Lodge of England on the terms in which it is offered.

Resolved,—That deeply deploring everything calculated to create discord or want of harmony among those who should be brethren dwelling together in unity, yet, this Grand Lodge being the equal, within its own jurisdiction, of any Grand Lodge in the universe within *its* jurisdiction, cannot in justice to itself recognize the Masonic authority of any foreign Grand Lodge within the limits of the Province of Quebec.

Resolved,—That in view of the unsuccessful efforts made by this Grand Lodge to bring about an amicable solution of the anomaly, unfortunately now existing, of Lodges working in this jurisdiction under Warrants from foreign Grand Lodges, if after the expiration of six months from this date any such Lodge be found working in this Province, all Masonic privileges be withdrawn from said Lodges and all connected with them in this Province.
