SEC. 6.—REVISED STATUTES OF ONTARIO RESPECTING VOTERS' LISTS.—The Sheriff shall immediately upon the receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon the receipt of his copies, shall cause one of them to be posted up in a conspicuous place in his office; every Public or Separate School Head Master or Mistress shall in like manner, post up one of his or her copies on the door of the school House; and every Post Master shall post up one of his copies in his Post Office.
