BIG ARMIES ARE LIVING UP FOR CLASH AT SIPINGHAI

Battle Not Unlikely Ere Week is Out—Japs on Move Toward Kirin to Separate Linvitch From Ussuri Base.

St. Petersburg, March 30.—Another duel between the two opposing armies in Manchuria may be on the program for the coming week. The Russians, according to the Associated Press' Harbin correspondent, are now strongly fortifying their positions at Sipinghai, against which the Japanese are reported to be gathering in force. The reported Russian retirement from Sipinghai to Chaomaiadai was incorrect, due to a telegraphic error in the confusion of similar names. Chaomaiadai, south of Sipinghai, from whence the Russian advanced force retired to the fortified line at Sipinghai. The Japanese followed to some extent, but a border of twenty miles of debatable ground still remains between the two armies, over which the Japanese probably will not advance until they are ready to attack.

Equally important news is that a column of Japanese is moving against Kirin, perhaps with the intention of striking the position eastward and striking at the Vladivostok line of communication with the double purpose of cutting the railway and separating Gen. Linvitch's army from a valuable base of supplies. The Russian district is of importance. Reconnaissance established the fact that the Japanese are gathering in heavy force twenty miles south of Sipinghai, evidently intending to attack the Chinese position at Sipinghai. The Russians are strongly fortified there and apparently expect to make a stand. The country between is comparatively clear of Japanese.

Oyama Names a Date.—The number of Chinese deaths is constantly augmenting. Chinese continue to report that Field Marshal Oyama has issued proclamations fixing the date for the occupation of Harbin as April 10, but this prediction seems apparently improbable of fulfillment.

THE TROUBLES AT HOME.

Opening of Volga May Spread Disorder—Poland is Angered.

St. Petersburg, March 30.—The disturbances at Yalta, in the Crimea, were largely fomented by Social Democrats. The same organization, which includes 20,000 workmen at Yalta, is influential at Mariopol, in the Ukraine, and is active in other industrial cities, and apprehension is felt lest the Yalta example may be followed at other points where the Socialists claim to have the situation at Yalta well in hand.

During the starting a building in Yalta devoted to the administration of the emperor's estate in Livadia, a few miles distant, was destroyed by fire. The cause of the fire is not yet ascertained. The government is contemplating the opening of the navigation of the Volga with apprehensions, as the discontent is to be carried up and down the river.

There is general disappointment reported at Warsaw as to the terms of the emperor's rescript. The feelings of the Poles have been hurt by the imperial rescript to Poland as "the Yastka Country," instead of the Kingdom of Poland, one of the emperor's titles being King of Poland. It is also pointed out that the rescript leaves reforms to the bureaucracy, which is hostile to reform measures.

Everything, it is now thought, depends on the governor-general's interpretation of his rescript. The order in Poland and the methods he will adopt.

POWERS WILL INTERVENE TO STOP CRETAN TROUBLE.

Canea, Island of Crete, March 29.—Prince George has issued a proclamation declaring that the powers had ordered foreign troops to participate in the restoration of order. The prince appeals to the revolutionists to lay down their arms.

Commissioner Named to Investigate Surrender of Port Arthur.

St. Petersburg, March 30.—(I. a. m.)—The membership of the commission to investigate the circumstances of the surrender of Port Arthur, under the presidency of General Roop, has been announced.

It consists of Generals Kourberg of the engineers; Giebelherg and Kanaroff of the infantry; Denonkoff, Krivonozki and Bolevich of the artillery, and Admirals Dikoff and Doubovoff.

The sittings will begin at the middle of May. The commissioners' report will determine whether or not one shall be tried by military tribunal.

G. T. R. EXTENDS RUNNING RIGHTS OVER CANADA ATLANTIC TRACKS

I. C. R. and C. N. R. to Profit, Sifton Influence is Said to Have Been Exerted.

Ottawa, March 29.—(Special.)—The G. T. R. has decided to give the Intercolonial Railway running rights over the Canada Atlantic, which the G. T. R. recently acquired. It is understood the government railway is to pay nothing for the privilege. However, there is a gap between Ottawa and Montreal, which is strictly Grand Trunk road, and over which the Canada Atlantic has had running rights. The probability is that the government railway will have to pay handsomely for running rights over this.

The deal also includes running rights over the Canada Atlantic for the Canadian Northern Railway, which owns the line from Hawkesbury to Quebec, and it has track rights over the Montreal terminal railway. By securing running rights over the Canada Atlantic it will be able to connect up its Hawkesbury-Quebec line with Montreal, and it will thus secure a direct summer line between Edmonton and Quebec. The government has endeavored the whole matter.

The bills providing for the transfer of the Canada Atlantic to the Grand Trunk have been purposely held back to force the Grand Trunk Railway to deal with the Intercolonial Railway and the Canadian Northern chief of the latter, in regard to running rights over the Canada Atlantic system.

It is also stated on good authority that Hon. Clifford Sifton, in the negotiations leading up to the compromise over the autonomy bill, submitted as a condition antecedent to compromise that certain concessions be granted the Canadian Northern Railway, among them being running rights over the Canada Atlantic.

In the elections of 1896, again in 1900, and once again in 1904, it declared against the party which endeavored to give it what were he believed, its just dues, and in the face of these decisions, Mr. Foster said, he could again hold the rights of the minority supreme as against the great forces of public opinion which are daily but forcefully dealt with the alleged tolerance of Henri Bourassa, M.P. He showed up the Quebec schools and denied that the privileges enjoyed by the Protestant minority indicated any great tolerance. ACQUIT LONEY AFTER 4 HOURS GRAND JURY BLAME THE PRESS FOR LIONIZING ROUGH PLAYERS

Prominence Given Sporting News Excites Spectators to Encourage Violence, and Legislative Prohibition May be Necessary.

Cornwall, March 29.—(Special.)—The Loney manslaughter case was concluded to-day. The defence called over 20 witnesses, the last one being the accused, Allan Loney, who claimed that Alcide Laurin had broken a hockey stick over his leg. As he turned to throw the stick, he received a blow in the face, either from the stick or a hockey stick, he could not tell which, and this dazed him so that he did not know how Laurin was struck.

His lordship addressed the jury at considerable length, explaining the law in regard to manslaughter. He held that the only reasonable homicide was that done to protect life or prevent grievous bodily harm. His charge to the jury seemed to be unfavorable to the defendant.

The grand jury in their report strongly condemned the tendency to rough play and brutal tactics in hockey, lacrosse and football, which frequently resulted in serious and permanent injuries and sometimes death to the participants. They criticized the press for giving so much prominence to sporting news, and held that the press was largely responsible, in a moral sense, for the results of the game.

The lionizing of rough players had reached such a stage that unless there was a change made it might be necessary to have such sports prohibited by legislation and placed in the class with bull fights and cocking.



There is no doubt that Centre Toronto is to go Conservative by acclamation. The writ has been issued, making polling April 18, with nominal a week earlier, but with the firm stand which Sir Wilfrid Laurier and his government have taken on the autonomy bill for the Northwest, and the opposition against the measure from adherents of both parties in Toronto, the Liberals feel that the question would be the test question, and that the election would be fought out on this issue alone. Then there would be such an awakening among the old-line adherents from every riding in the city that Liberalism would receive a severe setback. A rider would arise from all over the province to submit the issue to the people, and the feeling of revision against the government might spread far beyond the precincts of the city. From Ottawa comes the hope that Toronto Liberals will allow sleeping dogs to lie. The government is quite strong enough without endeavoring to get another supporter as a member for Centre Toronto, and the Liberal party, with the exception of Leighton McCarthy, is a unit in favor of the autonomy bill. T. C. Robinette, who contested Centre Toronto against F. Clark, would be the candidate, if the Liberals brought out a man; but Mr. Robinette does not favor the compulsory school clauses of the autonomy bill, and would not likely withdraw his opposition to the measure in order to receive the support of the government in this contest. The Liberal executive of Centre Toronto met last night and tendered a unanimous nomination to T. C. Robinette, but he declined. "Will the nomination be offered to anyone else?" he was asked. "I'll tell you," said Mr. Robinette. "That ends the matter as far as we are concerned." "Yes, unless the Toronto Reform Association decides to call a convention." The Man for the Vacancy. The Conservatives are almost unanimous in their choice, and at convention, to be held on Friday of next week, John Ross Robertson will, in all probability be the man. Mr. Robertson has been out of the city for some time, but it is understood that if his nomination is made unanimous, he will accept. Other gentlemen have been spoken of as likely to be in the running, but the nomination is made unanimous, and it is not likely that any other gentleman will have a nomination, if he is not chosen.
