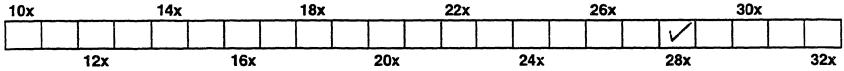

An Act to secure the Freedom of Election at at the next election for the County of Argenteuil.

An Act to secure the Freedom of Election at the next Election for the County of Argenteuil.

HEREAS it is necessary to make better provisions for securing the Preamble. Freedom of Election in the County of Argenteuil; Therefore Her Majesty, &c., enacts as follows:

I. Immediately after the passing of this Act, the Secretary-Treasurer of Secretary-5 each local Municipality in the County of Argenteuil, shall make from the Treasurers to last Valuation Roll for such Municipality, a list in the form of the Schedule make lists of voters. A. containing the names and surnames of all male persons who, by the said Roll, shall appear to be the owners of one or several lots of land in such Municipality, of the actual value of at least thirty pounds, 10 or of the yearly value of at least two pounds four shillings and five pence; also, a list of all the occupants of land of the actual value of fifty pounds, or of the yearly value of five pounds, and assessed as such occupants and not as owners or proprietors of such lot or of any other lot in such Municipality.

II. The list mentioned in the last section shall contain the names and What such 15 surnames of such proprietors or occupants, the description of the lot or lots lists shall owned or occupied by them, the value of such lot or lots, the whole as mentioned on the said Valuation Roll.

III. It shall be the duty of the Secretary-Treasurer of each such local Certificate to Municipality to prepare a certificate in the form of the Schedule B. for be given to each of the persons named in the lists by him prepared, as mentioned in the two preceding sections.

IV. The certificates so prepared by the Secretary-Treasurer shall, by him Oath may be be delivered on their application to the parties respectively named required 25 therein; and before delivering the same, the Secretary-Treasurer shall require from the applicant, if not personally known to him as the person_ named in such certificate, an oath in the form of the Schedule C. which oath he is hereby authorised to administer.

V. The Secretary-Treasurer of each such local Municipality shall, on the Lists and cer-30 day previous to the day on which any poll is to commence for the election of tificates to be a Member of Legislative Assembly for the County of Argenteuil, transmit Returning to the Deputy Returning Officer for such Municipality, and when there shall Officers. be no Deputy Returning Officer for the local Municipality, then to the Deputy Returning Officer for the place in which such local Municipality 85 shall be included for election purposes, the list by him made of the qualified voters at such election, and shall indicate opposite the name of each person

to whom he shall have delivered a certificate of qualification, the fact of his having so done, and he shall also at the same time hand over to the Deputy Returning Officer the certificates unclaimed.

List sworn to be by the Secretary Treasurer. VI. The Secretary-Treasurer, on delivering the lists and certificates mentioned in the preceding section, shall accompany the same with an affidavit in the form of Schedule D. to be taken before any Justice of the Peace having jurisdiction in the Municipality.

An Oath may be demanded of an elector producing a certificate.

VII. The Deputy Returning Officer of each local Municipality shall, at any time during and before the close of the Poll, deliver to the parties claiming the same, the certificates delivered to him by the Secretary-Treasurer, but he 10 may (and shall if required by any candidate or elector) require from the applicant the oath mentioned in the Schedule E., which oath he or any candidate or elector may also require of any person voting upon a certificate not delivered to him by the Deputy Returning Officer.

Voter must deliver his certificate. VIII. No elector shall be allowed to vote at such election unless he 15 shall deliver his certificate of qualification to the Deputy Returning Officer, who shall cause the same to be numbered with the number set opposite to the vote of such elector on the Poll-book.

Deputy Returning Officer to make list and certificates part of his return. IX. It shall be the duty of the Deputy Returning Officer of each local Municipality to return after the election to the Returning Officer with his 20 Poll-books, and as forming part of his return, the list of electors handed to him by any Secretary-Treasurer, and also the certificates both of the electors who shall have voted at such election, and the certificates of those who shall not have claimed such certificates, indicating also on the said list those who shall have voted and those who did not vote at such 25 election, and the Returning Officer shall count no vote for which there shall be no corresponding certificate.

Oath to accompany Return.

X. The return of such Deputy, Returning Officer shall be accompanied by the oath mentioned in Schedule F. to be taken before any Justice of the Peace having jurisdiction in the Municipality.

Lists, &c., to be returned to Clerk of the Crown.

XI. The Returning Officer shall transmit to the Clerk in Chancery with his return, the Poll-books, lists and certificates he shall have received from his Deputies.

Penalty for contravening this Act.

XII. Any Secretary-Treasurer, Deputy Returning Officer, or Returning Officer who shall contravene this Act or fail to perform any duty 35 hereby required of him, shall thereby incur a penalty of pounds, and shall be further liable for all damages sustained by any person by reason of such contravention or failure.

Act 18 V., c. 8 to apply.

XIII. The Act passed in the eighteenth year of Her Majesty's Reign, chaptered eight, is hereby revived as regards the County of Argenteuil 40 and any election therein, and shall continue in force as regards the same until the first day of January 1858.

Duration of this Act.

XIV. This Act shall continue in force until the first day of January, 1858 and no longer.
