An Act respecting the Salisbury and Harvey Railway Company.

**W**HEREAS the Salisbury and Harvey Railway Company Preamble.  
has, by its petition, prayed that it be enacted as herein-  
after set forth, and it is expedient to grant the prayer of the  
said petition: Therefore Her Majesty, by and with the  
5 advise and consent of the Senate and House of Commons of  
Canada, enacts as follows:—

1. The Salisbury and Harvey Railway Company, herein- Lines of  
railway  
described.  
after called "the Company," may lay out, construct and  
operate branch lines of the gauge of four feet eight and one-  
10 half inches from the Company's line of railway, as follows:—  
(a.) from Turtle station in a southerly direction to Baltimore  
at or near the farm of Samuel Stevens, in the parish of  
Hillsborough, in the county of Albert:  
(b.) from Baltimore siding, in the parish of Hillsborough,  
15 in a north-easterly direction to the city of Moncton, in the  
county of Westmoreland:  
(c.) from Baltimore siding, in the parish of Hillsborough,  
in a south-westerly direction to a point at or near Watters'  
oil works in the parish of Hillsborough.
- 20 2. The Company may acquire and operate all or any part Acquisition  
of other  
railways.  
of the railways of the Harvey Branch Line Railway Company  
and the Alma and Harvey Railway Company, and also the  
capital stock, bonds, rights, franchises, powers, privileges and  
25 property, or any part thereof, of the said companies, in such  
manner and upon such terms and conditions as the directors  
deem expedient under the authority of the shareholders to  
them given at any special general meeting called for the  
purpose, at which meeting shareholders representing at least  
two-thirds in value of the subscribed stock of the Company  
30 are present or represented by proxy.
3. With respect to either of the railways so purchased, as Exercise of  
powers of  
companies  
acquired.  
well as all other rights, franchises, powers, privileges and  
property thereof acquired therewith, the Company may, in  
addition to all the rights, franchises, powers and privileges  
35 conferred upon the Company by *The Railway Act* and the  
special Acts relating to the Company, exercise all the rights,  
franchises, powers and privileges conferred upon the Harvey  
Branch Line Railway Company or the Alma and Harvey Rail-  
way Company, as the case may be, by any special Acts.
