




UPPER SCHOOL.

Boys are received into the Lower School if they are under fourteen years of age. There is no examination test on entrance. They are prepared for admission to the Upper School.

The building is limited in capacity, and applications for admission should be made early. The great success of this school for little boys, the first of its kind in Canada, has secured its being practically filled ever since its erection.

If the numbers continue to increase, the intention is to erect another building, so as to prevent the overcrowding of little boys, and to secure for them thorough supervision, and surroundings as nearly as possible like those of home.

Boys are admitted to the Upper School upon graduation from the Lower, or if they have attained to scholarship of about the same standard as High School entrance.

Two Scholarships of the value of \$50.00 each are offered for competition to new boys entering the Upper
