

## Household Notes.

How many housekeepers who do their own washing stand over a hot stove an hour or more cooking flour starch? Here's the way to make it without cooking: Mix the required amount of flour with just enough cold water to make a thick batter, then add enough boiling water to thin it, stirring it as you pour the hot water in. Be sure that the water is very hot or the starch will stick.

To shorten the tedious process of preparing fruit juice for jelly place a colander over a wide-mouthed bowl or crock; put the jelly bag containing the pulp in this, and gently force the juice through the bag with a potato-masher, instead of hanging it up to drain. This can be done with the fruit quite hot by filling the bag only about three-quarters full at a time; a slight twist at the top prevents the juice getting out and gives the worker a place to hold the bag steady.

To purify water: To a pitcher holding about a quart of water add a tiny pinch of alum—about as much as will go on the rounded point of a pen-knife. Stir the water well with a spoon, and then let it stand. In less than an hour you will see a deposit on the sides and bottom of the pitcher, consisting of the impurities the alum has carried down. Shake the pitcher, and the deposit will sink to the bottom, but the water should stand five or six hours before being decanted, when it will be quite clear and fit for drinking purposes.

A good way to satisfy the members of a family who do not care for the same kind of cake is this: Make a batch of cake batter which will make six loaves. From this put in two loaves the plain white dough, then what is left divide and put half in another dish. To one part can be added lemon, orange, or spices to flavor. To another can be added some bitter chocolate melted in hot water, making a nice chocolate cake, or one can add either currants which have been half cupful of cocoanut, thereby giving enough varieties of cake to last a week without extra labour.

This is a good way to clean buff or cream-colored window blinds: Begin by taking off any trimmings there may be, washing them in hot soapy water, then pressing them on the wrong side with a hot iron. Next bake some flour in a dish in the oven; lay the blind flat on the table, dust it with a clean cloth, then dip a piece of flannel in the flour, and rub the blind evenly with it. Take fresh flour and flannel when soiled. Polish the blinds with a clean, soft cloth, sew on the trimmings again, and replace it in the bay window. Green blinds that have faded may be made to look almost like new by brushing them over with some insect oil.

**Letter From Councillor Martin.**

We publish to-day a letter from Councillor Martin in reference to the discussion which has ensued from the proposed expropriation on Casey St. for the purpose of street widening. The application for repairs was made by Mr. G. Ayre, who is the agent of the property, the Council were not willing to grant permission on the ground that it considered this property should be expropriated for street widening. Councillor Martin, in this letter, as well as in an oral statement to us this morning, distinctly declares that the Councilors were fully aware that part of the property was his, and that he had asked them to decide one way or the other, as his tenants were pressing him for repairs. Now we have understood hitherto that Councillor Mullaly is not aware that the property belonged to Councillor Martin until he examined the plan at the meeting at which it was tabled. There appears to be some conflict of testimony on this matter and perhaps it will be cleared up to-night. If the fact is as Councillor Martin states it, that clears him of much of the adverse comment we made. For the rest, we hold the opinion that the public should be fully informed whenever it is found necessary to deal with any property of a Councillor, and that it is the moral duty of a Councillor to make such matters public.



Chinese Emperor Capitulates.

Special Evening Telegram.

PEKIN, To-Day.—The Throne surrendered to China's National Assembly and in compliance with the demands of the Assembly dismissed Sheng Hsuan Hual, Minister of Posts. The Throne has ordered Prince Chuan, President of the Cabinet, before the Board of Inquiry, where he doubtless will be severely dealt with, and released from custody the President of the Sze Chuen Provincial Assembly and other leaders in the riots at Cheng Tu. In fact the Throne has agreed to all the Assembly's demands, and the Emperor is believed to be ready to abdicate in favor of Yuan Shi Kai to the second office in the Cabinet, if not to the Premiership. With the prospect of Yuan Shi Kai, who is which would be ruled by the National Assembly, it is evident the Manchus mean to offer the people complete and irrevocable constitutional government in return for a cessation of hostilities. It is reported that Yuan is already negotiating with the rebels, who are old in experience of Chinese affairs, would not be surprised if the revolution is terminated on those lines and practically without further fighting.

Italian Reverse.

MALTA, To-Day.—The Italian reverse at Tripoli on October 23rd amounted almost to a rout. The Italian troops, during a reconnaissance encountered a Turkish outpost, which retreated. The Italians followed and found themselves being attacked on all sides. Three companies of Light Infantry were totally annihilated and several officers were made prisoners and mutilated. The remainder of the Italian force, carrying a great number of wounded, said by some of the officers to be 7000, caused intense excitement among the Arab population at Tripoli.

Fighting the Steel Trust

TRENTON, N.J., To-day.—The Government's suit to break up the Steel Trust has been heard in the Circuit Court. The Government asks not only for a dissolution of the Steel Corporation, but for the inclusion of every constituent or subsidizing company which are alleged to have combined in violation of the Sherman Law in order to maintain or attempt to maintain a monopoly of the Steel business.

Died in Boston.

A cablegram was received by Mrs. W. H. Bartlett last night bringing the sad news that her father, Mr. J. W. Moulton, had passed away while resting in Boston on his way to San Francisco with Mrs. Moulton to make their home with a son of theirs who is settled on a farm in prosperous circumstances. He had been writing to his parents for some time about the beauties of the country and the grand views of the coast, and inviting them to come out and live with him. About six weeks ago Mr. Moulton and his wife decided to take the trip. They had spent the winter in Boston, two of whom are married there, and their parents decided to spend a few weeks with them in order to break the journey and to see the sights of the old city. Miss Mabel Moulton, who was finishing a term for a Trained Nurse's examination at the General Hospital here, also intended to join the old people at Boston and go on with them to California. She passed the examination successfully this week, coming out of the hospital with her diploma and left for Boston by the express last evening. A few hours after her departure Mrs. W. H. Bartlett, Victoria St., received the telegram telling of the death of her father as the outcome of a paralytic stroke, with which he was visited a few days previously. Deceased was in his 80th year, was a fine type of the sturdy Newfoundland. He was Light House Keeper at Cape St. Vincent for several years and resigning the position 15 years ago was appointed to the Customs Service in St. John's. He was a native of Pouch Cove and had a large and highly respectable family of two sons and seven daughters, two married and two single in Boston, one married in California. Mrs. W. H. Bartlett and Miss C. L. March of this city, one son in British Columbia and 1 son in California. To them and the bereaved widow the Telegram extends its sympathy. It is likely that the body of the deceased will be brought home for interment.

A Queer Story.

An Appeal.

S. S. "Home" St. Belle Isle, Oct. 24th, 1911.

Editor Evening Telegram. Dear Sir:—I have just visited a portion of the Labrador side of the Straits of Belle Isle, traveling on foot from Lause-u-Loop to Blanc Sablon, and staying for short periods in each settlement between these points. The fishery along this portion of the coast has been almost a blank, and there is a famine in the land. Lause-u-Clair has been struck particularly hard. There are some eighteen families more than half of which are without the merest necessities of life for the winter. I spent a portion of Sunday the 22nd, there and found six whole families without any food whatsoever in the houses and without any means of obtaining. When I reached Blanc Sablon, I found fourteen of the families of Lause-u-Clair waiting for the S. S. Home in the harbor. They would be landed for them from this Government. They had waited there since Friday with little to eat and in sufficient sleeping accommodations. The S. S. Home arrived on Monday the disappointment of the men when it was found that the flour had not arrived cannot be described. Before leaving Lause-u-Clair, a Mr. James Dumaresque informed me that he had the care of six barrels of flour at Forteau and that if some one in authority would direct him to give it to the six families that had nothing in their homes, he would give it out. I need not say that I did not hesitate to assume the authority.

But it is not the purpose of this letter to give the details of the distress on this portion of the shore. The Government has the provisioning of the people in their mind and it is to be hoped that whatever is to be sent will be sent immediately. My object is to appeal for some clothing for the children. People that cannot buy flour cannot buy clothing. Socks, boots, mitts, etc., wear out, and require to be replaced. I am thinking that in the settlements I have indicated there will during the coming winter be a great number of children with bare feet and legs; little shivering bodies without drawers, vests or petticoats, necks and heads without caps or mufflers.

If people who have plenty will send to Mrs. Blackall, 23 Forest Road, some of these things, I will arrange for the distribution through teachers and others known to me. He that gives quickly, gives twice. Attach name and address of sender to each parcel. The steamer has just reached my destination, Battle Harbor, and so I must close.
