the other to Elder Robert Davis, each of them claiming to he considered the Old or First Baptist Church, .. the Committee accordingly met at Halifax, in the Old Beptist Chapel, on the 3rd, of Sept. last the day appointed. That previous to that period Mr. Davis had left this Country for Europe. that Mr. Burton and those of the Church who supported him, met the Committee, but that the other party, altho invited to attend, both by letter and personal application, refused to meet or recognise the Committee as a Council. Committee found Brother Burton and a large majority of the members of the Church, well affected to each other, as Minister and flock. And after obtaining all the information in their power, they were una rimously of opinion, that M. The Ministering Brethren and Messengers from the Churches, having mostly reached Vermouth on Saturday, the 20th June, meeting was given out for two o'clock in the afternoon of that day, when Br. Theodore Harding preached to a respectable congregation, from Ephes 4 chap., 8 ver. "When he ascended up on high, he led captivity captive, &c."

On Lord's day the 21st of June, Br. Green preached in the Lorning. Br. McLearn at 3 o'clock, and Br. Miles of New Brunswick, at 6 o'clock in the Evening.

Br. Sears the Messenger from New Brutswick preached at 6 o'clock in the Evening of Monday, 22d Jn. 3, after the Association and adjourned for the day; and on Tuesday 23rd-Br. Crawley preached at half-past 10 o'clock, previous to the commencement of business. The Discourses were appropriate, instructive and powerful, and we truly believe in the genatics free, Sovereign, and mysterious communication, and in its free, Sovereign, and mysterious communication, and in its fransforming and holy operations.—Br. Edward Harris preached at 6 o'clock in the Evening, after the final adjournment of the Association.

At the close of several of the Sermons, the hearts of many were made to overflow, by the affectionate and spiritual addresses, and exhortations, of the aged Fathers in the Ministry, who have so long laboured in the cause of their Divine Master through evil and good report; among them we may particularly mention the names of Hand! 7 Chipman, Maming, Harris Farding, Tueodore Harding, and Aneley. We ought not to omit the high gratification which the Brethren experienced from the kind and Christian reception, which they universally received from the Brethren in Varmor h. The members of that interesting Church, as well as the Community at large, vied with each other in evincing their brotherly regard and attention to the utmost of their power, and only appeared to regret that they could not do so, to a much greater extent. Their kindness will be long remembered. All were much pleased with the appearance of frugality, industry and improvement which so generally characterises the Society at Yarmouth .. the neatness and comfort which mark the domestic circle of the Inhabitants, of this thriving portion of our Province, cannot fail to make a most favourable impression on every stranger, who visits it; and above all, we rejoice to believe, that the late blessed revival of religion there, has been followed by the most happy and permanent effects, in an humble and corresponding spirit and deportment, in almost all who have professed to be partakers of it.

Several very important topics were discussed in public, or were subjects of interesting conversations among the Brethren, during the Association. The interest that all the Ministering Brethren, as well as others, took in the establishment and growth of our Infant Seminary at Horton, and in promoting other means of moral and religious improvement, as the most probable way of diffusing education and useful knowledge of every kind among the rising part of the Community, was highly gratifying; and we look forward with confidence to a cordial and permanent support from our Brethren throughout the Province, to enable us to take a respectable stand among the various denominations of the Country, in the work of training our youth to fill the various stations, which they are destined to occupy in this growing Colony, with ability and advantage to themselves and the public. The remarks contained in our circular Letter, outhe important subject of the culture of the youthful mind, will doubtless be read with much interest. Another subject, although not publicly discussed, appeared to have taken adeep hold on the minds of many of the Brethren; we allude to the alarming extent to which the Sin of Intemperance is growing among us-sapping the foundations of all moral and domestic comfort-rendering its wrethed votaries the objects of moral abhorrence, and the willing slaves of crime and misery, public and private—and plentifully sowing the seeds of death, temporal and eternal. Much has been done in the United States by Temperance Societies, and the exertion of pious and public spirited individuals, to check the ravages of this poisonous mouster, this destroyer of souls, in that Country , and awfully does it rest upon every Pastor, every Parent, and indeed on every Member of Society, by their united precept and example, to put a stop to this prevailing sin, and strive mightily to put away this "cursed thing" from among ton the kind and Christian reception, which they anity

First Clements.—This Church is increasing, and enjoys a good degree of union; although they have been obliged of late to exercise gospel discipline with some severity. They report that there are several who possess public and improving gifts, in the Church.

Necture.—There has been a most extensive and happy revival in this Church, in which One Hundred and Fifty one persons have been added to it by baptism. It commenced last Autumn, shortly after the Annual Meeting, and gradually increased during the Winter. Br. Ingraham Bill, from the First Cornwallis Church, who had been tor some time previously, preaching among them, was ordained to the Ministry, on the 4th, of March last, and called by the Church to labour with their present aged Pastor, the Revd. Handley Chipman. Thirty seven Members have been dismissed to form a separate Church in New Albany; and Forty-three, to form the New Aylesford Church. Br Bills' labours have been greatly blessed in this District.

Horlon.—The Prespects of this Church appear very cheering: There has been a considerable increase since last Association, and there is at present the appearance of a general awakening in the settlement, adjoining the Gaspereau River. Many young persons especially, seem deeply impressed with a sense of their eternal interests. There appears to be a very deep interest felt by the Church, for the welfare of our Infant Institution—and they speak in the most pleasing terms, of the worth and assiduity of Br. Chapin, the Teacher.

Clustes Cove, or Wilmot Mountain Church.—This is one of the Churches that have shared largely in the Outpouring of the Hely Spirit, during the period of the late Revival, in the Western parts of the Province. The Church, from being in a very low state, has been made a partaker in the work of sovereign Grace, in a wonder of degree. Having no stated Pastor they gave a call to Br. Richard W. Cunningham, a Member of the Church at Horton, who had been previously licenced to preach, and who has lately been ordained over this Church. His Ministry has been abundantly successful, and eighty persons have lately been baptised and joined the Church.

It is stated that the Administration of the Ordinance of Baptism, has been remarkably blessed to the spiritual good of many. Great union and harmony exist among the Members of the Church.

Granville Street, Halifax. Much comfort and refreshment is stated to have resulted from the Ordinances of God's House, and the deep-rooted prejudice, against Evangelical truth, and the Denomination, to be disappearing. They have greatly improved and enlarged one most important and interesting means of usefulness of late, in their Sunday School, in which two or three hundred children are taught the most essential truths of religion; and they arge its importance on the minds of their Brethren, as a system of beneficence, which has been abundantly owned of God, and blessed to the sa vation of souls.

Second Cornwallis.—Is in a very prosperous state, and much increased within the last year. Br. Manning being able to appropriate but a small portion of his time and labours to this branch of his charge, the Church by general consent, invited Br. William Chipman, who was a Deacon and Licentiate of the First Cornwallis Church, to labour among them 1 and he was on the 19th of March last, duly ordained and set over them as their Pastor:—his exertions have been blessed in building up and feeding the Church of Christ.

First Baptist Church, I Their Letter relates chiefly to the Halifax. Slate differences that have existed, and the transactions of the Committee appointed at the last Association, to visit the Church, and which happily so ar regulated their affairs, as to restore it to order, and fully to vindicate the character of their venerable and worthy Partor Elder Burton.

Brier Island. — This Church was formerly united with that of Digby Neck, and met in Association; but since its separation has not sent Delegates, owing to its distance and want of a stated Minister, as well as to the low state of religion in the Church. They at present appear to have greatly revived, and having Br. Bancroft ordained over them as a Pastor during the last year, there is great reason to trust, that they will hereafter keep their place among the Churches of Christ, and increase in the fruits of the spirit.

Aylesford. The establishment of this Church is one of the happy fruits of the late Revivals. A few scattered members of Nictaur Church, had previously resided in the District, but, as their letter expresses it, "a glorious work of Grace" commenced after the General Meeting in September last, and on the 4th of March, a Conneil having been called by the Nictaur Church, the Aylesford Church was constituted, and Br.

Dear Brethren, I was will and my apay lang add his The progress of true religion in the world, cannot but be an object of the deepest interest to every christian. He feels that the happiness of all the generations to come, how numerous or distant soever, is inseparably connected with it. Viewed on a great scale the pleasure derived from other sources than religion, are mere passing emotions. We can hardly think of them, and they are gone. They all perish in the very act of enjoyment. The advancement of human happiness- of that which alone deserves the name, must be sought in the advancement of true religion. It becomes an interesting inquiry, then, to know in what way this latter can chad throughout the Free de be most effectually secured?

And here we assume it, as too obvious to need confirmation that this great object is to be accomplished by the instrumenta-Lity of men, and by the use of means. We rejoice in believing, that the time has past never again to return, when the maxims of the professed followers of Christ, in reference to the Spread of the Gospel, shall be, let us stand still and do nothing, that God may have all the Glory. Some there may be who deem it we are constrained to add "by reason of the ignorance that is in them,"] an infringement of the doctrine of Divine Sovereignty to maintain the necessity of a diligent use of means. We trust, Brethren, for Christ's sake and the Gospel's, that this cannot be said of any of you; and that while you are careful, as becomes believers, to maintain good works, you will be equally careful to ascribe to the Sovereign Grace of God all the beneficial results of them.

e season of eing taught, is obvious to all. That such advantages should be improved is a dictate of common prudence and common sense. In all the earlier developments of its powers, the mind is more sensibly alive to new truths, the acquisition of knowledge is accompanied with a livelier satisfaction perhaps than at any subsequent period. Curiosity is excited, the attention is strongly fixed on its ofjects, the memory is deeply impressed, insomuch that the earliest impressions in defiance of all the vicissitudes of life, are the last to be effaced. Many a boary headed sire, who has forgotten the atchievements of his manhood, can tell when and where he was first taught to believe in the existence of a God . when it was first made plain to his infant understanding, that the sun which called him to his morning sports, and the moon, which poured her silver light about him, and the stars which walked the beavens in majestic silence, were all the productions of that great, wise, and good Being. Nor did the history of his own existence, his accountability to God, his moral condition, and future destiny, find a less welcome reception. With equal distinctness and equal pleasure, does he recollect, when it was first made clear to him, that man was at enmity with God, and must be reconciled by the cross of Christ: Never can he forget the time or place, when consequent upon this knowledge he first formed the solemn determination of seeking God for his portion.

How effectually are such scenes impressed on the mind! We may say, almost without a figure, that they are engraven by the finger of God, and can be effaced only with the destruction of the mind itself. Facts of this sort are too obvious to need proof, and too important to be passed over in silence. It is from these that our moralists and poets, who most excel in the knowledge of human nature, have so often reminded us that

It was doubtless a knowledge of these facts which led the wisest of men to say "train up a child in the way he should go, and when he is old he will not depart from it." Nor was it without a reference to the peculiar susceptibility of the opening mind, that the Apostle enjoins fathers to bring up their children in the "nurture and admonition of the Lord." Thus the precepts of man and of God, the accumulated experience and wisdom of all ages, urge the importance of giving early religious instructions to the young.

But how is this to be effected? We answer by the promotion of Sunday Schools, by private parental instruction, and by Christian example. In every village and neighbourhood, and especially in every place of worship, let the children be assembled for the purpose of reading and committing to memory prisons of Scripture; for hearing them explained in a familiar way, and for answering questions from some approved catechism. Let pious teachers study to make the great truths of religion plain to their understandings and interesting to their hearts. An hour or two on each Sabbath spent in this way, will be to the young and susceptible mind, what the early rain is to the tender grass. But if any obstacle prevents the children from being thus assembled, let the parents employ a part of the Holy Day in teaching them at home. Very few Christian parents can plead inability to perform this duty. The few books which might be needful, are in almost every one's hands. or if not, they may be obtained either by a mere application for them, or at a very moderate price.

Such an exercise will be scarcely less useful to the parent, than to the child. He will find his own religious feelings awakened, his knowledge of Divine truth enlarged, his facility in importing knowledge, and his pleasure in reading the Scriptures, greatly increased. To his own soul, if he sets about the duty in the fear of God, such an exercise will be refreshing as the dews upon the Mountains of Israel. There seems to be a peculiar fitness in this kind of instruction. As the young mind begins to feel the consciousness of knowledge, and to glow with the desire of learning, to whom does it so naturally look for instruction as to the parent? What less sons will be so grateful, or received with such implicit confidence, as those which fall from parental lips.

It scarcely need be remarked that precept must be enforced by example. Example is one of the most efficient modes of teaching. It addresses itself with peculiar force to the imitative propensity, so remarkable in Children. Nor is it less influential with reason and reflection in riper years. As, it is incumbent on every Christian to walk worthy of his vocation, as it is especially incumbent on every Christian Parent to set before his children and family an example, worthy of imitation to leave it with them as a rich legacy, by which they shall profit long after the parent has been gathered to his fathers.

Do we want encouragement and motives to make a vigorous effort? Look at the manifest tendency of such instruction. It has many results in common with Education, in general, such as the acquisition of useful knowledge, the improvement and discipline of the mind, the formation of character, and the like. In this respect its vast importance to the well-being of individuals and the community, is obvious. It is a useful auxiliary to Education in general. So, on the other hand, general Education is highly favourable to this. They bland beautifully together, each in turn becoming the handmaid of the other, and both conspiring to secure the noblest result of intellectual and religious teaching.

But early religious instruction has some results peculiar to itself. It informs the conscience; it fixes in the mind those great principles of right and wrong; -of duty to God and to man, connected as they are with time and eternity. in such a manner, that they are seldom eradicated. It may not immediately produce the effects which we so much desire - a real conversion of the heart to God, yet it seldom fails to exert a powerful restraining influence. In the hour of temptation, those instructions form an invisible shield to quench the fiery dart of the tempter; or if this should not be fully effected, how often do they lend to conscience a weight of authority and rebuke, which are irresistible? How many and how affecting are the instances in which a disobedient son after years of profligate indulgence, has, at length, been arrested by a mother's warnings and a mother's prayers, and brought in deep contrition to the foot of the cross? With what heartfelt gratitude does he take up the long-neglected Bible which was presented with many benedictions as a token of parental love? From instances of this sort [and they are many] let parents learn to "cast their bread upon the waters," trusting that it will there be found again "after many days." "In the mouning sow thy seed, and in the evening withhold not thy hand, for thou knowest not whether shall prosper either this or that, or whether they both shall be alike good." On whom, Brethren, devolves this momentous charge, if not on us? Who will interest themselves in teaching the rising generation the way of life if we do not? And if the rising generation is not taught, what a moral desolation do we leave behind us? I say unless God should avert it by miracles, what a moral desolation must the world soon present? What excuse can we offer for neglecting so manifest and so important a duty? One in which ourselves and our posterity, the world at large and especially the Church of Christ is so deeply concerned? Is it not high time to awake out of sleep, to look abroad on the growing interests of the Redeemer's Kingdom, to consult in earnest for its more rapid advancement and gird ourselves for the work ? a balwood to have to notion and all all

Are you a parent, a christian parent? Do the retributions of eternity ever rest with solemnity on your mind, and bring you to the throne of grace on behalf of your beloved offspring? And is it possible, that you can neglect those instructions which alone can make wise unto salvation? O unnatural father! O more than unnatural mother! Tell it not in Gath. What must be your reflection in a dying hour? Could the faultering tongue still give utterance to the emotions of an agonizing heart, what arguments, what entreaties, what expostulations, should we have in favour of teaching the young the fear of the Lord! The Managing Committee of the Baptist Education Society, beg leave to state, that very shortly after the last Meeting of the Board, the Agents appointed to solicit subscriptions in various parts of this and the adjoining Province, proceeded on their respective circuits, and from time to time made their reports to the Committee.

Fhat it appears from such reports that about the sum of £1100 was promised to be contributed, towards the funds of the Society; but that few collections have as yet been

ting with the General Society.

That the Managing Committee have purchased in the centre of Horton, almost adjoining the Baptist Meeting House, a most eligible situation for the Buildings, intended to be erected for the purposes of the Institution. That the premises contain Fifty Acres of Upland, and Fourteen Acres of excellent Dyke; for which they have paid Logo, having borrowed the money, and given their personal security for the Amount, payable with interest, but that the rents arising from the premises, are about equal to the interest on the purchase money. That there are two dwelling houses, and other small buildings on the premises.

That the Committee have procured the Rev. Asahel Chapin, a gentleman from Amherst College, in Massachusetts, who has engaged to conduct the Seminary for a year; and that they have opened the Institution, and commenced teaching in the principal Dwelling house, on the Premises, which has undergone some repairs for that purpose, and that there are now about Fifty young persons of various ages, receiving the benefits of Education, with every prospect of a rapid

increase iu numbers.

That the Committee have fixed the rates of Tuition, at four pounds per annum, for the usual branches of English education, and the necessary sciences, and five pounds per annum for such branches with the addition of the Greek and Latin Classics, and as it is found requisite to have an introductory School for the separate instruction of the younger children, the Committee have fixed the rate of such instruction, at three pounds per annum.

That the Committee during the last Session of the House of Assembly, made application on behalf of the Society for Legislative aid, towards the necessary buildings, and the general objects of the Institution, and that a vote passed the House of Assembly almost unanimously granting that sum; but that His

Majesty's Council having refused to concur in such vote, the Committee failed in obtaining their object; but that they have much reason to hope, that they may meet with better success, at the next Session of the General Assembly.

We have fixed on Horton as the place best adapted, from its local advantages, for the scite of an Academy; being easily accessible by land or water to both Provinces. We have purchased a most eligible situation, and have procured from Amherst College in Massachusetts, Mr. Asahel Chapin, a Baptist brother of competent qualifications, and earnest piety and zeal, as well as of unblemished reputation, to conduct for the present our infant Seminary. It was opened on the first of May last, and there are now about Fifty youths of various ages, receiving instruction, with the most flattering

prospects of a rapid increase in numbers.

It is our intention with as little delay as possible, to erect a Building for the Seminary, on as extensive a scale as our means will admit; and we have the greatest reason to trust that with the blessing of the Most High, our attempts will ere long, prosper far beyond what we at first anticipated. We
