their experience. At all events, they should not lose temper over the ADVANCE'S making reference to the town being "the usual police service." They don't do so, in view of the too apparent consequences of their peculiar management.

As for the committee's "night patrol" its origin was a place in the "New-Brunswick" provided for a police committee and policeman and the committee's duties do not seem to extend in the direction of its merging itself into a "night patrol" committee and men maintaining what is really a semi-private service, under the high-sounding military title of "night patrol." What the ratepayers want and have a right to expect is the usual police service. They don't think it necessary to ignore dozens of good men belonging to Miramichi, and have time wasted in "correspondence and negotiations" with outsiders, but to a bit more intelligent, efficient or deserving than people at home.

The committee's writer says that the proposition to have the committee "use the assistance of the rate-payers in the 'difficulties that surround such duties,' originated in a large hall." We beg to suggest that it didn't require "a large hall" to originate the idea, but that the originators of the "difficulties" with which the committee concerned themselves to be evicted from it, and that the "difficulties" were not so great as the committee would have us believe. There is said to be a sad muddle in the "big hall" as to the position of the well developed in the case of the writer of the committee's rejoinder of Saturday.

"Big Hall" was evidently responsible for the gigantic proportion of the committee's indignation to assume; "big hall" caused the two policemen which Chatham usually has, to be referred to no less than six different times as "forces" and "armies" and that converted the good, old-fashioned term, night-watchmen into a "night patrol." Let our readers imagine a "night patrol" composed of one constable, by the name of "army" and the "force" of two men marshalled by the same officers. It reminds one of the old Irishman who, during the Crimean war, marched into camp with four brass bands and a regiment of musketeers. The committee's writer, who is asked by his colonel how he has contrived to escape them, he said "I jabsed, I surrendered 'em." It would be as difficult for the "night patrol" to succeed where the committee, especially if the "big hall" with which that body's writer is afflicted has communicated itself to his mates.

Seriously, we hope the committee will endeavor to engage two policemen for their own use, and put a stop to the present "correspondence" and "negotiations" which are the cause of their own predecessors and other exhibitions of childishness and incapacity for the duties devolving upon them. To express it in their own words, we would say that the committee is not able to grapple efficiently with the matter they might call a public meeting of the ratepayers who would be willing to assist them.

We did not anticipate that our reference to the subject would cause the committee to display bad temper, as they did in their rejoinder of Saturday, for our sole purpose was to awaken them to greater activity in the performance of their duties, and have not been thrust upon them against their will, but are connected with the position which each of them has sought.

The committee goes out of its way to reflect upon the "producers'" management, but that kind of rejoinder is to be expected, when their own has been a failure, so far. It may be said that this is the first time, since it was laid down by the committee, that a police committee, that has been for weeks without one, that is in favor of past management and a reflection on the present.

Such a condition of things seems the more anomalous when the committee say they are showing correspondence that has been going on since January, to prove that they have been conducting "negotiations to obtain a force" that could be relied on, and that would "meet the requirements of the situation"—whatever that may mean.
