## B I L L.

An Act to divide the County of Rimouski into two  
Districts for the Registration of Deeds:

**W**HEREAS the County of Rimouski is inconveniently large for Registration purposes: Be it therefore enacted, &c. Preamble.

And it is hereby enacted by the authority of the same,

5 That upon from and after the                      day of  
next after the passing of this Act, the county of Rimouski,  
shall for all the purposes of the Ordinance and Acts  
relative to the Registration of Deeds and other documents  
affecting real property in Lower Canada, be divided into  
10 two Registration Districts, the first of which shall include  
and consist of the Parishes of Rivière du Loup, St. Ar-  
sème, St. George de Kakouna, Isle Verte, St. Eloi and Trois  
Pistoles, with the Townships of Whitworth and Viger,  
and the Registry Office of the said Registration District  
15 shall be kept in the Parish of St. Jean Baptiste de l'Isle  
Verte, and a Registrar may be appointed at any time  
after the passing of this Act for the said Registration  
District, to enter upon the functions of his office on the  
said                      day of                      ; and the second Re-  
20 gistration District of the said County shall include and  
consist of all that part of the said County not included in  
the first Registration District, and the Registry office  
thereof shall be kept at Rimouski, where that for the  
whole county is now kept, and the Registrar now appoint-  
25 ed for the County shall, without any new appointment, be  
the Registrar of and for the said second Registration  
District.

II. And be it enacted, That for and notwithstanding  
anything to the contrary in any Act or law, the present  
30 Registrar or Deputy Registrar of the County of Rimouski  
may, if he be a Notary Public and be appointed Re-  
gistrar or Deputy Registrar of either of the Registration  
Districts in the said County, hold the office to which he  
may be so appointed, and at the same time practise as a  
35 Notary Public.
