








He felt no doubt that it would then be easy to prove her complicity in Savage's marderous design; in which case she must be condemned to death, and thus the life of the Queen, the security of the Protestant religion and the peace of the country would no longer be endargered, as it must

needs be, so long as the breath was in that woman's body. In this opinion-that the death of

the Opeen of Scots was necessary for the welfare of the Sovereign and the State, all the courtiers who were present coincided, to Elizabeth's egident gratification; although she thought good to protest at nothing would induce her to sign the death warrant of ber rival. 
