

The Rev. J. H. McCollum, M.A., presented and read the following Report of the Committee appointed to examine the Certificates of Lay Representatives, and moved, seconded by the Lay Secretary, that the same be adopted:

The Committee appointed by the Executive Committee to meet before the assembling of the Synod and examine the Certificates of the Lay Representatives beg to present their Report:

They find the Certificates from the following Parishes correct, viz. :

- 1. The Church of the Ascension, Canon Baldwin Memorial Church, Toronto.
- 2. The Certificate from the Parish of Charleston and Cataract.
- 3. The Certificate from the Parish of West Mono.
- 4. The Certificate from the Parish of Atherley and Beaverton.

The Committee would suggest that in case there be a Church edifice in the Parish or Mission, the name of such Church should be inserted in the certificate, as well as the name of the Parish or Mission.

The Committee hand in a list of Members of Synod, corrected up to the present time.

## BISHOP'S ADDRESS.

The Lord Bishop then delivered the following Address :---

REVEREND BRETHREN, AND BRETHREN OF THE LAITY,-On the 3rd of January last, I addressed to the Chairman of the Executive Committee of the Diocese, the following letter:

"It is, I believe, generally known that a Conference of the Bishops of the Anglican Communion is to be held at Lambeth palace, in the month of July next. The invitation to this Conference from His Grace the Archbishop of Canterbury, I have

felt it my duty to accept; because no one, I conceive, blessed with the needful health and strength, should decline such a duty; and, as respects myself, I could not wilfully lose the opportunity of gaining the instruction and the benefit which such a meeting of prelates from every quarter of the world is calculated to impart.

"But the purpose to carry out this intention, added to the desire of spending a few months in the older world, involves anxieties and responsibilities to which I cannot allow myself to be indifferent. At the advanced age which, by God's good Providence, I have been permitted to reach, I cannot restrain the feeling that my time for active and efficient work in God's Church cannot be long; and contemplating the need, perhaps, of early aid in the duties assigned to me, I cannot but feel strongly the duty of having this aid supplied during the term of absence from the Diccese which it is my desire to have.

"The obligation, then, of securing this aid without delay, forces itself upon me; and so 1 nust request that the Executive Committee of the Synod of the Diocese be summened at the enricest convenient period to make arrangements for a meeting of the Synod to give consent to the election of a Coadjutor Bishop; and if such assent shall be given, to proceed forthwith to such election."

I have fixed the time of this meeting with a view to the requirements of the case, and to the general convenience of the members of the Synod. I felt it necessary not to be later, if I were to be secured in the benefit of a Coadjutor before the time arrived for leaving the country. Some time must necessarily elapse between the election and the Consecration; and to meet the convenience of my brother prelates in the Province, the latter could not be delayed 'beyoud the last week in April.

The Metropolitan informs me that he has made his arrangements for leaving for England in the first week of May; and some of the others, I understand, intend leaving during the same month. The convenience of members of the Synod has also been consulted in making the present meeting take place during a week in which the Quarterly Meetings of the Committees of Synod are held.

There is not, as you are aware, any provision made for a stipend to a Condjutor Bishop; nor, in the mother country, in the case of the kindred office of Suffragan Bishop, does any provision exist. There, the Suffragan is permitted to hold his ecclesiastical preferments; and here, a Condjutor Bishop is not restrained from doing the same. Any compensation beyond, is a matter for private arrangement between him and the Bishop under whom he acts.

While upon this point I shall be excused, I feel assured, for making a brief reference to the position of the future Bishop of this Diocese as respects his means of support. When I inform you that, in my own case, one-flith of the whole episcopal income is absorbed by house-rent and taxes. I shall be excused, I trust, for pressing upon the Synod the benefit and the need of providing, as early as possible, a suitable episcopal residence. And if a Committee were, at this meeting, appointed to take into immediate consideration and report upon it to the Synod at its meeting in June next, means might then promptly be taken to secure to the Diocese a boon so essential.

As I have nothing more, pertinent to the occasion, to say, I shall only add, in the words of my revered predecessor, when he was called upon to address you as I am doing now, "Come, I pray you, brethren, to the exercise of this responsibility and solemn trust, with singleness of purpose, with unbiassed minds, with calm and thoughtful feelings. Ask earnestly for heavenly direction before you enter upon this sacred duty; regard as a first obligation the welfare of God's Church; and act as you think will most promote its growth, and purity, and expansion in this land."

It was then moved by Mr. Chancellor Harman, seconded by Ven. Archdeacon Wilson,

That his Lordship the Bishop, having signified in writing his desire that a coadjutor Bishop should be elected, this Synod declares that the election of such coadjutor Bishop is desirable and necessary.

Mr. Clarke C mble moved the following amendment :---

"The Synod of Toronto, assembled by direction of his Lordship the Bishop, would record their gratification at the announcement that he intends to be present at Lambeth and represent the Diocese at the meeting of the Pan-Anglican Synod in June next, and they earnestly pray that the Almighty Disposer of all things may direct the consultations of the assembled prelates of the Protestant Episcopal Church throughout the world to the good of that Church and the advancement of Hiskingdom. They trust that the rest which his Lordship is seeking by a lengthened sojourn in Europe may be blessed to him in a thorough restoration of his health, and that he may return to us in renewed health and vigour, and they would most respectfully urge his Lordship to make the necessary arrangements to have the affairs of his Diocese administered during his absence by his Commissary duly appointed."

His Lordship ruled Mr. Gamble's motion out of order, as not being strictly an amendment.

After a short discussion it was moved in amendment by Mr. A. H. Campbell, seconded by Rev. S. W. Young :--

"That until provision has been made by this Synod for the payment of a salary of at least \$2,400 per annum to the clergyman who may be elected Condjutor Bishop, this Synod is not in a position to proceed with such election."

Moved in amendment to the above by Mr. C. J. Blomfield, seconded by Mr. Kivas Tully:--

"That in order to carry out the wishes of his Lordship the Bishop, as signified in his address, further consideration of this question be deferred until the regular meeting of the Synod, and that a committee be appointed to draft a plan and provide funds for the salary of such Condjutor, to be submitted to the Synod at its next session."

Col. Boulton suggested—

"That provision be made for the support of the Suffragan Bishop by an assessment upon the Diocese for the sum of £600."

Moved by the Chancellor, seconded by the Clerical Secretary-

"That there be an evening session."-Carried.

## EVENING SESSION.

The Synod re-assembled in St. James's School House at 8 o'clock.

After a long discussion the Clerical Secretary read Mr. Blomfield's amendment, which was put to the Meeting and declared lost.

Lieut.-Col. G. T. Denison moved a third amendment, seconded by Mr. J. Fletcher Cross, which read as follows :---

"That in view of the announcement made by his Lordship the Bishop that he had determined to give up his endowment fund on 1st July, 1879, this Synod considers it advisable to postpone the appointment of a Coadjutor Bishop until after the 1st of July, 1879."

This amendment was ruled out of order.

Lieut.-Col. Denison proceeded to move a fourth amendment to the effect that in view of the generous offer of the Clergy to devote ouetenth or one-twentieth of their incomes towards the support of a Coadjutor Bishop, the Synod adjourn for a fortnight in order to take advantage of that generous offer.

The amendment dropped, having found no seconder.

Mr. A. H. Campbell's amendment to the original motion was then read by the Clerical Secretary, and on demand of the mover, a vote was taken thereon by orders, which resulted as follows:

The Registrar said that as the total clerical vote—seventy-two—did not represent two-thirds of the clergy on the list as present and voting, the number necessary for a choice would be two thirds of 72, viz :—48. The lay vote necessary for a choice was 42. The ballot therefore resulted in the election of Ven. Archdencon Whitaker, inasmuch as he had received the number of clerical and lay votes required for that purpose.

#### AN APPEAL.

Mr. J. K. Kerr arose and said, that before the election of Ven. Archdeacon Whitaker was confirmed, he desired to record an appeal against against it.

Mr. Chancellor Harman said any appeal against the election should be put in writing, and presented to the Bishop.

Mr. Kerr replied that in accordance with the rules of the Synod, he would present the appeal in writing, which he did. The document was signed by Mr. Kerr, and read as follows :--

I appeal against the election of Archdencon Whitaker, and against his being declared elected Suffragan or Condjutor Bishop of this Diocese, because two-thirds of the clergy entitled to vote were not present and did not vote, and that the Canon haw provides that unless two-thirds of the clergy entitled to vote be present and vote. and two-thirds of the parishes entitled to vote be represented, two-thirds of the votes of each order shall be necessary to determine the choice, and that Archdencon Whitaker has not received two-thirds of the votes of each Order.

A consultation ensued between the Bishop and Mr. Chancellor Harman, besides other members of the Synod. It lasted for about ten minutes, when—

Mr. Harman said, that he was desired by his Lordship to state, that he would give his decision on the appeal at 10.30 in the morning, to which hour the Synod was adjourned. If his Lordship's opinion upheld the appeal another ballot for the election of a Coadjutor would be immediately proceeded with.

The Synod accordingly adjourned until Thursday morning at 10.30.

## THIRD DAY.

## THURSDAY, 14TH FEBRUARY, 1878.

The Synod met in St. James's Cathedral, at 9.30 a.m. Morning prayer was said by Rev. C. R. Bell, Mus. Bac.

The Bishop then delivered his ruling on Mr. J. K. Kerr's protest, as follows :---

#### RULING ON THE PROTEST TO THE FIFTH BALLOT.

"I appeal against the election of Archdencon Whitaker, and against his being declared elected Suffragan or Co-adjutor Bishop of this Diocese, because two-thirds of the clergy entitled to vote were not present and did not vote; and that the Canon law provides that unless two thirds of the clergy entitled to vote be present and vote and two-thirds of the parishes entitled to vote be represented, two-thirds of the votes of each Order shall be necessary to determine the choice, and that Archdencon Whitaker has not received two-thirds of the votes of each Order."

## J. K. KERR.

The wording of the Canon regulating the voting is given for clearness, in considering the same, as follows:—

"In the election of a Bishop to a vacant See, or to a new See, the Clergy and Laity shall vote separately by ballot; the Clergy by individuals, and the Laity by parishes. A majority of votes in each order shall determine the choice, provided that two-thirds of the Clergy entitled to vote be present and vote, and that twothirds of the parishes entitled to vote be represented and vote; otherwise twothirds of the votes of each order shall be necessary to determine the choice.

See Digest of Canons, page 152 and page 294.

It will be seen from the above—

(1) That in the case of the Clerical Vote there were not at the time two-thirds of the Clergy entitled to vote present and voting, but that more than two-thirds of those present and voting voted for Archdencon Whitaker.

(2) That in the case of the Lay Vote there were at the time two-thirds of the Parishes entitled to vote present and voting, and that in this case more than a majority of the Parishes so represented and voting, voted for Archdeacon Whitaker.

Taken separately, therefore, the conditions of the Canon were fully complied with, and the Archdeacon received the required vote of each order.

The latter part of the Canon, (which to say the least is ambiguously worded) seems to require that, if in either case there are not two-thirds present and voting, then a two-thirds vote of each order shall be necessary; and under this latter provision, the Lay vote, fully sufficient when considered separately as above, when controlled, under the circumstances, by the Clerical vote, fully sufficient under *all* circumstances, must be held to require to reach, like the Clerical, two-thirds of these entitled to vote and voting.

The words entitled to vote and voting, are important in the consideration of the case, as several elergymen, including the Bishop, the Dean, Archdeacon Whitaker, and others were present without voting, and may have brought up the number of Clergymen present to the number of two-thirds of those entitled to vote, if the words present be taken apart from the additional words and voting.

Under these circumstances it will be necessary to proceed to another ballot.

The Registrar, then, at the request of his Lordship, read the following :---

The Rev. Arthur Henry Baldwin, rather than continue any longer even a passive occasion of the protracted struggle that this Synod has witnessed during this day, has begged the permission of his Lordship the Bishop, to make known to the Synod, through the Registrar of the Diocese, his desire that no vote may hereafter be recorded in his favour.

I therefore pronounce this meeting of the Synod to be adjourned.

The Benediction was then pronounced by his Lordship, and the Synod adjourned.

## Proceedings of Synod Committees.

AUGUST AND NOVEMBER, 1877, AND FEBRUARY, 1878.

The Regular Quarterly Meetings of the Standing Committees of the Synod of the Diocese of Toronto, were held at the Synod Office, Toronto, on Thursday and Friday, August 9th and 10th, 1877.

## Executive Committee.

Present.—The Archdeacon of York (appointed Chairman for the current year), the Archdeacon of Peterborough, Rural Dean Stewart, Revds. C. C. Johnson, Richard Harrison, Wm. Logan, J. H. McCollum, and A. J. Fidler. Colonel Boulton, Dr. O'Reilly, Dr. Snelling, Messrs. C. J. Campbell, Clarke Gamble, and Marcellus Crombie.

Resolved—That Mr. Clarke Gamble and Dr. Snelling be a Sub-Committee to prepare a Bill, in re Roctory Lands Act, for the next Session of the Ontario Legislature, and to give the necessary notice thereof, and to report the same to the next meeting of this Committee.

Resolved—That the Committee observe with much satisfaction and pleasure that the Journal of the last session of the Synod of this Diocese is printed and on the table at this, the Committee's first meeting.

#### Commutation Trust Committee.

Present.—The Rev. Dr. Lett (appointed Chairman for the current year), Revds. W. W. Bates, W. R. Forster, John Davidson. C. W. Paterson, A. J. Broughall, and Isaac Middleton. Messrs. Peter Paterson, Clarke Gamble, and R. Snelling.

Letter having been read from the Lord Bishop in reference to the case of the Rev. S. Briggs, and suggesting a reconsideration of his case :--

Resolved—That the Chairman be authorized to reply to the letter of his Lordship the Bishop, now read, referring to the Rev. S. Briggs's case, informing the Bishop that it is quite impossible for the Committee to interfere in behalf of the above elergyman in view of the Canon on the Commutation Trust Surplus.

Letter was read from the Standard Life Assurance Company claiming re-payment of \$569 on account of premiums on the Life Policy of the late Hon. J. H. Cameron, whose age has been proved to have been one year more than was represented.

Resolved-That the claim of the Standard Life Assurance Company on the Synod for the refund of §569, in the matter of Mr. Cameron's Life Policy, be admitted and paid.

Resolved—That the Secretary be empowered to pay to the Diocese of Niagara the sum of \$5000 on account of the moneys coming to said Diocese from the proceeds of the late Mr. Cameron's Life Policies.

In regard to proceedings in the Court of Chancery to prove the Synod's claim against the estate of the late Hon. J. H. Cameron, the decision of the matter was left with the Sub-Committee of Management.

Resolved—That the Sub-Committee be authorized to place one more name on the Pay List.

#### Land and Investment Committee.

Present.—Rev. Canon Brent (appointed Chairman for the current year) Revds. Wm. Logan and W. H. Clarke; Judge Scott, Capt. Wheeler, F. Farncomb, J. O. Browne, and S. B. Harman. Pine Grove Parsonage.—The Vestry having again applied for the \$500, (proceeds of the sale of the old parsonage) in the hands of the Synod and expressed dissatisfaction at the money being withheld, the Secretary was instructed to state that the Committee cannot take any action in the matter other than that previously indicated, viz., to pay over the money for the purchase of a new parsonage property, provided the land be vested in the Synod in accordance with the original trust; that the Synod has no power to Mortgage; and that if the Parish can suggest any plan for overcoming the difficulty in which they are placed, the Committee will carry it out.

Barrie Church Lot-One-fourth of an acre deeded to the late Church Society in trust for the support of a clergyman's son at Upper Canada College.

The church at Barrie having been built on one-half of this lot, the other half having been sold for taxes some years ago, application was made by the Vestry of Trinity Church, Barrie, to have a conveyance of the one-half in order to perfect the title to their church lot. Satisfactory evidence as to the value of the land having been furnished, the Committee agreed to a sale for \$200 cash.

Cartwright Endowment.—Lot 14, Con. 5, (190 acres,) and Lot S.  $\frac{1}{2}$  11, Con. 1, (100 acres).

The Rev. J Creighton appeared before the Committee with the tenders which had been sent in to the Incumbent and churchwardens for the purchase of these lots.

The Committee having opened and examined the tenders, it was *Ordered*—That Lot S  $\frac{1}{2}$  11, Con. 1, Cartwright (100 acres) be offered to Robert Hall for \$2,125. *Also*—That 190 acres of Lot 14, Con. 5, Cartwright, be offered to James Y. Mc-Laughlin for \$3,400, payable \$1,000 cash and the balance in fifteen annual instalments with interest at six per cent.

Resolved—That, referring to the Memorial of the Rev. William Logan presented to the Land Committee in Feb. 1873 and praying to be recompensed for his outlay in erecting a barn and other out-buildings and in putting the lands into their then productive state, the sum of \$200 be paid to Mr. Logan for a barn and other improvements made on Lot 14, Con. 5 Cartwright, the sale of which to Mr. McLaughlin is authorized as above.

A Sub-Committee was appointed to look after the investments during the current year, and sundry applications regarding the leasing and selling of land were considered and settled.

## Mission Board.

Present.—The Lord Bishop in the chair; the Archdeacons of York and Peterborough; Rural Deans Givins, Stewart, Allen, and Cole; Canon Morgan, Revs. L. H. Kirkby, Dr. Hodgkin, F. Burt, and I. Middleton. Alderman Boswell, Major Bligh, Clarke Gamble, J. C. Morgan, T. A. Agar, and A. R. Gordon.

A guarantee for \$75, from Sharon for one year, was received and accepted by the Board.

Communications in regard to the proposed reduction of grants were received from Woodbridge, Bradford, and North Orillia and Medonte.

Applications for aid were received from Ashburnham and Otonabee, and Apsley.

Resolved—That the proposed reduction of the grant to the Mission of Woodbridge be postponed until the next meeting of the Board, and that in the meantime the Deanery Committee on Missions be directed by his Lordship to make the necessary inquiries as to the feasibility of attaching some out-station to Woodbridge, thus enabling them to bear the proposed reduction.

In reference to North Orillia and Medonte, the following minute was-made, viz.: That mission was placed in Schedule B., after due consideration of all the circum-

stunces of the case, and the grant-in-aid was reduced \$50, as a station recently opened, which is said to be very promising, is estimated to contribute not less than that amount for the support of the missionary, which sum was not taken into account when the guarantees were renewed.

The application from Ashburnham and Otonabee was deferred for future consideration.

Resolved-That an addition of \$200 be made to the annual grant at present given to the mission of Apsley, to date from first of July last.

Resolved-That a grant of \$200 per annum be made to the support of a mission in West Brock, comprehending Sunderland.

Resolved—That the Secretary-Treasurer be instructed to write to the Churchwardens of the congregations in the mission of West Mulmur, calling their attention to the necessity for their giving bonds for the payment of the salary of their minister,

The Rev. Rural Dean Cooper having addressed a letter to the Board calling at tention to the fact that an unfair burden is laid upon the Mission Fund by reason of the receipts from Parochial Guarantees being assessed on account of Synod expenses, it was *Resolved*—That the Mission Board represent to the Synod of the Diocese that the Board is not justly liable to be assessed for the expenses of management of the funds paid in under guarantees from the several missions, as these funds form no part of the income of the Board; and the Mission Board respectfully request the Synod to recognize this, their exemption from liability to assessment and to instruct the Secretary—Treasurer accordingly.

Resolved—That the Committee appointed in August, 1875, to estimate what amount may reasonably be expected from each mission and congregation for the support of the missionary work in the Diocese, be re-appointed, and that the following members of this Board do constitute such Committee, to report on or before the 25th of September next:—The Archdencon of York, Rural Deans Givins, Stewart and Cole, and Messrs.C. J. Blomfield and A. R. Gordon,

A Sub-Committee was appointed to examine the accounts of the Rev. R. Hill in connection with the building of the Mission House at Shequaindah. Manitoulin Island the balance claimed by Mc. Hill to be paid him on the certificate of such Sub-Committee.

#### Widows and Orphans' Fund, and Theological Students' Fund Committee

Present.--Rev. Rural Dean Cooper (appointed Chairman for the current year), Revds. J. S. Baker and Canon Tremayne; Capt. Blain, Messrs VanKoughne. and Agar.

The Chairman was requested to draw up a statement of the W. & O. Fund, and send the same to each paris' before the October collection.

Mr Avant was placed on the Divinity Students' Fund as an Exhibitioner for the usual amount, commencing on the 1st of October next.

#### General Purposes Fund, Statistics, and Assessment Committee.

Present.—Marcellus Crombie, Esq. (appointed Chairman for the current year, Revds. John Vicars, S. J. Boddy, R. W. Hindes, W. H. Wadleigh and Thomas Ball; Dr. Langstaff, Alderman Boswell, Nessrs. S. W. Farrell, John Catto, and Elmes Henderson.

A letter was read from the Bishop of Niagara asking for a grant from the Burnside Bequest in aid of the building fund of the church now in course of erection on the sixth line of West Garafraxa. The Committee postponed consideration of the matter till next meeting.

A grant of \$50 was made in aid of the new church at Harwood, Mission of Gore's Landing; and a similar amount in aid of the new church at Allenwood (Craighurst Mission,) payable as soon as the church is so far finished as to admit of service being regularly held in it.

#### ON SUNDAY SCHOOL CONVENTION, PETERBOROUGH.

The Committee arranged preliminaries, with a view to an adjourned meeting to be held at Port Hope, in St. John's Church School House, on Tuesday, the 4th September, at 11 o'clock.

The Regular Quarterly Meetings of the Standing Committees of the Synod of the Diocese of Toronto were held at the Synod Office on Thursday and Friday, the 8th and 9th November, 1877.

#### Executive Committee.

Present.—The Archdencon of York, Chairman. The Dean of Torontc, the Archdeacon of Peterborough, Rural Dean Stewart, Revs. Wm. Logan. R. Harrison, A. J. Fidler and C. C. Johuson. Hon, George W. Allan, Messrs. Harman, Crombie, and Marling, and Dr. Snelling.

The Sub-Committee appointed to prepare a Bill for presentation to the Ontario Legislature amending the Rectory Lands Act reported that they had prepared a Bill similar in all respects to the Act obtained by the Synod of the Diocese of Ontario, with such modifications as were necessary to make the same applicable to the Diocese of Toronto, as indicated by the resolution of the Synod,—That the necessary notice had been given in the Ontario Gazette and Daily Globe and a copy of the Bill delivered to the Clerk of the Legislative Assemily with the necessary fee of \$100, as required by the rules of the House,—and, That Mr. James Bethune, Q. C., had kindly concented to take charge of the Bill in the House.

The report was adopted.

A Sub-Committee was appointed to consider the question of the election of delegates to Synod, referred to this Committee by the Synod.

Resolved—That the thanks of the Synod be given to the Honorary Lay Secretary, Mr. Huson Murray, for his kindness in looking after the business of the Synod Office during the vacation of the Secretary-Treasurer.

The Secretary having reported to the Committee that the Bank of Commerce require payment of the moneys which have been borrowed for some time past to pay the stipends of the missionaries, and that in laying the matter before the Mission Board at its meeting on the following day it was his intention to suggest a sale or pledge of the debentures held by the Synod on behalf of the Mission Fund in order to satisfy the demands of the Bank penting the receipt of sufficient collections to pay the Mission Fund debt, it was *Resolved*—That when this Committee rises it stand vdjourned to Tuesday, Nov. 20th, at 3 o'clock, to consider the action of the Mission Board with reference to the overdraft on its account with the Bankers of the Synol, and that in the meantime the opinion of the Solicitors be obtained as to the particular investments proposed to be realized for the satisfaction of said overdraft and the powers of the Synod in regard thereto.

#### Clergy Commutation Trust Committee.

Hon. G. W. Allan, Mr. Whitney and Dr. Snelling. Col. R. L. Denison was unable to attend, owing to illness.

Letters were read :

From the Solicitors of the Scottish Provincial Life Assurance Company claiming payment of \$503.46 on the same ground as the Standard Life Assurance Company claimed a similar payment.

From Rev. John Carry, (England) asking the Committee to reconsider their decision in regard to his case.

From the Rev. John M'Cleary, of Hastings, asking the Committee to allow him, in calculating his period of service, to include the years during which he laboured in the Diocese of Huron.

From the Rev. Alex. Williams, of Toronto, claiming to be entitled under the new canon to receive \$164 per annum from the Surplus Fund.

From the Rev. W. E. Cooper, of Trinity College School, Port Hope, renewing his application to be placed on the list of non-commuting clergy and claiming under the new canon an annuity of 3200. (Mr. Cooper's application was supported by letters from the Lord Bishop and the Rev. C. J. S. Bethune, Head Master of Trinity College School.)

From Messrs. Bethune, Osler, & Moss stating the position of the Synod in regard to the proceedings taken in the Court of Chancery to prove the Synod's claim on the estate of the late Hon. J. H. Cameron.

Resolved—That the Secretary-Treasurer is hereby authorized to liquidate the claim of the Scottish Provincial Assurance Company, as to additional premiums on Mr. Cameron's Life Policy claimed by it, he having been found to be one year older than represented, provided there be no condition in the Policy exonerating the Assured's representatives from such payment. And that the communications relating to the Administration Suit as to his estate be referred to the Sub-Committee.

Resolved-That the case of the Rev. J. McCleary be referred to the Sub-Committee to report thereon.

Resolved—That the Sub-Committee be nuthorized to place the name of the Rev. A. Williams on the pay list for the sum of \$164 per annum, whenever the funds will allow, and ho shall have complied with the usual conditions.

The Committee being of opinion that the Rev. W. E. Cooper is entitled to be placed on the list of non-commuting clergy, it was *Resolved*:—That the name of the Rev. W. E. Cooper with the papers and communications thereon he referred to the Sub-Committee for their consideration, with the view to his being placed on the Commutation Trust Fund as soon as the funds will admit.

The Committee decided not'to reconsider their decision in regard to the case of the Rev. John Carry.

Ordered -That a copy of the foregoing resolution be sent to Mrs. Cooper.

The Secretary presented the usual quarterly financial statement of the W. & O. Fund; also a statement showing the Assessment for the purposes of the fund and the receipts on account thereof.

The application of Mrs. Susan Cooper, Widow of the late Rev. H. C. Cooper, for a pension from the fund having been read, the same being supported by the recommendation of the Bishop and two clergyman of the diocese, it was *Resolved*— That Mrs. Cooper be and she is hereby placed on the Fund.

A Sub-Committee having been appointed to consider the collections made for the fund, it was agreed (at a meeting held on the 8th December) to issue a circular, to be signed by the Chairman, calling upon each parish to make up the amount of its assessment.

The Secretary laid before the Committee the resolution adopted by the Mission Board on the 9th November in regard to the debt due to the Bank of Commerce on account of the Mission Fund, viz: "That the Executive Committee, so far as this Board has power so to do, be authorized to pledge the Mission Fund debentures of the Synod to the Bank of Commerce to secure the overdrawn account of this Board."

Bethune, Osler, and Moss, as to the particular investments proposed to be realized for the satisfaction of the debtdue to the Bank and the powers of the Synod in regard thereto—such opinion being to the effect that as the debt had been incurred for Missionary purposes and the Bank were in a position to enforce payment, the Mission Fund debeatures might be sold or pledged or otherwise properly converted and applied in payment of said debt. It was thereupon *Resolved*—That a Sub-Committee consisting of Messrs. C. J. Campbell and S. B. Harman be authorized to propose to the Bank of Commerce that the Bank should extend the time of payment of the overdrawn account due by the Synod to the 1st July, 1878, and that in the meantime the Committee be authorized to transfer to the Bank as collateral eccurity for the payment of the said overdrawn account the following debentures, viz.: those held on account of the Mission Fund and amounting to \$6,717.14 as set forth on page 66 of Journal of Synod for 1877.

#### TUESDAY, NOVEMBER 27TH, 1877.

Pursuant to adjournment, the Mission Board met at noon.

Present.—The Archdeacon of York in the chair. Rural Deans Osler and Cole, Canon Morgan, Revs. L. H. Kirkby, Dr. Hodgkin, F. Burt, and I. Middleton. Messrs Farucomb, Blomfield, Agar, Cartwright, Morgan, Gordon, and Clarke Gamble.

In regard to the overdrawn Bank Account, the Secretary reported that the Executive Committee had made an arrangement with the Bank whereby the time for payment of the overdraft was extended to the 1st day of July next, and had

transferred to the Bank as collateral security for such payment the debentures held by the Synod on account of the Mission Fund, amounting to \$6717.14 as set forth on page 66 of the Journal of Synod for 1877.

In regard to the claim of the Rev. B. S. Hosken for services as missionary at Lloydtown, the Secretary read the opinion of Messrs. Bethune, Osler, and Moss, to the effect that so long as a missionary is allowed to remain doing duty in a mission on an agreement made under the mission Fund by-law, he has a right in equity to require the Synod to collect, and if necessary to take legal proceedings to collect, the money payable under the agreement.

Resolved—That on the payment by the congregation of Lloydtown to the Secretary-Treasurer of the arrears due to Mr. Hosken from them up to July 1st, 1877, amounting to \$58, the Bishop be moved by this Board to make a new appointment to Lloydtown; and that the Secretary-Treasurer is hereby authorized to arrange with Mr. Hosken in respect of any further claims to an amount not exceeding the sum of \$150 on his giving a receipt in full of all demands on the parish or the Mission Board, and vacating the parsonage.

In regard to the application of the Rev. T. W. Paterson, for payment of \$150 arrears due by his late mission of Bradford and West Gwillimbury, the Board decided that the case was not one in which they could grant the relief asked for.

Resolved-That a grant of \$100 be given to the Mission of Penetanguishene for one year from the 1st of October last.

Resolved-That the reduction proposed to be made in the grants to the Missions of Woodbridge and Bradford do not take effect until July 1st, 1878.

Resolved—That a grant of \$100 to the support of the services of the Church of St. Mark's, Otonabee, do stand first on the list of the Mission Board, to be made as soon as the condition of the Mission Fund is such as to warrant it.

Resolved—That a copy of the letter from the Bishop to the Clergy and Laity of the Diocese of Toronto. dated October 23, 1877, be sent to each member of the deputations prepared by a Committee of the Mission Board, with a request that he shall make a special effort not only to obtain subscriptions for the removal of the existing debt, but also annual subscriptions of liberal amounts so as to place the Mission Fund from this source alone permanently on a satisfactory basis.

#### TUESDAY, JANUARY 15TH, 1878.

A Special Meeting of the Executive Committee was held at three o'clock, to receive a communication addressed to the chairman by the Lord Bishop of the Diocese.

Present.—The Archdencon of York. Chairman: The Dean of Toronto, Rural Dean Stewart. Revs. Wm Logan, A. J. Fidler, and Richard Harrisou; Hon. G. W. Allan, Col. Boulton, Messrs C. J. Campbell, Marling, Harman, Clarke Gamble, Crombie, and James Henderson.

The communication above mentioned is set forth at length in the Bishop's address at the opening of the Special Session of the Synod for the election of a Coadjutor Bishop. (See page 9 of this number of the *Gazette*.)

The chairman having read the same, the Committee arranged the Order of Proceedings for a Special Meeting of the Synod to be held on Tuesday, the 12th February, and issued a notice to the Synod to meet in Toronto on that day.

The Reception Committee appointed at the last May meeting, for the June Session, were re-appointed for the ensuing Special Session.

## TORONTO DIOCESAN GAZETTE.

The Regular Quarterly Meetings of the Standing Committees were held at the Synod Office, Toronto, on Thursday and Friday, February 14th and 15th, 1878.

## Executive Committee.

Present.—The Archdeacon of York, chairman; The Archdeacon of Peterborough, Rural Dean Stewart, Revs. C. C. Johnson, A. J. Fidler, Wm. Logan, and R. Harrison; Hon. George W. Allan, Col. Boulton, Dr. Snelling, Messrs. Alex. Marling and Marcellus Crombie, Dr. O'Reilly.

Resolved.—That a Committee be appointed to investigate and report upon, at the next meeting, the financial position of the Dioces., its revenues and resources, its power of providing and enforcing ways and means, and to devise some system, embracing penalties or otherwise, for collection of the ordinary revenues and assessments of the Church; such Committee to be constituted as follows: S. B. Harman, Esq., Clarke Gamble, Esq., Colonel Boulton (convener), and Alexander Marling, Esq.

## Clergy Commutation Trust Committee.

The Clergy Commutation Trust Committee did not meet in consequence of the Synod being in Session.

### Land and Investment Committee.

Present.-The Rev. Canon Stepnett, in the chair; Rev. W. H. Clarke, Capt. Wheeler, and Mr. J. O. Browne.

Manvers Glebe —It being reported to the Committee that the tenant is cutting and celling timber from off this land, the Secretary was instructed to take legal proceedings to restrain the tenant, and to recover dumages for whatever injury has been done to the premises.

Minico Glebe — An application on behalf of Walter Wilson, for compensation for loss of land, by reason of the Township Council of Etobicoke opening a road across the land purchased by him from the Synol, was referred to the Solicitors.

Garafraza Lots.—The Secretary was instructed to pay Mr. Gordon, of Fergus, \$45 commission on the sale of these lots to J. F. Marsh, and \$15 to satisfy the claim of a squatter on one of the lots.

#### Mission Board.

Present.—The Lord Bishop in the chair; The Archdeacons of York and Peterborough; Rural Deans Givins, Stewart, and Osler; Canon Morgan; Revs. L. H. Kirkby, Dr. Hodgkin, F. Burt, and I. Middleton; Messrs. Morgan, Cartwright, Blomfield, and Gordon.

The Secretary presented the Quarterly Financial Statement, shewing overdrawn balances of \$12,157.85 on account of the Mission Fund, and \$1,101.10 on account of the Algoma Fund.

New guarantees were received and accepted from the following Missions -

St. John's, Mono Mills, \$175, for one year, from 1st October, 1877.

Haliburton (Dysart), \$110 per annum, for three years, from 1st October, 1877; and Guilford (Dysart), \$20 per annum, for three years, from the same date.

Letter was read from Rev. T. W. Paterson, with reference to the arrears due to him by his late Mission of Bradford and West Gwillimbury, and stating his opinion that when he accepted the Incumbercy of the Mission, he became the stipendiary of the Mission Board; and that, in accordance with the terms of the by-law, the Board is responsible for the due and regular payment of the stipend agreed upon. The Secretary was instructed to write to the churchwardens and bondsmen, requesting payment of the arrears claimed by Mr. Paterson.

The Rev. Johnstone Vicars, of Pickering, having sent in a statement of the arrears due to him on the Duffin's Creek and Greenwood guarantees, the Secretary was instructed to call upon the Churchwardens for payment.

The Rev. George Ledingham, West Mulmur, having reported that the people have not as yet taken steps to furnish guarantees for the payment of the Missionary's stipend, the Secretary was instructed to write and inform the people that the provisions of the by-law must be carried out.

Resolved.—That the Lord Bishop be requested to appoint a sub-committee of five to consider what alterations are required in the Mission Fund By-law, in order to remove the difficulties which at present exist in its practical working, and to report at the next meeting of the Mission Board. Committee appointed: The Archdeacon of York, Canon Osler, Rev. I. Middleton, Mr. John R. Cartwright, and Mr. Blomfield.

Resolved.—That the grant to the Travelling Mission of Galway be withdrawn on the 1st of April next.

Resolved.—That the Secretary-Treasurer be instructed to communicate to the several Parishes and Missions the necessity of sending in their contributions to the Mission Fund (usually sent in before the 30th April) not later than the 15th of March, as unless they are transmitted by that time, the Board will not be in a position to pay the salaries of the missionaries due on the 1st of April.

Resolved.—That the Rev. C. C. Johnson, Rural Dean Smithett, Rev. W. Logan, Dr. Hodgkin, Rev. I. Middleton, Rev. Canon Givins, and Rev. W. C. Bradshaw, be requested to undertake a canvass of the Diocese as soon after Easter as possible, with a view to obtain, by personal application to members of the Church, subscriptions to pay off the debt of the Mission Fund, and also annual subscriptions for Mission purposes. A Rural Deanery to be assigned to each collector. The travelling expenses of the collectors to be paid, and their duty, if possible, provided for.

The Secretary presented a statement shewing receipts on account of the October collection, \$1,943.92; balance due on basis of assessment, \$1,564.08.

Resolved.—That a further circular be immediately sent out by the Sub-Committee.

Letter was read from the Rev. John Fletcher, of Unionville, stating the inability of his parish to pay the assessment.

Application for a pension for herself and children was received from Mrs Elizabeth Mary Tilley, widow of the late Kev, William Harrison Tilley, who died on the 11th Novomber, 1877. Consideration deferred, pending information in regard to Mrs. Tilley's private income.

An adjourned Meeting to be hold on Friday, 29th Marob, at 2 o'clock.

On application of the Rev. W. C. Bradshaw, a grant of \$50 from the General Fund was made in aid of the building fund of St. Luke's Church, Ashburnham.

Synod Assessment-Resolved.—That the chairman, Rev. John Vicars, Rev. S. J. Boddy, and Mr. Alderman Boswell, be a Sub-Committee to estimate the probable expenses of the coming Synod (including the expenses of the late Sunday-School Convention and Church Conference, and also of the late Special Meeting of Synod), and levy the necessary Synod Assessment to meet those expenses. The Sub-Committee to meet on Wednesday, the 3rd of April, at one o'clock.

## Printing Committee.


