

His Grace dwelt at length on the holiness and happiness of Christian marriage, and upon its influence in the rearing of children. Sainly parents rear up children in holiness and the sanctification of Christian society.

In discussing Catholic education as an essential duty of parents, the archbishop charged with the primary and most important duty. On her fidelity to this duty in Catholic education depends the salvation of the soul of the Catholic mother.
