Europa.

THE REVENUE. The revenue returns for October quarter have been published, which exhibit a satisfactory state of affairs. The customs duties for the last quarter, ending 5th October, exhibit a decrease of £133,211; but on the year there is a general increase of £293,736. On the other hand, the excise has increased on the quarter by no less than £413,945—The stamps furnish a very satisfactory increase of £221,895 on the quarter, and on the year the increase is £125,408. The taxes give a very slight improvement on the quarter, and a year, whilst the property tax has especially improved by about £21,000 on the quarter—The post-office revenue has improved, and with the crown lands, have brought in £160,000 additional. The miscellaneous taxes have slightly increased by nearly £8,000; whilst on the year the improvement exceeds £120,000. Taking the whole income, we find the balance of increase on the quarter £214,113, whilst the increase on the year is £235,571.

In connection with this subject, the European Times says:—The trade accounts of last month again furnish the most satisfactory evidence of a vast increase in the exports and imports of the country, and if the increase of the customs duties does not go on in a corresponding ratio, at least it is satisfactory to believe that the masses of the people are in the enjoyment of greater comforts and even luxuries than heretofore, with the main article of food at a very moderate price. The increase of the exports of the country during the first eight months of 1849, is at £7,570,000, which not only absorbs the enormous decrease of last year, but leaves an improvement of £2,283,000, as compared with 1847. Whilst the total exports have thus augmented fully 24 per cent. as compared with 1848, our cotton manufactures have exported in an increased ratio of 25 per cent. for the eight months, and cotton yarns 33 per cent. Indeed, the latter article has shown an increase of no less than 55 per cent. on a comparison of the last official month with the corresponding one of last year. The imports of grain and flour, we have already stated last week, continue to exceed considerably a million of quarters per month. Under these circumstances, the manufacturing classes generally must be enjoying a considerable degree of prosperity, whatever complaints reach us of reduction of wages, short time working, or reduced profits.

IRELAND. The accounts from Ireland relative to the potato crop are painfully distressing. The distress of the people will therefore probably be greater than at any previous period, as the means of those able to afford them relief will be more exhausted. Emigration especially from the south, is proceeding it at a rapid rate. The Cork Reporter of Saturday says:—"A melancholy proof of the want of confidence felt by the people in any promise of improvement in the condition of the country is to be found in the extraordinary tide of emigration at this moment setting from our shores. The class of persons emigrating, we understand, is very respectable, and we have been told of one party who takes with him the sum of £450." The clergymen, Protestant and Catholic, share in the distress. On every side the signs of general ruin are accumulating, and the low prices prevailing in the Irish markets deepen the distress, and cut off all grounds of future hope.

Dismissal of the Earl of Roden.—The dreary lull of Irish politics has been at length broken by an event which can scarcely fail to rouse the dormant energies of party, and to evoke a storm of indignation on one side, and shout of triumph at the other. There could, however, be no second course adopted, as it was perfectly plain to any unprejudiced person who had carefully read the evidence taken before Mr. Estlin in the investigation into the circumstances connected with the lamentable case of life at Dolly's Brae, on the 12th of July last. Acting, it is to be presumed, on the report presented to the Government by their own Commissioner, the Lord Chancellor has removed the name of the Earl of Roden from the commission of the peace for the counties of Down and Louth, and the Messrs. Francis and William Beers have been deprived of the like office in the first named county. This prompt decision of the Irish Government came by surprise on all parties, and there were many who hesitated to give it entire credence, not believing that the Executive would in so decided a manner mark their disapproval of Lord Roden's share in the transaction.

Mr. Butt, Q. C. is in the field as a candidate for the city of Cork. The learned gentleman, in an eloquent address, declares against the repeal of the union and all interference with the established church. The northern papers contain a vast body of matter more or less connected with the dismissal of the Earl of Roden and the affair at Dolly's Brae. The dismissal of Lord Roden has caused a considerable ferment amongst the Orange party in Ulster; and sixteen magistrates of Down, assembled at Castlewellan petty sessions, including the Marquis of Downshire, have, with a single exception, refused to grant informations against some of the

Orange party, charged with being implicated in the transactions at Dolly's Brae and Magheramayo. It is now clear that the Magistrates have determined to make common cause with Lord Roden. After the case was concluded, the majority of the magistrates and a large number of gentlemen proceeded in a body to Tollymore Park, to pay their respects to Lord Roden. The Newry Examiner contains the following: but we apprehend that Lord Roden's removal from the office of Custos Rotularum does not necessarily follow his dismissal from the commission of the peace.—By the dismissal of Lord Roden from the commission of the peace, the important office of Custos Rotularum, or keeper of the records of this county becomes vacant. The custos is, by law, in virtue of his position, the principle of justice of the peace of the county. The appointment is in the gift of the Crown but it is generally annexed to the Lieutenancy of the county. Lord Roden will probably therefore, succeed Lord Roden as Custos Rotularum of Louth. Considerable patronage is attached to the office.

THE ROMAN STATES. A letter from Rome of the 25th ult. states that the effect of raising the siege of that city, demanded by the three cardinals will be to deprive the French general of all authority in civil and political questions, and to invest the cardinals with unlimited power. The French prefect of police and M. de Courcelles had, in consequence, apprised several ex-deputies of the constituent assembly that warrants had been issued against them by the Political police, but that the French authorities would suspend their execution until the 1st of October, and that in the meantime they should have a free passage to France, with liberty to reside there. Sixty deputies left immediately. On their leaving vast crowds attended them cheering and paying them marks of respect. The emotions of the people had a visible effect, not only on the French troops, but on the Government.

AUSTRIA AND HUNGARY. It has been rumoured that the Hungarian refugees near Widin, the leaders of course excepted, have applied for leave to return into Austrian territory, and that their request will be granted. The statement that Count Zely, who was executed by the Hungarians, has been contradicted. Most of the captive Magyar officers have incorporated as privates in the regular army. The Bishop of Nensohl has been deprived of his see, and sentenced to six years imprisonment, for having favoured the Magyars. Several Hungarian ladies, besides Kossuth's mother and Guyon's wife, are kept in close imprisonment by the Austrian authorities.

TURKEY. Since the suspension of diplomatic intercourse between the allied powers and the sultan, the consular business of Russia and Austria has been transacted by the Prussian legation. A large fleet of steamers is collected in the waters of the Bosphorus and in the harbour of the Golden Horn; and between the entrance to the Black Sea and the Propontis, or sea of Marone, there are 12 ships of the line at anchor, fully equipped and plentifully supplied with arms and provisions. In the army of 100,000 soldiers assembled round the Turkish capital, drilling and reviewing were going on from daylight to dusk; and the seraskier, and the pachas under his command, were constantly moving about to inspect the troops. Symptoms of disaffection had been manifested by some portions of the Greek population in the neighbourhood of Constantinople. Some of the refugees at Widin have adopted the Mahomedan faith in order to secure themselves against any danger of being delivered to the Russian Government. A letter, dated the 25th ult., states that before entering the Turkish territory official assurances were given by the Turks to Kossuth, that he and his fellow-refugees were welcome guests, and should be allowed to proceed to any part of the world. The refugees were subsequently alarmed by intelligence that the Russian and Austrian envoys had demanded the delivery of the Poles and Hungarians, and that a council had decided in favour of granting the demand, though the Turkish Ministers strongly opposed it; but that all admitted that none who should embrace the Moslem faith could possibly be delivered to infidels. The ministry despatched a reverend mollah to examine the refugees separately, and expose to them the state of the case, whilst numerous friends in Constantinople recommended the adoption of the suggestion as the only means of salvation. No words can express the consternation of the community at this intelligence. Many of the Hungarians exclaimed:—"Better the Russians than the Austrians—better Mahomedanism than the Russians;" and there appeared some prospects of the whole camp embracing Islamism. A council of the chiefs was immediately held at Kossuth's where Ben at once declared that his life was devoted to hostility to the Russians, and that he eagerly accepted the suggestion. The mollah promised at the same time the maintenance of their rank and the liberal allowance customary in the Turkish armies. General Kmetzet and Steen came to the same resolution, and several persons were for temporising. When Kossuth's turn came to speak, he briefly reminded his companions, in his impressive language, that now, in a strange land, where all authoritative hands were numbered, each one was at liberty to act accordingly to his own views, but that, for this part, welcome as it needs be, the axe or gibbet, but curses on the tongue that dares to make him so infamous a proposition. Guyon, the Irish gene-

ral, followed, declaring that no human power should induce him to swallow even a bunch of grapes upon compulsion. General Dembinski, and Count Zimoyski, were equally determined. The example of their chiefs was so effective, that of about 200 soldiers and 49 officers who had expressed their willingness to adjure Christianity, the soldiers, to a man, changed their intention, and there remain only three generals, and some twenty officers firm in their resolve. Ben took immediately a public step, and it is said assumed the name of Amurath, and becomes a three-tailed pasha with the Turks, who have an exalted opinion of his military genius. Kossuth has written a very eloquent letter on his present position to Lord Palmerston. The reply of the Emperor of Russia, which was expected with the most intense anxiety, would, it was thought, reach the Turkish capital about the 10th or 12th of October.—Apprehending that the decision of the Czar might be a declaration of war, the Porte was exceedingly impatient to learn the effect produced upon the cabinets of London and Paris by the hearing of their representatives at the sublime Porte. "It cannot be denied," continues our correspondent, "That those diplomats (the English and French ambassadors) have strongly pledged themselves to the Government of the Sultan; and that if the hopes which they have thus inspired should not be realized, they would have to reproach themselves for having contributed to precipitate the Porte into a position of imminent danger. But this is a question of humanity and honour; it is a question, moreover, of resisting the constantly increasing influence of Russia in the East; and surely, these are motives more than sufficient to determine England and France to approve the conduct of their representatives." Public opinion at Constantinople had already sanctioned the efforts of the ambassadors of the two great Powers, and in the course of the week the Sheikh-ul-Islam, the head of the people ecclesiastical, several members of the Mahomedan clergy, and a large number of public functionaries, of all classes, repaired to the residence of Sir Stratford Canning and General Aspin to congratulate them upon their energetic and resolute conduct, and to thank them for the support which they had afforded to the Turkish Government.

A considerable number of Polish or Hungarian refugees had been conveyed from Constantinople, on board an American cutter, and the French war-steamers, L'Aurore, Greece was thought to be their destination. The Turkish provinces of the Danube, especially Servia, had for some time been infested by Russian agents, including a large number of priests, who were making every exertion to foment a rebellion of the Christian tribes against the Porte.

SCOTLAND. Advice from Edinburgh and Glasgow, dated the 12th ult. are to hand. They are however, devoid of any item of interest. The Evangelical Alliance have concluded their sittings in Glasgow. The cholera has almost made its disappearance at both Greenock and Glasgow. From Glasgow we are informed there is still very little business transacting in the pig market, and the quotation of 4s 6d each, for mixed Nos., remains unaltered. The return of the Pope to Rome is fixed for the 15th inst. The Danish government has come to the determination of agreeing to no proposition for the division of Schleswig, being resolved on the indivisibility of the duchy. Returns to a petition.—The Young Irelanders have resolved to issue a requisition for signature in all parts of the country, for an aggregate meeting on an early day in November.

THE PROPERTY OF MR. O'CONNOR.—We understand that the property of Patrick O' Connor, for whose murder the Mannings stand charged, is about to be divided among his relatives, residing in the county of Tipperary. It is supposed that it will amount to seven or eight thousand pounds.—Channel Chronicle.

A cabinet council (the third within a week) was held at the Foreign-office, on Monday afternoon. It is rumoured that the Russian and Turkish question has led to these repeated reunions of the cabinet. LETTER FROM CALIFORNIA. The following extracts are taken from a letter received from Mr. John Nelson of St. John, to his friends in that city:—SAN FRANCISCO, (California), August 12, 1849. "I left the States on the 1st May last, and arrived here on the 9th of August, making 100 days travelling through the wilderness, and I must say that I never suffered so much hardship in all my life put together as I have in that 100 days, and many a poor fellow has found his last home on these plains. I cannot give you anything like a description of the hardships encountered, but I will confine myself to what will be most interesting, and in my next letter I will be enabled to give further particulars. I am going to leave here to-morrow morning for the Gold Diggins, about 25 miles from this place, where I shall stop. At present the diggings extend for 1000 miles, but many will be disappointed in the quantities of the precious article which they expect to dig. I have made all the enquiries I could, and from the best sources, and find that the general amount obtained by each man at the mines, averages from \$16 to \$20 per day, notwithstanding there are instances every day of some getting very large amounts at the mines, the term being applied in such cases, so if a man is lucky he may get a fortune in one day. Men can get \$16 a day, and to hire by the year get \$300 per year and found, though the prospects are not so

good as is reported at home. I have not as yet tried the mines, though I have obtained about 9 ounces of the precious metal by the way of trading. I have got every thing necessary for the mines. I paid yesterday \$32 for a machine that can wash more than six men with pans. I laid out \$130 for provisions and tools, and have enough left to buy my winter's supplies. I left my company at Green River, near the Rocky Mountains, and started for California on horse back. I made the distance of 1300 miles from the 4th July to the 9th August, and out of 107 men only one besides myself have been able to stand the journey, none of the rest have yet arrived. I suffered much crossing the Sandy Desert, 95 miles, without grass or water. My noble Indian Alage carried me over without a stop, my mule failed me, about 4 miles from the water. I left him and went out myself and obtained refreshments, and went back with some water and got him in. I have him now and need him to carry my provisions to the mines. The loss of property and life on the way is immense, not less than 2000 have died on their way from the lines since I left. I shall now give you an account of the state of the markets. Flour at this place is worth \$23 per cent.; Pork, 75 per cent.; Bacon and Ham \$1 per cent.; Coffee 45¢; Sugar, 50¢; per lb.; at a place called, Saguera Fort, prices are one half less; it is the high freight for teaming that causes such high prices, the distance is only 65 miles. I will not make as much as I expected when I started. The whole country abounds with gold, but it requires labour to find it, and no man need come here unless he intends to work harder than he does at home, and then he may expect to do something. In my next letter I will give you a real and true account, and this one I think will set the truth as near as possible. I would say that no man need calculate to make more than \$10 clear of expenses per day, and that I think he can do and chance to do better. I would advise no one to come by land, indeed, it is my desire that it should be put in the papers, or for to stop their coming that way to California, as they cannot comprehend the difficulties and dangers attending the land route. I have slept for 75 nights, without a covering save the canopy of heaven. I believe I shall be able to realise about \$5000 for my year's labour, according to present prospects, and perhaps three times so much. I have stated things just as they are, and have not over-rated anything. Board rates from \$25 to \$35 a week at the mines, but men can board themselves for a dollar and a half well. Honest prevails here, and there is better order than there is in St. John.

From Canada.—Montreal, Oct. 22.—The removal of the seat of Government from Montreal, which has been so long threatened, is now confirmed. A circular has been issued to the several departments of the Government, directing them to prepare immediately for removal. The circular has caused the greatest excitement, and there are rumors of ministerial resignations about. It is reported that the receiver general and provincial secretary have resigned. The anti-immigration protest is continued in the Montreal papers with the names of upwards of 600 professional men, traders and others attached to it. The Transcript says "we may observe that these names have been obtained without any regular canvass or organization, and that they are so far but a feeble index of what we take to be the real state of feeling in Montreal, and that it will serve to convince the Montreal Herald and its Yankee friends that the time for pulling down the British flag has not yet arrived."—[Quebec Morning Chronicle.

The steam ship Europa arrived at Halifax on Wednesday last, at 10 o'clock, less than 11 days from Liverpool. The Europa made the passage home in 11 days from Boston. The American steamer Washington reached Southamton on the 6th, in 15 days from N. York. We are indebted to the New-Brunswick for a summary of the news. Our Liverpool papers are to the 13th inst. Considerable excitement has been manifested in the Liverpool Cotton Market, and prices have advanced 3-8d to 1-2d. The sales for the week reached 118,770 bales.—The European Times, however, says—"Bills drawn against Cotton speculations are beginning to be looked upon with some little distrust both here and in London in certain quarters. The private accounts of the rising Cotton crops, received per last packet by some of the most interested, are said to be of a very different character to those current among the trade."

There is more firmness in the Grain Markets, and prices have slightly advanced. Indian corn is quoted at 2s. 10d. to 2s. 6d. per quarter for white and 2s. to 2s. for red. Flour is not much altered in value, being quoted at 23s. 6d. for Western Canal and Blue-Headed, 24s. to 24s. for New Western, 21s. for Baltimore, and 22s. per barrel for Ohio. There is no Indian Meal in market. There was considerable speculation in the Iron trade. Speculation from Manufacturing districts that in and around Manchester a healthy trade prevails. The Money Market was liberally supplied, and the rate of interest easy. A further depression has taken place in the price of Railway Stock and 2s. 6d. is some weeks elapsing of the unfavourable returns of weekly trade on all the leading lines. Considerable excitement has been created in Ireland in consequence of the removal by the Government of Lord Roden from the commission of the peace for the Counties of Down and Louth, on account of the part he took in the affair of Dolly's Brae. Lord Clarendon was satisfied that Lord R. attended in his magistracy capacity, and voted with the majority of magistrates in refusing to take information of the Dolly's Brae affair, therefore, as his Excellency says, "taking part in the judicial consideration of proceedings, the object of which was to determine the complexity or otherwise of certain parties in the act of an Assembly, charged to be illegal, which he had himself sanctioned and encouraged," and rendering him so longer fit to discharge the important functions and duties of a magistrate. Conciliation-hall has once more been opened under the auspices of Mr. John O'Connell, and upwards of £25 of "rent" collected. A great meeting has been held at London to give expression to the feeling of the public against war loans, and more particularly against any portion of the new Austrian loan.

The Court.—The Fall term of the Court of Oyer and Terminer and General Jail Delivery was opened here yesterday, by His Honor Mr. Justice STREET. Three criminal and eleven civil cases were entered on the docket for trial. We give the following synopsis of his Honor's charge to the Grand Jury:—His Honor observed that owing to business weather the opening of the Court had been postponed until the afternoon, in order to give time to the Jurors generally, to be present. He congratulated the County that the calendar contained so few cases for their consideration, and observed that he attributed the rapid decline of crime in this and other parts of the Province, to the efforts of Temperance Societies, which were reforming the morals of the people, and might under Providence, be the means of leading many, who were now abandoned and reckless, to a consideration of the importance of Religion. He also stated he had noticed throughout the Province, that the crops were most luxuriant.
