

An Act to incorporate the Montreal Baptist Church, under the name of "The First Baptist Church of Montreal," and for other purposes.

## (PRIVATE BILL.)

An Act to incorporate the Montreal Baptist Church, under the name of "The First Baptist Church of Montreal," and for other purposes.

WHEREAS the Minister, Trustees, and other officers of the Mon-Preamble. treal Baptist Church have, by their petition, set forth that they have been in possession of a lot of land and meeting-house thereon erected, situate in St. Helen Street, in the City of Montreal, acquired

- 5 by the Trustees of the said Church, by Deed executed before N. B. Doucet and colleague, Notaries, on the seventh day of June, 1832, from the late John Try of Montreal, Architect, and Ebenezer Muir, of the same place, then Merchant Tailor,—that the said lot of land has become valuable for business purposes, and is distant from the resi-
- 10 dences of the Members,-that the Trustees, with the consent of the said Church, have sold the said lot of land and buildings thereon erected, to James Hutton of Montreal, Merchant, by Deed executed before J. J. Gibb and colleague, Notaries, on the twenty-second day of January, 1861, in order that the proceeds may be applied to the crection of a
- 15 more central and eligible place of worship,-that doubts have arisen whether the said Trustees had the power to sell the said lot of land,and that they pray for the passing of an Act to remove the said doubts and confirm the said sale, and also to incorporate the said Church under the name of "The First Baptist Church of Montreal;"
- 20 And whereas it is expedient to grant such prayer; Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:
