This I tried to hide, but every evening when I unlocked my door, the letter appeared in some new conspicuous place—now pinned to the head of my bedstead, then in the window-curtain; now on the pillow, now on the sofa, or again stuck in the frame of the looking-glass—once tied to the gas-fixture, and twice to the door-handle. I could not get rid of its ever reproachful face, silent saying, "I warn, and you will not heed."

As far as I could without exciting suspicion as to my motives in making inquiries—I I dredged the sort of locality that would surely attach to one who was supposed to have received a supernatural communication—I satisfied myself that the landlady and servants had, and could have had, nothing to do with this letter, and its mysterious suggestions. It was ascertained that there had not been a duplicate key to my bureau, but not as far as was known, to the hall door. The other doors were bolted on both sides.

Now, whether it was altogether owing to the effect on my imagination of this mysterious agency of an insidious thing, or whether it was that the vexations and troubles of the business which detained me in town, and the physical and mental weakness it induced, combined with the undeniably poisonous cookery of the fashionable boarding house, had together seriously affected my nervous system, I do not know, but certain it is that day and night I could not escape from the haunting refrain, "I have warned, you will not heed, and you will be responsible for a life. For his life—the life of the father of the beautiful children you are so fond of, the husband of the woman you are so fond of, the friend whom you love for his own sake. It is for his life that you will be held responsible."

During the day time my mother's reproaches, and that I only heard it as a disturbing echo, but when evening came with its relaxations I could not shut it out. At the theatre, the brilliant stage with its Bagdad played Henry V., or where Wallcut personated the jaunty youth of fashion, seemed written over with the flaming words. When I dined with friends, and one said in a laughing way about some trifling thing, "You will be responsible for that," I felt as if I had received judicial condemnation. When my cousin stood on the rug in telling of Mrs. Murray's sitting-room fire, telling in eloquent words about Old World wonders which had burnt themselves into his ardent heart, I heard them there only as through a dim of burning waters, in which I saw his noble head uselessly struggling, or I heard his voice as the sob of wife and children lamenting for husband and father.

I had maturely reflected and decided upon my course, and I would not permit reason to be overruled by imagination so far as to let the latter influence my actions; yet many a night I would find myself bitterly weeping and praying the garden of G—'s wife that had not at least tried the effect of giving him the warning.

I was glad when my business was at length despatched, that I could leave the city, but it was not until several weeks after that my cousin started for France. The twelve days that elapsed between the sailing of the steamer and that on which his safe arrival was reported, on the New York papers were very long. And when as was all over, how sorry I was at myself that I should have paid any heed to such a vague, and, as it now seemed, transparently spurious sort of a warning.

My next thought was to send to a friend the letter of which I still held the third copy (its power of self-movement foretold when I left New York) with a request that he would ascertain for me if there were any such persons as A. B. Sears, professing to be a "Spiritual medium." After some weeks the answer was returned: "Yes, A. B. Sears is the son of a poor man, boards in the same house where you boarded last spring."
