LAWN TENNIS.

A Lawn Tennis Club has been organized in connection with the St. Alban's Cathedral Athletic Association, and from present indications bids fair to be a great success. Two courts are in process of preparation on the plot of ground west of the Cathedral, which is to be fenced in.

As is usual in organizations of this kind, all that is necessary to make the enterprise a complete success from the start is a large membership; at present, although the Club has not yet commenced actual play, some fifteen members have been enrolled, and several more have signified their intention of coming in as soon as the ground is ready. The initial expenditure will necessarily be rather large, it being estimated that at least \$125 will be required, and that will mean a necessary membership of fifty; so that if the tennis enthusiasts in this neighborhood wish to have a good live club in their midst, now is their opportunity by supporting this new organization to bring about a fulfilment of that desire.
