BILL.

An Act to amend the Act providing for the separation of the County of Peel from the County of York.

WHEREAS a majority of the Inhabitants of the County of Peel are in favor of Preamble.
the separation of that County from the County of York as appears by a
vote of the qualified Municipal Electors of the said County of Peel, taken in pursuance
of the Act passed in the nineteenth year of Her Majesty's Reign, intituled *An Act*
5 *to provide for the separation of the County of Peel from the County of York* ;
And whereas the Provisional Council of the said County of Peel have neglected to
select a place for the County Town of the said County as required by the said Act—
whereby the said Act is rendered inoperative, and it is expedient that the said Act
be amended by fixing the place for the said County Town ; And whereas the Village
10 of Brampton in the said County, from its population, business and central position
is the most suitable place for such County Town ; Therefore Her Majesty by and
with the advice and consent of the Legislative Council and Assembly enacts as
follows :

I. The fourth section of the said Act shall be and the same is hereby re- 4th sec of Act

II. The Village of Brampton shall be the County Town of the said County and the Pro- Brampton to be
visional Council of the said County shall have and exercise the powers conferred on the County
Provisional Municipal Councils by Law, and shall and may purchase the necessary Town.
property at the said Village of Brampton and proceed to erect the necessary Public
20 Buildings on such property. And all the provisions of the Act, lastly cited in the
said Act shall apply to the said provisional Municipal Council and to the said
County of Peel.

III. It shall be the duty of the Warden of the United Counties of York and Peel to
call a meeting of the said Provisional Council at the said Village of Brampton at Appointment of
25 such hour as he shall name on some day in the month of July, one thousand eight Provisional
hundred and fifty seven ; and the said Warden shall, by a Warrant under his hand Warden.
and seal, appoint some member of the said Provisional Council to preside at the said
meeting until a Provisional Warden shall be elected by such Provisional Council.
