

An Act to correct an Error in the Act passed in the Eighteenth year of Her Majesty's Reign, to amend and extend the Acts incorporating the Champlain and St. Lawrence Railroad Company.

An Act to correct an Error in the Act passed in the eighteenth year of Her Majesty's Reign, to amend and extend the Acts in corporating the Champlain and St. Lawrence Railroad Company.

THEREAS it appears by the Journals of the Legislative Preamble. Assembly, that the Bill which was sent up to the Legislative Council and was assented to by His Excellency the Governor General in Her Majesty's name, and became an Act 5 of the Parliament of this Province under the title of "An Act Error in 18 V. to amend and extend the Acts incorporating the Champlain c. 177, recited. and St. Lawrence Railroad Company," and which is printed among the Acts of the now last Session and chaptered one hundred and seventy-seven, was at the third reading thereof in 10 the Legislative Assembly, amended by striking out the several words and the proviso hereinafter mentioned, but that the said words and proviso were nevertheless by error allowed to remain in the said Bill, when it was sent up to the Legislative Council and when it received the Royal assent as aforesaid: 15 And whereas it is desirable to correct the said error: Therefore Her Majesty, by and with the advice and consent of the Legislative Council and Assembly of Canada, enacts as follows:

I. Act; but so many of the said bonds as shall not have been so issued at the time of the passing of this Act, shall be forthwith cancelled, or if issued hereafter, shall be void and of no effect.
