

An Act to legalize the operations of Patrice Renault Blanchard, Esquire, Land Surveyor, with reference to the survey, boundary lines, reports and plans executed and prepared by him for the division and settlement of the limits of the lots in the first five ranges of the township of Acton, in the county of Bagot and District of St. Hyacinthe.

WHEREAS, the original survey of the township of Acton, in the Preamble, county of Bagot and district of St. Hyacinthe, made in 1805, by J. Kilborn, Provincial Land Surveyor, was but imperfectly performed, and that the lines drawn by the said Surveyor had ceased to

⁵ be visible; and could not be identified on the ground in a satisfactory manner, and whereas Patrice Renault Blanchard, Esquire, Provincial Land Surveyor was, in the year 1856, employed by the Commissioner of Crown Lands to verify and complete the survey of the first five ranges of the township of Acton, and the subdivision of the lots in

- 10 the said ranges; and whereas that portion of the said operations of the said Patrice Renault Blanchard, which relates to the boundary lines of the said five first ranges of the said township, is as satisfactory as possible, and the nearest approach to the original survey of the ranges of the said township of Acton; and whereas it is important, in order to facilitate the clearing and settlement of the said township, that 15 thetraction of the accentices of the path Renewle Blanchard

Patrice Renault Blanchard, and which is deposited in the Office of the Department of Crown Lands, are hereby declared to be and shall be deemed to all intents and purposes whatsoever, the permanent division lines of the said ranges, and the said plan to be the only true, correct and authentic plan of the five first ranges of the said township of Acton,

³⁵ irrespectively of the division which is to be made of the said township into lots, in pursuance of the provisions of the Act 12th Victoria, chapter 35.

roads of the said ranges of the said township, and indicated on the plan of the said Patrice Renault Blanchard, shall be and the same are hereby declared to be the true limits of the said front roads respectively, and each front road of the said ranges shall be confirmed and established of the width and comprised between the posts, monuments, boundaries 5 and limits crected and established on the ground by the said Patrice Renault Blanchard, and indicated in the plan made by him in 1857, in order to establish the allowances for the said front roads of the said five first ranges of the said township of Acton.

Subdivision 3. The sub-division of the said ranges into lots, made by the said 10 into lots to be Patrice Renault Blanchard, not having been made in accordance with the provisions of the Act 12th Victoria, chapter 35, shall be made anew in accordance with the provisions of the said Act.

4. This Act shall be a Public Act.
