INTRODUCTION

BY LEONARD WILLIAMS

To the Special Hormone Number (April 1913) of "The Prescriber"

CONTERDAY was the day of the pathologist, more especially of the bacteriologist. The day before vesterday witnessed the triumphal progress of Surgery. Physiology and Medicine, all wrung in the withers and quite chapfallen, contented themselves, perforce, with the crumbs that fell from the rich microbic tables of these others. But the whirligig of time brings in his revenges. To-day and to-morrow, and the day after, are foreordained to the physiologist, the physician, and the therapist. Their hour has come through the agency of the internal secretory glands, which already unfold before the astonished view of the seeing eve, a land of promise beside which the vast territories conquered by Lister and Pasteur are destined to pale into honourable insignificance. The ductless glands and their hormones come to us as peaceful conquerors who brook no denial. They lighten our darknesses and show us miracles. In studying them and endeavouring to unravel their intricate and esoteric mysteries, one seems ever and anon to be on the trail of the Great Secret, and in danger of losing one's mental perspective."

ORGANOTHERAPY

STUDENTS of contemporary medical and scientific thought cannot but be profoundly impressed by the rapidity and certainty with which many of the old standards and conceptions in therapeutics are being replaced by new and improved methods of treatment, resulting from the uninterrupted advance of scientific research and observation.

The space formerly devoted, in medical literature, to Symptomatology and to the relative values of drugs in the treatment of the *results* of disease, is now occupied by articles of the utmost scientific value, written by some of the most brilliant writers and observers of the day, on such vastly important subjects as the chemistry of the body in health and disease, the internal secretions and their hormones, metabolic processes and their disturbances, the *causation* of disease and to a description of the remarkable results secured by those modern methods of treatment, Serum Therapy, Vaccine Therapy, and Organotherapy.

The work of the physiologist and the biological chemist is becoming more important and valuable year by year. The chemist is keeping well abreast of the scientist in research work, for each is necessary to the other for the progress of Medicine and scientific knowledge.

Attention is being ever increasingly devoted to, and precise knowledge obtained in respect of, the chemical substances of the body in relation to oxidation, auto-intoxication, metabolism, and cell life, and in regard to the various glandular secretions and the profound effects exercised by their hormones.

In the opinion of many of the most competent observers, it is in this field which is being found, and in which will continue to be found, that scientific data which is generally and definitively effecting a silent, yet nevertheless sweeping revolution in therapeutics.

Only comparatively recently has any important place been assigned to Organotherapy, or have the products of Organotherapy been extensively employed. To-day the subject finds a foremost place in scientific addresses (including that of the President of the British Association), in the lectures of eminent authorities invited to address medical congresses and associations, as also in the leading journals devoted to medical and scientific subjects.

The President of the British Association, in his memorable address (1912) on "The Origin of Life," said :----

"The activities of the cells constituting our bodies are controlled by chemical agents (hormones) circulating in

the blood. Many of these are produced by special glandular organs known as internally-secreting glands. The ordinary secreting glands pour their secretions on the exterior of the body or on a surface communicating with the exterior. The internally-secreting glands pass the materials which they produce directly into the blood. In this fluid the hormones are carried to distant organs. Their influence upon an organ may be essential to the proper performance of its function, or may be merely ancillary to it. In the former case, the removal of the internally-secreting gland which produced the hormone, or its destruction by disease, may prove fatal to the organism. The reproductive glands furnish, in many respects, a most interesting example of organs which, besides their ordinary products-germ and sperm cells (Ova and Spermatozoa)-form hormones which circulate in the blood and effect changes in cells of distant parts of the body.

It is only in recent years that changes have been shown to be brought about by the agency of internal secretions and hormones passed from the reproductive glands into the circulating blood. It is not too much to assert that the knowledge of the origin of so many diseases, and of the chemical agents which, on the one hand cause, and on the other hand combat, their symptoms, has transformed Medicine from a mere art, practised empirically, into a real science based upon experiment. The transformation has opened out an illimitable vista of possibilities in the direction, not only of cure, but more important still, prevention.

A French histologist—Jolly—has found that the white corpuscles of the frog, if kept in a cool place and under suitable conditions, show, at the end of a year, all the ordinary manifestations of life.

Carrell and Burrows have observed activity and growth to continue for long periods in the isolated cells of a number of tissues and organs kept under observation in a suitable medium. Carrell has succeeded in substituting entire organs, obtained after death from one animal, for those of another of the same species, and has thereby opened up a field of treatment, the limit of which cannot well be estimated.

An instance of nerve regulation is seen in secreting glands. Not all glands are thus regulated, at least not directly, but in those which are, the effects are striking. Their regulation is of the same general nature as that exercised upon involuntary muscle, but it influences the chemical activities of the gland cells and the outpouring of secretions from them. By means of this regulation a secretion can be produced or arrested, increased or diminished. As with muscle, a suitable balance is in this way

maintained, and the activity of the glands is adapted to the requirements of the organism.

We, and all the higher living beings, whether animal or vegetable, are entirely formed of aggregates of nucleated cells, each microscopic, and each possessing its own life. Life is embodied in the cell, and every living being evolved from these will, itself, be either a cell or a cell aggregate. What we term our life, is not a single indivisible property, capable of being blown out with a puff like the flame of a candle, but is the aggregate of the lives of many millions of living cells of which the body is composed.

The strides which were made in the advance of mechanical science in the 19th century, which is generally considered to mark that century as an age of unexampled progress, are as nothing, in comparison with those made in the domain of Biology, and their interest is entirely dwarfed by that which is aroused by the facts relating to the phenomena of life, which have accumulated within the same period."

Gibson, in a remarkably able address, stated:-

"All organs—in fact, all tissues—receive from the blood certain substances, and yield in return others. Every function of the body furnishes material which is restored to the blood. The glands produce special substances to which, alone, the name of secretion can be properly applied. Many glands of the body have the power of producing hormones, and, year by year, our knowledge of the subject is becoming more extensive and more thorough.

In our study of glandular processes, we find Nature lavish of her general provision, but parsimonious in particular instances, at times. Some excess or defect of secretion may be caused by processes which, in the light of our present knowledge, appear to be pathological.

During the menopause, many—sometimes all—of the troubles and symptoms then experienced may be removed, or at least relieved, by Ovarian substance. All that we can now know, all that we can now do, is the result of modern methods of investigation. The results obtained by devotion to the three sister studies of Physiology, Pathology and Pharmacology, are to us of paramount importance. Let us, in all our doings, walk along the path of safety, through accurate observation and unprejudiced investigation."

Pende, who, has exhaustively studied the internal secretory glands, writes (Feb. 1912):—

"The function of these glands is not, as was at one time believed, to neutralize certain hypothetical toxic products of tissue change, but rather to supply certain substances called hormones, whose property it is to stimulate the anabolic or katabolic processes of tissue change, to improve the tone of the two great divisions of the nervous system, and to stimulate growth during the period of active increase in the organism.

The endocrinic and the sympathetic systems form an apparatus functionally one—the endocrino-sympathetic apparatus—the changes in which, whether localized primarily on one or the other system, give rise to special clinical and dystrophic symptoms marked (1) by signs of altered tissue change, (2) by altered tissue development, (3) by changes in the sympathetic innervation.

The internal glands being correlated by chemical and nervous relations and functionally synergic, one ought to find evidence in each of the true cardinal symptoms, of some share by the whole endocrinic system, although in any given case the symptoms associated with one particular gland may predominate. On the other hand, every gland has a strictly specific function which cannot be replaced by another gland."

Osler wrote:--

"However produced, the ultimate processes of disease represent chemical changes in the fluids and tissues of the body, and in this direction, too, the advances of the past half century have had a profound influence on chemical medication."

"Our knowledge of normal metabolism has progressed with startling rapidity, and warrants the belief that before long we shall have a safe platform from which to investigate 'to a finish' such serious perversions as are present in Gout, Diabetes, etc. Already the studies upon internal secretions have not only given us a clear conception of the functions of certain glands, but have also enabled us to treat successfully such otherwise incurable maladies as Myxœdema. In the immediate future it is along chemical lines that we may look for the greatest advance."

Starling has written:-

"If the mutual control of the body be largely determined by the production of definite chemical substances in the blood, the discovery of the nature of these substances must enable us to interpose at any desired place in these functions, and by this means to acquire an absolute control over the working of the human body. Such a control is the goal for which medical science must ever strive."

The Herbert Spencer Lecturer (1912) said:-

"There are definite signs that we are at length awakening to the fact that the knowledge needed for the right direction of progress must be gained by biological experiments and observation." Articles and addresses upon the subject are voluminous in the present day, but considerations of space forbid further extracts.

In modern practice organic extracts are more largely exhibited, and their use is more rapidly extending than is the case with other agents. The reason for this undoubtedly is that in the treatment of disease (and especially its cause), the overwhelming importance of the part played by the chemistry of the organism, and by metabolic processes, is being widely recognized. No less is it being widely accepted that treatment by ordinary drugs alone, of conditions having as their origin metabolic derangement, degenerative changes, auto-intoxication, imperfect glandular functioning or insufficiency (with the resultant disastrous effects upon cell functioning) is unsatisfactory, and frequently entirely useless.

Modern scientific practitioners and others are increasingly impressed by the belief that in the treatment of such conditions, the rational and most successful method is to transfer to the human organism in an active state, from the animal kingdom, the eminently suitable compensatory and stimulative material which is to be found there.

It has been abundantly demonstrated, in practice, that when this is accomplished by the employment of reliable and active products, scientifically prepared, degenerative changes can be arrested, while normal metabolism and normal functioning (both on the part of glands and cells) can be restored.

The impairment of metabolic activity and disordered glandular functioning seriously weaken the nervous and muscular apparatus, nor do the tissues, organs, glands and cells of the organism escape the consequence of that impairment and derangement.

Unless new, and above all, suitable material (and the only really suitable material must of necessity take the form of scientifically prepared organic extracts), is supplied, the daily waste is not balanced, degeneration proceeds, vitality is lowered, resistance falls, and soon there sets in one or more of those troublesome physical, nervous or mental disturbances, directly following fatigue and exhaustion.

When the natural supply of the necessary new material, engendered by the organism itself, is insufficient to sustain the system, but little permanent good is to be hoped for from the administration of common drugs, but if it can be demonstrated that from the animal kingdom there can be transferred to the human organism, in an active and aseptic condition, that required new material which the body has ceased to be able to supply for itself, in sufficient quantity, then, certainly the arrest of degeneration, the restoration of normal metabolism and perfect functioning may be confidently anticipated and definitely realised. That this task *can* be accomplished, and is being constantly accomplished by the products named in this brochure, is indisputable, and the proof of this statement will be found in the remarkable record of the results from their administration sent in, without request, from British Practitioners, some of which are reproduced herein. Those reports are but representative of many others which come to hand week by week throughout the year.

The formulæ of the products will be found in another part of the brochure. From an examination of them it will be observed that the products are "pluriglandular" compounds, and do not consist of one organic extract only. There is an important reason for this.

Clinical experience, extended over a long period, has definitely proved the fact that the results obtainable from the administration of one organic derivative only are never so definite, rapid or permanent as when other organic extracts are combined in one preparation.

Thus in the treatment of, for instance, mental disturbance, it has been repeatedly found that treatment by brain extract alone was never as successful as when the brain extract was combined with Testicular Extract, Lymphatic Gland Substance and Spinal Cord Substance.

Similarly it has been demonstrated that in treating the various disturbances of the menopause by Ovarian Extract alone, results were never so rapid and definite as when Ovarian Extract and Mammary Gland Extract were combined in the same Compound.

Metabolism has been defined as the change produced in a substance by the action of living cells upon it, or alternatively, the process by which living cells incorporate the matters obtained from food into a part of their own bodies.

Constructive Metabolism or Anabolism has been defined as the change of matter from a lower to a higher state of organization, while destructive Metabolism or Katabolism, has been defined as the conversion of matter into a lower state of organization, and ultimately into waste products.

The study of Metabolism has three objects:-

1. The investigation of the "exchange of materials," and the extent and character of the incessant transformations which accompany and determine the changes occurring within the living tissues.

2. To ascertain the method of the conversion of chemical tension into living energy.

3. To ascertain how the normal process is affected by the disturbance of the proper balance which should obtain in the secretions. in th dison with

The antagonistic action of the internal secretions has been established by the researches of Krauss, Friedenthal, and others. It is conceded by practically all the authorities that if there is introduced certain of the animal substances with an internal secretion, there will be produced an excess of that secretion within the body, and, therefore, stimulation of certain antagonistic secretions which may not have been present normally.

It requires but simple reasoning to see that, if, by such stimulation, there can be restored that perfect harmony which, in normal health, obtains, any morbid condition must, of necessity, be benefited.

Extensive experiments have been conducted with what are assumed to be the individual active elements of a number of the animal derivatives, but the results obtained from their *individual* clinical employment has not been the same as the action of a pluriglandular compound. As examples of this may be cited the independent use of such agents as Nuclein, Lecithin, Cholesterin, Thyroidin, etc.

The definite tonic action of certain animal derivatives upon metabolic processes being established, there has been incorporated in the Lymph Compounds (Lowenthal), what is considered to be the newest addition to, and the farthest advance in, Organotherapy—products which research has demonstrated possess the greatest remedial activity.

With the animal substances have been included in the capsules, but not in the serum, drug synergists, which are important constituents of the normal cells, or have a selective action upon the nervous system or the eliminative process.

It is admitted by most competent authorities that what has been aptly described as the "labyrinth of metabolism," is being further penetrated year by year. As a result, the armamentarium of the modern practitioner is now being supplied with new and potent weapons in the form of scientific organotherapy products, with which to fight disease, degeneration and the toxin of fatigue—weapons at once more effective and more powerful than those which have been at his service in the past.

The objective and subjective phenomena of metabolic disorder are being increasingly recognized in modern practice, with immeasurable advantage to patients.

Atrophy, Perversions of Growth, Emaciation, Hypertrophy, Obesity, Impoverished Blood, disturbances of the circulation, Auto-intoxication (as in Acidosis and Glycosuria), increase of purin bodies (as in Gout), and disorders of functioning, are, much more frequently than not, the direct or indirect result of impaired nutrition, which causes, in turn, the neuroses of fatigue.

The nervous system is undoubtedly the chief sufferer in such conditions, for the phenomena which result can be found in Neurasthenia, Myasthenia, Hysteria, Neuralgia, Pscyhasthenia, local and general spasmodic affections, Hypochondriasis, Melancholia, and other conditions.

There is, perhaps, not one experienced practitioner, who would care to deny, that in conditions arising from disordered metabolism, drug medication, rest cures, Psychotherapy, Hydrotherapy, Climatotherapy and Electrotherapy (though useful under special circumstances in modifying *some* symptoms) have proved sadly wanting in effecting a permanent restoration to the normal, and a removal of the *cause* of disease.

Perfect nutrition and normal metabolism ensure a proper co-ordination in the activity of glandular organs and of the cells of non-glandular organs.

It is now agreed by most authorities that disorders of metabolism, and changes in glandular functioning have, as their cause, disturbances in balance in the chemistry of the body. The influence of the chemical action of the internal secretion of one gland upon that of another, when normally functioning, is the great defence of the organism against metabolic perversions.

Loewy reported as a result of the experiments which he conducted, to ascertain the influence exerted by the internal secretions of the sexual glands upon metabolism, that extirpation was always followed by a reduced metabolism, while the administration of testicular extract invariably resulted in a higher metabolism. Testicular Extract, aseptic, active and scientifically prepared, is one of the principal ingredients of the Lymph Compounds (Lowenthal).

It has been demonstrated that disordered metabolism of the Mammary Glands can be productive of a virulent toxin, which condition can be overcome by the administration of Mammary Gland Extract (scientifically prepared).

Perhaps the disease in which metabolic disorder is illustrated most graphically is Diabetes Mellitus. Falta has shown that the glands with an internal secretion play a most important part in the causation of this disorder, the influence of the nervous system being exerted through them.

A striking example of the "balancing" effect of the compensatory material in the Lymph Compounds (Lowenthal) may be observed in the treatment of this disease by these products, for in at least 90 per cent. of the cases of this disorder treated up to the present, a marked reduction of sugar has been reported as being obtained. A reduction of from 5 per cent. or 4 per cent. to 1 per cent., is a common experience, func its e also, corre

That there is throughout the whole animal kingdom a uniformity in chemical processes is no longer disputed. The chemical products of every organ of the body must, to a greater or less extent, influence the remainder of the organism.

An eminent biologist has recently expressed the view, that, as every chemical process is accompanied by some definite loss resulting from the formation of by-products, it is probable that in the human organism, the cumulative effect of such losses in the constant breaking-down of cells, must, unless compensated for, bring the machinery of the organism to a complete standstill in the course of time.

The belief is becoming general that all forms of nerve action are expressions of chemical activity.

Neurasthenia (Primary or Secondary), Borderland Insanity, Hypochondriasis, Fatigue, Emotional Breakdown, Obsessions, Hysteria, etc., produce chemical and cellular defects of the ductless glands. Mental strain induces disorders of functioning because of the inability of cells to resist that strain.

Similar changes have been observed in cases of shock, as, for instance, in Exophthalmic Goitre. That a complete restoration of normal chemical activity, cell functioning, and metabolism, with the eradication of the conditions named, can be obtained and maintained by supplying the requisite compensatory material, will be found to be demonstrated in the reports which appear in the later portion of this brochure.

It has been truly said that life is the expression of a function. That organism, which is in perfect balance with its environment, and which has all its parts in proper balance also, *must* be in health.

Unless there be present in the organism that perfect correlation of functioning which follows from a perfect adaptation of its cells to their environment, individually and collectively, perfect health cannot exist.

Departures from normal glandular functioning, with the resultant and inevitable disturbance of pluriglandular balance, spell disease.

Reactions, which, after all, are but biological manifestations, do not need treatment one half so urgently as do the causes of those reactions.

Perfect correlation of cellular and glandular activities, which alone is manifested in a condition of perfect health, and by means of which perfect functioning and a normal metabolism is secured, is by far the most important asset which the human organism can possess.

Probably the most effective weapon of defence which that organism possesses is the ample provision made by nature

against the complete loss of cells engaged in furnishing the products of glandular secretions. Meltzer has aptly termed this provision, "the factor of safety."

That the chemical activity of the organism is largely originated by sensations, emotions and impressions, is no longer in doubt. That this activity extends to the glands of the body, profoundly modifying their secretions in one direction or another, is not now disputed.

A modification, of whatever nature, in the internal secretion of one gland, necessarily disturbs that normal balance in the chemistry of the body, which is essential to its health. This *must* be so because the hormones, or (as they have been well named) the "chemical messengers" of the secretion so modified, influence the secretions of other glands or act as stimulating agents in regard to other activities.

That perversion in functioning of a gland with an internal secretion is inevitably accompanied with a marked modification in nutrition, is a matter of common observation.

Knowledge of the internal secretions and cell life has advanced sufficiently for it to be definitely known that cells are incapable of individual or spontaneous action. They remain inactive until stimulated into action by a ferment or hormone. If a cell loses its activity, the supply of the hormone still continues, because other cells take upon themselves the duty of manufacture, or else the effect of the changed product is neutralized, or antagonized, by a secretion which has become modified, in its turn, because of the original chemical change.

This action of products, thus modified, may well explain many of the varying symptoms observed in disease.

Koehl has pointed out that absence of functioning or imperfect functioning of the same gland, in various patients, lead to similar, but in some respects, quite different symptoms.

Glycosuria is observed in disease of some glands. The failure in one gland cannot fail to affect other glands standing in relation to it. It is agreed by all observers in this field that glands with an internal section have definite interrelationship, the unimpaired maintenance of which is essential for the normal functioning of all.

Perversions of glandular functioning and in the internal secretions, are the origin of many affections which seriously 'mpair health, and cause much suffering. Both hyposecretion and hypersecretion are strictly accountable for many of those well-defined symptoms of nervous disturbance which are matters of every-day experience.

A gland which is over-functioning can be controlled by stimulating the antagonistic gland. A gland which is underfunctioning can be regulated by supplying to the organism a similar secretory product, provided that product is scientifically prepared and active. The provision of the required stimulative and compensatory material is the whole work of

scientific Organotherapy in general, and of the Lymph Compounds (Lowenthal) in particular.

Practioners of experience agree as to the necessity of employing indirect methods of treatment by securing the proper regulation of functioning, normal metabolic activity, the elimination of auto-intoxication, and by providing stimuli for obtaining cellular activity. Not only are the *symptoms* of a morbid process thus modified, but the morbid process itself is rectified.

Only by the stimulation of physiological processes and the provision of suitable compensation to arrest and off-set the effects of degenerative changes can the goal of perfect chemical activity be attained, and normal functioning consequently secured. The results thus obtained are shown, by all experience, to be of a permanent character.

Ott has written:---

"Just as glands with an internal secretion concur in taking up the work not accomplished by the others, and unite in the perfection of the products to be brought forth, so in a similar way the glands with an internal secretion concur in the metabolites to be produced. By reason of this, physiological balance is maintained between the activities of the different glands in the wilderness of metabolism.

It will probably be agreed by most practioners that the most pronounced expressions of functional disease are to be found in the neuroses of fatigue. It has been stated, probably without exaggeration, that fatigue, with its consequent imperfections in functioning and abnormalities in the chemistry of the body, gives rise to more suffering, shortens life, and causes death more frequently than any other agent.

To fatigue can rightly be credited many of the serious and deep-seated nervous disturbances which so increasingly call for treatment nowadays. The results of fatigue are infinitely more far-reaching than would at first sight appear, and it will not be seriously disputed that the older methods of treatment which stimulated, and which did NOT *compensate*, have proved wanting.

Modern clinical observation has demonstrated conclusively that by supplying to the organism those cellular elements, in an active state, which Organotherapy can alone yield, fatigue and its results can, in most cases, be banished, until such time, at least, as natural decay shall bring the patient to a point at which no compensation can avail. Up to that point, Organotherapy can ensure the substitution of new cellular activity for that which has been lost.

A reference to some of the cases of physical and mental fatigue which have been successfully treated by the Lymph Compounds (Lowenthal) when the older methods have failed and which may be found in the latter part of this brochure, will demonstrate how the results of fatigue may be definitely overcome and permanently overcome by the compensation afforded by those products.

The active agents of the glands with an internal secretion are essential for the proper functioning of the nervous system, for normal circulation, correct metabolism, and for the growth of tissue. Pluriglandular efficiency is vitally necessary for the health of the organism, for each gland with an internal secretion has a many-sided relationship to the remaining glands with an internal secretion, as has been shown.

Defective elaboration of the secretion of one gland, or the cessation of that elaboration, must inevitably injure the whole organism, and the nervous system especially.

The power of self-nutrition, possessed by the human organism, which enables it to exercise resistance, to protect itself by counteraction, and, by the destruction or elimination of deleterious agents, to provide for the re-establishment of chemical balance, when that has been disturbed, very frequently fails. That failure is directly responsible for a heavy percentage of those physical, nervous and mental ailments to which the organism is prone.

Therapeutic agents, therefore, which, as in the case of the Lymph Compounds (Lowenthal), have been clinically demonstrated to be capable of reinstating that power, and thus restoring normal functioning, must be of incalculable service.

For all disorders of the body Nature endeavours to make provision for defence, but extraneous aid is frequently necessary. The requisite help cannot, in those disorders originating in degeneration, or metabolic disturbance, be well obtained from either the vegetable or mineral kingdoms, but from the animal kingdom can indisputably be secured those secretions and organic derivatives from the administration of which, such striking and eminently satisfactory results, are being increasingly obtained.

Biological methods must logically, and, as a matter of fact, do, in practice, produce the best results. The assisting of Nature when there is a deficiency, and the enabling of her to control and balance when there is excess, is found to be, by experience often repeated, the surest method of removing the cause and preventing the return of many disorders.

Deficiency of an internal secretion in the human organism can be overcome by the administration of that secretion obtained from the animal kingdom, when scientifically prepared, while excessive secretion can be controlled by administering the secretion of an antagonistic gland, obtained and prepared similarly. The Lymph Compounds (Lowenthal) exert two direct and powerful influences, namely, the strengthening and building up of the muscular and nervous systems, and the introduction into the blood of new and requisite material for cell nutrition.

It has been well said that, "To use intelligently in disease those natural products by which the body is enabled to do its *own* work in health, can but be regarded as reasonable, and *must* form the basis of a rational therapy."

Extensive clinical employment of the Lymph Compounds (Lowenthal) has proved to demonstration that those products (judged solely by the results obtained from their use in cases of the most difficult description, in which many other forms of treatment had previously failed) provide such adequate stimulation, regulation and compensation as enables the body to do its own work thoroughly and faultlessly.

The full and complete formulæ of the Lymph Compounds (Lowenthal) and the Ovammamoid Compound (Lowenthal) will be found set out in this brochure. From these it will be seen that in the case of the Lymph Compounds (Lowenthal) there are present (in an active and aseptic condition) that most potent and compensatory agent Spermine, Brain Substance, Extracts of Lymphatic Glands (chosen for their importance) and Spinal Cord Substance, together with perfectly preserved Sperm cells, Lymph cells, tissue cells, and Leucocytes, as also those active principles Cerebrin, Nuclein, Cholestrin, Lecithin and Organic Phosphorus. In the case of the Ovamammoid Compound (Lowenthal) it will be seen that there are present (in an active and aseptic condition) Ovarian Extract (with the homone of the secretion) and Mammary Gland Extract.

By the adequate administration of the scientificallyprepared products of these formulæ, it is being constantly demonstrated that impediments to what has been aptly termed "the essential process of life," namely cell activity, are definitely and permanently removed.

It may be taken that the Lymph Compounds (Lowenthal) contain more Lecithin, dose for dose, than any other preparation at present available.

The formulæ of the products have invariably appealed immediately to scientific practitioners as being rational and likely to prove of exceptional service in practice. That those expectations have *not* failed of realisation may be confirmed by reference to the case reports and medical opinions to be found in the latter part of this book.

The treatment has been found of exceptional service not only in cases of functional disorder, but in diseases involving organic change also, though in the latter no exaggerated or absurd claims are made for the products. It is freely admitted that in cases of organic disease the treatment has certain well-defined limitations, yet, nevertheless, within those limitations, marked and often striking benefit is obtained. Those results are secured solely by the cellular compensation which the tonic action of the preparations induces. When one kidney is removed there is a compensatory hypertrophy of the one remaining. If one of the senses be lost, the remainder are rendered more acute, and a certain compensation for the loss is observed.

In Tabes Dorsalis, for instance, the sclerosis begins at the posterior end of the cord, and gradually progresses upwards. With this progressive developemnt of the disease there is a progressive increase of ataxic symptoms.

It is known that by the use of the Lymph Compounds (Lowenthal) the progressive symptoms have been arrested in a great many cases. The number has been sufficient to take the results entirely out of all possibility of accidental action.

There is, through the agency of this combination, enough compensatory action upon the cellular tissue of the cord unaffected by the degenerative process, to arrest the progress of the condition and permit the patients to resume their avocations, with only slightly impaired faculties, and with little or no pain.

It is not intended to infer that the Lymph Compounds (Lowenthal) can restore cells which are dead, and there are long-standing cases of Tabes in which the degenerative process has progressed to a point where no compensatory development of the cell tissue could be effected.

Marked benefit will follow administration of the Compounds in the great majority of cases, and in most the progressive symptoms will be positively arrested when that point has not been reached.

It is unnecessary to point out to the skilled physiologist or pathologist that whenever a cell, which was originally endowed with a special function has undergone a process of degeneration, it is for ever dead to the system so far as specialising activity is concerned.

It is therefore manifest that in such cases the object aimed at should be to arrest the degenerative process as rapidly as possible, and to enable the healthy surviving cells to obtain such compensatory reinforcement as will enable them to carry out the functions of those cells which have become incapable by degeneration.

This is what is actually accomplished by the Lymph Compounds (Lowenthal), and in that direction they have proved remarkably successful, and are of considerable service to practitioners. The claim made by some that *their* organic preparations can and do revitalise and restore to full activity cells that are degenerated or dead, is obviously an absurd and indefensible exaggeration. Carefully kept records indicate that, of 700 cases of Locomotor Ataxia treated with the Lymph Compounds (Lowenthal) there has sufficient compensatory action upon the cellular tissue of the cord unaffected by the process of degeneration, to arrest progressive symptoms and to enable the patient to return to active life with little or no pain, and much improved gait, in the great majority of those cases.

No compensatory development of the cell tissue could be obtained in some cases, owing to the degenerative process having progressed too far.

* *

Of the numerous disorders which may rightly be included amongst those originating in functional disturbance, perhaps the one in which the Lymph Compounds (Lowenthal) is most frequently prescribed (because of its prevalency) is Neurasthenia.

Under that general heading is grouped a variety of conditions which are among the most trying the physician is called upon to treat. One may search the text-books or review one's personal experience, and be surprised to find what a limited number of agents are available for the treatment of this condition.

It is clearly demonstratable in Neurasthenia that there is a disturbance of the normal metabolism. If one unhesitatingly accepts the theory that the internal secretions are mutually inter-active, and that the excessive functioning of one gland increases the functioning of the others in the effort to maintain the proper balance, it is not irrational to believe that the introduction of agents which we know play a stimulating part in the process involved, should prove beneficial.

In cases of utter nerve exhaustion, or where overwork or worry has induced nervous disorder, the Lymph Compounds (Lowenthal) have clearly demonstrated their exceptional value. Those preparations, in nervous conditions, supply the body with an added amount of certain of the internal secretions.

Nature's method of maintaining the normal balance causes certain antagonistic secretions to be developed whichprobably have been defective. That some such process takes place is evidenced by the fact that in profound nervous excitement the administration of the products has a sedative action, whereas in nervous depression, it has a stimulating effect.

This seems paradoxical, but is supported by a mass of corroborative data.

The employment of the Lymph Compounds (Lowenthal) in the various forms of Neurasthenia is very extensive, and the success remarkable. Often the etiology of the condition is obscure, but the justification for the employment of the Lymph Compounds (Lowenthal) is based upon the same principal that obtains with any remedial agent, i.e., the endorsement of unprejudiced and competent medical observers.

The agents which have hitherto been employed in the treatment of Neurasthenia have admittedly proved more or less ineffective. The Lymph Compounds (Lowenthal) are at least worthy of trial, for it is beyond dispute that immeasurably greater success has attended the practical application of the rational theory herein set out, in this condition, than by that of any other.

Information as to the methods and the processes employed in the preparation of the Lymph Compounds (Lowenthal) may be rightly required by practitioners, and a description of them is therefore now given. First of all it is desired to draw special attention to the fact that none of the glands and organs utilized for the preparation of the products, nor any material whatsoever, is obtained from slaughter-houses, and that no pain is inflicted when dissecting those glands and organs.

Those who are anti-vivisectionists by conviction may employ the products freely without violation of principle.

Compression is never employed in manufacture. Compression *must* be employed when organic derivatives are put up in the form of tablets or powders. Compression invariably results in a very definite depreciation of activity.

The selected animals, at the zenith of their vitality, are, after detailed examination, placed under an anæsthetic. When the anæsthesia is deep, the required organs and glands are removed, and the products immediately prepared therefrom.

Stringent precautions are observed throughout the whole work of preparation, both as to environment, and in every other respect. Thus an unqualified guarantee can at all times be given that all products are, whenever sent out, absolutely aseptic and active, and that they will remain so, (subject to the observance of the specified conditions as to temperature and absence of light) for six months at least.

The best evidence which can be produced as to the complete success of the precautions taken, and the processes employed, is the fact that, although the Capsules manufactured and distributed, upon prescription, in a year, number at present more than two millions, and although the amount of Serum manufactured and distributed upon prescription by the Company reaches in a year to many hundreds of ounces, not one case of ill-effect has ever been reported.

In the preparation of the products, the glands and organs required are derived from goats, bulls and rams. The animals used are between twelve and fourteen months old, because during this time the lymphatic structures attain their highest development and yield the largest amount of lymph and lymphatic extract. The goat is practically immune from all infectious diseases, and is possessed of a lymphatic system capable of unusual development.

The selected animal is placed completely under the influence of an anæsthetic as stated, and, under the strictest aseptic precautions, is bled and relieved of the following structures, viz., Lymphatic Glands and Ducts (except glands exterior to thoracic and abdominal cavities), Testicles, Spinal Cord, Medulla and grey matter of Cerebrum and Cerebellum.

From these structures the following ingredients of the Lymph Compound are derived, viz., Lymph, Extracts of Lymphatic Glands and Extracts of Spinal Cord, Medulla, and grey matter of Brain.

These extracts are practically emulsions of the cellular ingredients of the structures named. The glands, cords, etc., are reduced to a highly concentrated fluid with a heavy cellular sediment.

Filtration, through a porous composition and the use of re-agents, removes the connective tissue, fat and coagula, but not the lymphocytes, nor all of the fixed cells which have been loosened by the mechanical processes employed. A thorough post-mortem examination absolutely prevents the use of unhealthy animals. Animals are rejected if the slightest abnormality is found, even the results of traumatism.

Orchitic fluid is taken from the testicles of bulls, goats or rams (chiefly bulls) immediately after castration. Threefourths of this fluid is taken from the globus major and minor, because in these reservoirs the orchitic fluid is excessively rich in spermatozoa, and is expressed as thick and creamy fluid. This fluid is treated by exactly the same process as the other ingredients already mentioned.

The derivatives are first fumigated with chlorine gas, and then subjected to carbonic oxide under 300 atmospheres pressure for several hours. The cylinder is then opened and the menstruum added, after which the entire product is filtered through a thick layer of sterilised gauze.

The menstruum above mentioned consists of carbon water, to which has been added a small amount of chloride of gold and sodium (10 minims of the lymph contain 1-40th of a grain). This salt is used because of its preservative properties and also because it is mildly synergistic to a cell tonic in view of its cell alterative effects.

With a microscope (1-8th objective), the sediment of the end product will be found to be very rich in perfectly preserved Spermatozoa, and Lymph Cells, with fixed tissue cells, Red Cells, Crystals of Lecithin, Chloride of Sodium and Spermine Phosphate.

The finished product appears as a canary-yellow colour fluid, often with a slight brownish tinge. It has a heavy sediment almost wholly composed of cells, which sediment is perfectly emulsified by agitation. The Lymph Compound

is acid in reaction. Its method of preparation renders it decidedly aseptic, its bactericidal strength equalling that of 1-10,000 Bi-Chloride of Mercury Solution.

The active principles in the preparation are chiefly contained in the Lymph Gland Extracts, Lymph Cells and Spermatozoa, these cells being preserved in a perfectly normal condition so that, when injected into the body, they give up their active principles, such as Spermine and Nuclein, in a nascent condition.

The fact that most of the active principles in the Compound are contained in these cells, and the concentrated fluid organic extracts, is demonstrated positively by the experiment of filtering the lymph. After removing the sediment the fluid will effect only very moderate cell tonic reaction.

Until it is possible to more accurately define the various internal secretions (the existence of which and their positive metabolic influence have been positively proven), one cannot accurately define the chemistry of the active principles contained in these cells and fluid organic extracts.

It is known that the action of the Lymph Compounds can by no means be wholly explained by the known ingredients of Spermine and Nuclein. A comparison of physiological actions positively demonstrated this fact. In view of clinical results one is bound to conclude that the method of extraction and preservation employed incorporates in the Compounds the positively identified but imperfectly understood, internal secretions of the Testicles and Lymph Glands.

The Lymph Compounds are powerful direct cell tonics and cell compensators, having a direct effect upon the specialised functions of most organic cells, and expecially those of the nervous system, as also upon the general processes of fixed metabolism (assimilation, disassimilation and elimination).

The conclusion is legitimate that the Lymph Compounds are a powerful tonic to Phagocytosis, because the reactions effected are very often more decided and complete than could be explained by the action of the lymph in increasing the resistance and functional capacity of fixed tissue cells.

The Lymph Compounds are powerful alteratives, since they alter the inherent processes of cell metabolism. The alterative effects are proven conclusively by clinical results. The Lymph Compounds are unusually efficient cell nutrients. This effect has been positively determined by clinical results, and is explained by the composition of the lymph, which is unusually rich in Cell Albumin, Lecithin and Organic Phosphorus, presented in a form which permits of immediate and complete assimilation.

The Lymph Compounds have a direct tonic effect upon the Cerebral Cells, Spinal Cord and Heart and Unstriped Muscle Fibre.

Many hundreds of reports of cases treated by the Lymph. Compounds (Lowenthal) have been received from practitioners. Every report indicates that the Compounds are powerful nerve cell tonics and compensators, and that they are especially indicated in mental cases where there are functional psychoses.

A careful examination of the formulæ of the Lymph Compounds (Lowenthal) will demonstrate to physicians that the harmonious action of each of the ingredients incorporated *must* be perfect. They are all potent tonics, as well as being active compensatory and stimulative agents, and they act directly upon the cells of the organs and tissues of the body.

All conditions in which there exists a need of nerve cell stimulation and compensation cannot fail to materially benefit by the exhibition of these Compounds. It has already been stated that the Lymph Compounds (Lowenthal) contain more Lecithin than any other preparation. It is equally true that they contain more Spermatic elements than any other preparation.

All the literature on Organotherapy by the leading authorities and scientists of the world is unanimous that spermatic elements have a very special and decided influence upon cell stimulation and cell compensation.

In the course of a heavy correspondence with practitioners many questions have been asked and answered in respect to the Lymph Compounds (Lowenthal). Some of these queries and replies are summarized below.

When the Lymphoid Compound is given by the mouth, does not the gastric juice change or render ineffective the constituents of the products?

This is not the case, for if it was so, the striking results constantly reported from the administration of the treatment would not be obtained.

Secondly, it has been demonstrated that if Thyroid Extract be administered in certain quantities to a nursing mother by the mouth, the infant can develop thyroidism, thus proving that the derivative passes into the milk, meeting with no obstacle.

Thirdly, an exhaustive study as to the effect of passing tuberculin and other emulsions through the lining walls of the intestinal tract has been made.

It has been clearly proved that such action is not only possible, but that it can be done without a change in the character of the agent employed.

Are not the Products empirical?

In the sense that the precise mode of action of the constituents of the Compounds cannot be demonstrated, the products *are* empirical. As to the ultimate results of adequate administration of the preparations however, practitioners are referred to the reports included in this brochure, for conclusive evidence. When such permanent and positive results are obtainable from the exhibition of any agent, scientifically prepared, what matters it that the actual *modus operandi* cannot be set out in detail for the present?

Can it be disputed that in the case of every therapeutical agent, or combination of agents, an idea (based upon scientific knowledge of their properties) that they *ought* to produce such and such a result, originated in the brain of the discoverer, and that those preparations later became accepted, and widely employed, because it was discovered, from the results of clinical observation, that the theory was a correct one, and that the anticipated results could, as a matter of fact, be definitely secured? This is precisely what has happened in the case of the Lymph Compounds (Lowenthal).

In these days of enlightenment there are surely but very few who would consistently maintain that suffering patients must wait until the precise mode of operation of a therapeutical agent (in respect to which an abundance of clinical evidence as to its value exists) has been fully demonstrated.

Some day, in all probability, the precise nature of the internal glandular secretions will be definitely known and proved. Until then one must rest satisfied with the proved clinical data and the theories based on observation of Organotherapy in general, and also with the striking and indeed remarkable results which are being constantly secured in conditions of the most troublesome character, by the practical application of that data and those theories.

One of the most eminent of consulting physicians has written:---

"We are still compelled on many occasions to employ empirical methods. Successful treatment must depend to a great extent upon the power of the practitioner to employ empiricism in individual cases."

Another consulting physician, equally eminent, has written:— "Much of the best medical practice is empirical. Rational empiricism has never held a higher place in the history of medicine than to-day. We should not forget that empiricism has often anticipated scientific discovery in medicine. Clinical experience alone has certified the nature of some agents, whose action the scientist has long subsequently learnt to explain. There are still many remedies, of which the efficacy is well assured, but whose exact action remains to be explained on a scientific basis. There is undoubtedly a growing loss of faith in drugs."

If the method of treatment be brought to the touchstone of clinical experiment and observation, and is certified as of definite therapeutical value by careful and prolonged experibee ma in res

Although it may be readily understood from an examination of the formulæ, that the products can be of service in conditions arising from FUNCTIONAL disturbance, upon what ground is the claim that the treatment can be of definite use in conditions involving organic change, based?

Strikingly successful results have been definitely obtained and certified to by many practitioners in diseases involving organic change. A reference to the reports from practitioners reproduced in this brochure, will confirm this. In the great majority of cases of organic disease in which the products are exhibited, other methods of treatment, including Iodide of Potassium, Mercury, and other forms of drug treatment, as well as other therapy, have been previously employed without success.

This fact notwithstanding, the degenerative process has been reported as definitely arrested, and the main symptoms markedly modified, by the action of the products (usually in Serum form, or Capsules and Serum conjointly). Such results would never be reported at all if treatment had no definite action after administration.

If a specialized cell is degenerated, it is practically dead so far as its special functioning is concerned. From a scientific standpoint it is absurd to discuss the possibility of restoring that cell even one step towards its original condition.

Therefore in degenerative and organic diseases affecting specialized cells, the only hope, now and ever, is to stop the progress of degeneration, and to accomplish, as far as possible, a compensation.

To deny the possibility of providing compensation in organic degeneration is to deny every-day occurrences. There is probably not one practitioner of wide experience who has not knowledge of cases of indisputable organic disease, which have never been and never will be cured, *theoretically* or *absolutely*,but in which sufficient compensation has been afforded from one source or another to enable the patient to live in comparatively good health for many years, and eventually to die of some other disease.

That the instinctive tendency of nature herself is towards compensation for structural insults is not arguable. Such common examples as the wholly adquate compensatory thickening of the heart wall in valvular deficiency, and the maintenance of health, at or near the ordinary level, upon the loss of one kidney or one lung, by compensatory changes in the remaining one, corroborate that statement. In view of these facts, it is surely a rational postulate that powerful and direct cell tonics, stimulators and compensators, as the Lymph Compounds (Lowenthal) have been demonstrated to be, provide the best possible means of assisting Nature in her compensatory efforts.

The provision of sufficient compensation by the administration of the requisite and only suitable material, so as to cause the undegenerated cells to take up the work, only partly performed, or laid down altogether, by the crippled and destroyed cells, is the office which has been proved to be successfully performed in case after case of organic disease by the Lymph Compounds (Lowenthal).

Is it not possible that many of the striking results reported by practitioners from the employment of the products, are due to "suggestion" only?

In certain types of a few intangible conditions accruing from functional disorder "suggestion" might conceivably be thought to explain the action of a therapeutic agent, but the conditions in which the Lymph Compounds (Lowenthal) are employed, and in which complete and permanent recoveries, or else (in organic diseases) a definite arresting of the degenerative process have been obtained, are conditions which are not amenable to psychotherapy.

"Suggestion" alone has never yet produced a radical and permanent result in a tangible morbid entity of a chronic type, and never will. No practitioner or scientist of experience will seriously debate the potency of "suggestion" in chronic degenerative, atrophic or inflammatory lesions.

No conceivable psychic influence can permanently compensate for, or arrest, the progress of lesions in the fixed cells of the body, neither can any such influence restore normal metabolism, secure proper glandular functioning, or secure that the chemistry of the organism shall be efficiently regulated.

Reports frequently come to hand from practitioners in respect to cases which recovered by the employment of the Lymph Compounds (Lowenthal) long ago. Those reports are to the effect that the definite benefit then obtained has never been lost, and that the patients are enjoying normal functioning capacity. In none of the cases could "suggestion" have had any more permanent influence than a whisper upon the great pyramids of Egypt.

Why are the indications for the products so varied, so wide and so dissimilar?

The work to be done, and which is actually accomplished by the products, is to strike at the origin of each condition in which the treatment is indicated, and thus to permanently remove the cause of the trouble as well as its symptoms. It is true that the conditions in which the products are indicated are varied, and, in some instances, apparently disassociated. tulate combeen ussist-

shed ition ently It ated ited. Nevertheless, the Compounds are not in any sense "curealls," nor are they ever claimed to be such. An examination of the complete list of indications, will establish the fact that every one of them may, and most frequently does, have as its antecedents cell degeneration, metabolic disorder, irregularity of functioning, defective oxidation, auto-intoxication, or disturbances of the vaso-motor and sympathetic nervous systems.

It is owing to the potent compensatory and stimulative effect of the treatment upon these *sources* of disease that the permanent recoveries, continually reported, are attributable.

Why do you include glycero-phosphates in the formula of the Lymphoid Compound (Lowenthal)? How am I to know that the results reported from the exhibition of the products may not be justly attributed to the action of the glycero-phosphates only?

The glycero-phosphates are included merely by way of side treatment and for the promotion of appetite. The great majority of cases placed under treatment by the Lymphoid Compound (Lowenthal) are those in which, previous to the adoption of that treatment glycero-phosphates had been employed without any success, and yet, notwithstanding, those same cases have yielded completely and permanently to the action of the Lymphoid Compound (Lowenthal).

The Lymph Serum (Lowenthal) contains no glycerophosphates at all, and neither does the Ovamammoid Compound (Lowenthal), and yet in respect to both these products the results secured are equally as striking and as satisfactory as in the case of the Lymphoid Compound.

In view of all these facts, it must be definitely admitted that the glycero-phosphates included in the formula of the Lymphoid Compound are by no means indispensable, but merely an auxiliary to the main constituents, namely, the organic derivatives, the absence of which latter could but be productive of negative or, at the best, very unsatisfactory and incomplete results.

Many aspects of physiology and pathology have been already revolutionized by the results of the study of glandular physiology. By the penetration of the "jungle of metabolism" thus far, there have been discovered facts of the profoundest significance and importance. The continuous investigation of the character and office of the secretions and hormones of the ductless glands is yielding results which add agents of enormous value to the equipment of the modern practitioner.

Ott has recently written:-

"The human organism has secretions which have hitherto been unsuspected, and which do and must play a most important part in our economy. Most potent are the secretions of the ductless glands. We observe in the results of their action the simple external manifestations of the great forces at play in the nutrition of the organism."

In Organotherapy more than in any other branch of therapeutics, bio-chemistry is enlisted for the assistance of the organism when its own bio-chemical mechanism needs readjusting.

The intimate association between man and the biological world is recognized by science to-day as it has never been before. There is now no dispute as to the fact that he represents the highest type of organisms, that his functions and organs are highly specialized, and, more important than all, that the same biological laws which govern the lowest types of life, govern him also.

The laws of biology must therefore for ever be essential considerations in the minds of those whose methods of treatment are modern and scientific. It has been well said that the trend of modern therapeutics must increasingly be in the direction of "driving health in" rather than in that of "driving disease out."

The *causation* of disease must increasingly be the subject of scientific treatment rather than the amelioration of symptoms alone.

The chief object of the conscientious practitioner of to-day is indubitably to preserve and prolong life and to mitigate suffering. He knows that experiments and research are yielding new facts which are altering earlier conceptions, and that further advances in chemical knowledge, and the study of nitrogenous metabolism, are enriching thereapeutics.

No one knows so well as he that the heavy demands of a busy practice leave him but little leisure to enable him to keep abreast of the latest developments in scientific chemistry and the results which are being secured from their application.

To such, a resume of those results must be a convenience; for, given a method of treatment the scientist basis of which is admittedly sound, and the clinical results of which are attested by numerous members of his profession, sufficient prima facie evidence is in his possession to justify his making at least a trial of that method of treatment in his own practice.

A month previous to coming to me, patient put himself in charge of three of the leading specialists in Chicago and they were all of one opinion that the patient was suffering from Locomotor Ataxia and advised specific treatment. Patient presented himself at my office October 26, 1909. Upon examination I found absolute loss of sensation for lower limbs, Argyle-Robertson pupil, Rhomberg's sign, patient complained of restriction around the abdomen, also shooting pains in the limbs. The patient had the tabetic gait, knee reflexes were absolutely lost. There were areas of anæsthesia, also paræsthesia present. The patient weighed 116 pounds. I put the patient on the Lymph Serum treatment, administered ten drops every other day, in connection I gave him the Lymphoid Compound Capsules, one before each meal. I also put him on re-educational exercises and as early as the tenth day the patient noted marked improvement. Since that time he has been able to walk without a cane or crutch and has put on 13 pounds. The patient is still under treatment and feels as though he has been absolutely restored in every way. I am going to continue the treatment for at least three months longer, giving patient one treatment per week in connection with the capsules.

DR.A.A.L. (CHICAGO), writes:-

"I wish to give case reports on a few very interesting cases that responded beautifully to the Lymph Compound Treatment.

Case No. 1—Male, forty-two years old. Pronounced case of Tabes Dorsalis. Patient has been treated by some of our leading neurologists. This case was considered absolutely hopeless. Patient was unable to walk and had every symptom characteristic to this type of disease, even a marked ptosis of the left eye lid. Patient weighed 116 lbs. After administering Lymph Serum in ten drop doses three times a week for four months, I discharged the patient. I have over 300 very interesting cases that I have treated this last year at my clinic and will furnish clinical data on same in the very near future.

"The result of the treatment in the patient of advanced age, suffering from Locomotor Ataxia, has been remarkable."

M.R.C.S. (ENG.), L.R.C.P. (LOND.), L.S.A. (LOND.), writes:-

"I have been so pleased with the effect of your Serum that I think it right to let you know the circumstances of one of my cases.

All these symptoms soon disappeared, and her friends began to notice she was getting fat; she had gained over 28 lbs. in weight. The skin, as I expected, was very favourably affected. The indurated pustules got soft, and expulsion of their contents was easy and practically painless. All the affected parts healed well, and now she only has a few comedones, which are easily removed with the nail. Her people, who had put her under several doctors, thought it was a miraculous cure. The organic derivatives named in the formula are combined in one Compound, and put up in the form of a soluble capsule. It is believed that this is the first occasion upon which these two important products have been united in one Compound. The reasons for the combination will become apparent from a perusal of the following pages.

The close and intimate relationship which admittedly exists between the Mammary Glands, Uterus and Ovaries, accounts for the exceptionally positive and satisfactory results which have followed the numerous clinical tests to which the Ovamammoid Compound (Lowenthal) has been subjected.

Precisely the same scientific processes are employed in the preparation of the Ovamammoid Compound (Lowenthal) which have proved so successful in the preparation of the Lymph Compounds (Lowenthal).

Every successive process from first to last is stringently supervised by skilled Chemists and the most thorough circumspection is exercised. A searching examination entirely prevents the use of unhealthy animals. Even the slightest abnormality secures their immediate rejection.

Attention is specially drawn to the fact that the Canadian Organotherapy Company, never, under any circumstances, obtains the organs or any other material required for the preparation of its products from slaughter-houses. The selected animals, at the zenith of their vitality, are, after detailed examination, placed under an anæsthetic. When the anæsthesia is deep the required organs and glands are removed, and the products immediately prepared therefrom. Stringent precautions are observed throughout the whole of the work of preparation, both as to environment and in every other respect. Thus the Canadian Organotherapy Company, is at all times ready to give an unqualified guarantee that all their products are, whenever sent out, absolutely aseptic and active, and that they will remain so, (subject to the observance of the specified conditions as to temperature and absence of light) for six months at least.

The best evidence which can be produced as to the complete success of the precautions taken and the processes employed is the fact that, although the capsules manufactured and distributed by the Company, upon prescription, in a year, number several millions, and although the amount of serum manufactured and distributed, upon prescription, by the Company, reaches in a year to several hundred ounces, not one case of illeffect has ever been reported.

The Ovamammoid Compound (Lowenthal) is the outcome of two years' laboratory work, and it has been tested clinically and exhaustively. In accordance with its invariable practice, the Canadian Organotherapy Company, resolved not to place the new product at the service of practitioners until it was possible to say, unreservedly, and as a result of actual experience, that the Ovamammoid Compound (Lowenthal) was scientifically perfect, absolutely aseptic and active, and of demonstrated therapeutical value to an exceptional degree. The new product is now offered to the Medical Profession with the assurance that after adequate administration there will be obtained RESULTS of an exceptionally satisfactory character in the conditions in whi c indicated.

THE OVARIES

The close relationship between the ovaries and the nervous system, referred to above, is illustrated by the fact that vasomotor weakness is often the sole cause of ovarian and uterine congestion, leading to serious hæmorrhage.

Owing to the sympathy existing between the ovaries and the uterus, disorders of the one influence the other, and such influence is undoubtedly exerted through the nervous system.

The ovaries add to the blood passing through them a peculiar product of metabolism which is able to powerfully modify uterine functioning.

The leading part played by the ovaries in the organism is illustrated in those reported experiments in which functioning has been restored to animals (whose ovaries had previously been removed) by ovarian grafting.

Ovarian inactivity produces a tendency to put on flesh, thus illustrating the profound influence exerted by the ovaries upon assimilation and nutrition.

A lack of ovarian development, malformation, or a rudimentary condition of the ovaries are frequently associated with mental disease, frigidity, Nymphomania, and grave psychical derangement.

In wasting diseases in women, atrophy of the ovaries is frequently present.

Acute mania often follows Ovariotomy, as shown by Barwell, Pozzi, Gaillard, Thomas, Butler-Smythe, and others. Premature menopause results from removal of the ovaries. Artificial menopause also follows if the uterus is removed and the ovaries left. Complete removal of both ovaries brings about a permanent cessation of menstruation in 95% of cases, while it will continue unaltered if only a portion of one ovary be left.

The ovary increases the number of red cells. Perrin (of Paris) has shown that the hormone of the internal secretion of the ovary is a primary agent in regulating the mechanism of the manufacture of blood.

The theory that the ovary, like the testicle, elaborates an internal secretion (in the production of which interstitial cells are primarily concerned) is generally accepted. If this were not so, the neuroses, obesity, flushings and other disturbances following the cessation of the elaboration of the secretion of the ovary would be difficult to account for. The ovary undoubtedly contains an oxidising ferment, and the phenomenon of the menopause, either natural or artificial, is probably due to the absence of that ferment. The symptoms of the menopause, therefore, are closely associated with the influence of the secretion of the ovary upon the organism. This is illustrated by the fact that Oöphorectomy is invariably followed by a diminished output of phosphorus.

Loewy and Richter removed the ovaries of bitches and found marked alterations, including a 10% diminution of oxygen absorption. Ovarian extract was then given, when it was observed that the oxygen absorption rose to beyond normal. Loewy and Richter recorded, as a result of their experiments, their opinion that Oöphorectomy produced a disturbance in the combustion of fats and other non-nitrogenous substances.

Exner has stated that the function of the ovary is to regulate Sexual activity and the formation of fat.

Some competent observers have recorded the opinion that the ovary discharges into the system an antitoxic product, which neutralizes certain toxic substances resulting from metabolic changes. The cessation of the discharge of that antitoxic product invariably results in a definite and marked disturbance of metabolism.

It is believed, by those who have devoted much attention to the subject, that the general sexual characteristics of the female are influenced, not strictly by ovulation, but by a product or secretion of the ovary which has a profound influence on the economy generally. Arrested development of the ovaries means sterility.

The increased severity of the symptoms in cases of artificial menopause over those in cases of natural menopause is believed by many to be due to the increased rapidity of the rate at which the change in the activity of the ovaries is made, and because of the more sudden withdrawal of the ovarian secretion.

CLINICAL RESULTS SECURED BY THE ADMINISTRATION OF OVARIAN EXTRACT.

Inasmuch as the Ovaries supply to the female organism a marked stimulation which is essential to its well-being, the success which follows the administration of Ovarian Extract (when scientifically prepared) is not difficult to explain.

Clinical observation has proved that the ovarian nerves can be kept active and inhibition prevented by the administration of Ovarian Extract, when properly compounded.

Fosburg and Dalché have reported numerous cases in which climacteric flushing has been cleared up by the administration of Ovarian Extract, but only when suitably prepared.

Martin and Kippenberg have reported fourteen cases of total Ovariotomy in which the subsequent health of the patients has benefited by the administration of Ovarian Extract (when suitably prepared.)

Saafeld has reported that he has employed Ovarian Extract (suitably prepared) for skin troubles at the menopause, and for Prurigo at the menstrual periods with great success.

In 1896 exhaustive experiments and observations were made by Mainzer, Mond, Chrobak, Muret, Jacobs, Martin and others, in regard to the influence of Ovarian Extract upon postovariotomy symptoms, and *all* reported satisfactory results.

Bestion de Chamboulas has stated that the symptoms of the menopause can' be materially relieved by giving Ovarian Extract without any side treatment at all. He states that the mental symptoms are, especially, favorably influenced. Sensations of heat, due to vaso-motor disturbance, were, in his experiments, readily relieved. In omnia and headache disappeared. Bestion de Chamboulas specifically states that throughout his observations all possibility that the favourable results shown were due to "Segestion" could be positively excluded. In no single instance did the patients know what was being given.

Burghart gave Ovarian Extract (suitably prepared) to women of twenty who exhibited marked obesity and a lack of development of uterus and ovaries. He reports that, by the employment of Ovarian Extract in these cases, he was able to obtain a reduction of weight to the extent of as much as sixteen pounds.

Jayle states that Ovarian Extract was first used by Regis in the case of a female patient suffering from Insanity, who definitely improved.

Ovarian Extract has been employed with marked success in cases in which the uterus and ovaries were poorly developed, and where the onset of puberty was delayed.

Ovarian Extract has been demonstrated by experiment to be capable of stimulating cellular activity, and of increasing the power of cells to destroy sugar. Interest in the effects produced by Ovarian Extract was first shown as a result of its empirical use in the treatment of Insanity and other symptoms following Oöphorectomy.

The therapeutic value of Ovarian Extract is supported by the results of careful physiological experiment, which has abundantly justified its use and placed it on the same value level as Thyroid Extract.

It is an interesting fact that when Ovarian Extract is administered to women whose ovaries are in a normal condition, it exercises no observable influence whatever.

Parhon, Papinian and Senator have shown that the administration of Ovarian Extract increases the elimination of Calcium.

Geash reports that he treated a woman of sixty for delusional Insanity by Ovarian Extract, and obtained a complete recovery in three months.

Delaunay reports that he treated a case of Climacteric Grave's Disease with Ovarian Extract, and secured a complete recovery.

Loewy and Richter believe that reduction in climacteric obesity secured by the administration of Ovarian Extract is at the expense of non-nitrogenous and not proteid substances.

Ovarian Extract and its influence has been studied for many years, and its definite therapeutic value fully demonstrated.

The failure of some preparations of Ovarian Extract to secure results is due entirely to faulty and unscientific methods of preparation, compression into tablets, atmospheric exposure, etc., resulting in material loss of activity.

It cannot be too strongly emphasised that successful results from the administration of Ovarian Extract are entirely dependent upon the employment of scientific methods in its preparation. The product *must be active* and properly prepared. Crude methods (which are unfortunately so frequently employed, owing to lack of knowledge) invariably mean an inert derivative.

The scientific methods of preparation so successfully employed for the production of the Lymph Compounds (Lowenthal) (avoiding entirely compression and other faults) are also employed in the preparation of the Ovamammoid Compound (Lowenthal).

Clinical observation has demonstrated that Ovarian Extract is of great service by the compensation it affords in controlling the nervous disturbance which follows the removal of the ovaries.

Numerous observers have testified to the definite therapeutic value of Ovarian Extract (when suitably prepared) in troublesome cases of Sexual Apathy in women.

Ovarian Extract has been employed largely in Chlorosis and Hysteria with positive results which were unobtainable from the previous employment of other therapy. A long experience, extending over several years, has demonstrated that Ovarian Extract, when scientifically prepared and administered in suitable doses, is entirely harmless and never causes any ill effect.

Ott has shown that Ovarian Extract definitely reduces Arterial tension.

It is impossible to disassociate the menopause from retrogressive changes taking place in the ovaries, inasmuch as the symptoms of the natural menopause are so closely allied to those of the artificial menopause.

Gissler has shown that anginal attacks occurring at the menopause, can be considerably relieved by the administration of Ovarian Extract (suitably prepared).

Einhauser found and reported that the administration of Ovarian Extract, when scientifically prepared, gave considerable relief from the troublesome symptoms arising from either the natural or an artificial menopause.

MAMMARY GLAND EXTRACT

The inter-connection existing between the mammary glands, uterus and ovaries is constantly illustrated in practice.

Cases are on record in which menstruation has been accompanied by a monthly discharge of milk.

Beatson has shown that there is a close relationship between the ovaries and the secretion of milk.

Scanzoni has shown that the absence of one ovary is directly associated with arrested development of the corresponding mammary gland.

Bell and Schaber employed Mammary Gland Substance in Uterine Myoma, and obatined a definite diminution in the size of the tumour and total cessation of the hæmorrhages.

Mykartschianz demonstrated that the administration of Mammary Gland Substance caused the disappearance of Fibroma in two cases, a diminution in size, in twenty-one cases, and that results were negative in three only in a total of twenty-six cases. He found that hæmorrhage and pain were diminished. He further reported that he had obtained excellent results from the administration of Mammary Gland Substance in Metritis.

It has been shown by several observers that there ensues from derangement of the functioning of the pelvic generative organs under sympathetic excitement, a hyper-activity of the secreting cells of the mammary glands with distention and enlargement.

Mammary Gland Substance has been employed with definite success as a galactagogue.

That the mammary glands are closely related to the pelvic generative organs is evidenced by the fact, amongst others, that the mammary glands become tender and enlarged just before each menstrual period. It is not without significance that the mammary glands enlarge as the generative organs approach maturity.

The reflex nervous relationship between the reproductive organs of women and the mammary glands is of first importance.

Enlargement of the mamma is initiated by puberty or pregnancy.

Laumonier has shown that Mammary Gland Substance has been successfully employed to produce uterine contraction and to check hæmorrhage. He also has shown that the administration of the product reduces the size of the tumour in Uterine Myoma, and that it arrests hæmorrhage.

Mammary Gland Substance has been attested by many authorities to be of exceptional service in the treatment of the neuroses following Mastotomy.

It has been demonstrated that small doses of Mammary Gland Substance definitely improve nutrition.

Hare has also shown that Mammary Gland Substance can be successfully employed for checking Metrorrhagia.

Abnormal hæmorrhage is, as is well-known, often due solely to an irregular condition of uterine circulation during the menopause. It has been demonstrated that the irregularity can be overcome, and the hæmorrhage stopped by the administration of Ovarian and Mammary Gland Substance.

The onset of Rheumatoid Arthritis, so frequently associated with the advent of the menopause can be definitely prevented in many cases by the administration of Ovarian and Mammary Gland Substance when the menopause sets in.

At the advent of the menopause it is imperative that nature should be assisted to arrange and re-adjust the nervous and vascular equilibrium. Clinical experience demonstrates that the most successful method of accomplishing this is to provide a suitable compensation for the cessation of the secretion of the ovary (which cessation is the cause of the disturbance of equilibrium) in the form of Ovarian Extract combined with Mammary Gland Substance.

The obesity of many married women, the thinness of many unmarried women, the atrophy (or else the excessive fattening) of mammary glands, the marked nervous and vaso-motor disturbance, the heats and flushes, the palpitation, the profuse perspiration, the giddiness, the faintness, the exhaustion, the morbid fears, the mental depression, the loss of memory, the numbness and tingling, the sensations and delusions, the hyper-aesthesia of special senses, the moral perversities and the liability to disease which set in (in whole or in part) at the menopause can be materially and definitely modified and, in many cases, prevented by the compensation provided by the administration of Ovarian Extract with Mammary Gland Extract at the climacteric period. The truth of this fact has been demonstrated by clinical observation in many hundreds of cases. The generally accepted nervous origin of the menopause is believed by many to be the direct result of a cessation of the elaboration of the secretion of the ovary. The subsequent degeneration and disease is believed to be traceable also to the same cause.

Clinical experience shows that, by the timely employment of Ovarian Extract with Mammary Gland Substance (suitably prepared), the hysterical phenomenon and tendency to Melancholia, so frequently associated with the menopause, can be effectively warded off.

MENSTRUATION.

Painful, profuse or suppressed menstruation are, as is wellknown, frequently associated with lesions of the ovary.

Amenhorrhœa is frequently produced by disordered metabolism or, in other words, a disturbance in the balance of anabolism and katabolism, due to some fault in the internal secretion of the ovary or to imperfect functioning. Amenhorrhœa also results from Oöphorectomy and ovarian diseases. The nervous symptoms are much more severe in Oöphorectomy than in Hysterectomy, doubtless owing to the absence of the internal secretion of the ovary.

Dysmenhorrhœa is, admittedly, frequently due to a degenerative condition of the ovaries, or to nervous distrubance resulting from imperfect ovarian functioning.

Disturbances of the catamenia frequently co-exist with mastitis.

Most observers concur that both the uterus and ovaries are active agents in the production of menstruation.

Jayle believes that Amenhorrhœa, Dysmenhorrhœa, and Metrorrhagia, when associated with vaso-motor disturbance, are invariably symptomatic of functional ovarian insufficiency, for, in his experience, such cases have responded well to the compensatory action of Ovarian Extract (when suitably prepared and preserved).

Sudden cessation of menstruation frequently precedes hypertrophy of the mamma. It would therefore appear certain that disturbances of the sexual organs of woman play an important part in the causation of mammary gland hypertrophy.

Williams has reported cases in which mammary gland hypertrophy occurring in childhood has been closely associated with precocious sexual development.

CHLOROSIS.

Chlorosis materially interferes with the development of activity of the ovaries and uterus.

Disorders in the sexual functions are frequently the inciting cause of aglobulia in women.

The stimulation of the blood-forming organs, to replace losses, depends on the internal secretion of the ovary. The loss of such stimulation, from ovarian insufficiency, endangers the normal course of blood formation.

As stated elsewhere, the hormone of the internal secretion of the ovary is a prime y agent in regulating the mechanism of the manufacture of bloc ¹. According to the researches of Perrin, the ovarian secretion increases the number of red cells. Ovarian insufficiency is a most frequent cause of Chlorosis. It is believed by some eniment authorities that the symptoms of Chlorosis are caused largely by the want of the antitoxic ovarian secretion. They believe that until puberty sets in, antitoxic substances are supplied by the thymus gland. After that gland has atrophied, the ovarian secretion influences blood formation.

Dalché reports that, by the administration of Ovarian Extract so prepared as to retain its activity, he has definitely cured Chlorosis in numerous cases.

Spillmann, Etienne, and Moscucai all report that they have proved that Ovarian Extract (when scientifically prepared) definitely increases the number of red cells and materially helps to establish the menses in Chlorosis.

Bestion de Chamboulas and many others also report equally favourably as to the definite and exceptional therapeutic value of Ovarian Extract in Chlorosis.

In Chlorosis, as is well-known, there is a marked diminution of red cells and hæmoglobin. The red corpuscles are small and light, and the oxidation processes in the body are interfered with. An active stimulant is therefore required, and the most efficient agents are the various organic derivatives, such as Ovarian Extract and Spermine, the latter of which is the base of the Lymph Compounds (Lowenthal).

The Organotherapy Compounds (Lowenthal) are, it is believed, more powerful lymphatic stimulants than any other therapeutic agents at present available.

The Ovamammoid Compound (Lowenthal) is one of the best examples of treatment by "substitution" or "compensation," and equally as efficient as Thyroid Extract.

It is a galactagogue and an emmenagogue of definite value.

IN CONCLUSION

The results obtained from the exhibition of the Ovamammoid Compound (Lowenthal) in the conditions in which it is in licated have proved to be superior to those secured from the employment of other agents.

The reflex nervous relationship between the reproductive and other organs of woman are numerous and important. The unstable equilibrium between expenditure and repair of nerve force so frequently found to exist at puberty and at the menopause has been proved by clinical experience to be more easily and effectively remedied by treatment by "Substitution" or "Compensation" than by drug treatment or other therapy.

Demonstrated physiological facts have alone been taken into account in the initiation, elaboration and perfecting of the Ovamammoid Compound (Lowenthal). The findings of observers of great experience, to some of whom reference has been made herein, have formed the basis of all the laboratory work and clinical tests which have been devoted to the new product over a long period.

In accordance with the invariable practice of the Canadian Organotherapy Company, the Ovamammoid Compound (Lowenthal) has been kept back until, in the opinion of the Company's chemists and scientific advisers, it was as perfect as it was possible to be, and until it was fully demonstrated that by the employment of the Company's own scientific processes, the product will (subject to the fulfillment of the conditions as to temperature and absence of light) remain active and perfectly aseptic for six months at least, as in the case of the Lymph Compounds (Lowenthal).

Furthermore, the new product has also been kept back until exhaustive clinical tests have demonstrated that, not only is the basic theory of the treatment scientifically sound, but that the results secured from the exhibition of the product in all the conditions indicated herein are definite and permanent, in the great majority of cases treated.

REPORTS

LACK OF MAMMARY GLAND DEVELOPMENT

M.D. (DURH.), M.R.C.S., L.R.C.P. (LOND.), states:-

"I have been employing the Ovamammoid Capsules in a case of a patient suffering from lack of Mammary Gland Development, and who desired improvement in her bust measurement. I administered the treatment for a few weeks only, when I had to discontinue it because the patient informed me that her bust measurement was, owing to the action of the treatment, becoming greater than she desired."

HYPERTROPHY OF MAMMARY GLAND WITH PAIN

M.D. (EDIN.), states:-

"The patient for whom I prescribed the Ovamammoid Compound (Lowenthal) has done exceedingly well. She came to me complaining of acute pain in her left breast. Upon a superficial examination I found the breast considerably enlarged, the right breast being normal. It was impossible to ascertain whether the overgrowth was malignant or not as the patient declined to submit to an exploratory examination, and the blood gave no indication. I suspected Mammary Gland hypertrophy. I gave the patient Ovamammoid Compound for six weeks, by which time the left breast was as equally normal as the right. M.R.C.S., L.S.A. (LOND.), states:-

"A woman patient suffering from severe Menopause disturbance has been under treatment by the Lymphoid Capsules for three months and has derived considerable benefit. This patient had previously been under the care of another physician for two years but she obtained no relief. I have treated her for three months with the Capsules, and I am now able to tell you that she is cured."
