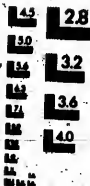
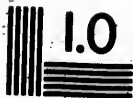

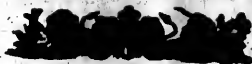

SUB-SECTION 4 OF SECTION 2, OF THE ACT TO CONSOLIDATE AND
AMEND THE LAW RESPECTING VOTERS' LISTS.

4.—The Sheriff shall immediately upon receipt of his copies, cause one of them to be posted up in a conspicuous place in the Court House; the Clerk of the Peace, upon receipt of his copies, shall cause one of them to be posted up in a conspicuous place in his office; every Public or Separate Head Master or Mistress shall in like manner put up one on the door of the School House; and every Postmaster shall post up one of his copies in his Post Office.—30 V., C. 11, S. 4, S. S. 2.

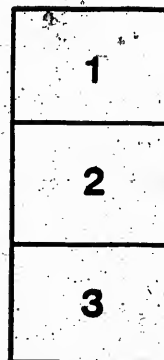
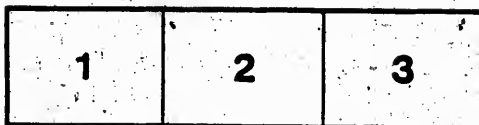
