## EAST YORK'S WILLIAM TELLS.

## The Famous Contest for the Possession of the Kennedy Challenge Cup Fought Out at Osgoode Hall.

The men of East York pride themselves on many things, but on nothing so much as their ability to shoot with the rifle. It is a common practice after the manner of William Tell for an East York farmer, and especially those who live around the centre of Markham or along the town line of York to go out into the farm yard every morning and shoot an apple off the head of their favorite sons. The nickel-plated spurs on the top of lightning rods have been shot from every barn by these amateur marksmen.

The whole of Markham rifleman has been convulsed for the past eight or nine weeks over a dispute as to the ownership of the cup contested for at Osgoode Hall last March, and for the past week half the residents of the township have been about Osgoode Hall waiting to give evidence in the lawsuit arising therefrom. There has been enough money spent in expenses to buy 500 cups of the value of the one whose ownership was disputed, but Mr. Rennie, who claimed the cup, was bound to have it if he would give it to him even if he had to sell his broad acres.

The plaintiff was Mr. Simpson Rennie, who sued the Managing Committee of the Kennedy Challenge Cup for its possession. The case was tried before Justice Meredith at Osgoode Hall yesterday.

The plaintiff asked the court to award him the custody of the cup for the next year, and to declare him the winner in the competition. The cup was originally owned by 35 members, who agreed that the one who made the highest score in three successive times should be declared the owner of the cup. The matches were to be held on the last day of March and September of each year until the cup was won.

He made out which the dispute arose over, the cup was won by Mr. Rennie on March 28 last. The plaintiff, Simpson Rennie, scored 48 out of 50, while the defendant, James Rennie, scored 47 out of 50.
